1:23 PM on 16 Dec 2019 The availability of alcohol whether by delivery or direct purchase on the Premises of Bush Centre Service station after 11pm exacerbates the problems experienced by residents of Shepherds

Bush Green and the surrounding streets.

We experience high levels of ASB on both Shepherds Bush Green and the surrounding streets, the Police deal with the consequences on a daily basis. There is no need or requirement for deliveries of alcohol after 11pm. There are a couple of 24/7 alcohol Licences within a couple of hundred yards and this additional Licence would increase the levels of both public nuisance and

public safety.

LBHF has become a 'destination' for alcoholics as a result of these 24/7 Licences. Many of our alcoholics are local residents and it will be very easy for them to order

wine and have it delivered.

There have been a flurry of bids for Deliveroo and 1 hour deliveries will very soon become mainstream. The alcoholics can then join their 'friends' on and around Shepherds Bush Green with new supplies between the hours of 11pm and 8am.

They can effectively circumvent the 'delivery' clause which I presume is supposed to suggest that it is for legitimate customers.

I see absolutely no reason why a customer would find it necessary to order alcohol between the hours of 11pm and 8am.

Shepherds Bush Green is intimidating to LBHF residents particularly those with young children at night. The public nuisance, urination and faeces has to be dealt with by the LBHF street cleaners.

As a community we are doing everything in our power to improve safety with the Police.

It would be a very retrograde step to issue a 24/7 Alcohol Licence with OR without the restriction to 'deliver'.
