Re: **Premises Licence 2020/00672/LAPR - Premises: (81 -85 Bloemfontein Road) 81 Bloemfontein Road London W12 7DA**

Please see below correspondence between Police and the applicant's agent. The following three conditions have been agreed:

- No beers, lagers, or ciders over 5.5% ABV shall be sold at the premises save for premium beers, lagers, or ciders in glass bottles. This list of products will be agreed in writing with the Police Licensing Team.
- There shall be no sale of single cans or bottles of beer, lager or cider from the premises and no single bottles of beer, lager or cider in vessels of less than 500ml. For the avoidance of doubt customers are permitted to purchase two (or more) single cans/bottles from different brands.
- The Premises Licence Holder shall, on receipt of a request in writing (email will suffice) from the Police, suspend alcohol sales at the premises on days when Queens Park Rangers Football Club (QPR) have a 1st team match at Loftus Road that the police consider to be high risk in terms of supporter behaviour. Such requests from the police must be on at least 48 hours; notice and will be limited to the period of 2 hours before the stated kick of time and the period of 1 hour after the match ends.
