4	<p>LAND</p> <p>Any beneficial interest you or the relevant person have in land within the area of Hammersmith and Fulham.</p>	None
5	<p>LICENCES</p> <p>Any licence (alone or jointly with others) you or the relevant person have to occupy land in the area of Hammersmith and Fulham for a month or longer.</p>	None
6	<p>CORPORATE TENANCIES</p> <p>Any tenancy where (to your knowledge)—</p> <p>(a) the landlord is Hammersmith and Fulham Council; and</p> <p>(b) the tenant is a body in which you or the relevant person have a beneficial interest.</p>	Hammersmith and Fulham Council
