1. ELECTION OF MAYOR 2006/07

7.00pm – Former Councillor Charlie Treloggan, as the outgoing Mayor, took the Chair at the start of the meeting.

The Chief Whip, Councillor Frances Stainton, proposed, seconded by the Deputy Chief Whip, Councillor Donald Johnson, that Councillor Minnie Scott Russell be elected as Mayor of the Borough for the 2006/07 Municipal year.

There being no further nominations, the proposal was formally put to the vote:

Councillor Minnie Scott Russell was duly declared elected as Mayor of the Borough for the 2006/07 Municipal Year, following which she made the statutory Declaration of Acceptance of Office and signed the statutory undertaking to observe the Code of Conduct for Councillors.

The Mayor announced that she had decided to appoint Mr. Harry Spencer Smith as Mayor's Consort for the 2006/07 Municipal Year.

The Mayor then announced that she had appointed Councillor Andrew Johnson as Deputy Mayor for the 2006/07 Municipal Year, and that he had asked Councillor Rachel Ford to be his Deputy Mayoress.

The Mayor then called on the Leader of the Council, Councillor Stephen Greenhalgh, to speak on the presentation of the Past Mayor's badge. Councillor Greenhalgh paid fulsome tribute to former councillor Charlie Treloggan, who had served as Mayor of the Borough for the past three consecutive terms. The Leader of the Opposition, Councillor Stephen Cowan, also paid fulsome tribute to former councillor Charlie Treloggan, before he was presented by the Leader of the Council with his Past Mayor's badge.

The Leader of the Council then moved, on behalf of the Council, a Vote of Thanks to the past Mayoress, Ms. Eleanor Carlson; the past Deputy Mayor, Councillor Mercy Umeh; and the past Deputy Mayor's Consort, Mr. Maxwell Umeh, for their work in supporting the past Mayor in carrying out his civic functions, before they were each presented with tokens of appreciation.

8. COUNCIL CONSTITUTION 2006/07

7.19pm - Noted the addenda to the Constitution (previously marked "to follow") and errata sheet circulated to all Councillors and tabled at the meeting. [Copies attached at **Appendix 1** to these minutes].

The report of the Monitoring Officer on the Council's Constitution was moved for adoption by Councillor Stephen Greenhalgh, Leader of the Council, seconded by Councillor Frances Stainton, Chief Whip.

Councillor Colin Aherne, Opposition Whip moved, seconded by Councillor Michael Cartwright, Deputy Opposition Leader, that under Council Procedure Rule 15 (e) (ix), the meeting be adjourned for a short period in order to give the opposition time to study the Overview & Scrutiny Committees' terms of reference and an amendment to the Leader's Portfolio, only recently circulated to all Councillors.

The Chief Whip, Councillor Frances Stainton, on behalf of the Administration, agreed the opposition request for a short adjournment of the meeting for a period of 10 - 15 minutes.

"This Council agrees that, for the Municipal Year 2006/07, meetings of the Council, its Committees and Panels, be held on the dates specified as set out in the Council Calendar, as circulated to all councillors and tabled at the meeting."

Councillor Colin Aherne, Opposition Whip moved, seconded by Councillor Cartwright, an amendment to the motion under Council Procedure Rule 15 (e) (vi), that the council provisionally agree the calendar, with a revised version being brought back to the June Council meeting for ratification, due to the fact Councillors had only just received copies

of the proposed calendar dates and were already aware of various clashes of membership.

10. ADMINISTRATION'S MANIFESTO FOR 2006 - 2010

7.40pm - The Leader of the Council, Councillor Stephen Greenhalgh, outlined the new Conservative Administration's manifesto for the Council for 2006 -2010, which was based on the five principal aims of :

- Lowering Council Tax and providing quality, value for money, services;
- Improving markedly the local environment;
- Cutting crime in the Borough;
- Improving educational standards, and
- Supporting the most vulnerable in society

In speaking to the item, Councillor Greenhalgh also unveiled the new corporate identity logo for the Council, and its new mission statement - "putting residents first".

Councillor Stephen Cowan, Leader of the Opposition, made a speech in reply, before the item was duly noted.

7.50pm - **RESOLVED**

That the new Conservative Administration's manifesto for the Council for 2006 – 2010 be duly noted and adopted.

11. REVISED LOCAL AUTHORITIES "GOLD" RESOLUTION

7.51pm - The report of the Chief Executive on the adoption of a revised Local Authority "Gold" resolution, vesting the "Gold" Chief Executive with the power to act on behalf of all London Authorities in the event of a catastrophic disaster or emergency was put to the vote:
