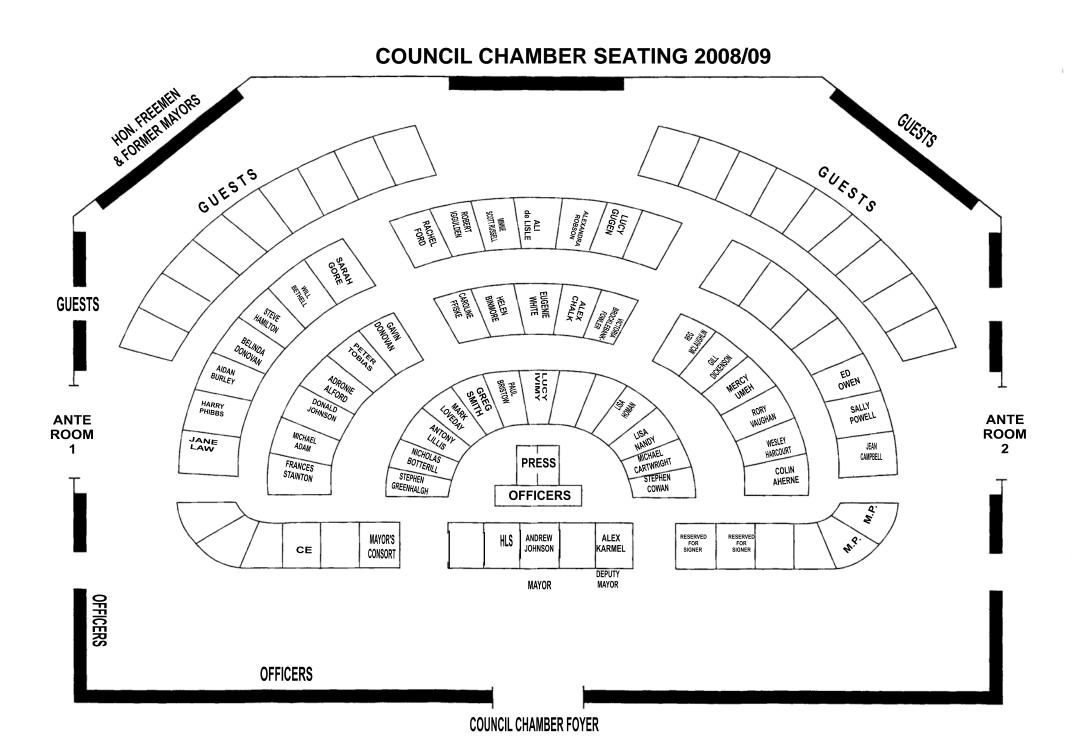

1. ELECTION OF MAYOR 2008/09

7.00 pm – Councillor Minnie Scott Russell, as the outgoing Mayor, took the Chair at the start of the meeting.

The Chief Whip, Councillor Frances Stainton, proposed, seconded by Councillor Jane Law, that Councillor Andrew Johnson be elected Mayor of the London Borough of Hammersmith and Fulham for the 2008/9 Municipal Year.

There being no further nominations, the proposal was formally put to the vote:

FOR Unanimous

AGAINST 0 ABSTENTIONS 0

Councillor Andrew Johnson was duly declared elected as Mayor of the Borough for the 2008/09 Municipal Year, following which he made the statutory Declaration of Acceptance of Office and signed the statutory undertaking to observe the Code of Conduct for Councillors.

Under Standing Order 21 (d), the Mayor suspended the meeting while he put on the Mayor's robes.

The motion was declared **CARRIED**.

(The meeting was adjourned until 7.15 pm)

The Mayor announced that he had decided to appoint Ms Joanna Richardson as the Mayoress for the 2008/09 Municipal Year. The Mayor then announced that he had appointed Councillor Alex Karmel as Deputy Mayor for the 2008/09 Municipal Year, and that the Deputy Mayor had asked Councillor Jane Law to be his Deputy Mayoress.

The Leader of the Council, Councillor Stephen Greenhalgh, proposed, seconded by the Chief Whip, Councillor Stainton, that the past Mayor's badge be presented to Councillor Scott Russell in recognition of her service to the Council in undertaking the office of Mayor, and in carrying out other associated civic duties as a Councillor.

The Leader then made a speech about the tremendous work the outgoing Mayor had undertaken during her two terms in office. Councillor Scott Russell accepted her badge and made a brief speech. Councillor Stephen Cowan, Leader of the Opposition, also appreciated the work of the outgoing Mayor to the Borough and her citizens.

The Leader of the Council then moved, on behalf of the Council, seconded by the Chief Whip, a Vote of Thanks to the past Mayor's Consort, Mr Harry Spencer-Smith and the past Deputy Mayoress, Councillor Rachel Ford, for their work in supporting the past Mayor in carrying out her civic functions, before they were each presented with tokens of appreciation.

7.25 pm - The minutes of the Budget Council Meeting held on 27 February 2008 were confirmed and signed as an accurate record.

The Mayor advised Councillors that, in relation to agenda item 11 – Councillors' Allowances Scheme: Revision, the Standards Board had advised that it was necessary for all Councillors to declare their allowances as personal interests under the Code of Conduct. In order to manage this with the minimum of disruption, all Councillors present in the Chamber would be deemed as having declared a personal interest in this item (unless the Councillor objects), and this fact would be duly noted and recorded in the Minutes. This was agreed unanimously.

I note that the Audit Commission's report of June 2007 for Hammersmith & Fulham ALMO states -

"Paragraph 108: Service charges have not been introduced for tenants. Charges for communally provided services such as grounds maintenance have not been de-pooled and applied as a separate service charge. HFH and the Council have agreed a way forward for the introduction of service charges but will only do this when efficiencies are achieved in key service areas".

Why was I misled with the previous response, given that the report is the subject of consultation with the Council over a period of time? Within what time frame do the Council propose to introduce this charge? Will rent lower as a result of the service charge being "split out" or "de-pooled"? What is the "way forward agreed by HFH Homes & the Council for the introduction of this charge", that is what is the plan?

QUESTION TO FULL COUNCIL ON 27 FEBRUARY 2008

"Does the current administration propose, during the course of its current term in office to make an additional charge to council tenants, in addition to rent, for the provision of Estate Maintenance and up keep? If so, when?"
