LOCAL DEVELOPMENT FRAMEWORK:
LOCAL DEVELOPMENT SCHEME

SUMMARY:

The Planning and Compulsory Purchase Act 2004 introduced a new planning system consisting of Local Development Frameworks (LDF) to replace Unitary Development Plans (UDP). The Local Development Scheme (LDS) sets out the content and programme for preparing the LDF.

The Act requires the council to revise its LDS at such time as it considers appropriate. It is proposed to revise the LDS, principally so that the programme is better related to the London Plan review.

The report details the changes required to the programme for preparing the Core Strategy Development Plan Document and proposes a programme for the Generic Development Management Development Plan Document.

The report seeks approval of the proposed changes to the revised Local Development Scheme and its submission to the Mayor of London and Secretary of State for approval.

The report will also seek agreement to bring the revised LDS into effect once it has been agreed.
