Hi licencing,

Planning permission was granted for ref.2011/01852/FUL "Erection of a single storey wraparound extension to the existing early years centre; erection of two single storey storage buildings one to the east and one to the west of the site; erection of a temporary modular classroom during construction work."

The following conditions were imposed as follows;

Condition 7

Neither music nor amplified voices emitted from the development hereby approved shall be audible at any residential/ noise sensitive premises.

To ensure that the amenity of occupiers of surrounding premises is not adversely affected by noise, in accordance with Policy EN20A, EN20B and EN21 of the Unitary Development Plan, as amended 2007.

Condition 10

No tannoys or public address systems shall be used unless details have been submitted to and approved in writing by the Council. Approved details shall be implemented prior to use and thereafter be permanently retained.

To ensure that the amenity of occupiers of surrounding premises is not adversely affected by noise, in accordance with Policy EN20A, EN20B and EN21 of the Unitary Development Plan, as amended 2007.

There was quite a lot of "chat" amongst neighbours in the street with regards to the noise, parking and littering issues that understandably were a potential concern. However, we have been incredibly impressed with the respectful manner in which the market has been operated in even from the very first Sunday that it opened.
