- 1. No supply of alcohol may be made under the premises licence -
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. (a) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
 - (b) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

- 3. Alcohol shall not be sold or supplied in an open container or be consumed in the licensed premises.

Underage sales test purchase

I am writing to inform you that you have successfully passed a test purchase carried out by Hammersmith and Fulham Trading Standards service. On 8/26/2010 this service carried out a test purchase at your premises. 1 boy aged 14 volunteer/s attempted to purchase Alcohol (off licence) and was refused by the member of staff working on that day.

This service routinely carry out test purchases to ensure that shops do not sell agerestricted products to persons under the required age limit. We advise traders to "Challenge 21" by asking for identification if the purchaser looks under 21. We also advise traders to display posters supporting the "Challenge 21" scheme as this may deter children from attempting to buy age-restricted goods. Posters may be available from Trading Standards, if you want to display posters in your shop please contact us.

I would like to remind you that it is a criminal offence to sell age-restricted products to persons under the required age limit. This table shows the age restrictions and penalties for selling age-restricted products:

Product	Age restriction	Maximum penalty
Alcohol	18 and over	£5,000 and potential for review of licence
Tobacco and tobacco products	18 and over	£2,500
Fireworks	18 and over	£5,000 and/or 6 months imprisonment
Knives	18 and over	£5,000 and/or 6 months imprisonment
Butane Gas	18 and over	£5,000 and/or 6 months imprisonment
Solvents	18 and over	£5,000 and/or 6 months





We understand the Applicant will operate as a responsible and respectable alcohol retailer.

We have inserted clauses in the lease which prevent the Applicant from using the ground floor of the Premises in any way that may cause any nuisance or inconvenience to the other occupiers of the Premises and understand that the Applicant's occupation of the Premises will not cause disturbance to the current residents who live at the Premises.

We support the Applicant's application for a Premises licence.

(Including conditions/hours agreed with police and outstanding conditions from the operating schedule that are enforceable or not otherwise replicated)

Revised Hours for sale of alcohol (off-sales) with opening hours in brackets

- Monday –Saturday 10:00-23:00 (08:00 23:00)
- Sunday 10:00-22:30 (10:00-22:30)

Conditions (in addition to mandatory conditions)

(Note: these exclude the fire safety conditions originally proposed in the operating schedule given these conditions are of no effect pursuant to paragraph 43 of the Regulatory Reform (Fire Safety) Order 2005. They also exclude matters already addressed in the mandatory conditions)

- 1. The premises licence holder shall effectively and responsibly manage the Premises.
- 2. Every incident of crime or disorder in the Premises shall be reported to police by the Designated Premises Supervisor or a nominated member of staff.
- 3. The Designated Premises Supervisor and all members of staff shall ensure that all lawful and reasonable instructions and/or directions given by the police are complied with.
- 4. High-Definition CCTV shall be installed, operated, and maintained at all times that the Premises is open for licensable activities and:
 - Shall be checked every two weeks to ensure that the system is working properly and that the date and time are correct. A record of these checks, showing the date and name of the person checking, shall be kept and made available to Police or authorised Council officers on request.
 - One camera will show a close-up of the entrance to the Premises, to capture a clear, full-length image of anyone entering.
 - Shall cover any internal or external area of the Premises where licensable activities take place.
 - Recordings shall be in real time and stored for a minimum period of 31 days with date and time stamping.
 - Footage shall be provided free of charge to Police or authorised council officer within 24 hours of a request.
 - A staff member from the premises that is conversant with the operation of the CCTV system shall be on the premises at all times. This staff member will be able to show police or authorised officers of the Licensing Authority recent data

footage with the minimum of delay when requested. This data or footage reproduction shall be almost instantaneous.

- 5. All staff responsible for selling alcohol shall receive regular training in the Licensing Act 2003 in terms of the licensing objectives, offences committed under the Act and conditions of the Premises Licence. Written records of this training shall be retained and made available to police and authorised officers of the Licensing Authority on request.
- 6. Strong beer, lager, cider and stout above 5.5% ABV shall not be displayed or sold.
- 7. The premises shall operate a 'Challenge 25' age-restricted sales policy and promote it through the prominent display of posters.
- 8. The licence holder see shall put arrangements in place to ensure that before serving alcohol or other age-restricted goods to customers they believe to be less than 25 years of age, staff ask to see accredited proof of age: that is, proof of age cards carrying the 'PASS' logo (and no others), a Passport, or UK Driving Licence bearing the photograph and date of birth of the customer.
- 9. The licence holder shall require staff to note any refusals in a refusals log. The refusals log shall record the date and time of the refusal; the name of the staff member refusing; and the reason for refusal. It must be checked and signed monthly by the designated premises supervisor. The refusals log shall be made available for inspection upon request by the Licensing Team, Police or Trading Standards.
- 10. Any alcohol sold for consumption off the Premises shall be sold in a sealed container.
- 11. There shall be displayed at the entrance to the Premises a sign, which is visible to members of the public visiting the Premises containing details of the trading hours under the premises licence.
- 12. There shall be displayed at the entrance to the Premises sign, which is visible to members of the public visiting the Premises requesting the customers to respect the neighbours surrounding the Premises and to behave in and orderly and courteous manner.
- 13. All staff shall be instructed and trained to ensure customers are discouraged from congregating outside the Premises.
- 14. All staff shall be instructed and trained to ensure no deliveries of stock are made to the Premises between 22:00 and 08:00 on any day.
- 15. All staff shall be instructed and trained to ensure the sale or supply of alcohol is prohibited to any person who is intoxicated.

16. A notice or notices shall be displayed in at the entrance to the Premises where they can be clearly seen and read and shall indicate that it is unlawful for persons under 18 to purchase alcohol or for any person to purchase alcohol or for any person to purchase alcohol on the behalf of a person under 18 years of age.

Dear Maria Dimitriou, Licensing Officer (cc: Lic Authority: Charles Francis, Karen Layug, Adrian Overton)

Having received the Agenda Pack and Supplementary Agenda items this morning, April 27, I would like to make the following further comments to the Licensing Committee.

1. Agenda Pack page 82, Email of LBHF Planning Officer James Carleton, attaching email of Graham Simpson, Planning

James Carleton clearly states that Planning would object to the hours submitted by the Applicant for a License (until 02:00), 2022/00168/LAPR 19A Michael Road, based on the Planning Permission 2014/01279/FUL which clearly states the opening hours allowed as

06:00-22:00 on weekdays

and

07:00-20:00 on weekends and bank holidays

James Carleton states: "Please see condition below. We would object to extending these hours."

Reading this carefully, his Representation could actually a possible hint at what would happen, were the Applicant to actually apply for Planning Permission as a gym, for this new address, 19A Michael Road.

This Point 1, above, relates to my next points 2, 3 and 4.

2. Agenda Item 6, page 18 of Supplementary Agenda

On 2 Feb 2022, the Applicant submitted 2022/00168/LAPR requesting hours from 09:00 - 02:00.

On 25 April 2022, the Applicant revised its originally requested licensing hours in the Application dated 2 February 2022.

The revised hours requested are: 10:00-12:00am (midnight) Monday - Sunday.

May I please point out to the Licensing Committee, and again to the Applicant, that these newly proposed hours are not in line with the allowed opening hours, which supersede any granted licensing hours.

Those permitted opening hours, including for licensed activities, are, as clearly stated in the LBHF Planning Representation of James Carleton email trail dated 28 February 2022, 14:17 and Graham Simpson 28 Feb 14:22, quoting Planning Permission 2014/01279/FUL:

06:00-22:00 on weekdays

and

07:00-20:00 on weekends and bank holidays

- 3. The LBHF Licensing Policy 14.10 clearly states that "all Applicants are encouraged to obtain the correct planning permission". May I please bring to the attention of the Licensing Committee that the Applicant does NOT have planning permission to use this new address, 19A Michael Road specifically as a Gym; no application has been made for such, as far as I can see and as confirmed to me by Planning.
- 4. The LBHF Licensing Policy 14.10 also states that "operating a license without the relevant planning permission could be a breach of planning control and could leave license holders vulnerable to enforcement action".

The Applicant states that she has looked at the opening hours of The Rose, 1 Harwood Terrace, a pub close by, and aligned her new suggested hours to those hours. In fact, the proposed licensed hours need to be aligned with the Planning Permission hours of the proposed Premises, not a pub nearby, although local cumulative impact could well be taken into consideration by the Licensing Committee.

In conclusion, were the Licensing Committee to grant a License, would they please consider using the official Planning closing hour of 22:00 so that this point is clear, once and for all, to the Applicant and to everyone; otherwise, as also stated in the LBHF Licensing Policy 14.10 a protracted Enforcement issue could ensue with Planning.

5. Fire Risk Assessment

On page 66 of the Agenda Pack, the Applicant mentions that a Fire Risk Assessment will be undertaken on 21 March. The results of this have not been included in the Pack or the Supplementary Agenda.

I assume that the Fire Risk Assessment was made BEFORE the Red double decker bus was in situ.

Email of 10 March page 40 of Agenda Pack

It would be in the interest of all to see the Fire Risk Assessment, perhaps especially as it relates to the outdoor forecourt space that the Applicant added, in an email of 10 March (page 40 of Agenda Pack) to the 'licensable area' on a map (page 41) showing the forecourt as vacant. In that email the Applicant does mention the portacabins but makes no mention of the double decker party bus.

An arial view (page 60) submitted by the Applicant also shows the forecourt as vacant.

I submitted two photos of the actual forecourt now, full up with serious kit (page 77 of the Agenda Pack).

Photos of forecourt with portacabins and red double decker bus pages77-78 I have supplied photos (page 77-78) of the forecourt now looking visually full to capacity with the Red double decker bus announced online (page 78) as well as temporary portacabins (applied for by the developer who is knocking down 19 Michael Road).

Paragraph 15 of the LBHF Licensing Policy requires applications to be unambiguous and for applicants to be clear about what they intend to achieve.

Architectural plans/drawings submitted by the Applicant showing empty forecourts that are not empty cannot give the Licensing Committee confidence in how the Applicant intends to operate.

Arial photos submitted by the Applicant with empty forecourts that are no longer empty do not inspire confidence in the Applicant giving a true picture of what is going on at this site.

6. Capacity numbers for corporate events/brand launches/parties.

The LBHF Lic Policy 9.5 addresses the need for safe capacities.

The capacity numbers are still unclear; I initially asked about maximum capacity numbers inside; now with the forecourt added to the licensable area, and that area now full with the double decker party bus and portacabins it would be useful to have accurate numbers.

I was asking for two reasons: fire safety concerns as well as amenity as it relates to traffic ie cabs, ubers, vehicles transporting attendees of corporate events/parties etc to and from this venue.

What if a fire ensues? One of the first questions relating to liability and insurance would be about official capacity numbers. Surely the Lic Committee needs assurances that the Fire Risk Assessment took into consideration this forecourt with portacabins and double-decker party bus.

The Licensing Officer, Mr Overton, told me that capacity numbers should be in the fire risk assessment. Perhaps the Lic Committee could ask about this, especially as the forecourt now looks very full indeed.

My questions in my Representation of 7 April, pages 72-76 of the Agenda Pack regarding BBQs, smoking etc in this forecourt remain unanswered.

I hope that the fire officer answered them, perhaps verbally to someone in the Licensing Authority, to the Lic Committee's satisfaction (as the fire safety person who rang me (Kevin Keown) told me that they don't comment on such applications—see my 7 April Representation page 2, point 6, second paragraph, (page 73 of the Agenda Pack)). Were there ever to be a fire....

7. Bullet point 6, page 57

This mentions alcohol being served after 22:00. As the allowed hours are only until 22:00 on weekdays and 20:00 on weekends and banks holidays, this point needs rewriting.

8. Bullet point 6, page 66

This mentions private parties falling within capacity. What are those capacities and what are they based on and approved by whom?

9. Bullet point 3, page 67

This mentions alcohol being served after 22:00. As the allowed hours are only until 22:00 on weekdays and 20:00 on weekends and banks holidays, this point needs rewriting.

10. Bullet point 5, page 67

This mentions alcohol being served after 23:00 and assessment of the possible need for SIA staffing. As the allowed hours are only until 22:00 on weekdays and 20:00 on weekends and banks holidays, this point needs reassessment. Perhaps SIA staff will be needed for private parties, corporate events etc, even when those will run until a pre-closing time of 21:30 for closing/all dark at 22:00.

11. Traffic Plan/travel plan

None has been supplied especially as it relates to cabs, Uber vehicles etc before and after corporate events.

One assumes that events would need to end at 21:30 for drinking up time and managed dispersal. Could the Lic Committee please add Conditions to this end as clarity is paramount.

12. Residential amenity

The Applicant does not mention the very large development across the road from them, being expanded now, for more residential apartments—part of a larger redevelopment of the entire area. It is these future residents and their amenity who may well be negatively affected by noise, nuisance mid-to-late evenings up to 22:00, as well as a swell of cabs, Uber vehicles etc arriving at dispersal of the planned events, brand launches, parties etc.

13. <u>Agenda Pack page 80 Email</u> of the Applicant to Lic Officer Maria Dimitriou, March 17 16:04

The Applicant mentions my name under her point two, regarding opening hours, and says that she will come back to Maria Dimitriou, 'following some more information gathering."

I see no further evidence of the Applicant coming back to Maria on this important issue. Apparently, the Applicant was unable to reach Planning (why did they not ask Licensing to intervene?) and they definitely did not attempt to reach me.

I am not aware that the Applicant tried to reach me by email or phone to discuss these planning allowed opening hours with me, or any other points that I made in my Representation of 7 April (pages 72-76 of the Agenda Pack). I answer all the my phone calls, including 'no caller ID' calls, and I always ring back any missed calls.

It is unfortunate that the Applicant has not attempted to contact me; nor has the Applicant invoked the power of the Licensing Authority to assist in being put in direct contact with someone from Planning. Thus, the Applicant has not clarified several points and it is now up to the Lic Committee to take much time in ascertaining the answers.

Finally, I thank the Licensing Committee in advance for their careful consideration of these points as well as the points raised in my Representation dated 7 April,

2022, pages 72-76 of the Agenda Pack, against this very ambiguous and confusing Application.
