Dear Licensing,

Following the concerns of the Representation made by residents of Edith Villas mentioning various companies at this address.

I would like to point out to the Sub-Committee that the Applicant, Mr Zahid Zaheer, filled in and signed the Licensing Application Form using the name 'Pizza Pronto'. However, I see that Pizza Pronto was dissolved, which means it does not exist.

The Sub-Committee will see that the Companies House Certificate and the summarized information on the website called 'Check Company' shows that on 31/03/2022 a new company was incorporated, called Pronto Pizza W14 LTD. The address associated with this new company is shown as 30, North End Crescent W14 8TD.

I conclude: Pronto Pizza is not Pizza Pronto.

If nothing else, this needs to be corrected in the Application and in the LBHF Licensing Register so that if warning letters, notices or otherwise were served on this company or the Applicant, or both, the correct company name associated with the correct address will be used.

I mention this because this is a problem with another very similar but separate application, of another pizza shop, on Fulham Palace Road, that will soon be considered by the Sub-Committee; warning letters were apparently served on the wrong address, or the wrong name was used, or both, so the three warning letters were effectively invalid, apparently (this is still being looked into at residents' request).

Please include these three screen shots (taken Sunday 18 Sept at around 14:35, as time stamped on my computer) in the supplemental information for the Sub-Committee.

Dear Licensing:

I would like the Sub-Committee to be aware of various delivery and collection times of Pizza Pronto, 30 North End Crescent. These are screen shots that I took on my phone on Aug 19 at 18:29.

I established in my written Representation that, for now nine months and counting, the Premises has been operating without a Late Night Refreshment licence to prepare/serve/deliver food after 23:00, as required by the 2003 Licensing Act.

1. The first screenshot, from [Just-Eat.co.uk](https://www.just-eat.co.uk) shows collection times up 03:30 on a Monday, with other also very late, ie early hours, on other days, as set out in the table of the screenshot.

2. The second screenshot, from Deliveroo, shows 'closes' until 23:59 and also shows delivery time of up to 25 minutes, which could mean that my pizza might arrive around 00:30, and only at that point is the sale complete. So the Premises is technically still open until the last delivery is made and the 'sale completed' pings audibly.

3. The third screenshot is similar to the first one, just a different time of taking the screen shot

4. The fourth screenshot, from [Just-Eat.co.uk](https://www.just-eat.co.uk) shows delivery times of up to 03:45 on Fridays, plus delivery times of up to 50 minutes, so that takes us to 04:35 for the final sale. Perhaps the good news, at least for the Premises, is that from 05:00 the Premises won't need a licence to deliver, as a Late Night Refreshment licence is only needed between the hours of 23:00-05:00.

All of this delivery bandwidth from a Premises that does not have a licence to operate after 23:00. This is not only concerning, it is illegal.

Would the Sub-Committee please ask the Applicant how he has been upholding and promoting the Four Licensing Objectives whilst has been operating outside of the law and therefore was not obliged to promote those very objectives.


