Subject: Our phone call and further request for Conditions. Supplementary Agenda item

Dear Piers Warne, (Representing the Applicant 680 Fulham Road)

We have just now spoken on the phone (11am, 8 Nov).

I am copying in the Licensing Authority to request that this be included as a further Supplementary Agenda item, if possible. If not, it will suffice for the Sub-Committee to consider these at the hearing as they are points already raised in Representations.

Two points:

1)

In addition to my email below to you of 4 Nov, in which I agree to your suggested Conditions, we would continue to ask the Applicant to consider three Conditions which we believe are reasonable and proportionate (residents covered reasons for these in our initial representations—Agenda Pack starting on page 62, so I won't repeat them here):

a) The Premises Licence Holder shall consult with the Police, the Licensing Authority and LBHF Safeguarding to implement a written drink spiking policy.

(To promote the Lic Objective The Prevention of Crime and Disorder and The Protection of Children from Harm)

b) There shall be no offers at any time of unlimited alcohol promotions whereby an unlimited amount is supplied for a fixed price or for free. Bottomless birthdays, bottomless football lunches or dinner offerings or similar offerings/events shall not be offered.

(To promote all four Lic Objectives as well as Responsible Drinking)

c) That the Premises closes at midnight on Thursday, Friday and Saturday.

(To promote all four Lic Objectives as well as Responsible Drinking and to specifically address the unique situation of new residential flats being built directly above the Premises)
