Dear Chair and Councillors,

Given the current economic climate this small independent family run business has felt the need to apply for a premises licence in order to capture existing and hopefully new trade, deliveries are now a large part of any food business now and completely necessary going forward.

We are quite an upmarket business in a recently refurbished premises, we offer a fun and relaxed dining experience catered mostly to families, couples or small groups, where they can expect well-presented food and desserts with an eye for detail and extremely attentive service.

We have also adopted new hours after consultation with the Police, there will now be no LNR Sunday to Thursday and 23: to 00:00 on Friday and Saturdays indoors. Thursday will be 23:00 to 00:00 Friday and Saturday will be 23:00 to 00:30, the premises will open from 11:00 and closing hours to match.

There are additionally CCTV conditions to further enhance the safety of the public and specific instructions for delivery riders to adhere to so as not to cause a public nuisance.

There are several similar premises in the immediate vicinity that currently close later than the proposed hours they have applied for, i.e:-

Food & Fire. 300 Uxbridge Road Mon-Thu 11:00 to 01:00 Fri-Sun 11:00 to 02:00 Sammy's Chicken 268 Uxbridge Road Sun-Thu 11:00 to 00:00 Fri-Sat 11:00 to 01:00

Tasty & More 280 Uxbridge Road Mon-Sun 12:00 to 00:00 Chicken Cottage 270 Uxbridge Road Mon-Sun 12:00 to 02:00 Vine Leaves Taverna 71 Uxbridge Road Tue-Sun 12:00 to 00:00

Having read through the representations we are at the most proposing an extra hour and a half at the weekends which will not affect parking in an adverse way. We are well within the council guidelines for mixed use areas.

We also feel the reports of crime and disorder will not be affected by this application and hope the standard of this premises will reflect in its clientele, a well lit decent establishment should help to make other road users feel safer. We wish only to enhance the local area and intend to offer a litter patrol in the immediate area to ensure a clean and safe environment around our premises.

The footfall from the local Mosque mentioned in some of the representations will not be affected by this application and we separate ourselves in a slightly different bracket to the premises mentioned in these representations.

We do not tolerate drug taking in or around the premises and no alcohol has been applied for in this application.

There is also a slightly disturbing anti-arabic rhetoric displayed in one of the representations and I feel I must address the language used, which was unacceptable in any setting.

Finally whilst we accept the issues in Uxbridge Road eluded to in some of the representations we seek to buck this trend and uplift the area.
