Hi Walaiti

Good to hear from you.

Clearly, recollections vary as to the 11-minute telephone conversation I initiated with you on 25 July at about 18:30.

To clarify: it is your client who the Licensing Authority kindly contacted on our behalf.

On 14 July we saw 2023/01096/LAPR Papa John's 63 Walham Grove, ref transfer of the premises licence from DFSI M25 Ltd to PJ Corp Stores Limited. A new operator might spell hope, we thought.

On the same day, we asked, and they obliged, the Licensing Authority to contact for us the new Premises Licence Holder (GDPR prohibits direct initial contact), suggesting it could be an opportunity for the new licence holder to proactively engage with residents.

Whilst we waited, and we did not have to wait long, on 25th July PJ Corp Stores Limited lodged a new licensing application for 24-hours, without any discussion with residents.

I don't speak for all 50 Responders. Supporters of your client's Application may well be the ones open to a discussion with you at this point.

Freedom of Information Act 2000

I can confirm that the information requested is held by London Borough of Hammersmith and Fulham. I have enclosed copies of the information that is being released to you.

The Law Enforcement Teams dedicated ward officers have carried out regular patrols in this area and in general, has not seen a great deal of refuse in this area. The LET officer has previously issued FPNs to the residents of the flat beside Papa Johns, but it was only on the 17th of July 2023 that he found refuse bags outside specifically relating to Papa Johns. The LET officer issued a FPN for a commercial waste receptacle breach. This was followed up with a Section 34 Notice of the EPA 1990, and the business have subsequently supplied their waste contract details.

On 1st August 2023 one FPN was issued by the Nighs LET officer for incorrect presentation of commercial waste which resulted in a further FPN.

On a recent visit, there were bags onsite and the LET officer has managed to ascertain that they had come from the residents of the flat next door, who had moved out the day before.

The team are aware of the delivery bikes at this location, but this is a similar issue in all the side streets along North End Road. There were some ASB issues investigated by the team on Walham Grove, but these issues were not related to Papa Johns.
