




#### ADDITIONAL 660 Dispersing Between 00.00am - 02.00am = Noise & Nuisance, Crime & Disorder:

With the proposed 'licensing application hours' – ending Midnight. This will definitively mean additional persons dispersing in the '00.00am-2am' core residential sleeping hours.

After matches, the venues that close between 00.00am-1am are normally filled at capacity soon after the games. Having another venue open until midnight will absolutely impact on increased numbers/dispersal between Midnight-2am timeframe which causes the biggest problems for Residents. It takes a minimum of 45mins to 1 hour for dispersal of venues that cater for large numbers. This will further put a strain on an already existing low police resource during the hours of 0.00am-2am. # Cocaine traces found at Arsenal, Tottenham and Chelsea stadiums amid rise in fan violence

All three London clubs were said to have discovered traces of the class A drug inside their respective stadiums as fan violence within English football looks to be on the increase

Traces of cocaine have reportedly been found at the respective stadiums of a number of top **Premier League** sides including the likes of **Arsenal**, **Tottenham** and **Chelsea**, seemingly linked to a rise in violent conduct from fans.

An investigation conducted by **The Sun** saw multiple stadiums in the English top flight swabbed for traces of the class A drug, **Brighton & Hove Albion** another club that has seen fans abuse the substance in their ground as well as the aforementioned trio.

Off the back of the violent scenes witnessed outside Wembley Stadium in the summer ahead of the final of **Euro 2020**, some of which was fuelled by fans high on cocaine, police chiefs are calling for stricter punishments for supporters found guilty of using the drug at games.

Chief Constable Mark Roberts, a senior policeman with experience of dealing with football fan-inspired disruption, explained how more fans than ever were taking the drug, leading to a "toxic mix" of drug-fuelled violence.



- Persons returning to parked cars/taxi's after 23.00pm specifically disturb residential sleep (many homes with children have bedrooms facing the road)



#### Dear

Last night, as usual, an overwhelming fleet of private hire vehicles took up all available residents' parking spaces, and loitered (with their engines running) on all the yellow lines – all entirely untroubled by a single traffic warden. I didn't think things could possibly get worse from what we suffer every single match day but...

Just before the match started, a convoy of 6 or 7 black SUVs swept into the North section of Britannia Road (just South of the barrier) and blocked it entirely by parking down the middle of the road. Several of them were unmarked people carriers and at least two were armoured vehicles with US government license plates. They were accompanied by a UK marked police car. I asked the drivers who they were working for and what right they had to force the entire street into lock-down, they simply said they couldn't tell me who they worked for, but that they were with the police.

They stayed put for the entire duration of the match and shortly after it ended, they swept out with doors banging and lights flashing on several of the vehicles.

My 8 year-old twins were in bed and of course the excitement got them up again. Another match day school night deeply disturbed.

If the disruption residents face on match days was well managed, we would accept it as a legitimate aspect of living so close to Stamford Bridge. The apparent absence of any parking or traffic controls to protect us, game after game after game is offensive in the extreme. It's iniquitous that on top of the usual, the families living on Britannia Road should have been in lockdown last night just because an unelected spouse feels like going to a football match. (I believe I saw Doug Emhoff getting into one of the cars.) What right does Chelsea Football Club have to use our purely residential road as a parking lot for the convenience of entertaining their VIP guests? To have not considered the impact is sadly entirely indicative of their relentlessly high-handed treatment of us. Even worse, they may have considered the impact and decided that one VIP was more important than an entire street full of families.

Chelsea Football Club is demonstrably unable to manage the nuisance caused to residents. To add to this by increasing their hospitality offering is excessive and sickening. Are CFC legally committed to providing police to patrol the streets around our homes? Will they issue the necessary penalty notices to keep our roads clear and safe?

On our behalf, please will you ask the Licensing Committee to consider the compound impact of adding 660 more people, over an even longer period – this will patently increase, rather than decrease the problems we live with every single match day and evening.

### THE EXISTING BUILDING CONDITIONS CLEARLY HIGHLIGHT THAT THE CHANGE OF PURPOSE COULD ALTER TRAFFIC GENERATION CHARACTERISTICS & RESTRICTING HOURS WILL MITIGATING NOISE

#### The Sports & Leisure Centre & Museum

- 11.I.1 Use of the Sports and Leisure Centre and Museum for purposes other than those intended and described could alter traffic generation characteristics that are critical to the mix of uses in Chelsea Village. Restriction of the uses is therefore necessary notwithstanding the presumption against doing so.
- 11.1.2 Mitigation of noise and traffic impact would be achieved by restriction of the hours of use. I feel that 0700 hours is a more appropriate time to allow the building to open bearing in mind that coincides with the end of the night-time regime, except on Sundays, and the fact that many people find early mornings to be particularly convenient to use such facilities in a busy schedule. The night-time regime would not permit parking beside the centre before 0930 on Sunday by placement of the removable bollards and by prohibiting use of this block of parking (block A on COR 112D Plan 3). With other measures this opening time should not cause adverse effects. Because the closure time of 2200 hours agreed for the building accords with commencement of the night-time regime I do not consider that closure of the East Stand concourse and other night-time measures can reasonably be required of this development. For similar reasons I do not consider that comprehensive stadium signage should be required of the construction or use of the building on its own.

### SECTION 4: Licensing Objectives - Prevention of Noise & Nuisance & Protecting Children from Harm:

Residents are experiencing high levels of Anti-social Behaviour and Noise and Nuisance on Match Days – this becomes particularly problematic when fans come out of venues after 23.00pm-2am. People often loiter in residential roads and/or have taxis and cars idling waiting for them. At this time of night, noise is amplified. Many residential homes have street facing bedrooms.

Residents have a right to quiet enjoyment and get the necessary core sleeping hours. Affects on health due to broken sleep has been widely written about. Adding another 'midnight' large capacity venue will only compound the problem.

- Page 13: Research undertaken shows H&F as being the worst Sleep Disturbed London Borough.
- Page 14: Lancet Research undertaken provides the very serious impacts of sleep deprivation on Children. This area of Fulham has high levels of schools in the area with many families living in residential roads.

### <u>Licensing Objective – Protecting Children from Harm</u>

### Children – 2022 Lancet Research finds Insufficient Sleep = unnecessary mental health & behaviour issues:

The researchers identified more than 4,000 ABCD participants, ages 9 or 10, who generally got nine or more hours of sleep per day, according to their parents. This group was compared to a similar number of age-matched children who typically got less than the recommended nine hours of sleep. The research team carefully matched the two groups based on some key factors that can confound study results. These factors included sex, household income, body mass index, and puberty status. Participants were assessed and followed over a two-year period. Results appeared in *Lancet Child & Adolescent Health* on July 29, 2022.

The researchers found that children in the insufficient sleep group at the start of the study had more mental health and behavioral challenges than those who got sufficient sleep. These included impulsivity, stress, depression, anxiety, aggressive behavior, and thinking problems. The children with insufficient sleep also had impaired cognitive functions such as decision making, conflict solving, working memory, and learning. Differences between the groups persisted at the two-year follow-up.

2.1 Venue Operational Timings

Restriction that the premises only operates on match days and only 3 hours before kick-off and 90 minutes after the conclusion of the game will be a condition on the licence.

The premises should close at 23:00 Monday - Saturday and 22:00 on Sundays.


Please note: Matchday safety will take over the venue from in-house security only 3 hours before kick-off and 90 minutes after the conclusion of the game.

#### Earlier Closing Hours would encourage usage of Public Tube Transport as opposed to compounding vehicle traffic.

If the venue adheres to more sensible closing hours such as 23.00pm (Mon – Sat) and 22.00pm (Sunday) this:

- Offers fans the option to take public transport home instead of impacting further on compounding traffic & noise issues late at night and supports H&F Climate Change objectives.
- Note: Majority of tubes run just before midnight and 30mins after midnight (Source: TFL)

### **CONCLUSION**

- The Additional Impact of 660 persons dispersing after 00.00 will negatively impact Key Licensing Objectives: Crime & Disorder, Noise & Nuisance and Protecting Children from Harm.
- 2. It's clear CFC are not fully aware of the ACUTE traffic and noise problems that Residents are experiencing.
- Existing planning appeal conditions (Hours) were well thought out to protect residents particularly Brompton Park Crescent Residents (approx. 300 flats) that will be affected should this venue cater for large crowds dispersing at midnight.
- 4. There are real concerns regarding the lack of SIA security numbers for over 600 persons particularly needed as there are lots of sqm concourse areas whereby customers can loiter that back directly onto Brompton Park Crescent Residents.
- 5. There is no designated outside smoking area on floor plans or agreed numbers at one time? Having large numbers of persons smoking, talking being loud which comes with alcohol consumption impacts on noise. A designated timeframe should also be put in place i.e. closed from 22.00pm.
- 6. There is no mention of 30mins drinking up time this absolutely needs to be put in place to assist with staggered dispersal. CFC to date has not addressed these in conditions (nor points 4 &5).
- 7. There is no reason that this venue should operate after 23.00pm (taking into account latest 8pm match kick offs).

#### Dear Lorna

This is a request for the Licensing Sub-Committee Chair to consider postponing the 8th Nov hearing. I explain below our reasoning.

Yesterday, the forty-two Representors received the link to the 77 MegaBite Agenda Public Reports pack, published yesterday 31 October, for the planned 8 November 2023 LBHF Licensing Hearing.

I was able to look through it last night and this morning and realised that we residents are up against a huge legal package of information that we cannot begin to comprehend without legal counsel. We have now instructed a barrister to help us. There is no way that we can begin to create a written response by working through the weight of the information in the Reports Pack in two days, let alone other papers that might appear from CFC before your requested cut off for Supplemental Agenda items of 3pm on Friday 3 November. As I write, another email arrives from CFC with more suggested Conditions to consider and respond to.

I know that your 3pm Fri 3 Nov cut off is not legally binding in the 2003 Lic Act but I now am concerned that the Committee will not look favorably on residents, were we to submit further papers on Monday, 6 November or Tuesday 7 November.

Our fear is that the Committee might find our submissions of Monday and Tuesday unreasonable.

Residents are aware that overwhelming residents with confusing legalities and reams of reports is common practice for CFC; we learned this months ago during the Concerts on the Concourse application and the Drinks Tent for 1,000 application, which were withdrawn in May. Now, CFC wants to turn quiet community floorspace of a Health Club built for the use of local residents, schools etc into a full blown hospitably venue for 600-plus 'low to mid-tier' fans who can afford paying £280-£700 for a pre and post match drink up.

The comments from Planning on pages 145-170 of the Reports Pack reveal that much is unanswered, certain documents have yet to be found, non-binding opinions confuse at least me. We are baffled as to how decisions can be taken on November 8th without all the facts.

Therefore, I request that you contact the three committee members with my email here and ask them to postpone the hearing.

Particulars of Resolution

The Committee resolved as follows:

Had they been empowered to determine this application, full planning permission would have been refused for the following reason(s):

1 The siting of the proposed development, together with the need to provide space for emergency and other essential vehicles, would reduce the width of the perimeter walkway thereby restricting the flow of spectators resulting in the

potential for unsafe conditions to occur on match days. The design of the development would therefore conflict with the needs to ensure a safe and secure environment for pedestrians contrary to the Unitary Development Plan Policy TN5.

- 2 The proposed development would create a demand for on site parking which together with parking demands associated with other uses of the site could not adequately be provided thereby resulting in on street parking stress with a consequent loss of amenity to the surrounding area contrary to the Unitary Development Plan Policies TN 12-15.
- 3 The parking layout is unacceptable in that it takes no account of the need for pedestrian/vehicular segregation and provision of parking spaces for other vehicles. Consequently, the reduction in availability of parking spaces would lead to cars using the underground car park resulting in a displacement of vehicles on-street to the detriment of the surrounding area contrary to the Unitary Development Plan Policies TN 12-15.

# Residents hit out at plans for new hospitality suite at Chelsea's ground Stamford Bridge

Residents say VIP guests already cause disruption - including King of Spain

Fulham residents have hit out at plans for a hospitality suite at Chelsea FC's ground over fears of antisocial behaviour outside their homes.

The Premier League club wants to create a new venue at Stamford Bridge for match days called the Rose and Ball.

But in a letter of objection, some residents claim to have already been inconvenienced by VIP match-goers using their street as a car park - such as the King of Spain.

However, Chelsea has vowed that a series of conditions would minimise harm to those living nearby.

"Drug taking is very visible, drunken behaviour, urination and even defecation is often seen," said one resident in an objection to Hammersmith and Fulham Council.

"Again, think of the health issues. Just consider the implications for the elderly and families.

"One example, the King of Spain attended an event and these vehicles blocked access to our road for a lengthy period of time, engines running, fumes being emitted."

Another added: "For a recent match we had the King of Spain's entourage's vehicles hovering in front of our house for two hours.

"All the roads around here become a double parking waiting lot for VIPs, their drivers,

and their vehicles. This is a crime and causes disorder as most of these cars are illegally parked."

It is not clear if objectors are referring to the current king, Felipe VI, or the disgraced former king Juan Carlos, who is known to have jetted in to watch Real Madrid beat Chelsea in April.

The club is seeking permission to turn its former gym, said to have counted Hugh Grant and Lord Coe as being among its members, into the suite, which would cost a minimum of £280 per person.

It said this would be a "lower mid-level" offering compared to its more elite options which can cost nearly  $\pounds10,000$ , and would provide inclusive drinks and food.

The club has told residents in a letter: "The facility will offer those attending matches an attractive and sophisticated environment in which to socialise before a match (for up to three hours) and after a match (for up to ninety minutes).

"All attendees will be going to the match. The facility will not increase the capacity nor attendance at matches. Rather it will provide a new amenity for some of our fans who will already be attending."

Councillors are set to decide on the licensing application on November 8.

Chelsea football club has scrapped plans for an all-day music venue outside Stamford Bridge stadium after facing pressure from local residents.

Since he became Chelsea's owner Todd Boehly, an American businessman, has unveiled proposals to redevelop the area around the stadium.

These included the construction of a large marquee venue for music events. The club submitted licensing plans to Hammersmith and Fulham Council that would have allowed it to serve alcohol in the marquee from 10am-11pm every day of the week. There were further plans for redevelopment of the concourse and plaza areas around Stamford Bridge.

In a letter to residents this week, Glick said: "Having spoken to some residents further to understand the issues involved, we have decided to withdraw both license applications and we have informed LBHF accordingly."

"Our primary concern is building a strong relationship with our neighbours. We want to do that independently from those applications."

Hundreds of locals objected to the proposal when a consultation was held in March. At a testy meeting with residents, the club's President of Business Tom Glick admitted he had "underestimated" opposition to the plans.

It is one of London's most desirable neighbourhoods – so Chelsea has always seemed an unlikely setting for a huge football stadium.

But given that Chelsea FC set up home just off the fashionable Fulham Road in 1905, its well-heeled residents are used to thousands of fans packing their streets a few times a month.

Now, however, they are rankled over a plan to convert part of the 41,000-capacity stadium into an all-day drinking and music venue – open every day.

The club submitted licensing plans to Hammersmith & Fulham Council this month which, if granted, would allow live and recorded music to be played, and alcohol to be sold between 10am and 11pm with the concourse 'accessible to the public 24 hours a day'.

Writer Kate Reardon, 54, who lives nearby with her two young children, said: 'It appears they're applying for some sort of version of Glastonbury meets Munich's Oktoberfest for stadium-capacity crowds, 365 days a year.

'It will destroy our lives. Already on match days, locals have profoundly compromised access to Chelsea and Westminster Hospital because ambulances can't get through.

'If alcohol is sold until 11 o'clock at night, and they're open 24 hours a day, how on earth will they police the noise and the disruption?'

She added: 'Thousands of families' lives in the neighbourhood are going to be ruined.'

She added: 'Thousands of families' lives in the neighbourhood are going to be ruined.'

Briony Eastman, 70, who lives in Britannia Road next to Stamford Bridge stadium, said: 'I moved with my young family to this neighbourhood 28 years ago knowing about the football matches and have lived here happily, accommodating the football crowds, as there are excellent transport facilities, shops and schools.

'But we didn't expect it to become a music and film venue, where alcohol can be freely drunk on the premises and in the Fulham Road, risking the area becoming an unacceptable place for people, families and communities wanting to be safe.'

Jeremy Lyon-Lee, 48, who has lived in the area for nearly ten years with his wife and their three children, said he was concerned about how it would affect the area's value.

'There are knock-on implications for house prices if it becomes known as an area that is congested and polluted with lots of nuisance,' he said.

Average house values in Britannia Road last year were £1.85 million.

It has been suggested that the application by the club, owned by a consortium led by an American billionaire, is merely intended to 'improve fans' experience on matchdays' and does not extend to standalone concerts or one-off events.

Chelsea Football Club declined to comment.

I am contacting you as a representor against the Chelsea Football Club, The Rose and Ball application.

The agent has proposed the following conditions to be considered to be added to the licence, should it be minded to be granted at the committee. For full transparency, the agent has asked the Licensing Authority to forward the attached document and the below:

Please may we put forward the following proposals for consideration by the committee.

- 1. Premises licence to only operate on CFC match days.
- 2. The balcony not to permit licensable activity, nor consumption of alcohol. No customer access to be permitted (saving cases of emergency).
- 3. The premises will adopt the "ask Angela" (or similar) scheme. All staff will be trained in the process to be adopted when any customer "asks for Angela". Should the customer "ask for Angela" the matter will be recorded in the incident log.
- 4. A written policy to prevent customers or staff bringing illegal drugs onto the premises at any time shall be in place and operated at the premises. Staff will be trained in such policy.
- 5. A written policy to prevent drinks being "spiked" shall be in place and operated at the premises. Staff will be trained in such policy.

One of the representations raises concerns about a specific condition within the Operating schedule (namely the interpretation of the word public). We would therefore propose to amend the condition that reads "no customer carrying open or sealed beverage container shall be admitted to the premises when it is open to the public" such that the condition should now read:

1. "No customer carrying open or sealed beverage containers shall be admitted to the premises".

Please let me know if the above addresses the concerns raised in your objection, and you are minded to withdraw? If you are not minded to withdraw, you are invited to attend a licensing sub-committee on the 8<sup>th</sup> November 2023 at 6.30pm to provide your representation and supporting evidence verbally. #### **Dear Licensing**

Thanks for the ongoing stream of oft repetitive as well as confusing emails from CFC via the Licensing Authority.

CFC had weeks to put together their Application, proudly using the pre-application advice process to boot, and now they are confusing residents with last minute emails.

- Previously, they sent out, twice, their 25MB 'Blue' powerpoint presentation and a 3-page letter about the 660 'low to mid-tier' punters they plan to attract to the Health Club at £270-£700 for bottomless drinks and nibbles three hours before a match and 90 minutes after. CFC mailings are becoming akin to a bot.

- Yesterday we had the 77MB Public Reports Pack of 238 pages with a lot of their repetitive info plus new confusing procedure reports that we are to sift through in a flash.

- Now, today, Nov 1, they are adding Conditions to clarify their position, hoping to lose a few Responders who might email their withdrawal of their Rep.

- All these sudden, suggested Conditions below do in fact represent specific concerns raised in Reps by residents who were gobsmacked at the lack of detail as well as mistakes made in the Operating Schedule; this shows how little thought was put into this Application. This shows how much time is spent and wasted by residents when Applications are not thought through fully. Applications should have all of this material attached to them from the start instead of residents having to beg for common sense thinking, and back that up with facts. CFC is not above the law, at least not yet.

-They needed residents to tell them that they need these Conditions? Do they now need residents to suggest again Conditions regarding spiking vs a policy that gets lost in iCloud docs? Or to commit to at least the industry standard of 8 SIA security for alcohol-led events of 600 plus, and drug sniffing dogs to stop problems at the door? A commitment to swabbing toilet seats for drugs would go a long way in showing that they are at least attempting to get a grip on the concerning headlines ref Chelsea fans in the top league tables of 15% fans arriving for matches already very 'high'.

The answer is, no. The truth is that we recognise this pattern.

They are using the process to drip feed into Responders, in the hope that they can come to the 8 Nov hearing to tell the Committee something akin to, 'xxx Responders were so pleased with the lastminute suggested Conditions that xxx Reponders withdrew their Reps'. We residents are not legal experts, but we see through these tricks of the trade; the Committee needs to know about these tactics of the Applicant.

This is abuse of process.

Most residents are already totally overwhelmed with the idea of turning a quiet health club's fitness first floor into a giant drinking parlor for over 600, of course with alcohol absorbing offerings passed around; a new interpretation of community floor space as never before.
