The document down below contains pictures that where to big send in a normal email. This is why I have had to put them on a word document.

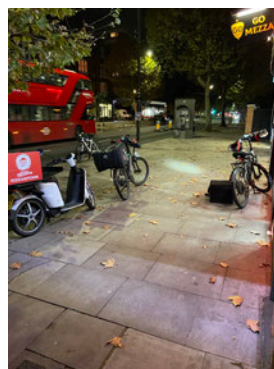
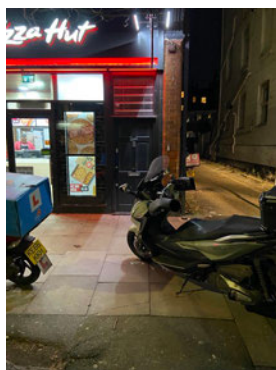

As I mentioned previously , there is an alleyway between 284a and 282 King street. There has been an effort lately to keep this alleyway clean but over the years , I have often seen empty bottles of alcohol and as you can see in the pictures attached , I have found evidence of what I believe to be drugs paraphernalia in that alleyway.

I strongly believe that should go Mezza be allowed to stay open longer , this alleyway would become a focal point for drug taking and selling as the people taking those drugs would see an opportunity to beg or harass customers for money. This would in turn attract dealers who would see an opportunity to sell drugs.



The second thing I wanted to highlight was the fact that the staff working at go Mezza have no control over the delivery drivers who park their bikes and scooters outside. It is not rare to find bikes parked just outside our doors which not only is a fire hazard but also extremely annoying when I am trying to leave or enter my home. The pictures attached don't really reflect the extent of the problem as they have been taken over the past couple of weeks and due to the cold , I imagine that the amount of trade has been greatly reduced.



The other points I was making in my representation are still valid but I can explain those on Monday. I just wanted you to see those pictures prior to the hearing so you get a better understanding of the point I am trying to make.
