Yes, I do plan to view the 2pm session. I have just discovered the other licence applications are to be heard at 10am which I may not be able to view.

I have just been down to the River Walk and am appalled to see tins and plastic glasses abandoned on the railings beside the river adjacent to FFC and [REDACTED] block of flats which have been left following this afternoon's match. The river is suffering enough with sewage and dumping without the added burden of this rubbish which will only be exacerbated if the Council is unwise enough to grant the licences for sale of drinks for off ground consumption. I do hope common sense will prevail. I have also been looking at the same beer cans for months in the part of Bishop's Park which FFC has now been using for years and into which fans throw their rubbish through the rails. Nothing is ever done to clear it and it is very depressing to see our area become a large rubbish tip.

1 RIVERSIDE STAND EXHIBITION

Introduction

Welcome to our exhibition providing an update on progress of the Riverside Stand development.

As you will be aware, we have experienced delays in the Riverside Stand project from the outset, largely caused by:

- 1 The Covid-19 pandemic which required the implementation of special construction measures and reduced the amount of people who could work at the site.
- 2 The demolition process took longer than programmed as site conditions were more complex than expected.

- 3 More recently our main contractor the Buckingham Group Contracting Ltd. has also gone into administration which has created further challenges to the programme.

We are now working with our fit out contractor, Portview Fit-Out Ltd. ('Portview') to minimise any further delays as we are keen to open the Riverside Stand and the Riverside Walk as soon as it is possible and safe to do so.

The Stand currently provides interim match day seating for up to 4,968 spectators whilst works are ongoing.

The Approved Scheme

Fulham FC brings significant economic benefits to the area.

Unlike a traditional football stand that only provides match day seating, the Riverside Stand will create a range of new spaces that will create year-round activity looking out onto the River Thames. The spaces within the Riverside Stand are shown on the diagram below.

Once completed the Riverside Stand will bring further economic benefits including the creation of over 200 jobs (FTE*).

Through the legal agreement linked to the Riverside Stand planning permission we are also providing financial contributions towards enhancements of Bishops Park.

Fulham FC Foundation is the Official Charity of Fulham Football Club, committed to a vision for a healthy, inclusive and thriving community. The new floorspace within the Riverside Stand will significantly enhance the Foundation's ability to deliver community programmes.

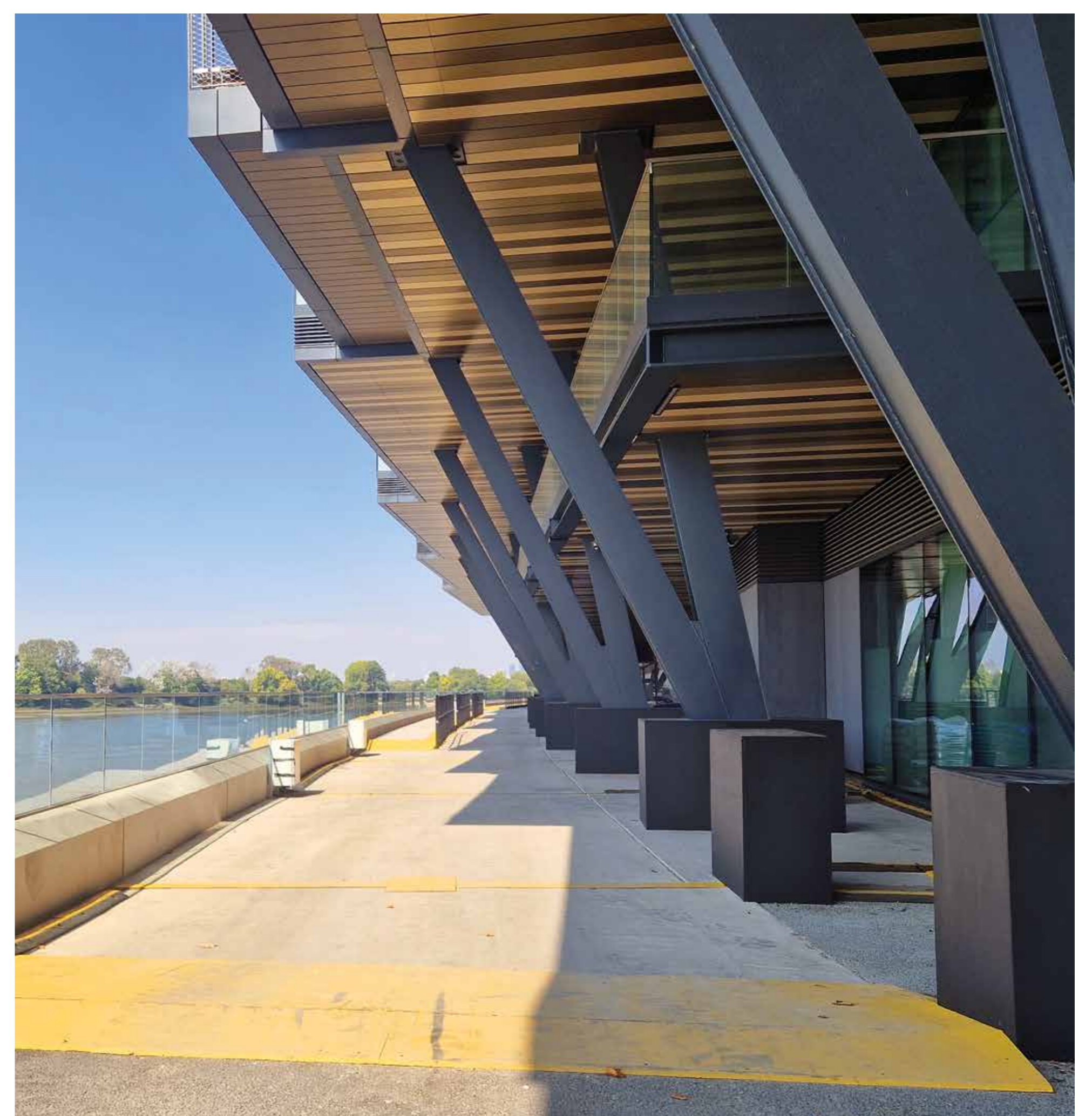
Riverside Walk

Another key public benefit of the scheme is the Riverside Walk which will allow for the continuation of the existing Thames Path, meaning people will no longer be diverted via Stevenage Road.

At present, special arrangements are in place to allow the limited use of the Riverside Walk area by fans during home games. This comes at a significant financial cost to the Club as the Riverside Walk is still a construction site.

Once it is safe to do so and the Riverside Walk is no longer a construction site, we will be able to open the walkway for public access which is something we all want to achieve.

Our planning permission requires that once occupation of the Riverside Stand exceeds the current 4,968, the Riverside Walk will be open to the public.

The Orange Box is a bar and hospitality space located within the basement of the Riverside Stand.

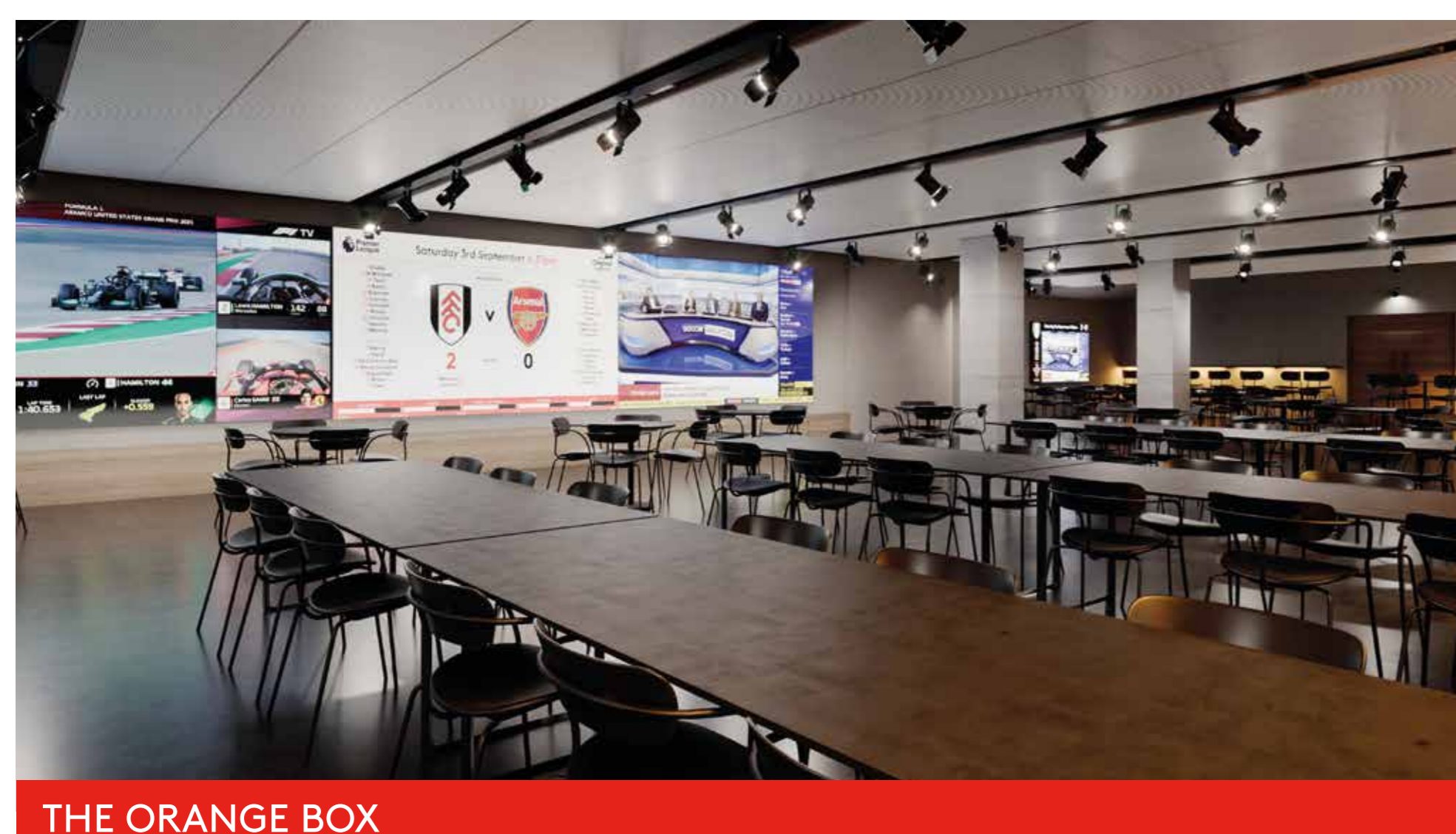
- Match day – the space will be available to fans pre and post match.

Members Club and Health Club and Spa

Above the restaurants at levels three to five is the **Members Club** that will provide a unique setting for people to meet, work and relax. The members club will include an ancillary creche and will be a family friendly space. Details of membership packages are yet to be created and if you'd like more information when available please leave your details with members of the team.

At the Putney Stand end is the **Riverside Stand health club and spa** which includes a range of relaxation and spa treatment rooms. At the fourth floor terrace there is also an outdoor heated swimming pool.

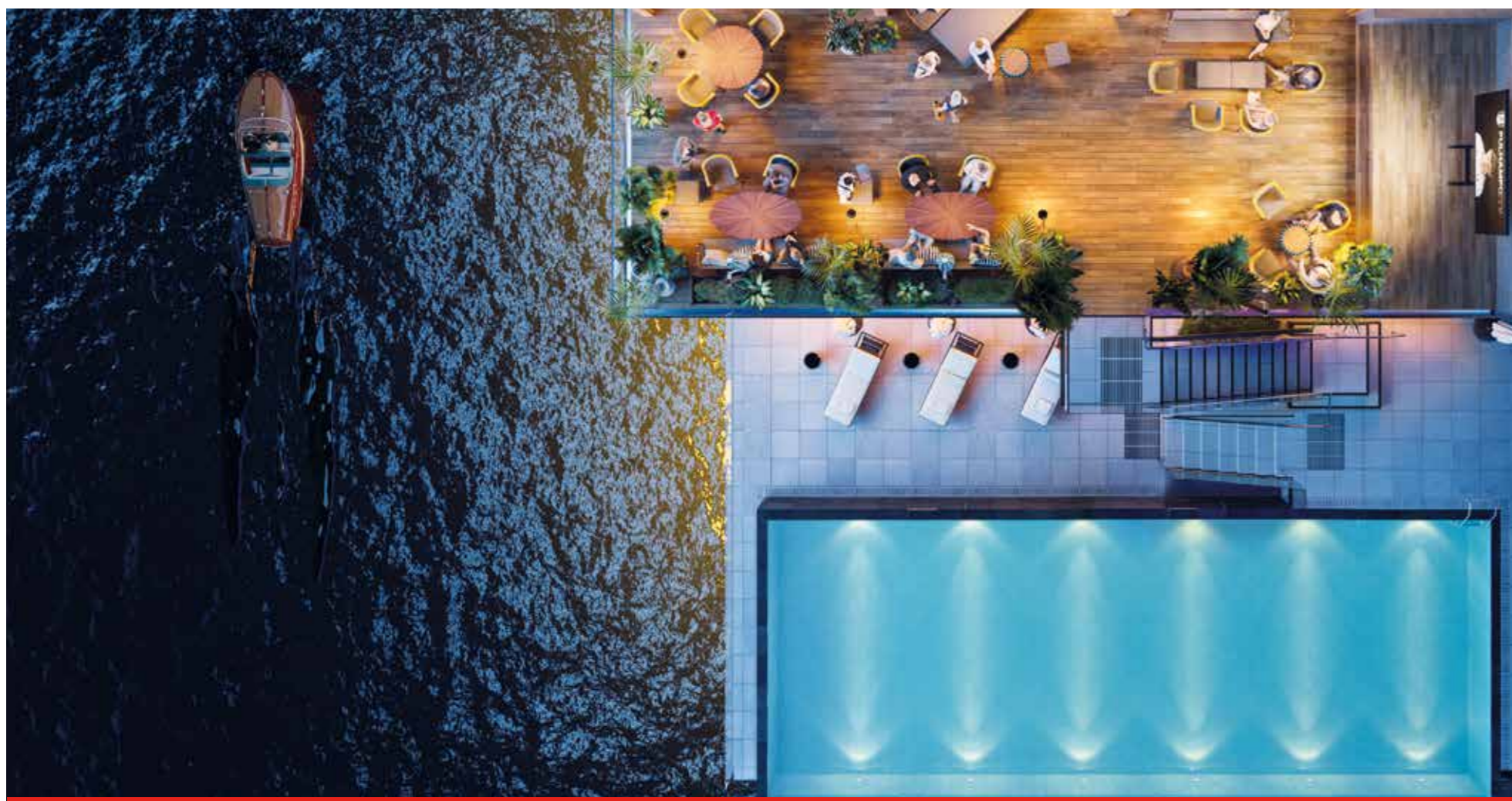
Spa packages will be available to all and bookings will be operated independently of the Football Club. Further details will be provided as the spa packages are developed.



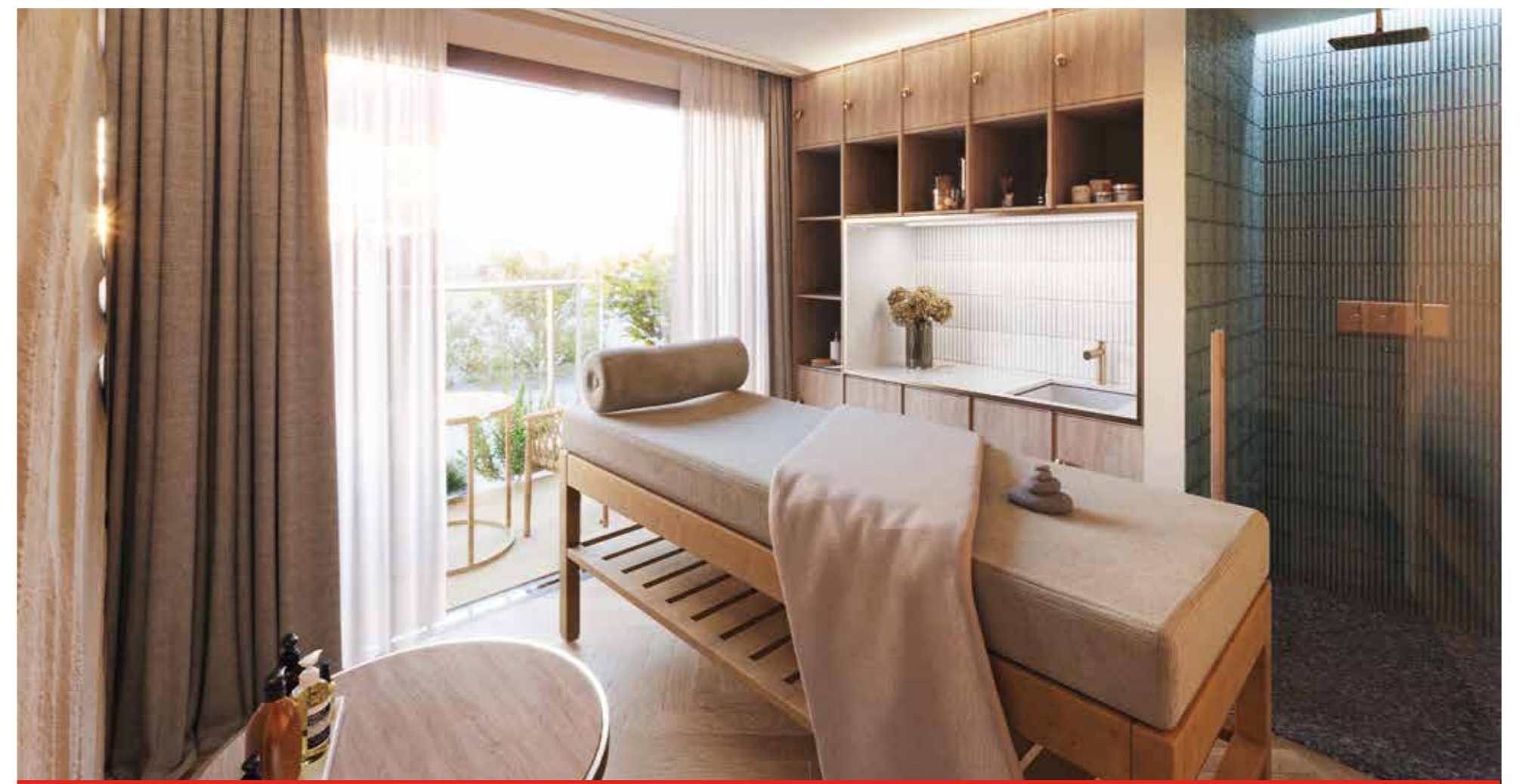

Next Steps

Over the coming months we will be working with our contractors Portview to complete construction of the various spaces within the new Stand.

We will also be submitting Alcohol License applications to the Council for the different Riverside Stand spaces to allow us to operate and sell alcohol. This will also include an update to our existing match day License for the Riverside Stand.

Additional seating in the new stand will be available, subject to licensing, from the commencement of the 2024/25 football season.

When the additional seating becomes available and the interim seating capacity is exceeded (i.e. when seating exceeds 4,968) the Riverside Walk will also be open to the public.

Not all of the spaces in the Riverside Stand will be available at the same time and further information on the hotel and health club/spa will be provided when available.
