**Trading Hours:**

- Sunday to Thursday: trade until 1am
- Friday and Saturday: trade until 3am, with 1 SIA on duty from 00:00 to 03:00

**Conditions:**

- Upstairs seating area to be closed from midnight to all patrons and not to reopen until the following business days trading commences
- Wi-Fi to be switched off at the venue from 2300 with no public access to this being allowed during 2300-0300
- Classical music to be playing from 2300 – 0300 over the internal sound system
- No open alcohol containers inside the premises
- Store advertised as a safe space for anyone who is vulnerable to allow them a safe place during Late night refreshment hours

Policy for delivery drivers to wait inside the store however they cannot enforce this as they are not employed directly by McDonalds.
