Dear Licensing Sub-Committee Members -

RE: The Black Bull – 257 King Street (New Premises Licence Application)/ Supporting Document for Licensing Sub Committee – Withdrawal of Public Safety Objection.

As you will see from the correspondence between us and the Applicant uploaded on the Council's website (Appendix 6, pages 48 - 66), we as a Public Safety Team objected on 14 July 2025, owing to the ongoing failure of the Applicant to provide evidence of the following public safety measures:

- Confirmation of adequate fire safety arrangements with all necessary measures in place to prevent fire and evacuate people safely if fire does occur.
- Measures and policy pertaining to safety and admittance for disabled customers within the premises.
- Confirmation that checks on equipment are carried out at specified intervals, e.g., gas safety checks and Portable Appliance Testing.
- Confirmation that standards are maintained, e.g., Fixed electrical installations to comply with British Standards and carried out in the required timescales.
- Confirmation that Health and Safety risk assessments, accident reporting procedures and staff training protocols are in.

In the lead up to the hearing, on <u>02 September 2025</u>, the Applicant (Gaston Baldoncini) provided the Local Authority with statutory compliance records, including Fixed Electrical Wiring record, Gas/boiler safety record, PAT testing records, fire detection and fire fighting equipment records.

A site visit was carried out on <u>03 September 2025</u> to the Black Bull, which was facilitated by Mr Bashar Gregorian. The condition of the premises structure, including floors, walls, lighting and electrical plug sockets appeared to be in a satisfactory condition. This was further supported by reviewing of the statutory compliance records provided. It is on this basis that the Objection based on Public Safety has been withdrawn.

It must however be formally noted that the applicant has indicated that the Fire Risk Assessment will only be completed and handled by the new tenant once the premises is leased.

Please note that it is critical that a Fire Risk Assessment be completed by a competent Fire Risk Assessor with significant findings addressed (where identified) before the premises is allowed to open to the Public.

As mentioned above, this representation is hereby withdrawn, but I will be available for the first hour of the hearing on <u>09 September 2025</u> for any questions that may arise in relation to the Public Safety element of this application.



Hi Matt,

Please could I request a speaking slot for this hearing. I can confirm that I still strongly object to this application and would like it denied in its entirety. Please find below the reasons for my objection:

#### 1. Prevention of Crime and Disorder

Late-night pubs correlate directly with alcohol-related crime. King Street is not a latenight economy zone but a residential and mixed-use area. Selling any alcohol, especially until midnight would:

- Increase the risk of violent incidents, with national figures showing over 60% of weekend night assaults linked to alcohol.
- Attract people seeking "one last drink," leading to anti-social behaviour at closing time.
- Place strain on local policing, particularly in an area without the infrastructure of central nightlife hubs.

When the Black Bull originally opened, the surrounding area was not residential. Offices and commercial uses dominated, meaning there were fewer risks to neighbours. That is no longer the case. The context has changed fundamentally, and what might once have been tolerated cannot now be justified.

## 2. Public Safety

Safety risks include:

- Drunk patrons leaving onto the busy road and cycle lane which already has a lot of accidents (King Street).
- Strain on emergency services at late hours, when resources are limited.
- A compromised sense of safety for Premier Inn guests and residents in Ravilious
  House. Ravilious House residents are metres away from the Black Bull courtyard
  with no form of segregation between the courtyard and their front doors, creating
  an increased feeling of insecurity for the residents.

The Metropolitan Police originally objected, only withdrawing after demanding strict new conditions such as CCTV, incident logs, and door staff risk assessments. The fact that such conditions were required at all is proof that this site poses significant safety concerns if alcohol is sold late into the night.

## 3. Prevention of Public Nuisance

This is the most acute issue:

- Ravilious House bedrooms are only metres away from the pub's single-glazed frontage. Music, chatter, and dispersal noise will be unavoidably intrusive.
- The WHO advises outdoor night noise should not exceed 40 dB, yet normal pub operations easily exceed this threshold. Prolonged sleep disruption is linked to cardiovascular disease, mental health decline, and chronic stress.
- The pub's **large forecourt** encourages outdoor congregation and late-night smoking, amplifying nuisance.
- Guests at the Premier Inn next door will also be disturbed, undermining both amenity and local reputation.

When the pub was first licensed, there were no adjacent residential properties to disturb. Today, it sits in the heart of a family-friendly neighbourhood, where noise carries directly into homes. No signage or conditions can realistically mitigate this.

# 4. Protection of Children from Harm

- **Sleep disruption:** Children in nearby homes will suffer disturbed nights, which WHO research shows directly harms learning and cognitive development.
- **Exposure to disorder:** Children risk witnessing late-night drunken behaviour or its aftermath (vomit, litter, public urination) in the morning.
- **Community wellbeing:** Families deserve a calm, safe environment. Extending alcohol sales into the night undermines this, exposing children to harm in their own neighbourhood.

### Conclusion

When the Black Bull was last licensed, the local context was commercial, not residential. The area has since transformed, with homes, a hotel, and families now in immediate proximity. What might once have been acceptable is no longer compatible with the licensing objectives.

- Crime and disorder will increase.
- Public safety will be compromised.
- Public nuisance is inevitable.
- Children's wellbeing will be harmed.

No conditions can sufficiently address these risks. The only responsible decision, consistent with the Licensing Act 2003, is to refuse the application in its entirety.
