Please see below correspondence and the below agreed police conditions to be included in the premises licence:

1. Any alcohol sold for consumption off the premises shall be sold in a sealed container.
2. On days when Chelsea Football Club Men's First Team are playing home matches at Stamford Bridge the licensee shall ensure that;
 - No sales of alcohol in glass containers to be undertaken during the period 2 hours before kick-off or start of event and 1 hour after.
 - Avoid stacking alcohol stock close to the entrance and exit doors and employ staff and security to monitor control customers, entrance and exits;
 - SIA staff shall be employed to assist staff and keep order on match/event days.
