Dear Licensing Team,

The Environmental Public Protection Team has reviewed the application for the White Horse, which includes the addition of an external bar on the outside area. We object to this element of the proposal on the grounds of public nuisance risk, as defined under the Licensing Act 2003.

## Reasons for Objection

- Noise Impact on Nearby Residents: The external bar will encourage prolonged outdoor drinking and socialising, increasing the likelihood of raised voices and disturbance late into the night.
- Amplified Music and Spillover Noise: Although recorded music is indoors only, the presence of an outdoor bar will lead to door/ windows being opened and sound escaping. No acoustic mitigation measures have been provided for the external area.

- Lack of Management plan. The Application does not include a detailed dispersal policy or outdoor area management plan. No conditions proposed to limit the number of patrons outside or restrict use after a certain time.

This objection aligns with the Licensing Act 2003 objective of preventing public nuisance and is consistent with the local Statement of Licensing Policy, which prioritises residential amenity and noise control. The proposed external bar introduces significant risk of noise disturbance beyond acceptable levels, particularly during late – night hours. The cumulative impact of outdoor service combined with extended hours is likely to undermine the licensing objectives.

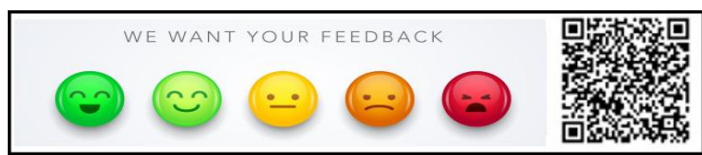

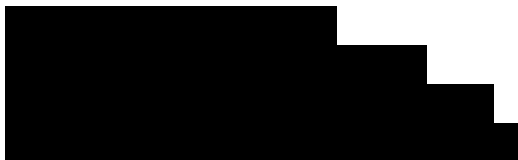
Pls add this email of mine and the email below of Sgt Farrugia as a Supplemental for The White Horse public house hearing on Dec 10.

The Committee should also be informed that the Met shared further info with us when I requested it, namely that the 3 shops which suffered criminal damage just after midnight on Monday 1st December were in the parade of shops very close to The White Horse pub, just at the far corner of Parsons Green ('PG'), namely, between Winkworth's estate agent on the corner of PG and New Kings Road and the Friarwood wines shop (retail sales only) on New King's Road@Molesford Road.

The car broken into was on New Kings Road in the area of Molesford Road.

[REDACTED] of our Ward Panel obtained this information for me/for us.

Unfortunately, this is Met-verified evidence that crime, real crime, is happening after midnight around our very precious Parsons Green and its surrounding, very densely residential roads.

## **Suspect Charged - Criminal Damage to Local Businesses**

Dear Charlotte,

I wanted to provide you with an update regarding Violent crime, which people around your area have highlighted as an issue of concern on the priority survey.

Dear Community,

I'd like to provide a further update regarding the incident that occurred at 0005 hours on Monday 1st December 2025. A male smashed the windows of several business premises and a vehicle on New Kings Road. Police were called immediately, and the male was swiftly arrested at the scene.

I can now confirm that the suspect has been charged with criminal damage and threats to kill. I would also like to reassure the community that the suspect does not live in the borough of Hammersmith & Fulham. The Fulham Safer Neighbourhoods Team

continues to carry out targeted operations and increased patrols, particularly in areas where crime data and community feedback highlight concerns.

I encourage you to continue reporting crime and anti-social behaviour to the police so that we can act promptly and effectively. We remain committed to ensuring Fulham stays a safe and peaceful place for everyone.
