- How can we encourage business, employers and the voluntary sector to provide the maximum benefit to Londoners' health?
- What resources are needed to address future challenges in improving health and reducing inequalities in the most cost-effective way?
- What are the strengths of London's public health system and what can we learn from other cities globally about improving the population's health, reducing health inequalities and maximising system working?

#### Health economy, research and education

- How can London's health sector (including industry, services, research, education and training) best support economic growth?
- How can health research best support London's future needs?
- How can health education and training best support London's future needs?
- How can the Academic Health Sciences Centres and Academic Health Sciences Networks better support London's health and economic goals?
- What can London learn from other cities globally about increasing the contribution of the health sector towards economic growth?
