

8.58pm – Councillor Stephen Cowan moved, seconded by Councillor Andrew Jones, the special motion standing in their names:

"This Council regrets the likely closure of Threshold Housing Advice following the cancellation of its funding and notes that it has been helping homeless people in this Borough since 1978.

The Council recognizes the public service Threshold accomplished when it challenged the treatment of Ms. K and caused the Ombudsman to find the London Borough of Hammersmith and Fulham to have been in Maladministration. The Council notes that Threshold was also challenging the Council on two further cases while the organizations funding was under review.

This Council believes that it would be detrimental to homeless people for Threshold Housing Advice to disappear from Hammersmith and Fulham and agrees to immediately reinstate Council funding."

Speeches on the motion were made by Councillors Stephen Cowan, Andrew Jones, PJ Murphy and Lisa Homan (for the Opposition) and Councillor Lucy Ivimy (for the Administration).

30.2 Special Motion 5 - The Mayor, Hammersmith and Fulham

9.27pm – Due to the subject of the motion, the Mayor vacated the chair and left the meeting. The Deputy Mayor took the chair.

Councillor Colin Aherne moved, seconded by Councillor Michael Cartwright, the special motion standing in their names:

"The Council notes that at the Extraordinary Meeting of the Council on the 16th September 2010 the Mayor allowed Administration members to use their majority to stop public debates on the three Opposition Special Motions. This is the first time ever that this has happened in this borough. These motions had been legitimately placed onto the agenda for that meeting and were representing matters of concern brought to the Opposition by members of the public.

The Council notes that this unprecedented measure was proposed by the Conservative Chief Whip and agreed by all of the majority Conservative Members present. This happened despite the presence of over sixty homeless people, charity workers and other members of the public who had attended to witness these special motions being debated and voted upon.

This Council agrees that it is important that all Mayors must use the powers vested in that office to ensure that the ruling group do not abuse their powers to disregard the legitimate rights of the Opposition.

The failure of the Mayor to use these powers on the 16th September 2010 has had the consequence of Opposition Members being unable to maintain any confidence that the Mayor will act in an non-partisan manner to safeguard the democratic process at council meetings.

Finally, it is with deep regret that the Council is asked to note that the Opposition members of the authority have no confidence in the impartiality of the current Mayor as she has endangered the non-political nature of her office."

Speeches on the motion were made by Councillors Colin Aherne and Michael Cartwright (for the Opposition) and Councillors Alex Karmel and Matt Thorley (for the Administration).

ANNOUNCEMENTS BY THE MAYOR

 I am sure everyone shares my sadness to hear of the deaths of a former Councillor and Mayor. Mr Frederick (Fred) Inniss on 24th October 2010 in London and a former Honorary Freeman of the Borough, Mr Andrew Holmes MBE.

Mr Frederick Inniss, was elected as a Councillor representing College Park and Old Oak Ward from May 1988 until 1994. Mr Inniss was also appointed Mayor in May 1990 until May 1991.

Mr Andrew Holmes MBE, started rowing aged 12 at Latymer Upper School, Hammersmith. Mr. Holmes MBE, went on to become GB Rowing Champion in 1988 at the Seoul Olympics, where he won a Gold Medal. QUESTION

"I am given to understand that in any proposed relocation of services, there must be 'like for like' with no diminution of services.

The pottery studio in Sands End Community Centre was custom built after being relocated from Beaufort House eight years ago. Essential equipment includes four kilns, four work benches to accommodate 16 students, two surfaces for wedging clay with storage for tools, cloths etc. 9 wheels, a pug mill, extruder, a spray booth, grinder, and large double sink for cleaning equipment with sufficient drainage to cope with waste material. There is also an area to re-claim waste clay. There is separate storage for stoneware and earthenware glazes, slips, hazardous oxides, bulk ingredients for glaze making, (some hazardous), earthenware, stoneware and other specialist clays; storage for work in progress, bisque firing and separate storage for stoneware and earthenware firing, plus storage for finished work.

The space in which all this is housed is the <u>minimum</u> for the range of work by the students who range from the beginner to those at professional level. There is good disabled access, and health and safety issues can be easily addressed.

This is the best equipped pottery studio in London and would certainly equal any in a university which runs a ceramics degree course.

Where do you propose to relocate the studio?"

RESPONSE

This was open to a continuing consultation. Funding for the Hammersmith and Fulham Adult Learning and Skills Service (ALSS), which organises the pottery courses at Sands End, is provided by the national funding agency, the Skills Funding Agency (SfA), this funding has been significantly reduced this year by nearly 15% and it is expected that further reductions which could be the order of 40%, will be made this coming year. If the closure of Sands End Community Centre does go ahead, the ALSS will continue to seek to provide a range of pottery courses in the borough, including those for personal interest, from

either Hurlingham and Chelsea School, another venue in Sands End or the Macbeth centre. The intention is that all the existing equipment, that can be safely be re-located, will be moved to one of those venues. However the reduction in the public subsidy for much of the present type of provision is likely to mean that the course fees will have to be significantly increased in coming years.

Officers have been working for a couple of months at looking at what could be potentially different venues for the pottery equipment and there are at least two if not three in Sands End and the potential of the Macbeth Centre.

"Given the very strong local distress over the proposed demolition of 30-52 Goldhawk Road – expressed in the many emails to the council, our Facebook page with over 300 members, petitions and letters; the concern expressed by local groups such as the Hammersmith Society and Hammersmith and Fulham Historic Buildings Group; the fact that these shops are of historic significance being very probably the earliest shops to be built on the road; that all the shop keepers are keen to stay; and that these shops provide significant social and economic benefits from the well loved Pie and Mash shop to the important fabric shops; and finally the real danger that if we move these shops from their current context we could crush the life and community that presently thrives along the Goldhawk Road; would the council consider – in the light of all this – the possibility of the restoration rather than the demolition of this terrace as part of the regeneration of Shepherds Bush market?"

RESPONSE

Shepherds Bush Market is in urgent need of investment if it is to fulfil its undoubted potential. It is clear that the vast majority of traders and local people want to see investment in Shepherds Bush Market so it can remain the pride of Shepherds Bush. Given the constrained layout of the existing market and the opportunity to include new cultural facilities (such as a theatre use in the former library), we believe the most realistic way of achieving regeneration and securing the necessary investment is through the inclusion of the surrounding land and buildings. This will allow for the creation of a vibrant mixed use development of retail, residential and cultural activities. The regeneration area therefore includes the terrace of shops on 30 -52 Goldhawk Road as it is considered essential to deliver a number of key regeneration objectives, specifically:

 to replace the frontage buildings and market entrances with a high quality distinctive design of buildings and public realm that will enhance the town centre including a new gateway to draw visitors into the market;

- The opportunity to provide a servicing route from Goldhawk Road to service the market stalls and commercial floor space.
- The opportunity to provide an access to a new parking area to serve the market, this is a high priority for market traders. (The entrance to the site through the terrace in Pennard Road is too restricted in width to meet this objective.)

We acknowledge the strength of feeling regarding the shops on 30 – 52 Goldhawk Road and the service they provide to the local community. The draft brief already included guidance that these businesses should be re-provided within the regenerated market scheme. In response to the public consultation exercise we have strengthened the guidance advising that these businesses should be offered opportunities to relocate back to new retail premises along the Goldhawk Road frontage. The brief now states: "...re-provision of businesses in the Goldhawk Road frontage within high quality new retail accommodation along the frontage...(page 4, second objective)...it is recognised that some of these businesses have an important historical place in the heart of the local community". (page 7, para.2.5)

While we understand the historic context of this row of shops, physically they are now generally of poor appearance and contribute little to the street scene. They have suffered from inappropriate alterations over many years and have lost most of the architectural detailing which once contributed to their character and appearance. It is unlikely that they could be refurbished and restored without significant rebuilding which would erode even further any remaining historic integrity of the terrace. Some of them are currently in a state of disrepair and it is unlikely that they will receive the kind of investment required from their private owners in the near future.

- 1.2 The Petition's prayer is as follows:-

"We the undersigned hereby express our strong opposition to the council's intention to sell the Irish Cultural Centre.

We respectfully request that you as the elected leaders of the council do everything in your power to reconsider the future of this building and its people.

Help to preserve their excellent Cultural Programme, the broad spectrum of support and services it provides, and to maintain a centre for both the Irish in London, and the large number of users from all other backgrounds".

- 1.3 The Petition also contained a statement which is attached at an appendix to this report.
- 1.4 Under the Council's Petitions Scheme, a petition attracting a minimum of 5000 valid signatures (of people who live, work or study in the borough) triggers consideration of the petition by Full Council.
- 1.5 A report on the H&F Buildings Consultation, including recommendations regarding the Irish Cultural Centre is due to be considered at Cabinet on 7th February 2011.

- 2.1 In accordance with the Council's Petitions Scheme, the petition organiser (or someone he/she nominates) may address the Council for up to 5 minutes on the subject of the petition. The Council may then decide to take one or more of the following courses of action:

- g) refer the petition for consideration by the relevant Select Committee

This report contains an estimate of the Council Tax collection rate and calculates the Council Tax base for 2011/12.

The Council Tax base will be used in the calculation of the Band D Council Tax undertaken in the Revenue Budget Report for 2011/12.

CONTRIBUTORS

Recommendation:

DFCS ADLDS That Council approve the following recommendations for the 2011-2012 financial year:

- 1) That the estimated numbers of properties for each Valuation Band, as set out in this report, be approved.
- 2) That an estimated Collection rate of 97.5% be approved.
- 3) That the Council Tax Base of 79,799 Band "D" equivalent properties be approved.

1. BACKGROUND

- 1.1 Under Section 33(1) of the Local Government Finance Act 1992 and the Local Authorities (Calculations of Council Tax Base) Regulations 1992, the Council (as billing authority) is required to calculate its Council Tax Base. This comprises both the estimated numbers of properties within each Valuation band plus the Council's estimate of its collection rate for the coming financial year.
- 1.2 For the current financial year, the Council approved a Council tax base of 81,079 Band D equivalent dwellings, and an estimated Collection Rate of 97.5%, which resulted in a tax base of 79,052.
- 1.3 Under Section 11A of the Local Government Finance Act 1992 and the Council Tax (Prescribed Classes of Dwellings) (England) Regulations 2003 the Council has reduced discounts for Second Homes and Long Term Empty properties.
- 1.4 For 2005/06 and subsequent years until revoked, the Council approved discount reductions on Second Homes from 50% to 10% and on Long Term Empty properties from 50% to 0%.

2. PURPOSE

2.1 The purpose of the report is for Council to approve the recommendations on the estimated Collection Rate and Council Tax Base for 2011/12.

3. DISCOUNTS

3.1 Second Homes

- 3.1.1 There are some 1,877 second homes in the borough. The reduction in discount from 50% to 10%, will add an additional 882 Band "D" equivalents to the taxbase for 2011/12.
- 3.1.2 Based upon 2010/11 Council Tax levels this reduction in the discount will generate income to the Council of £0.72m. Such additional income will directly benefit the Council and is allowed for within our Medium Term Financial Strategy. Our preceptor, the GLA, will also benefit from the reduction in the discount.

3.2 Long Term Empty Properties

- 3.2.1 There are some 871 long-term empty properties and these have been reflected in the CTB1 return, which the Council provided to the DCLG on 15 October 2010. The net impact of the reduction in the discount on long term empty properties from 50% to nil, is to add an additional 492 Band D equivalents to the taxbase.
- 3.2.2 Based upon 2010/11 Council Tax levels this will generate additional income of £0.40m. Unlike the income generated from the reduction in the second homes discount the Government consider that such

additional Council Tax income should not directly benefit the Council. Accordingly, it is taken account of within the Formula (RSG) Grant process. The Government suggest that any decision regarding the long term empty property discount rate should be made for housing, rather than financial, reasons.

4. VALUATION BAND PROPERTIES

- 4.1 The latest information on the number of properties within each valuation band is contained within a return (CTB1), which the Council provided to the DCLG on 15 October 2010.
- 4.2 This return reflected the actual number of properties shown in the Valuation List as at 13 September 2010 and the Council's records as at 4 October 2010.
- 4.3 A detailed analysis of the properties in each valuation band can be summarised as follows. There are a total of 81,836 dwellings on the list with some 32,546 properties estimated to receive a sole occupier discount. The total Band "D" equivalent is approximately 81,638 properties.

5. ADJUSTMENTS TO THE VALUATION LIST

5.1 The above table shows the valuation band position at 13 September 2010 but the Council is also required to take into account likely changes during the financial year 2011-2012. The following potential adjustments need to be considered:

(i) New Properties

There are likely to be a number of new properties, conversions etc. added to the valuation list at some point during the year. There are approximately 321 units currently under construction on various sites in the Borough that will be added to the tax base sometime during 2011/12. It is estimated after allowing for different completion dates that this will equate to an additional 302 Band 'D' equivalents.

(ii) Banding Appeals

There have been over 9,500 appeals lodged with the valuation office in respect of initial Council Tax bandings. There are now only a small number unsettled so it is not proposed to make any adjustments for these.

(iii) Second Homes

The effect of reducing the discount for second homes from 50% to 10% from 1 April 2011, would add a further 882 Band "D" equivalents as outlined in section 3.1.

(iv) Student Exemptions

Dwellings wholly occupied by students are exempt from Council Tax. The projected Council Tax base needs to be adjusted to allow for students that have yet to prove their exemption for the new academic year. It is estimated that an adjustment of 977 Band "D" equivalents is required.

- 5.2 The Council is required to set its Tax Base on the total of the relevant amounts for the year for each of the valuation bands shown or is likely to be shown for any day in the year in the authority's valuation list.
- 5.3 Taking into account the latest information from the CTB1 return to the DCLG and the proposed adjustments, the Council is requested to approve the

estimated numbers of properties for each valuation band as set out in the following table:

6. COLLECTION RATE

- 6.1 The Council is also required to estimate its Collection Rate for 2011/12 at the same time as arriving at the estimated number of properties within the Tax Base. In arriving at a percentage Collection Rate for 2011/12, the Council should take into account the likely sum to be collected, previous collection experience and any other relevant factors.
- 6.2 The actual sum to be collected from local Council Tax payers cannot be finally determined until the preceptors' requirements are known and the Council has approved its budget. The Council therefore has to make an estimate of the sums to be collected locally, making estimated allowance for sums from Council Tax Benefits and write-offs/non-collection.
- 6.3 The actual collection rate for 2010/11 achieved to mid November 2010 is 68.7% comprising cash collection of £51.3m and Council Tax benefit of £17.0m. It is estimated that a further £20.1m (26.9%) will need to be collected by 31 March 2011 and £1.4m (1.9%) thereafter.
- 6.4 Collection performance has been calculated in order to comply with Best Value performance indicator calculations. Latest calculations for 2009/10 and 2010/11 show that the current collection rate can be continued for 2011/12. It is therefore suggested that the collection rate for 2011/12 is maintained at 97.5%

7. THE TAX BASE

- 7.1 Under Section 33(1) of the Local Government Finance Act 1992 and the Regulations, the Council's tax base is calculated by multiplying the estimated number of Band "D" equivalents by the estimated collection rate.
- 7.2 Based on the number of Band "D" equivalents in the table in paragraph 5.4 above and the estimated collection rate in paragraph 6.4 above, the calculation is as follows:-

(Band D equivalents) x (Collection Rate) = (Tax Base) 81,845 x 97.5% = 79,799

8. COMMENTS OF THE DIRECTOR OF FINANCE AND CORPORATE SERVICES

- 8.1 The tax base is set by 31 January each year, as outlined in the Local Government Finance Act 1992. It is used within the overall Council Tax and budget setting process, due to be reported to Budget Council on 23 February 2011.
- 8.2 The proposed Council Taxbase for 2011/12 of 79,799 is 747 band D equivalents higher than the 79,052 agreed for 2010/11. This will result in a net increase in forecast 2011/12 Council Tax income, for the Council, of £0.61m.
- 8.3 The Local Government and Finance Act requires that all Council Tax and non-domestic rates income is paid into a Collection Fund along with payments out regarding the Greater London Authority precept, the national pool for non-domestic rates and the contribution towards the Council's own General Fund. As at the close of 2009/10 the Fund had an underlying deficit of £0.46m. The uplift now reported in the 2010/11 Council Tax Base should address this deficit as the amount now forecast to be collected is more than that assumed within the 2010/11 Revenue Budget. Accordingly there are no plans to recover the Collection Fund deficit as part of the 2011/12 Revenue Budget process.
- The recent 2010 Spending Review announced two new unringfenced revenue grants. Both relate to Council Tax Base data. They are:
 - A Council Tax Freeze Grant. This is will provide a grant equivalent to a 2.5% increase in the 2010/11 Council Tax charge. Based on these Taxbase figures this would deliver a 2011/12 grant of £1.62m.
 - A New Homes Bonus Grant. This is intended to match fund the additional Council Tax for each new home and property brought back into use, for each of the six years after that home is built. It is not yet clear how this will operate in practice. Based on the increase in the Council Tax Base the potential grant could be in the region of £0.5m-£0.6m.

More details on these schemes are expected to be released in the forthcoming weeks. Any grant award will be taken account of within the MTFS process.

9. COMMENTS OF THE ASSISTANT DIRECTOR (LEGAL & DEMOCRATIC SERVICES)

- 9.1 The Council is under a statutory duty to set the Council Tax for the forthcoming financial year and to make a budget. This report forms part of that process. The Council is obliged, when making its budget, to act reasonably and in accordance with its statutory duties, the rules of public law and its general duty to Council Tax payers.
- 9.2 The basic amount of Council Tax must be calculated in accordance with Section 31(1) of the Local Government Finance Act 1992 and the Local Authorities (Calculation of Council Tax Base) Regulations 1992.
- 9.3 The Council Tax base has been calculated in accordance with the Act and the Regulations. Reducing the estimated collection rate to 97.5% is a reasonable and realistic estimate.
- 9.4 Regulations under the Local Government Act 2003 allow the Council to reduce Council Tax discount for dwellings that are not the sole or main residence of an individual and which are furnished (second homes) to a minimum of 10%. The regulations also allow the Council to reduce Council Tax discount for dwellings that are unoccupied and substantially unfurnished for more than six months (long term empty properties) to zero.

Treasury Management update for the six months of 2010/11

1. Introduction

- 1.1 CIPFA issued the revised Code of Practice for Treasury Management in November 2009 following consultation with Local Authorities during the summer. The revised Code suggests that members should be informed of Treasury Management activities at least twice a year. This report therefore ensures this Council is embracing Best Practice in accordance with the Chartered Institute of Public Finance and Accountancy's (CIPFA) revised Code of Practice.
- 1.2 This report covers both quarters and provides information on the Council's debt, borrowing and investment activity up to 30 September 2010.

2. Economic Background

- 2.1 The first six months of the financial year of 2010/11 saw:
 - The new coalition government enact a fiscal squeeze set to be the most severe since the end of the 1930's, through its Emergency Budget on the 22 June;
 - The labour market show some tentative signs of improvement;
 - The UK's trade position deteriorate, despite the weak pound;
 - The Monetary Policy Committee maintain Quantitative Easing (QE) and keep Bank Rate on hold at 0.5%; Quantitative easing is the purchase of government bonds or gilts by the Bank of England to increase the money supply.
 - UK GDP increase 1.2% in the second quarter of 2010 which takes the annual figure up to 1.7%
 - GDP forecast staying positive but low through 2010. Growth is expected to be slow, at a rate of just over 3% in two years time due to the extra fiscal tightening announced in the June budget;
 - US GDP grow slower than initially estimated;
 - EU growth grow at its fastest pace in more than three years, boosted by a strong performance by Germany and France;
 - UK CPI Inflation in August remain its lowest since February at 3.1%,
 - RPI remain high at 4.7% in August;
 - Public Sector Net Borrowing post a record high in August at £15.3 billion as interest payments on gilts shot up because of higher inflation;
 - British house prices rise 0.2 percent in August, confounding expectations for a decline (Halifax). It is expected that UK house prices with remain static overall in 2010;

 Nationwide report that house prices fell 0.9% in August due to a rise in the number of properties available.

3. Economic Forecast

3.1 The Council's Treasury Adviser, Sector, provides the following interest rate forecast:

- The forecast is based on moderate economic recovery and moderate Monetary Policy Committee concerns about inflation looking 2 years ahead
- The first Bank Rate increase is expected to be in the quarter ending September 2011;
- Long term Public works loans Board (PWLB) rates are expected to steadily increase to reach 5% by the end of 2012 due to high gilt issuance, reversal of Quantitative Easing and investor concerns over inflation:
- The double dip recession worries have eased slightly in the UK but the economy is still fragile.
- There is considerable uncertainty in all forecasts due to the difficulties
 of forecasting the timing and amounts of QE reversal, the fiscal effect
 of a general election, speed of recovery of banks profitability and
 balance sheet position, changes in the consumer saving ratio,
 rebalancing of the UK economy in terms of export and import etc;
- Inflation is expected to fall below 2% in two years time even if interest rates remain at their record low.

4. Treasury Management Strategy Statement:

4.1 Annual Investment Strategy:

The Treasury Management Strategy for 2010/11 was approved by Council on 24 February 2010. The Council's Annual Investment Strategy, which is incorporated in the overall strategy, outlines the Council's investment priorities as follows:

- Security of Capital
- Liquidity

The Council will also aim to achieve the optimum return on investments commensurate with the proper levels of security and liquidity. In the current economic climate it is considered appropriate to keep investments short term, and only invest with highly credit rated financial institutions using the Sector suggested creditworthiness matrices, including Credit Default Swap overlay information provided by Sector.

4.3 Officers can confirm that the approved limits within the Annual Investment Strategy was not breached during the first half of 2010/11.

As illustrated in the interest rate section above, investment rates available in the market are at an historical low point. These funds were available on a temporary basis, and the level of funds available was mainly dependent on the timing of precept payments, receipt of grants and progress on the Capital Programme. The table below shows that the authority outperformed the benchmark by 0.54%.

5.3 Variation on Investment Balances

It is quite usual for cash balances to fluctuate daily but in the first six months there was a payment to the DCLG of £30 million relating to Non Domestic Rates which has resulted in a reduction in overall cash balances.

6. Prudential Indicators

- 6.1 This section shows the Council's position against the prudential indicators for 2009/10 agreed by Council in February 2009.
- 6.2 It is a statutory duty under Section 3 of the Local Government Act 2003 and supporting regulations for the Council to determine and keep under review how much it can afford to borrow. The amount so determined is termed the "Affordable Borrowing Limit" or "Authorised Limits". In England and Wales the authorised limits represent the legislative limits specified in Section 3 of the Local Government Act 2003.

The Council must have regard to the Prudential Code when setting the Authorised Limit, which essentially requires it to ensure that total capital investment remains within sustainable limits and, in particular, that the impact upon its future council tax and council rent levels is 'acceptable'.

Whilst termed an "Authorised Limit", the capital plans to be considered for inclusion incorporate financing by both external borrowing and other forms of liability, such as credit arrangements.

6.3 Limits to Borrowing Activity

- a) The Authorised Limit This represents the maximum amount the Council may borrow at any point in time in the year. It has to be set at a level the Council considers "prudent" and it needs to be set and revised by members. It reflects the level of borrowing which, while not desired, could be afforded in the short term, but is not sustainable and encompasses borrowing for temporary purposes. It is not a limit that is designed to be brought into consideration during the routine financial management of the authority. That is the purpose of the Operational Boundary.
- b) The Operational Boundary This indicator is the focus of day to day treasury management activity within the authority. It is a means by which the authority manages its external debt to ensure that it remains

within the self imposed Authorised Limit. Sustained breaches of the Operational Boundary would give an indication that the authority may be in danger of stepping beyond the Prudential boundaries it has set itself.

6.4 Interest Rate Exposures

Interest rate risk management is a top priority for local authority management. While fixed rate borrowing and investment can contribute significantly to reducing the uncertainty surrounding future interest rate scenarios, the pursuit of optimum performance may justify, or even demand, retaining a degree of flexibility through the use of variable interest rates on at least part of a treasury management portfolio. This is a best practice approach to treasury management and is to be encouraged to the extent that it is compatible with the effective management and control of risk.

- a) Upper Limit on fixed rate exposure This indicator identifies a maximum limit for fixed interest rates based upon the debt position net of investments.
- b) Upper Limit on variable rate exposure This indicator identifies a maximum limit for variable interest rates based upon the debt position net of investments.
- c) Total principal funds invested for periods longer that 364 days These limits are set to reduce the need for early sale of an investment, and are based on the availability of investments after each year-end.

NEW BYELAWS FOR PLEASURE GROUNDS, PUBLIC WALKS AND OPEN SPACES

The Council has been seeking to update its open space byelaws. The Office of the Deputy Prime Minister (now Department of Communities and Local Government) has recommended that the Council should do so in line with that Department's set of Model Byelaws for Parks and Open Spaces.

The report seeks a resolution by Full Council to approve a new set of byelaws based on the 'Model Set 2' before seeking provisional approval from the Department of Communities and Local Government (DCLG).

RECOMMENDATIONS:

That Council resolves to:

- (1) Approve the new model Byelaws (as set out in Appendix 1); and
- (2) Authorise the Assistant Director (Legal and Democratic Services) to apply to the Secretary of State for the Department of Communities and Local Government for provisional approval of the proposed byelaws.

1. BACKGROUND

- 1.1 The current set of general byelaws for the borough's parks and open spaces were approved and adopted by the Council in 2000. However due to the unenforceable nature of many of the byelaws, and also omissions of a number of sites, the Council's current byelaws are becoming increasingly more obsolete and unenforceable.
- 1.2 Since 2004 the Council has been reviewing the appropriateness of other byelaws and in 2005 following internal consultation with community safety, legal and environment services it was concluded that the Office of the Deputy Prime Minister (ODPM) (now the Department of Communities and Local Government (DCLG)) model set 2 (relating to Parks and Open Spaces) would meet the needs of the Council, address the local issues in the borough and therefore are being recommended for approval by Full Council.

2. PROCEDURE FOR ADOPTING MODEL SET OF BYELAWS

- 2.1 The Local Government White Paper "Strong and Prosperous Communities" (October 2006), states that it is the Government's intention to end the Secretary of State's role in confirming byelaws. In the meantime, however, progress on amending or approving new byelaws still remains with the Secretary of State.
- 2.2 Therefore, until authority has been passed to local councils the following procedure for approval applies:
 - Council amends model set byelaws where appropriate with consent from DCLG.
 - Council to consult relevant impacted stakeholders to evidence the need for proposed byelaws to be adopted.
 - Full Council resolves to approve draft byelaws and apply for provisional approval from the Secretary of State for Communities and Local Government.
 - Council seeks provisional approval from the Secretary of State (SOS) for Communities and Local Government.
 - Following approval from SOS, a Full Council is required to seek a resolution to adopt the byelaws, under common seal, subject to confirmation from the SOS.
 - A formal notice will then be advertised for at least another month. A copy of the byelaws must be held on deposit at the offices of the Council for inspection by the public.
 - Following this deposit period an application to DCLG is forwarded with the sealed byelaws for confirmation. The Secretary of State will then fix a date when the byelaws come into force.

Throughout the process the DCLG does expect that the Council continues to consult its residents and objections received by them will be sent to officers for comment.

Appropriate signage will be commissioned at all sites to enable enforcement of byelaws.

3. SCOPE OF DCLG MODEL BYELAWS

- 3.1 The model byelaws can only be applied to parks and open spaces managed by the local authority and disused burial grounds. This therefore excludes active cemeteries (Fulham Cemetery) as well as local nature reserves (e.g. part of Wormwood Scrubs is a designated Local Nature Reserve).
- 3.2 Specific reference to dog related issues is not included in the byelaws. This is because the byelaws should not replicate existing primary legislations such as Dog Control Orders or Environmental Protection Act which already provide sufficient legislation for addressing many dog related issues.
- 3.3 The DCLG model set byelaws are restrictive regarding the extent of amendments possible with all changes requiring approval by DCLG. If extensive changes are made it is most likely that these would not be accommodated by DCLG and a more bespoke set of byelaws would need to be developed.

4. WHY USE MODEL BYELAWS

- 4.1 The process of adopting model byelaws is effectively a 'fast track' approval process that minimises the potential challenges that bespoke byelaws may raise. The legality and applicability of each byelaw have already been reviewed by DCLG.
- 4.2 Where there are specific local issues, Local Authorities should consider devising more locally specific byelaws. It should be noted that the current Model Set of Byelaws is a product of national consultation and has taken into account many of the issues councils had difficulty addressing that fall outside primary legislation. This has resulted in the extension of the byelaws from No.33 to 47.

5. PROPOSED CHANGES AND ADDITIONS

- 5.1 The proposed changes to the byelaws may have an impact on how the public are able to use the sites covered under the proposed new byelaws. The following details the key changes proposed:
 - New Byelaws in relation to the protection of wildlife, gates, camping, fires, missiles, interference with life-saving equipment, horses, overnight parking, cricket, archery, golf, bathing, ice skating, model boats, fishing, public shows and performances, kites and metal detectors (respectively byelaws numbered 8, 9, 10, 11, 12, 13, 15, 18, 26, 27, 28, 30, 31, 32, 33, 41, 42, and 43)
 - Updated list of areas to which the new byelaws apply (Schedule 1): As per the existing byelaws, plus inclusion of the following additional open spaces to be covered by new byelaws:
 Bayonne Road, Godolphin Road, Loris Gardens, Mitre
 Bridge Public Open Space, Norland North Park, Old Oak Sidings Birch Woodland and White City play area.
 - Updated list of areas to which byelaw number 3 in respect of opening times apply (Schedule 2 Part 1. Opening Times for Parks): as per the existing byelaws, plus additional open spaces: All Saints' Church Gardens,

- Brook Green children's play area, Maxwell Road play area, Norland North Park, Ravenscourt Park, St Paul's Church (Hammersmith Road) and White City play area.
- New Schedule 2 Part 2. No Ball Games: This refers to Byelaw 23 (1). Although ball games were prohibited in existing byelaws for certain sites, there is a further additional open space, Frank Banfield Park, where balls are to be prohibited in the proposed byelaw.
- Updating byelaws (numbered 35-37) in respect of model aircraft and New Schedule 2 Part 3. Model aircraft: a more restrictive regime of flying hours is now proposed for Wormwood Scrubs to reduce noise pollution at that sensitive time for local residents and to reduce the risks to the adjacent football pitches.
- New Schedule 3: This refers to Byelaw 25, updates rules for Ball games in designated areas.

6. CONSULTATION AND REVIEWS

- 6.1 The adoption of the model byelaws has been subject of a number of reviews since 2004. The Cleaner and Greener Scrutiny Committee meeting on 4 September 2006 resolved that Full Council should approve the adoption of the proposed byelaws subject to a number of recommendations that have now been incorporated into the byelaws, where permissible by DCLG.
- 6.2 Parks Development has been working closely with Parks Constabulary section to ensure the appropriateness of the new model byelaws.
- 6.3 The Council has consulted key park stakeholders and conducted a borough wide public consultation in the Autumn of 2010. The following main concerns were raised:
 - Flying kites and land kite boarding new byelaws considered too restrictive on types of flying aircraft or kites permitted and the hours of flying allowed – proposed byelaws are more comprehensive to include previously excluded airborne objects and to limit their risk to the public.
 - Absence of Dog controls and management in new byelaws proposed byelaws does not duplicate primary legislation which already provide measures for addressing dog related issues.
 - Cycling in parks remains contentious as to whether more or less restrictions should apply – the proposed byelaws only permit cycling in designated areas and routes but are flexible to be able to change them according to need and circumstances according to designation.
- 6.4 A summary of all the main comments received are provided in Appendix 2 and the Council's response to the issues raised and actions to resolve them where possible.
- 6.5 Consent has also been acquired from land owners for sites managed by the Council as part of the consultation process.

7. COMMENTS OF THE CLEANER AND GREENER SCRUTINY COMMITTEE

- 7.1 The Cleaner and Greener Scrutiny Committee at its meeting on 4 September 2006 resolved that Council be recommended to approve the proposed byelaws subject to:
 - Standardising the times that model aircraft may be flown on a small part of Wormwood Scrubs;
 - The specified times for flying model aircraft being strongly enforced;
 - Due consideration being given to the noise pollution impact on the areas for flying relative to local housing;
 - Consideration being given to encouraging club involvement in flying model aircraft on Wormwood Scrubs to help improve management;
 - Brook Green listed in Schedule 1 ('Grounds to which byelaws apply generally')
 also includes Little Brook Green.
- 7.2 The current byelaws retain the permitted hours for flying model aircraft on part of Wormwood Scrubs. There are potential conflicts with other uses on the Scrubs (especially football and training by the Ministry of Defence's Kings Troop). However, Royal Society Of Prevention of Accidents, who conducted a risk assessment, recommended that the schedule of permitted hours is satisfactory and also proposed that only members of flying clubs authorised by the Council and with adequate public liability insurance should be permitted to fly planes. These additional conditions have been reviewed and the Council has begun discussion to establish a flying club on the scrubs but consider that membership of the club is not mandatory.

8. RISK MANAGEMENT IMPLICATIONS

8.1 The adoption of the byelaws will reduce many of the risks involved in managing and enforcing anti-social behaviour (ASB) and crime in parks and open spaces. Clearer and enforceable restrictions can be applied which have developed through national consultation. It should be recognised that the model byelaws does not address all present or foreseeable issues relating to ASB. These will need to be addressed on a local basis and proportionately within either existing legal framework or by locally developed byelaws where necessary.

9. CONCLUSION

- 9.1 The current byelaws are in need of an update: primary legislation has changed making some of the byelaws obsolete, a number of new sites are now managed by the Council, and they also do not provide adequate provisions to safeguard the borough's public open spaces and users. Although the model set byelaws may not comprehensively address all issues they provide the 'best fit' solution.
- 9.2 The model byelaws takes into consideration recent changes to primary legislation that affect environmental protection and other related open space regulatory matters. It provides a practical set of governance which all agencies tasked with enforcing them can apply. Therefore it is recommended that the new byelaws are approved by Full Council.

10. COMMENTS OF THE DIRECTOR OF FINANCE AND CORPORATE SERVICES

- 10.1 Should the proposals outlined in this report be agreed, appropriate signage will need to be commissioned at all sites to enable enforcement of these byelaws. The cost of replacing and installing the byelaws signage has been included in the parks signage replacement project totalling £136k across all parks in the borough. This has been fully provided for within the overall existing parks capital programme, for which there is £0.5m funding available for each of the years 2010/11 2014/15.
- 10.2 No other financial liability is anticipated.

11. COMMENTS OF THE ASSISTANT DIRECTOR (LEGAL AND DEMOCRATIC SERVICES)

- 11.1. The decision to adopt new and revoke existing byelaws must be made by Full Council. The procedure is set out at paragraph 2.2 of the report. Following Council approval and provisional approval from the Secretary of State for the Department of Communities and Local Government, the Council will need to make a further resolution to adopt the byelaws subject to confirmation from the Secretary of State.
- 11.2. The Council is empowered to make these byelaws for the regulation of and admission to the open spaces and burial grounds and for the preservation of order and prevention of nuisances. Government guidance advises that byelaws should only be made to address an existing problem.

Byelaws made under section 164 of the Public Health Act 1875 and sections 12 and 15 of the Open Spaces Act 1906 by the London Borough of Hammersmith & Fulham with respect to pleasure grounds, public walks and open spaces.

PART 1

GENERAL

General Interpretation

1. In these byelaws:

"the Council" means the London Borough of Hammersmith & Fulham;

"designated area" means an area in the ground which is set aside for a specified purpose, that area and its purpose to be indicated by notices placed in a conspicuous position;

"the ground" means any of the grounds listed in Schedule 1;

"invalid carriage" means a vehicle, whether mechanically propelled or not,

- (a) the unladen weight of which does not exceed 150 kilograms,
- (b) the width of which does not exceed 0.85 metres, and
- (c) which has been constructed or adapted for use for the carriage of a person suffering from a disability, and used solely by such a person.

Application

2. These byelaws apply to all of the grounds listed in Schedule 1 unless otherwise stated.

Opening times

- 3. (1) No person shall enter or remain in the ground except during opening hours.
 - (2) "Opening hours" means the days and times during which the ground is open to the public and which are indicated by a notice placed in a conspicuous position at the entrance to the ground.
 - (3) Byelaw 3(1) applies only to the grounds listed in Part 1 of Schedule 2.

PROTECTION OF THE GROUND, ITS WILDLIFE AND THE PUBLIC

Protection of structures and plants

- 4. (1) No person shall without reasonable excuse remove from or displace within the ground:
 - (a) any barrier, post, seat or implement, or any part of a structure or ornament provided for use in the laying out or maintenance of the ground; or
 - (b) any stone, soil or turf or the whole or any part of any plant, shrub or tree.
 - (2) No person shall walk on or ride, drive or station a horse or any vehicle over:
 - (a) any flower bed, shrub or plant;
 - (b) any ground in the course of preparation as a flower bed or for the growth of any tree, shrub or plant; or
 - (c) any part of the ground set aside by the Council for the renovation of turf or for other landscaping purposes and indicated by a notice conspicuously displayed.

Unauthorised erection of structures

5. No person shall without the consent of the Council erect any barrier, post, ride or swing, building or any other structure.

Climbing

6. No person shall without reasonable excuse climb any wall or fence in or enclosing the ground, or any tree, or any barrier, railing, post or other structure.

Grazing

7. No person shall without the consent of the Council turn out or permit any animal for which he is responsible to graze in the ground.

Protection of wildlife

8. No person shall kill, injure, take or disturb any animal, or engage in hunting or shooting or the setting of traps or the laying of snares.

Gates

- 9. (1) No person shall leave open any gate to which this byelaw applies and which he has opened or caused to be opened.
 - (2) Byelaw 9(1) applies to any gate to which is attached, or near to which is displayed, a conspicuous notice stating that leaving the gate open is prohibited.

Camping

10. No person shall without the consent of the Council erect a tent or use a vehicle, caravan or any other structure for the purpose of camping.

Fires

- 11. (1) No person shall light a fire or place, throw or drop a lighted match or any other thing likely to cause a fire.
 - (2) Byelaw 11(1) shall not apply to the lighting of a fire at any event for which the Council has given permission that fires may be lit.

Missiles

12. No person shall throw or use any device to propel or discharge in the ground any object which is liable to cause injury to any other person.

Interference with life-saving equipment

13. No person shall except in case of emergency remove from or displace within the ground or otherwise tamper with any life-saving appliance provided by the Council.

HORSES, CYCLES AND VEHICLES

Interpretation of Part 3

14. In this Part:

"designated route" means a route in or through the ground which is set aside for a specified purpose, its route and that purpose to be indicated by notices placed in a conspicuous position;

"motor cycle" means a mechanically-propelled vehicle, not being an invalid carriage, with less than four wheels and the weight of which does not exceed 410 kilograms;

"motor vehicle" means any mechanically-propelled vehicle other than a motor cycle or an invalid carriage;

"trailer" means a vehicle drawn by a motor vehicle and includes a caravan.

Horses.

- 15. (1) No person shall ride a horse except:
 - (a) in any of the grounds listed in Part 2 of Schedule 2; or
 - (b) in the exercise of a lawful right or privilege.
 - (2) Where horse-riding is permitted in any ground by virtue of byelaw 15(1)(a) or a lawful right or privilege, no person shall ride a horse in such a manner as to cause danger to any other person.

Cycling

16. No person shall without reasonable excuse ride a cycle in the ground except in any part of the ground where there is a right of way for cycles or on a designated route for cycling.

Motor vehicles

17. No person shall without reasonable excuse bring into or drive in the ground a motor cycle, motor vehicle or trailer except in any part of the ground where there is a right of way for that class of vehicle.

Overnight parking

18. No person shall without the consent of the Council leave or cause or permit to be left any motor vehicle in the ground between the hours of 10 p.m. and 6 a.m.

PLAY AREAS, GAMES AND SPORTS

Interpretation of Part 4

19. In this Part:

"ball games" means any game involving throwing, catching, kicking, batting or running with any ball or other object designed for throwing and catching, but does not include cricket;

"self-propelled vehicle" means a vehicle other than a cycle, invalid carriage or pram which is propelled by the weight or force of one or more persons skating, sliding or riding on the vehicle or by one or more persons pulling or pushing the vehicle.

Children's play areas

20. No person aged 14 years or over shall enter or remain in a designated area which is a children's play area unless in charge of a child under the age of 14 years.

Children's play apparatus

21. No person aged 14 years or over shall use any apparatus stated to be for the exclusive use of persons under the age of 14 years by a notice conspicuously displayed on or near the apparatus.

Skateboarding, etc

- 22. (1) No person shall skate, slide or ride on rollers, skateboards or other self-propelled vehicles except in a designated area for such activities.
 - (2) Where there is a designated area for skating, sliding or riding on rollers, skateboards or other self-propelled vehicles, no person shall engage in those activities in such a manner as to cause danger or give reasonable grounds for annoyance to other persons.

Ball games

- 23. (1) No person shall play ball games in the grounds listed in Part 3 of Schedule 2.
- 24. No person shall play ball games outside a designated area for playing ball games in such a manner:
 - (a) as to exclude persons not playing ball games from use of that part;
 - (b) as to cause danger or give reasonable grounds for annoyance to any other person in the ground; or

- (c) which is likely to cause damage to any tree, shrub or plant in the ground.
- 25. It is an offence for any person using a designated area for playing ball games to break any of the rules set out in Schedule 3 and conspicuously displayed on a sign in the designated area when asked by any person to desist from breaking those rules.

Cricket

No person shall throw or strike a cricket ball with a bat except in a designated area for playing cricket.

Archery

27. No person shall engage in the sport of archery except in connection with an event organised by or held with the consent of the Council.

Golf

28. No person shall drive, chip or pitch a hard golf ball.

WATERWAYS

Interpretation of Part 5

29. In this Part:

"power-driven" means driven by the combustion of petrol vapour or other combustible substances;

"waterway" means any river, lake, pool or other body of water and includes any fountain.

Bathing

30. No person shall without reasonable excuse bathe or swim in any waterway except in a designated area for bathing and swimming.

Ice skating

31. No person shall step onto or otherwise place their weight upon any frozen waterway.

Model boats

32. No person shall operate a power-driven model boat on any waterway.

Fishing

33. No person shall in any waterway cast a net or line for the purpose of catching fish or other animals.

Pollution

34. No person shall foul or pollute any waterway.

MODEL AIRCRAFT

Interpretation of Part 6

35. In this Part:

"model aircraft" means an aircraft which weighs not more than 7 kilograms without its fuel:

"power-driven" means driven by:

- (a) the combustion of petrol vapour or other combustible substances:
- jet propulsion or by means of a rocket, other than by means of a small reaction motor powered by a solid fuel pellet not exceeding 2.54 centimetres in length; or
- (c) one or more electric motors or by compressed gas.

"radio control" means control by a radio signal from a wireless transmitter or similar device.

General prohibition

- 36. No person shall cause any power-driven model aircraft to:
 - (a) take off or otherwise be released for flight or control the flight of such an aircraft in the ground; or
 - (b) land in the ground without reasonable excuse.

Model aircraft permitted in certain grounds on specified days at specified times

37. Byelaw 36 does not apply to the grounds listed in column 1 of the table in Part 4 of Schedule 2 on the days and times indicated for each ground in column 2 of that table.

Model aircraft permitted in designated areas

- 38. No person shall cause any power-driven model aircraft to:
 - (a) take off or otherwise be released for flight or control the flight of such an aircraft; or
 - (b) land in the ground without reasonable excuse;

other than in a designated area for flying model aircraft.

OTHER REGULATED ACTIVITIES

Provision of services

39. No person shall without the consent of the Council provide or offer to provide any service for which a charge is made.

Excessive noise

- 40. (1) No person shall, after being requested to desist by any other person in the ground, make or permit to be made any noise which is so loud or so continuous or repeated as to give reasonable cause for annoyance to other persons in the ground by:
 - (a) shouting or singing;
 - (b) playing on a musical instrument; or
 - (c) by operating or permitting to be operated any radio, amplifier, tape recorder or similar device.
 - (2) Byelaw 40(1) does not apply to any person holding or taking part in any entertainment held with the consent of the Council.

Public shows and performances

41. No person shall without the consent of the Council hold or take part in any public show or performance.

Kites

42. No person shall fly any kite in such a manner as to cause danger or give reasonable grounds for annoyance to any other person.

Metal detectors

43. No person shall without the consent of the Council use any device designed or adapted for detecting or locating any metal or mineral in the ground.

PART 8

MISCELLANEOUS

Obstruction

- 44. No person shall obstruct:
 - (a) any officer of the Council in the proper execution of his duties;
 - (b) any person carrying out an act which is necessary to the proper execution of any contract with the Council; or
 - (c) any other person in the proper use of the ground.

Savings

- 45. (1) It shall not be an offence under these byelaws for an officer of the Council or any person acting in accordance with a contract with the Council to do anything necessary to the proper execution of his duty.
 - (2) Nothing in or done under these byelaws shall in any respect prejudice or injuriously affect any public right of way through the ground, or the rights of any person acting lawfully by virtue of some estate, right or interest in, over or affecting the ground or any part of the ground.

Removal of offenders

46. Any person offending against any of these byelaws may be removed from the ground by an officer of the Council or a constable.

Penalty

47. Any person offending against any of these byelaws shall be liable on summary conviction to a fine not exceeding level 2 on the standard scale.

Revocation

48. The byelaws made by the London Borough of Hammersmith and Fulham on 20th April 2000 and confirmed by the Secretary of State for the Home Office on 29th June 2000 *r*elating to the ground are hereby revoked.

SCHEDULE 3 RULES FOR PLAYING BALL GAMES IN DESIGNATED AREAS (BYELAW 25).

Any person using a designated area for playing ball games is required by byelaw 25 to comply with the following rules:

- (1) No person shall play any game other than those ball games for which the designated area has been set aside.
- (2) No person shall obstruct any other person who is playing in accordance with these rules.
- (3) Where exclusive use of the designated area has been granted to a person or group of persons by the Council for a specified period, no other person shall play in that area during that period.
- (4) Subject to paragraph (5), where the designated area is already in use by any person, any other person wishing to play in that area must seek their permission to do so.
- (5) Except where they have been granted exclusive use of the designated area for more than two hours by the Council, any person using that area shall vacate it if they have played continuously for two hours or more and any other person wishes to use that area.
- (6) No person shall play in the designated area when a notice has been placed in a conspicuous position by the Council prohibiting play in that area.
