SUMMARY OF DECISION

The Committee has considered an application for the grant of a new premises licence under the Licensing Act 2003 for the sale of alcohol – on the Premises only ("the Application")

In summary, the Committee has decided, after taking into account all of the individual circumstances of this case and the promotion of the four licensing objectives to:

1. Grant the application in part by modifying the proposed hours for the sale of alcohol on the Premises as follows

Monday - Sunday 12:00-21:00 hours

2. The hours the premises will be open to the public will be as follows

Monday - Sunday 0800-22:30 hours

- 3. The licence is subject to any mandatory conditions
- 4. Modify the conditions of the licence as volunteered by the Applicant, the conditions proposed by the Police, as well as those conditions agreed at the hearing.

This licence becomes operational with immediate effect. If problems are experienced, then an application for a review of the premises licence can be made.

A copy of this Committee's full decision including its reasons and the full text of the conditions added to the licence will be sent to the parties forthwith.

If the Applicant is unhappy with the decision, they are entitled to appeal to the magistrates' court within 21 days from the date of notification of the full decision.

SUMMARY OF DECISION

In summary, the Committee has decided, after taking into account all of the individual circumstances of this case and the promotion of the four licensing objectives to:

1. Grant the application as follows

Sale of alcohol – Both On and Off the Premises Monday to Sunday 10:00 - 22:30

Hours open to public:

Monday to Sunday 08:00 - 23:00

- 2. The licence is subject to any mandatory conditions
- 3. To Modify the conditions of the licence volunteered by the Applicant in the operating schedule, by altering or omitting or adding them.
- 4. Add the conditions proposed by the Police, Noise and Nuisance officer and Environmental Health officer as agreed by the Applicant.

This licence becomes operational with immediate effect. If problems are experienced, then an application for a review of the premises licence can be made.

A copy of this Committee's full decision including its reasons and the full text of the conditions added to the licence will be sent to the parties forthwith.

If the Applicant is unhappy with the decision they are entitled to appeal to the magistrates' court within 21 days from the date of notification of the full decision
