1. THE APPLICATION

On 17 May 2022, Mr Farhad Khan Niaz ("the applicant") submitted an application for a new premises licence to be granted in respect of the premises known as Selekt Chicken located at 349 North End Road London SW6 1NN.

1.1 Application Requested

The applicant has applied for a new premises licence for the provision of late night refreshment as outlined below:

The Provision of late night refreshment - Both Indoors and Outdoors

Monday to Sunday 23:00 – 03:00

Hours open to public:

Monday to Sunday 10:00 - 03:00

A copy of the application form and plans can be seen on pages 10-15 of this report.

1.2 Applicants Operating Schedule

The applicant has proposed a number of steps to promote the four licensing objectives if the application is granted. A copy of these steps can be seen on page 13 of this report.

On 20 June 2022, following correspondence received from the Police, the applicant agreed to amend their activity and opening hours as well as add extra conditions to their licence if granted. A copy of this amendment and relevant correspondence can be seen on pages 16-18 of this report. The agreed activity and opening hours are as follows:

On 21 June 2022, the licensing section received one representation from the Licensing Authority objecting to the licence application. However, on 18 July 2022, based on the reduced hours and additional conditions agreed with the Police, the Licensing Authority confirmed that is able to withdraw its representation. A copy of relevant correspondence can be seen on page 19 of this report.

On 21 June 2022, the licensing section received one representation from the Noise and Nuisance Authority objecting to the licence application. However, on 15 July 2022, based on the reduced hours and additional conditions agreed with the Police, the Noise and Nuisance Authority confirmed that is able to withdraw its

representation. A copy of relevant correspondence can be seen on page 20 of this report.

2. BACKGROUND

The main access to the premise's unit will be located on North End Road. There is a mixture of both residential and commercial premises within the area (75m buffer zone). A map showing the location of the premises and neighbouring licensed premises can be seen on pages 21-23 of this report.

There are several options for transport away from the area including buses and taxis which run from in and around the North End Road area. West Kensington tube station is a 10-minute walk away and Fulham Broadway tube station is a 10-minute walk away.

3. CONSULTATION

A public notice was displayed at the premises for 28 days. The application was advertised in a local circular and all statutory consultees were notified as required by the Regulations. The Council has served written notice of hearing upon the applicant and all those parties that have made representations in respect of the application.

3.1. Relevant Representations

The licensing section received one representation from Cllr Ben Coleman objecting to the licence application. A copy of this representation can be seen on page 24 of this report.

The licensing section received one representation from Cllr Trey Campbell-Simon objecting to the licence application. A copy of this representation can be seen on page 25 of this report.

The licensing section received one representation from the Chair of the Fulham Broadway Ward Panel objecting to the licence application. A copy of this representation can be seen on page 26 of this report.

The licensing section received one representation from the Co-Chair of the Fulham Ward Panel objecting to the licence application. A copy of this representation can be seen on page 27 of this report.

The licensing section received one representation from the Barclay Road Neighbourhood Watch objecting to the licence application. A copy of this representation can be seen on pages 28-29 of this report.

The licensing section received 11 representations from local residents objecting to the licence application. A copy of these representations can be seen on pages 30-40 of this report.

On 14 July 2022 the licensing section received further comments from two objectors in response to the agreed hours and conditions between the applicant and the Police. A copy of these comments can be seen on page 41 of this report.

4. OTHER INFORMATION

4.1 Enforcement History

There have not been any warnings, simple cautions or prosecutions given in respect of the premises during the past three years.

4.2 Temporary Event Notices ("TENs")

No TENs have been submitted in respect of this premises in the past twelve months.

5. POLICY CONSIDERATIONS

- **5.1** Section 5.1 page 12 of the Statement of Licensing Policy ("SLP") states that where there is a relevant representation, the Licensing Authority will consider each particular case on its merits having regard in particular to the following matters:
 - Whether the licensed activities are likely to have an adverse impact especially
 on local residents and, if there is potential to have an adverse impact, what, if
 any, appropriate measures will be put in place to prevent it;
 - Whether there will be a substantial increase in the cumulative adverse impact from these or similar activities, on an adjacent residential area;
 - Whether there is a suitable level of public transport accessibility to and from the premises at the appropriate times;
 - Whether the activity will be likely to lead to a harmful and unmanageable increase in car parking demand in surrounding residential streets suffering high levels of parking stress or on roads forming part of the Strategic London Road Network or the London Bus Priority Network leading to a negative impact on the Licensing Objectives relating to the prevention of crime, disorder and nuisance; and
 - Whether there have been any representations made by Responsible Authorities, or other relevant agency or representative.
- **5.2** Section 5.4 page 13 of the SPL states that the Licensing Authority advises applicants that it would be beneficial if a lawful planning use can be demonstrated for the activities proposed in all applications for premises licences.
- 5.3 Section 6.1 page 13 of the SLP states that in determining an application where there has been a relevant representation the Licensing Authority will, where appropriate, take into account the cumulative (collective) effect of the number, type and density of licensed premises already existing in the area. A saturation of licensed premises can attract customers to an area to such a degree that it has an adverse impact on the surrounding area beyond the control of individual licence holders.
- **5.4** Section 6.2 page 13 of the SPL states that in accordance with paragraph 13.30 of the Secretary of State's current Guidance, where the cumulative effect of many licensed premises within an area gives rise to problems of public disorder and nuisance in the surrounding area the Licensing Authority may consider it inappropriate for any further licensed premises to be established in the area or

extension to licensed hours of existing premises to be approved. In such circumstances, an application for a licence for activities which would undermine the promotion of any of the four Licensing Objectives would be refused.

- **5.5** Section 8.1 page 15 of the SLP states that the Licensing Authority will require applicants to detail in their operating schedule the steps proposed to ensure the deterrence and prevention of crime and disorder on, and in the vicinity of, the premises, having regard to their location, character, condition, the nature and extent of the proposed use and the persons likely to use the premises.
- 5.6 Section 9.1 page 17 of the SLP states that the Licensing Authority will require the applicant to detail in their operating plan the steps proposed to ensure the physical safety of people using the relevant premises or place.
- **5.7** Section 10.3 page 19 of the SLP states that the Licensing Authority will particularly consider the following matters where they are material to the individual application:
 - The proximity of residential accommodation;
 - The type of use proposed, including the likely numbers of customers, proposed hours of operation and the frequency of activity;
 - The steps taken or proposed to be taken by the applicant to prevent noise and vibration escaping from the premises, including music, noise from ventilation equipment, and human voices. Such measures may include the installation of soundproofing, air conditioning, acoustic lobbies and sound limitation devices;
 - The steps taken or proposed to be taken by the applicant to prevent disturbance by customers arriving at or leaving the premises. This will usually be of greater importance late at night and/or in the early hours of the morning. However, nuisance can arise at any time of the day or night so the Licensing Authority will consider representations from Responsible Authorities and/or Interested Parties relating to potential nuisance from any activity at all times dependent on the merits of the application/steps taken or proposed to prevent nuisance.
 - The steps taken or proposed to be taken by the applicant to prevent queuing (either by pedestrian or vehicular traffic). If some queuing is inevitable then queues should be diverted away from neighbouring premises or be otherwise managed to prevent disturbance or obstruction;
 - The steps taken or proposed to be taken by the applicant to ensure staff leave the premises quietly;
 - The arrangements made or proposed for parking by patrons, and the effect of parking by patrons on local residents;
 - The provision for public transport in the locality (including taxis and private hire vehicles) for patrons;
 - The level of likely disturbance from associated vehicular and pedestrian movement to and from the premises;
 - The delivery and collection areas and delivery/collection times;
 - The siting of external lighting, including security lighting that is installed inappropriately:
 - The arrangements for refuse disposal, storage and the prevention/tidying of litter (including fly posters and illegal placards);
 - The generation of odour, e.g. from the preparation of food;
 - Any other relevant activity likely to give rise to nuisance;

- **5.8** Section 15.11 pages 30 and 31 of the SLP states that the following provides a non-exhaustive list of risks associated with the public nuisance objective that applicants may want to consider when preparing their Operating Schedule:
 - Deliveries/collections noise from deliveries to and/or collections (e.g. refuse) from the premises are another common source of complaint. Consider the times of such deliveries/collections and make sure you specify to any contractors that deliveries/collections should not be made at antisocial times. As a guide, the Noise and Nuisance Service recommend that deliveries/collections should only be made between the hours of 7:30am and 9:00pm, depending on the proximity of residential and/or other noise-sensitive properties.
 - Late night refreshment applicants in respect of late night takeaways should demonstrate that they have assessed the risk of persons congregating in large numbers in the vicinity of their premises. Where appropriate, applicants should demonstrate suitable measures to address this problem.
 - Light pollution this is an increasingly common source of complaint, particularly from illuminated signs and external security lighting. Where provided, illuminated signs should not cause glare to neighbouring properties, ideally being turned off at night, and external lighting should be angled and/or diffused to also prevent nuisance.
 - External Areas External areas such as gardens can be the source of noise disturbance to surrounding premises. Consider limiting the use of the garden to a reasonable time and number of people.
 - Odour odour from cooking is a common source of complaint, particularly from restaurants and fast-food takeaways. The Council's Noise and Nuisance Service may therefore require evidence that the kitchen ventilation and/or extract systems are regularly maintained and serviced to ensure that it is operating efficiently and with minimal nuisance to neighbours arising from odour and also noise. This includes the siting of BBQs.
 - Queue management establishing appropriate procedures to avoid the need for customers to queue before entering the premises or, where queuing cannot be avoided, to manage queues so as to minimise the potential for crime and disorder or public nuisance by customers who are queuing.
 - Waste consider how and where waste will be stored/disposed of at the end
 of trading hours, particularly if trading until late at night. This is important
 because the disposal of glass and/or cans to outside bin areas can be very
 noisy and give rise to complaints, so it may be necessary to store such items
 and other non-degradable refuse inside the premises until the next trading
 day. Consideration should also be given to the time of deliveries to minimize
 disruption to local residents.
 - Litter for example, litter patrols for late night take-away premises

6. DETERMINATION

- **6.1** In determining this application, the Committee must have regard to the representations and take such of the following steps as it considers necessary for the promotion of the licensing objectives. The steps are:
- (a) Grant the application in full

- (b) Grant the application in part modifying the proposed hours, activities or conditions.
- (c) Reject the application.

It is the Council's duty under the Licensing Act 2003 ("The Act") to determine applications with a view to promoting the four licensing objectives; Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance and the Protection of Children from Harm.

In reaching a decision the Council shall consider the details of any relevant representations received; the applicant's Operating Schedule; the Council's adopted Statement of Licensing Policy and the guidance issued by the Secretary of State under section 182 of the Act.

If the Committee is minded to grant the application, conditions may be attached to the licence to alleviate the concerns raised through any representation(s).





Good Afternoon Farhad,

It was good to speak to you just now and discuss your application and the concerns that the Police have.

As I stated, the Police would not object to the following timings:-

The Provision of late night refreshment - Both Indoors and Outdoors Sundays-Wednesdays inclusive between the hours of 23:00 to 00:00 Thursdays-Saturdays inclusive between the hours of 23:00-01:00

Hours Open to the Public:

Sundays to Wednesdays between the hours of 10:00 to 00:00 Thursdays to Saturdays between the hours of 10:00-01:00.

As I mentioned, several conditions are required to be placed on the premises licence to ensure that the premises operates responsibly and promotes the licensing objectives. I recommend the following conditions also be added to the premises licence:-

1. High Definition CCTV shall be installed, operated and maintained, at all times that the premises are open for licensable activities and;

- shall be checked every two weeks to ensure that the system is working properly
 and that the date and time are correct. A record of these checks, showing the
 date and name of the person checking, shall be kept and made available to
 Police or authorised Council officers on request
- one camera will show a close-up of the entrance to the premises, to capture a clear, full length image of anyone entering.
- shall cover any internal or external area of the premises where licensable activities take place.

- recordings shall be in real time and stored for a minimum period of 31 days with date and time stamping.
- footage shall be provided free of charge to Police or authorised council officer within 24 hours of a request.
- a staff member from the premises that is conversant with the operation of the CCTV system shall be on the premises at all times. This staff member will be able to show police or authorised officers of the Licensing Authority recent data footage with the minimum of delay when requested. This data or footage reproduction shall be almost instantaneous
- 2.Appropriate signage shall be displayed in prominent positions, informing customers they are being recorded on CCTV
- 3. Signs shall be prominently displayed in the outside area reminding patrons that there are residents living nearby and instructing them to respect neighbours and to conduct their behaviour accordingly.
- 4. Notices shall be prominently displayed at all exits used by delivery drivers requesting them to respect the needs of local residents and leave the area quietly
- 5. After 23:00, drivers shall wait inside the premises between deliveries/for deliveries
- 6.Delivery drivers/riders will be given clear, written instructions to use their vehicles in a responsible manner so as to not cause nuisance to any residents or generally outside the licensed premises; not to leave engines running when the vehicle is parked; and not to obstruct the highway. The licence holder will positively encourage delivery drivers/riders to use quieter vehicles that are less likely to cause a nuisance such as bicycles



It has come to our attention that this company has been flouting the law by providing refreshments without a licence after 11pm. Therefore the Licencing Committee should be circumspect about rubber stamping the application.

I was unable to submit this online, so, I write on behalf of residents in our Council-registered Barclay Road Neighbourhood Watch (NHW), SW6 1EJ and SW6 1EH, this also includes our very active WhatsApp NHW ALERTS group of 81 households and individuals who are very concerned about this application, for two reasons; one for keeping North End Road open beyond midnight when more crime and disorder is unfortunately inevitable in this big city on a main A road with a lot of outlets, and two for the inevitable motorbike noise of deliveries and zooming even on Fulham Road late at night when there is less traffic and no enforcement of speed limits. It makes it difficult to sleep in this big city and it leads to altercations, between delivery drivers and motorists/bicyclist and pedestrians.

Operating illegally:

Residents are VERY concerned that 349 North End Road is operating and has been operating for some time until midnight, without a license to sell indoors and outdoors' Late Night Refreshment'.

We respectfully ask the Licensing Sub-Committee to consider, why reward a shop/Premises that has been operating illegally?

Would it not be better for them to take the Licensing Authority and Met Police advice to shut at 23:00 and prove that they have done this for some time, before granting them hours for what is, in simple terms, illegal, and bad behaviour? I am attaching/sending to the Licensing officer a screen grab of a Deliveroo App order; one can see that orders can be taken until 23:45 and that the order will be delivered within 25 minutes. This in itself raises a few questions about whether they really close at midnight.

North End Road regeneration LBHF scheme:

We give high praise to Leader Cowan and LBHF for the vast improvements underway now in North End road (grants of £1.2 million received and further money spent by the Council), for better access for market stall holders, traffic calming methods, parking pushed off North End Road, loading bays created on side roads for deliveries in North End Road etc.

What we also notice is that the plan for North End Road improvements is all about the daytime economy. The night time economy is not mentioned at all in the close to £2 million scheme, and for good reasons. There are no plans for North End Road to turn into a night time economy.

McDonalds closes at midnight due to planning restrictions regarding amenity of the many residences above the shops of North End Road (especially from Lillie Road down to Fulham Road) and residences on side roads up and down this same part of what we call here 'lower' North End Road.

We are very concerned about the licensing objective, The Prevention of Crime and Disorder. Beyond this chicken shop operating illegally ie without a proper license but open till at least midnight...we bring to the Committee's attention the following

Crime on the rise again:

The recent statistics included in the Draft Licensing Policy Consultation (closes 24 June on haveyoursay website) show that crime is again on the rise in North End Road, and the neighboring Fulham Broadway core area/zone after a hiatus due to COVID closures/restrictions.

More noise and nuisance

ie disorder, public safety (Licensing Objectives) at risk in and around the Premises applying for this License.

A licence until 3am could add to the ongoing problems in North End Road at late night hours. 349 North End Road is in close proximity to residential properties, with several directly above as well as across the road and so would harm the amenities of these properties as a result of noise and disturbance, particularly late at night, generated by customers and delivery drivers entering and leaving both the Premises itself and neighboring residential side streets where customers are likely to park their vehicles and delivery drivers tend to congregate.

In conclusion,

Post COVID, crime in North End Road is rising, unfortunately, not only during the day but also at night; more delivery drivers causing altercations with vehicles and bicycles, cycle altercations, problems at McDonalds (open till midnight) including robberies witnessed by families with children are becoming too common at McDonalds and at the various food outlets on North End Road, again. Residents on the NextDoor app report these unfortunate incidences, specifically in North End Road Premises, all too regularly.

The Council is making great strides in improving North End Road during daytime hours through traffic calming measures such as 'parklets', wider pedestrian pavements and improved facilities for market traders; the emphasis of these North End Road improvements is solely on daytime activity. The nighttime economy is not at all addressed in the Council's plans for North End Road, most likely because no one envisions North End Road becoming an all-night destination. Although Planning is a separate matter, all planning decisions on North End road include specific mention of amenity, noise, nuisance, proximity to residential properties and likelihood of harming the amenities of those properties as a result of noise and disturbance, particularly late at night.

A "Premises' in the new Delivery Economy is being extended from what was a counter where food was served and paid for directly/at the same time, to a collection counter where food is dispatched and the Premises elongates itself to the front door of the person who ordered the food. Until the handover, the sale is not complete. We fully appreciate that the Licensing Committee and its Sub-Committee is now grappling with the reality of this very real situation; the Premises now extends itself through residential roads, causing all kinds of problems, especially late at night.


Were the Lic Sub-Comittee minded to grant a new License at this time, which we hope it is not, we ask for it to be for no later than 12 midnight. A general stop at 23:00 and sometimes, perhaps at midnight for North End Road will lead to less crime and disorder and a better handle on Public Safety overall, 2 of the four most important licensing objectives in this context of this specific application. The Police do not have the resources to patrol this area; thus, the lack of any oversight, bar when things become so bad that someone rings 999, calls for clear and concise hours that help to self-regulate things in North End Road, at least this portion of it south of Lillie Road down to Fulham Road/roundabout.

As a local resident of over 20 years I am and have become increasingly concerned about the balance between reasonable commercial interests and the rights of residents in these matters. The North End Road (NER) is surrounded by roads that are a fully residential and indeed the NER is itself only semi-commercial. Late night disturbances are becoming and have increasingly been an every encroaching issue especially during the sensitive hours when families including our young children are tying and need to sleep.

Licensing Objective Prevention of Crime and Disorder: From what I have witnessed, Selekt Chicken 349 NER is already trading illegally, without any license at all to serve 'Late Night refreshment' after 23:00. Their hours have been until midnight, as shown on Google maps until 3 days ago, and Deliveroo is still offering orders from this shop until 23:45. This is illegal and illustrates a complete disregard for playing by the existing rules. What conditions (see my comments in the next paragraph) are there to ensure that LBHF will enforce against this and why should we trust an operator who already ignores the law?

Why reward a Premise/site that has not been upholding the law by granting them a licence for 3am? It makes total sense for the Premises to show that they can work within the law for at least a year or more and then apply for a licence for one hour after 23:00?

Post COVID, crime in NER is rising, unfortunately, not only during the day but also at night; more delivery drivers causing altercations with vehicles and bicycles, cycle altercations, problems at McDonalds (open till midnight) including robberies witnessed by families with children are becoming too common, again. Residents on the NextDoor app report these unfortunate incidences, specifically in NER Premises, regularly. We constantly struggle against bicycle and noisy moped dispatch riders racing at over the speed limit on our street, riding on the pavements, congregating late at night on our residential road, blocking pavements, dropping litter, urinating etc.

A licence until 3am could add to the ongoing problems in North End Road at late night hours. 349 North End Road is in very close proximity to residential properties, with several directly above as well as across the road and so would harm the amenities of these properties as a result of noise and disturbance, particularly late at night, generated by customers and delivery drivers entering and leaving both the Premises itself and neighbouring residential side streets where customers are likely to park their vehicles

and delivery drivers tend to congregate. What good to the local community does the sale of alcohol post-midnight possibly do?

We have also seen instances where younger people are being sold alcohol and have had regular problems at night with them running and screaming down our road, hitting our cars, smashing glass bottles of alcohol, littering outside our houses etc.

The Council with the full support of residents is making huge and welcome improvements to the NER during daytime hours through traffic calming measures such as 'parklets', wider pedestrian pavements and improved facilities for market traders.

All of this is at a very significant cost no doubt partly funded by the Council Tax bills we pay. The aim of these NER improvements is solely on daytime activity. The night-time economy is not at all addressed in the Council's plans for NER, most likely because no one at the Council appears to be considering the NER, from Fulham Road up to Lillie Road, becoming a 'late night' or even all-night destination. For us the positive steps made to boost business during the daytime must be balanced with respect for residents' concerns and their living space at night. It cannot and should not be all one-way. The deal was always put to us as one to attract more people to the NER and the market during the day six days a week but respecting the needs and rights of families (who after all will shop and spend more time and money using the NER facilities if they are implemented responsibly).

If the Licencing Sub-Committee is minded to grant a License at this time, we ask for it to be for no later than 12 midnight.
