Following the agreement with the Police, further comments were received from the objectors. A copy of these comments can be seen on pages 34-41 of this report.

#### 2. BACKGROUND

The main access to the premise's unit is located on Fulham Road. There is a mixture of both residential and commercial premises within the area. A map showing the location of the premises and neighbouring licensed premises can be seen on pages 42-45 of this report.

There are several options for transport away from the area including buses and taxis which run from in and around the Fulham Road area. Fulham Broadway tube station is a 4-minute walk away and Parson's Green tube station is an 8-minute walk away.

#### 3. CONSULTATION

A public notice was displayed at the premises for 28 days. The application was advertised in a local circular and all statutory consultees were notified as required by the Regulations. The Council has served written notice of hearing upon the applicant and all those parties that have made representations in respect of the application.

#### 3.1 Relevant Representations

The licensing section received one representation from the Noise and Nuisance Authority objecting to the licence variation application. A copy of this representation can be seen on page 46 of this report.

The licensing section received one representation from the Barclay Road Conservation

Area Neighbourhood Watch objecting to the licence variation application. A copy of this representation can be seen on pages 47-50 of this report.

The licensing section received 19 representations from local residents objecting to the licence variation application. A copy of these representations can be seen on pages 51-63 of this report.

On 27 July 2022 the applicant's licensing solicitor requested for a letter to be forwarded to the Noise and Nuisance Authority as well as the objectors. A copy of this letter and further responses can be seen on pages 64-68 of this report.

#### 4. OTHER INFORMATION

#### 4.1 Enforcement History

There have not been any warnings, simple cautions or prosecutions given in respect of the premises during the past three years.

#### 4.2 Temporary Event Notices ("TENs")

No TENs have been submitted in respect of this premises in the past twelve months.

#### 5. POLICY CONSIDERATIONS

- **5.1** Section 5 pages 12 and 13 of the Statement of Licensing Policy ("SLP") states that in order to ensure the promotion of the four Licensing Objectives the Licensing Authority will require applicants to detail in their operating schedule:
  - the steps proposed to promote the licensing objective of the prevention of crime and disorder on, and in the vicinity of, the premises, having regard to their location, character, condition, the nature and extent of the proposed use and the persons likely to use the premises;
  - the steps proposed to ensure the physical safety of people using the relevant premises or place;
  - how they intend to prevent nuisance arising, prevent disturbance and protect amenity so far as is appropriate to ensure that the Licensing Objectives are met. Where there is a relevant representation regarding extended hours, the Licensing Authority will not permit an extension unless it is satisfied that the Licensing Objectives would be met;
  - the measures and management controls in place to protect children from harm. Where appropriate a written childcare policy should be available and be incorporated in the induction of staff.
- **5.2** Policy 3 page 21 of the SLP states that where there is a relevant representation, the Licensing Authority will consider each particular case on its merits having regard in particular to the following matters:
- a) Whether the licensed activities are likely to have an adverse impact especially on local residents and, if there is potential to have an adverse impact, what, if any, appropriate measures will be put in place to prevent it;
- b) Whether there will be a substantial increase in the cumulative adverse impact from these or similar activities, on an adjacent residential area;
- c) Whether there is a suitable level of public transport accessibility to and from the premises at the appropriate times;
- d) Whether the activity will be likely to lead to a harmful and unmanageable increase in car parking demand in surrounding residential streets suffering high levels of parking stress or on roads forming part of the Strategic London Road Network or the London Bus Priority Network leading to a negative impact on the Licensing Objectives relating to the prevention of crime, disorder, anti-social behaviour (ASB), nuisance and vehicle emissions:
- e) Whether there have been any representations made by Responsible Authorities, or other relevant agency or representative.

The Licensing Authority will closely scrutinise extended hours applications to ensure that the Licensing Objectives are met. In determining an application the licensing committee might decide that the circumstances are such that a restriction on hours is the only appropriate means to achieve the Licensing Objectives. If an 'hours' restriction is imposed, the Licensing Authority will normally require that customers should be allowed a minimum of thirty minutes to consume alcohol.

To act as a guide for new or existing operators we have set out the suggested closing times for licensed premises below:

5.3 Policy 4 pages 22 and 23 of the SLP states that in determining an application where there has been a relevant representation the Licensing Authority will, where appropriate, take into account the cumulative effect of the number, type and density of licensed premises already existing in the area. Consideration will be given to the proximity to any drug and alcohol treatment site, A&E department or homeless hostel in a local area type remit ie applicants need to make the case for how they would not increase further problems for residents/clients nearby.

In coming to any decision regarding cumulative impact the Licensing Authority will consider other mechanisms outside of the licensing regime which may also be available to address this issue, these include but are not limited to:

- Police and other enforcement of the normal law concerning disorder and antisocial behaviour.
- Police powers to close down instantly any licensed premises or temporary events on grounds of disorder, the likelihood of disorder or excessive noise emanating from the premises, for up to 24 hours.
- The power of the police, other responsible authorities, a local resident, business or Councillor to seek a review of the licence or certificate in question.
- Police and Local Authority power to issue a Closure Notice for up to 48 hours where serious antisocial behaviour is taking place at licensed premises under the Anti-social Behaviour, Crime and Policing Act 2014.
- To ensure that residents are protected from the negative impact of late-night local licensing activities the Licensing Authority may decide to adopt an Area Specific Cumulative Impact Policy in relation to a specific area; where the number, type and density of premises providing licensable activities is having a serious negative impact on the local community and local amenities.
- **5.4** Policy 11 page 30 of the SLP states that population densities in this borough are high, with many residential premises located above or in close proximity to licensed premises. This means that the public nuisance and crime and disorder objectives will be of paramount concern when evaluating Operating Schedules. Licensing Committees will place high regard on the control measures put in place by the applicant to ensure that our residents are protected from the potential detrimental effects of any licensed premises.

- **5.5** Policy 14 page 32 of the SLP states that in relation to delivery services, although these types of services are not provided for in the Licensing Act 2003 or in the s182 guidance in any way differently from other licensed premises they do provide their own unique circumstances that need to be addressed. In particular the Licensing Authority has concerns with the potential for the following:
  - The safety of delivery drivers at the point of delivery;
  - Safety of the premises from which orders are taken and sent out for deliver; and,
  - Possible public nuisance and anti-social behaviour (ASB) caused by delivery drivers collecting deliveries from the licensed premises.
- **5.6** Annex 1 pages 35 and 36 of the SLP in relation to the prevention of crime and disorder states licence applicants will be expected to demonstrate the following in their operating schedules:
  - g) Conditions will, so far as possible, reflect local crime prevention strategies, and the Licensing Authority will also have regard to the views of the local Crime and Disorder Reduction Partnership.
  - h) Crime and disorder in the vicinity of the premises: this may include the crime and disorder risks arising from persons queuing to enter the premises; persons exiting the premises and customers smoking eating or drinking in outdoor areas and on the highway outside the premises. This can also include crime arising from pickpockets and bag snatchers, particularly in open spaces or crowded areas where alcohol is being consumed.
  - j) CCTV using CCTV inside and/or outside the premises together with appropriate procedures and having staff properly trained to use CCTV equipment.
  - k) dispersal procedures establishing appropriate dispersal procedures to minimise the potential for crime and disorder when customers are leaving the premises.
  - p) local schemes joining and attending local Pubwatch meetings and participating in the Behave or Be Banned Scheme (BOBB) and/or signing up and using the Council's Safety Net Radio scheme.
- **5.7** Annex 1 pages 38 to 40 of the SLP in relation to the prevention of public nuisance states that the Licensing Authority will particularly consider the following matters where they are material to the individual application:
- ii. The proximity of residential accommodation;
- iii. The type of use proposed, including the likely numbers of customers, proposed hours of operation and the frequency of activity;
- iv. The steps taken or proposed to be taken by the applicant to prevent noise and vibration escaping from the premises, including music, noise from ventilation equipment, and human voices. Such measures may include the installation of soundproofing, air conditioning, acoustic lobbies and sound limitation devices;
- v. The steps taken or proposed to be taken by the applicant to prevent disturbance by customers arriving at or leaving the premises.
- viii. The steps taken or proposed to be taken by the applicant to prevent queuing (either by pedestrian or vehicular traffic). If some queuing is inevitable then queues should be diverted away from neighbouring premises or be otherwise managed to prevent disturbance or obstruction;

- ix. The steps taken or proposed to be taken by the applicant to ensure staff leave the premises quietly;
- x. The arrangements made or proposed for parking by patrons, and the effect of parking by patrons on local residents;
- xi. The provision for public transport in the locality (including taxis and private hire vehicles) for patrons;
- xii. The level of likely disturbance from associated vehicular and pedestrian movement to and from the premises;
- xiii. The delivery and collection areas and delivery/collection times;
- xv. The arrangements for refuse disposal, storage and the prevention/tidying of litter (including fly posters and illegal placards);
- xviii. The generation of odour, e.g. from the preparation of food;
- xix. Any other relevant activity likely to give rise to nuisance;
- xx. Any representations made by the Police, or other relevant agency or representative;

The following provides a non-exhaustive list of risks associated with the public nuisance objective that applicants may want to consider when preparing their Operating Schedule:

- j) **Deliveries/collections** noise from deliveries to and/or collections (e.g. refuse) from the premises are another common source of complaint. Consider the times of such deliveries/collections and make sure you specify to any contractors that deliveries/collections should not be made at anti-social times. As a guide, the Noise and Nuisance Service recommend that deliveries/collections should only be made between the hours of 7:30am and 9:00pm, depending on the proximity of residential and/or other noise sensitive properties.
- k) Late night refreshment applicants in respect of late night takeaways should demonstrate that they have assessed the risk of persons congregating in large numbers in the vicinity of their premises. Where appropriate, applicants should demonstrate suitable measures to address this problem.
- l) **Light pollution** this is an increasingly common source of complaint, particularly from illuminated signs and external security lighting. Where provided, illuminated signs should not cause glare to neighbouring properties, ideally being turned off at night, and external lighting should be angled and/or diffused to also prevent nuisance.
- m)Noise and/or vibration breakout from the provision of regulated entertainment, particularly from (but not limited to) live music consider what type of entertainment is to be provided, in what room/area of the premises and the suitability of the construction of this room/area to contain sound. Windows are a particular weak-point for noise break-out so consider providing regulated entertainment in a room without windows or with as few windows as possible, particularly windows that face towards nearby 40 residential properties. Where suitable, install a lobby to prevent spillage of noise each time an entrance/exit door is opened.
- o) **Odour** odour from cooking is a common source of complaint, particularly from restaurants and fastfood takeaways. The Council's Noise and Nuisance Service may therefore require evidence that the kitchen ventilation and/or extract systems are regularly maintained and serviced to ensure that it is operating efficiently and with minimal nuisance to neighbours arising from odour and also noise. This includes the siting of BBQs.
- p) Queue management establishing appropriate procedures to avoid the need for customers to queue before entering the premises or, where queuing cannot be

avoided, to manage queues so as to minimise the potential for crime and disorder or public nuisance by customers who are queuing.

- q) **Ventilation** where regulated entertainment is to be provided there may be a requirement to keep doors and/or windows closed during its provision to limit noise breakout, consider therefore the provision of air conditioning for the comfort of your customers if doors and windows have to be closed during the summer. However, also note air conditioning can be the source of noise complaints in itself, so careful consideration also needs to be given to the siting of this equipment.
- r) **Waste** consider how and where waste will be stored/disposed of at the end of trading hours, particularly if trading until late at night. This is important because the disposal of glass and/or cans to outside bin areas can be very noisy and give rise to complaints, so it may be necessary to store such items and other non-degradable refuse inside the premises until the next trading day. Consideration should also be given to the time of deliveries to minimize disruption to local residents.
- s) Litter for example, litter patrols for late night take-away premises

#### 6. DETERMINATION

- **6.1** In determining this application, the Committee must have regard to the representations and take such of the following steps as it considers necessary for the promotion of the licensing objectives. The steps are:
- (a) Grant the application in full
- (b) Grant the application in part modifying the proposed hours, activities or conditions.
- (c) Reject the application

It is the Council's duty under the Licensing Act 2003 ("The Act") to determine applications with a view to promoting the four licensing objectives; Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance and the Protection of Children from Harm.

In reaching a decision the Council shall consider the details of any relevant representations received; the applicant's Operating Schedule; the Council's adopted Statement of Licensing Policy and the guidance issued by the Secretary of State under section 182 of the Act.

If the Committee is minded to grant the application conditions may be attached to the licence to alleviate the concerns raised through the representations.



#### Annex 2 - Conditions consistent with the operating Schedule

- 1. Signs shall be prominently displayed at the exit from the premises reminding patrons there are residents living nearby and instructing them to respect the neighbours and leave the premises promptly and quietly.
- 2. Signs shall be prominently displayed at the exit from the premises asking patrons to dispose of their waste in litter bins.
- 3. Deliveries and collections (including refuse collections) associated with the premises shall be arranged between the hours of 08:00 to 20:00 only.
- 4. Patrols of the area outside the premises shall be undertaken at regular intervals during the use of the licence and any litter accumulations cleared. A book shall be kept at the premises to record all details of the patrols. The book shall contain the name of the member of staff who carried out the patrol and the time of the patrol.

- 5. All plant and equipment shall be correctly maintained and regularly serviced to ensure that they are operating correctly and efficiently so as not to cause a nuisance to neighbours arising from noise and odour.
- 6. All ventilation and extraction systems shall be correctly maintained and regularly serviced to ensure that they are operating correctly and efficiently so as not to cause a nuisance to neighbours arising from noise and odour.
- 7. High Definition CCTV shall be installed, operated and maintained, at all times that the premises are open for licensable activities or customers are on the premises and; o shall be checked every two weeks to ensure that the system is working properly and that the date and time are correct. A record of these checks, showing the date and name of the person checking, shall be kept and made available to Police or authorised Council officers on request
- o at least one camera will show a close-up of the entrance/entrances to the premises, to capture a clear, full length image of anyone entering.
- o shall cover any internal or external area of the premises where licensable activities take place.
- o recordings shall be in real time and stored for a minimum period of 31 days with date and time stamping.
- o footage shall be provided free of charge to Police or authorised council officer within 24 hours of a request.
- o a staff member from the premises that is conversant with the operation of the CCTV system shall be on the premises at all times. This staff member will be able to show police or authorised officers of the Licensing Authority recent data footage with the minimum of delay when requested. This data or footage reproduction shall be almost instantaneous.
- 8. Appropriate signage shall be displayed in prominent positions, informing customers they are being recorded on CCTV.
- 9. A daily incident log (electric or paper based) shall be kept at the Premises and made available on request to an authorised officer of the Council or the Police or the Fire Service which shall record the following:
- (a) all crimes reported to the venue
- (b) all ejection of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) seizures of drugs or offensive weapons
- (f) any faults in the CCTV system
- (g) any visit by a relevant authority or emergency service



It was really nice Teams meeting you last week to discuss the above application.

Many thanks for agreeing to the timings that we have proposed. Regarding the possibility for deliveries, the concern of the Police is predominantly the location of this premises. As discussed, the area of Fulham Broadway and the vicinity suffers with a high level of anti-social behaviour and criminal activity, specifically in the early hours.

We have had incidents at similar premises (along the North End Road) that have been closed to patrons and just operating for deliveries, where irate customers have forced their way into a premises, resulting in the Police being called. I am of the opinion that it is difficult to manage a premises in a location such as this when considering deliveries only.

I would strongly recommend that deliveries are not applied for at this stage and of course this could be reviewed in the future.

By way of background, there has also been significant interest in this application from Local Residents who have expressed their concerns about the late hours applied for. They have also expressed concerns about the possibility of delivery riders congregating in the vicinity of the premises and causing a noise and nuisance issue. 

This shop is in the Fulham Broadway Cumulative Impact Zone, evidence for which has been gathered and continues to be gathered by Responsible Authorities. Unfortunately, crime is rising, ASB is rising and new developments mean more people are out and about searching for a find 'legal' nitrous oxide canisters and glue/silicon/'high' oder dispensers that are being used by groups inside cars that are starting to park in residential roads. 4 or 5 people in a car, shooting off these noxious oders inside a car(where they accumulate and create lack of oxygen) is leading to howling and screeching for not just minutes but hours. As evidence to my initial Representation against 2022/00806/LAPR 607 Fulham Road I would like the Lic Committee to be aware of this Met Police 'WANTED' poster of 17 June 2022, referring to a man who used a knife to stab the shop employee/(one of the owners) at 605 Fulham Road, the Cashcounts shop next to the Applicant of Piri Chicken, 607 Fulham Road. One JPEG attached.

This is the kind of crime that goes on around this Premises applying for a 3am and 4am licence to serve hot food/Peri Chicken. When I spoke in person with the owner for about twenty minutes, in his shop, he told me about all the crime problems that he witnesses right outside his big windowed shop. So far, he had not had much trouble inside, he volunteered. I asked him if he rings 999 when he sees or experienced problems. He told me he does not but that he just received a '5' food rating. I asked him about the Borough's 5-year Licensing Policy and how his Application fit in with that Policy, and he mentioned his food safety rating again. We agreed it was really excellent and not easy to achieve.

I asked him if he had spoken to the Police about his Application. He said no that he does not talk to the police.

We chatted about the area and where I live, on Barclay Road. He volunteered to me he knows there are too many drug dealers on the corner (of Fulham Road at Barclay Road).

The owner told me on his own, without me asking him, that he did not know that the Council, as he put it, 'interviews residents about applications'... he said he thought, 'that they ask other businesses about licensing applications.'

He offered me chicken, but I politely said no thank you.

He then told me that Deliveroo drivers are stealing his food, especially when two rice sides are in one delivery bag. He has had to install a further internal cctv to prove to Deliveroo that drivers are stealing. He explained in detail how these culprits operate. I suggested he report it every night to the police for two weeks straight and write down the CAD numbers, which I explained and why they were important to write down/collect.

I suggested to him that longer hours would add to more stealing and crime, public safety and nuisance right in front of his shop and I wondered about the risks inside for him with no police patrolling the area. I told him I knew the good mini-cab guys at 603 Fulham Road keep an eye out for everyone along this stretch of five late night shops, and he agreed. They all have each other's mobile numbers.

He said he needs the money and for that reason he asked me to support his application, for his family, he suggested. I commended to him the LBHF Licensing Policy and told him I'd stop by again but I suggested, as I got up to leave, that he consider withdrawing his application. He asked me to return for some chicken, with rice.



Having lived here 19 years, this is one of the most outrageous applications I have ever seen to vary a license for a restaurant. Are we serious that this chicken shop wants to take it's hours from 00:00 midnight on Sun-Thurs to 03:00??!! And even worse, until 04:00 on Fri and Sat??!! So this is 7 days a week, right around the corner from the residential Barclay Rd Conservation Area?? This means our crucial sleeping hours (midnight to 06:00 minimum) would likely be smashed to pieces every night!! Most of us eat dinner at say 6-9pm so who exactly needs a meal between midnight and 03:00/04:00? Who are they appealing to? No doubt drunk people coming out of pubs and clubs! We do not need a watering hole that would encourage noise, nuisance and a place to congregate at hours that are literally cutting the middle of the night in two. People who are doing drugs would also want to eat late and people with criminal intent, such as pickpockets would hang around there too. Of key concern are customers leaving the chicken shop and stumbling around the corner to Barclay Rd, Effie Rd and Effie Place. The key local bars here are Redback - closes at 01:30 all week, Broadway Bar and Grill - closes at midnight all week at and 1am on Fri/Sat and McGettigans - closes 23:00 all week and 01:00 Fri/Sat. Therefore, going to 03:00 and 04:00 on Fri/Sat does not match these times and is excessively long for no apparent reason. When I recently did a 12 hour Police ride along, we visited McDonalds on Shepherds Bush and the police said their Sat 24 hour license was nightmare as it attracts trouble and crime on a weekly basis. We do not want Peri Peri Chicken to emulate these problems so they should be restricted to the current license hours or a possible small extension to 01:00 to match the bar hours. I spoke to the manager Mohammed Shabbir who said times had been tough recently and they had to do everything possible to survive. However, this doesn't mean daily sales throughout the early morning hours! I said they need to focus on normal hours and maximise those. He suggested a compromise but this was 02:00 which local residents still feel is too late. There would also have to be many license conditions attached that would cover security staff, CCTV, noise issues, littering, seating in store vs takeaway etc. Altogether, this application is awful and not a good addition to Fulham Broadway as it seeks to destroy the peace in the neighbourhood at outrageous hours. There was a licensing committee hearing this week for Selekt Chicken at 349 North End Rd to extend their hours. The details and documents are in the link below along with the YouTube recording. After more than one hour of deliberation, the application was rightfully declined. Of note, Deputy Leader of LBHF provided a representation to decline the application in support of local residents. The bottom line was that despite the good intentions of the applicant, they could not provide sufficient answers and mitigants to the increased risks, negative impacts, noise and nuisance to locals. The hours proposed by Selekt were to a maximum of 01:00 from Thurs-Sat.

Peri Peri Chicken wants to extend their hours to 03:00 from Sun-Thurs and 04:00 on Fri & Sat. After initial resistance, they cut this back to 02:00. This is a few yards from the largely residential Barclay Rd Conservation Area - Barclay Rd, Effie Rd, and Effie Place. This application is subject to the same arguments and logic applied on 27th July with Selekt Chicken.

The letter sent by the applicant fails to mention that several local bars, including Redback opposite them, serve alcohol so many of Peri Peri Chicken's customers could be highly intoxicated in their restaurant. While Peri Peri doesn't serve alcohol, their late-night customers would likely be drunk and make a lot of noise and nuisance for locals, especially after leaving the premises. The food delivery apps would also ensure many delivery drivers would be outside waiting for orders and their motorbikes add to the late night noise footprint. Again, these are all the same issues we already discussed at the Selekt hearing.
