1. THE APPLICATION

On 27 June 2022, Mr Shakeeb Ayash (“the applicant”) submitted an application to vary the premises licence in respect of the premises known as Ringo Pizza, located at 40 Fulham Palace Road London W6 9PH.

1.1 Current Hours of Operation

The premises currently benefit from a premises licence. The current premises licence permits the following:

1.2 Application Requested

The applicant has applied to vary the indoor hours for the provision of late night refreshment in addition to the opening hours of the premises. As a result of these proposed changes the licensee wishes to remove condition 6 from the premises licence. The proposed days and times are as follows:

Condition 6 applied to be removed:

The supply of Late night refreshment after 02:00 hours shall only be by means of delivery to a residential or business address.

No other changes to the permitted hours, activities or conditions are sought.

A copy of the application form can be seen on pages 22-41 of this report.

1.3 Applicants Operating Schedule

The applicant has proposed a number of steps to promote the four licensing objectives if the application is granted. A copy of these steps can be seen on pages 37-38 of this report.

On 19 July 2022, following correspondence received from the Police, the applicant agreed to keep the hours currently shown on the Premises Licence and amend condition 6 instead of removing it as well as add the following conditions:

6. The supply of late night refreshment after 02:00hrs shall be by delivery or take away service only.

7. All deliveries shall be made to bona fide business and residential addresses only.

8. Signs shall be displayed informing customers that the provision of late night refreshment shall be provided by delivery or take away service only after 02:00hrs.

2. BACKGROUND

The main access to the premise's unit is located on Fulham Palace Road. There is a mixture of both residential and commercial premises within the area. A map showing the location of the premises and neighbouring licensed premises can be seen on pages 45-47 of this report.

There are several options for transport away from the area including buses and taxis which run from in and around the Fulham Palace Road area. Hammersmith and City tube station is a 2-minute walk away and Baron's Court tube station is an 11-minute walk away.

3. CONSULTATION

A public notice was displayed at the premises for 28 days. The application was advertised in a local circular and all statutory consultees were notified as required by the Regulations. The Council has served written notice of hearing upon the applicant and all those parties that have made representations in respect of the application.

3.1. Relevant Representations

The licensing section received two representations from local residents objecting to the licence variation application. A copy of these representations can be seen on pages 48-50 of this report.

On 28 July 2022 the applicant's licensing solicitor requested for a letter to be forwarded to the objectors. A copy of this letter can be seen on pages 51-53 of this report.

4. OTHER INFORMATION

4.1 Enforcement History

Warning letters have previously been issued to the licence holder in response to unauthorised late night refreshment witnessed at the premises on the 6th and 21st November 2020 and 11th March 2021 by the Police and the Council's Noise and Nuisance team. However, after reviewing this case in more detail, it appears that these letters were issued in error and should have been issued to 38 Fulham Palace Road.

4.2 Temporary Event Notices ("TENs")

No TENs have been submitted in respect of this premises in the past twelve months.

5. POLICY CONSIDERATIONS

5.1 Section 5 pages 12 and 13 of the Statement of Licensing Policy ("SLP") states that in order to ensure the promotion of the four Licensing Objectives the Licensing Authority will require applicants to detail in their operating schedule:

- the steps proposed to promote the licensing objective of the prevention of crime and disorder on, and in the vicinity of, the premises, having regard to their location, character, condition, the nature and extent of the proposed use and the persons likely to use the premises;
- the steps proposed to ensure the physical safety of people using the relevant premises or place;
- how they intend to prevent nuisance arising, prevent disturbance and protect amenity so far as is appropriate to ensure that the Licensing Objectives are met. Where there is a relevant representation regarding extended hours, the Licensing Authority will not permit an extension unless it is satisfied that the Licensing Objectives would be met;

- the measures and management controls in place to protect children from harm. Where appropriate a written childcare policy should be available and be incorporated in the induction of staff.

5.2 Policy 3 page 21 of the SLP states that where there is a relevant representation, the Licensing Authority will consider each particular case on its merits having regard in particular to the following matters:

- Whether the licensed activities are likely to have an adverse impact especially on local residents and, if there is potential to have an adverse impact, what, if any, appropriate measures will be put in place to prevent it;
- Whether there will be a substantial increase in the cumulative adverse impact from these or similar activities, on an adjacent residential area;
- Whether there is a suitable level of public transport accessibility to and from the premises at the appropriate times;
- Whether the activity will be likely to lead to a harmful and unmanageable increase in car parking demand in surrounding residential streets suffering high levels of parking stress or on roads forming part of the Strategic London Road Network or the London Bus Priority Network leading to a negative impact on the Licensing Objectives relating to the prevention of crime, disorder, anti-social behaviour (ASB), nuisance and vehicle emissions;
- Whether there have been any representations made by Responsible Authorities, or other relevant agency or representative.

The Licensing Authority will closely scrutinise extended hours applications to ensure that the Licensing Objectives are met. In determining an application the licensing committee might decide that the circumstances are such that a restriction on hours is the only appropriate means to achieve the Licensing Objectives. If an 'hours' restriction is imposed, the Licensing Authority will normally require that customers should be allowed a minimum of thirty minutes to consume alcohol.

To act as a guide for new or existing operators we have set out the suggested closing times for licensed premises below:

5.3 Policy 4 pages 22 and 23 of the SLP states that in determining an application where there has been a relevant representation the Licensing Authority will, where

appropriate, take into account the cumulative effect of the number, type and density of licensed premises already existing in the area. Consideration will be given to the proximity to any drug and alcohol treatment site, A&E department or homeless hostel in a local area type remit ie applicants need to make the case for how they would not increase further problems for residents/clients nearby.

In coming to any decision regarding cumulative impact the Licensing Authority will consider other mechanisms outside of the licensing regime which may also be available to address this issue, these include but are not limited to:

- Police and other enforcement of the normal law concerning disorder and anti-social behaviour.
- Police powers to close down instantly any licensed premises or temporary events on grounds of disorder, the likelihood of disorder or excessive noise emanating from the premises, for up to 24 hours.
- The power of the police, other responsible authorities, a local resident, business or Councillor to seek a review of the licence or certificate in question.
- Police and Local Authority power to issue a Closure Notice for up to 48 hours where serious antisocial behaviour is taking place at licensed premises under the Anti-social Behaviour, Crime and Policing Act 2014.
- To ensure that residents are protected from the negative impact of late-night local licensing activities the Licensing Authority may decide to adopt an Area Specific Cumulative Impact Policy in relation to a specific area; where the number, type and density of premises providing licensable activities is having a serious negative impact on the local community and local amenities.

5.4 Policy 11 page 30 of the SLP states that population densities in this borough are high, with many residential premises located above or in close proximity to licensed premises. This means that the public nuisance and crime and disorder objectives will be of paramount concern when evaluating Operating Schedules. Licensing Committees will place high regard on the control measures put in place by the applicant to ensure that our residents are protected from the potential detrimental effects of any licensed premises.

5.5 Annex 1 pages 35 and 36 of the SLP in relation to the prevention of crime and disorder states licence applicants will be expected to demonstrate the following in their operating schedules:

- g) Conditions will, so far as possible, reflect local crime prevention strategies, and the Licensing Authority will also have regard to the views of the local Crime and Disorder Reduction Partnership.
- h) Crime and disorder in the vicinity of the premises: this may include the crime and disorder risks arising from persons queuing to enter the premises; persons exiting the premises and customers smoking eating or drinking in outdoor areas and on the highway outside the premises. This can also include crime arising from pickpockets and bag snatchers, particularly in open spaces or crowded areas where alcohol is being consumed.
- j) CCTV - using CCTV inside and/or outside the premises together with appropriate procedures and having staff properly trained to use CCTV equipment.

- k) dispersal procedures - establishing appropriate dispersal procedures to minimise the potential for crime and disorder when customers are leaving the premises.
- p) local schemes – joining and attending local Pubwatch meetings and participating in the Behave or Be Banned Scheme (BOBB) and/or signing up and using the Council's Safety Net Radio scheme.

5.6 Annex 1 pages 38 to 40 of the SLP in relation to the prevention of public nuisance states that the Licensing Authority will particularly consider the following matters where they are material to the individual application:

- ii. The proximity of residential accommodation;
- iii. The type of use proposed, including the likely numbers of customers, proposed hours of operation and the frequency of activity;
- iv. The steps taken or proposed to be taken by the applicant to prevent noise and vibration escaping from the premises, including music, noise from ventilation equipment, and human voices. Such measures may include the installation of soundproofing, air conditioning, acoustic lobbies and sound limitation devices;
- v. The steps taken or proposed to be taken by the applicant to prevent disturbance by customers arriving at or leaving the premises.
- viii. The steps taken or proposed to be taken by the applicant to prevent queuing (either by pedestrian or vehicular traffic). If some queuing is inevitable then queues should be diverted away from neighbouring premises or be otherwise managed to prevent disturbance or obstruction;
- ix. The steps taken or proposed to be taken by the applicant to ensure staff leave the premises quietly;
- x. The arrangements made or proposed for parking by patrons, and the effect of parking by patrons on local residents;
- xi. The provision for public transport in the locality (including taxis and private hire vehicles) for patrons;
- xii. The level of likely disturbance from associated vehicular and pedestrian movement to and from the premises;
- xiii. The delivery and collection areas and delivery/collection times;
- xv. The arrangements for refuse disposal, storage and the prevention/tidying of litter (including fly posters and illegal placards);
- xviii. The generation of odour, e.g. from the preparation of food;
- xix. Any other relevant activity likely to give rise to nuisance;
- xx. Any representations made by the Police, or other relevant agency or representative;

The following provides a non-exhaustive list of risks associated with the public nuisance objective that applicants may want to consider when preparing their Operating Schedule:

j) **Deliveries/collections** – noise from deliveries to and/or collections (e.g. refuse) from the premises are another common source of complaint. Consider the times of such deliveries/collections and make sure you specify to any contractors that deliveries/collections should not be made at anti-social times. As a guide, the Noise and Nuisance Service recommend that deliveries/collections should only be made between the hours of 7:30am and 9:00pm, depending on the proximity of residential and/or other noise sensitive properties.

k) **Late night refreshment** - applicants in respect of late night takeaways should demonstrate that they have assessed the risk of persons congregating in large numbers in the vicinity of their premises. Where appropriate, applicants should demonstrate suitable measures to address this problem.

l) **Light pollution** – this is an increasingly common source of complaint, particularly from illuminated signs and external security lighting. Where provided, illuminated signs should not cause glare to neighbouring properties, ideally being turned off at night, and external lighting should be angled and/or diffused to also prevent nuisance.

m) **Noise and/or vibration** breakout from the provision of regulated entertainment, particularly from (but not limited to) live music – consider what type of entertainment is to be provided, in what room/area of the premises and the suitability of the construction of this room/area to contain sound. Windows are a particular weak-point for noise break-out so consider providing regulated entertainment in a room without windows or with as few windows as possible, particularly windows that face towards nearby 40 residential properties. Where suitable, install a lobby to prevent spillage of noise each time an entrance/exit door is opened.

o) **Odour** – odour from cooking is a common source of complaint, particularly from restaurants and fastfood takeaways. The Council's Noise and Nuisance Service may therefore require evidence that the kitchen ventilation and/or extract systems are regularly maintained and serviced to ensure that it is operating efficiently and with minimal nuisance to neighbours arising from odour and also noise. This includes the siting of BBQs.

p) **Queue management** - establishing appropriate procedures to avoid the need for customers to queue before entering the premises or, where queuing cannot be avoided, to manage queues so as to minimise the potential for crime and disorder or public nuisance by customers who are queuing.

q) **Ventilation** – where regulated entertainment is to be provided there may be a requirement to keep doors and/or windows closed during its provision to limit noise breakout, consider therefore the provision of air conditioning for the comfort of your customers if doors and windows have to be closed during the summer. However, also note air conditioning can be the source of noise complaints in itself, so careful consideration also needs to be given to the siting of this equipment.

r) **Waste** – consider how and where waste will be stored/disposed of at the end of trading hours, particularly if trading until late at night. This is important because the disposal of glass and/or cans to outside bin areas can be very noisy and give rise to complaints, so it may be necessary to store such items and other non-degradable refuse inside the premises until the next trading day. Consideration should also be given to the time of deliveries to minimize disruption to local residents.

s) **Litter** – for example, litter patrols for late night take-away premises

6. DETERMINATION

6.1 In determining this application, the Committee must have regard to the representations and take such of the following steps as it considers necessary for the promotion of the licensing objectives. The steps are:

(a) Grant the application in full

(b) Grant the application in part – modifying the proposed hours, activities or conditions.

(c) Reject the application

It is the Council's duty under the Licensing Act 2003 ("The Act") to determine applications with a view to promoting the four licensing objectives; Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance and the Protection of Children from Harm.

In reaching a decision the Council shall consider the details of any relevant representations received; the applicant's Operating Schedule; the Council's adopted Statement of Licensing Policy and the guidance issued by the Secretary of State under section 182 of the Act.

If the Committee is minded to grant the application conditions may be attached to the licence to alleviate the concerns raised through the representations.

Annex 1 – Mandatory Conditions

1. Mandatory Condition

1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

- (a) a holographic mark, or
- (b) an ultraviolet feature.

2. Mandatory Condition

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purposes of the condition set out in paragraph 1—

- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula—

$$P = D + (D \times V)$$

where—

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4(1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

3. Mandatory Condition

(1) No supply of alcohol may be made under the premises licence-

(a) at a time when there is no designated premises supervisor in respect of the premises licence, or

(b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

(2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Annex 2 – Conditions consistent with the operating Schedule

4. High Definition CCTV shall be installed, operated and maintained, at all times that the premises are open for licensable activities or customers are on the premises and;

- shall be checked every two weeks to ensure that the system is working properly and that the date and time are correct. A record of these checks, showing the date and name of the person checking, shall be kept and made available to Police or authorised Council officers on request.
- at least one camera will show a close-up of the entrance/entrances to the premises, to capture a clear, full length image of anyone entering.
- shall cover any internal or external area of the premises where licensable activities take place.
- recordings shall be in real time and stored for a minimum period of 31 days with date and time stamping.
- footage shall be provided free of charge to Police or authorised council officer within 24 hours of a request.
- a staff member from the premises that is conversant with the operation of the CCTV system shall be on the premises at all times. This staff member will be able to show police or authorised officers of the Licensing Authority recent data footage with the minimum of delay when requested. This data or footage reproduction shall be almost instantaneous.

5. A daily incident log (electric or paper based) shall be kept at the premises and made available on request to an authorised officer of the Council or the Police or the Fire Service which shall record the following:

- (a) all crimes reported to the venue
- (b) all ejection of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) seizures of drugs or offensive weapons
- (f) any faults in the CCTV system
- (g) any refusal of the sale of alcohol

(h) any visit by a relevant authority or emergency service

6. The supply of late night refreshment after 02:00 hours shall only be by means of delivery to a residential or business address.

7. Alcohol shall not be sold or supplied in an open container or be consumed in the licenced premises.

We have received your objections to the application for Ringo Pizza, there appears to be some misunderstanding, we would like to take this opportunity to clarify, we have not applied for delivery of late night refreshment as we already have this on our current licence.

What we have applied for is takeaway service from the premises to match the existing hours of operation.

To answer your 3 points of objection:

1. Delivery motorbikes are well used all across the borough and clearly not exclusive to our premises, in fact there appears to be several busy premises that deliver just a few metres from Barclay Road where you are being disturbed or woken, namely Kennedys fish & chip shop, Dominoes both are on the corner of your road, Best Mangal, Caffè Nero and countless others in the Fulham Broadway area. We are 2 miles from this address and do not have any deliveries to this area as there are many shops offering our service much closer. This would make it impossible for our deliveries to wake anyone in your area, the wording of the complaint may suggest a more general objection to motorcycle deliveries completely. Lastly i must emphasise this application is not for delivery as we already have this in place.

2. Condition 6 has been agreed with the police and amended to read:

The supply of Late Night Refreshment after 02:00 shall be by way of delivery or TAKE AWAY ONLY.

All deliveries shall be made to a bona fide business or residential address only.

Signs shall be displayed informing customers that the provision of late Night Refreshment shall be provided by delivery or takeaway only after 02:00.

The above clearly does as you have asked and tightens control on deliveries and operations after 02:00. It merely now includes the word 'Take away' to incorporate meals purchased from the premises.

3. All applications are scrutinised by all the responsible authorities on submission of the application, hence the negotiated wording of the condition above to be added to any granted licence. This has been agreed with the police following consultation and examination of the premises and area, the premises is in the Hammersmith Broadway Ward and a further 2 miles away in Fulham is Walham Green Ward, which contains your address within it.

To Summarise we are 2 miles from your address and do not deliver to your area, we are in completely different wards and therefore do not affect the Barclay Road Conservation Neighbourhood Watch, from my understanding the 'Town Ward' no longer exists and has been replaced by Walham Green Ward, i hope i have this information is correct but as a member you will know better than i. We already have in place Late Night Refreshment and have simply applied for takeaway from the premises utilising the hours we currently already have, there is no extension sought to the operating hours here and no extension to delivery hours.

The licensing section received one representation from the Town Ward Panel Fulham objecting to the licence variation application. A copy of this representation can be seen on pages 93-95 of this report.

4. OTHER INFORMATION

4.1 Enforcement History

There have not been any warnings, simple cautions or prosecutions given in respect of the premises during the past three years.

4.2 Temporary Event Notices ("TENS")

No TENS have been submitted in respect of this premises in the past twelve months.

5. POLICY CONSIDERATIONS

5.1 Section 5 pages 12 and 13 of the Statement of Licensing Policy (“SLP”) states that in order to ensure the promotion of the four Licensing Objectives the Licensing Authority will require applicants to detail in their operating schedule:

- the steps proposed to promote the licensing objective of the prevention of crime and disorder on, and in the vicinity of, the premises, having regard to their location, character, condition, the nature and extent of the proposed use and the persons likely to use the premises;
- the steps proposed to ensure the physical safety of people using the relevant premises or place;
- how they intend to prevent nuisance arising, prevent disturbance and protect amenity so far as is appropriate to ensure that the Licensing Objectives are met. Where there is a relevant representation regarding extended hours, the Licensing Authority will not permit an extension unless it is satisfied that the Licensing Objectives would be met;
- the measures and management controls in place to protect children from harm. Where appropriate a written childcare policy should be available and be incorporated in the induction of staff.

5.2 Section 7 page 15 of the SLP states that for sales of alcohol for consumption off the premises – applicants in respect of off licences and other premises selling alcohol for consumption off the premises may need to consider whether:

- there are shutters to prevent alcohol from being selected in non-licensed periods.
- there are appropriate numbers of staff on duty to deal with possible ‘intimidation’ to sell alcohol.
- there are restrictions required on the sale of low price, high strength alcohol and drink promotions.
- an incident log book is available to record incidents.
- there are measures in place necessary to prevent underage sales. (See Annex 1)
- there are measures in place necessary to prevent alcohol from being sold outside permitted hours where the operating hours of the premises exceed those for the sale of alcohol.
- there are procedures in place to prevent sales of alcohol to intoxicated persons (with particular attention to street drinkers) or individuals leaving premises in the vicinity such as a late night bar; where there is evidence to suggest this is a problem the Licensing Authority may require a temporary cessation of alcohol sales during high risk times.

5.3 Policy 3 page 21 of the SLP states that where there is a relevant representation, the Licensing Authority will consider each particular case on its merits having regard in particular to the following matters:

- a) Whether the licensed activities are likely to have an adverse impact especially on local residents and, if there is potential to have an adverse impact, what, if any, appropriate measures will be put in place to prevent it;
- b) Whether there will be a substantial increase in the cumulative adverse impact from these or similar activities, on an adjacent residential area;

- c) Whether there is a suitable level of public transport accessibility to and from the premises at the appropriate times;
- d) Whether the activity will be likely to lead to a harmful and unmanageable increase in car parking demand in surrounding residential streets suffering high levels of parking stress or on roads forming part of the Strategic London Road Network or the London Bus Priority Network leading to a negative impact on the Licensing Objectives relating to the prevention of crime, disorder, anti-social behaviour (ASB), nuisance and vehicle emissions;
- e) Whether there have been any representations made by Responsible Authorities, or other relevant agency or representative.

The Licensing Authority will closely scrutinise extended hours applications to ensure that the Licensing Objectives are met. In determining an application the licensing committee might decide that the circumstances are such that a restriction on hours is the only appropriate means to achieve the Licensing Objectives. If an 'hours' restriction is imposed, the Licensing Authority will normally require that customers should be allowed a minimum of thirty minutes to consume alcohol.

To act as a guide for new or existing operators we have set out the suggested closing times for licensed premises below:

5.4 Policy 11 page 30 of the SLP states that population densities in this borough are high, with many residential premises located above or in close proximity to licensed premises. This means that the public nuisance and crime and disorder objectives will be of paramount concern when evaluating Operating Schedules. Licensing Committees will place high regard on the control measures put in place by the applicant to ensure that our residents are protected from the potential detrimental effects of any licensed premises.

5.5 Annex 1 pages 35 and 36 of the SLP in relation to the prevention of crime and disorder states licence applicants will be expected to demonstrate the following in their operating schedules:

- c) Operators of off-licences in areas problems relating to street drinking and under age drinking are prevalent, measures should be outlined to strictly monitor the way alcohol is sold, specifically where the premises are located close to schools and hostels and similar premises that provide shelter or services to alcohol dependent persons.
- d) It is important to ensure that staff working at off licences are suitably trained and receive appropriate refresher training in their responsibilities under the Act and can discharge their duties in full compliance with the licence conditions and requirements of the Act. This includes the ability to competently check a customer's age with acceptable forms of identification where necessary. The Licensing Authority will

particularly consider the following matters where they are material to the individual application:

- i. The likelihood of any violence, public order or policing problem if the licence is granted;
 - ii. The measures taken to control admission to the premises, and to take reasonable steps to prevent the occurrence of crime and disorder and public nuisance immediately outside the premises, where and to the extent that these matters are within their control.
 - iii. Past conduct and prior history of complaints against the premises;
 - iv. Whether a dispersal policy has been prepared to minimise the potential for disorder as customers leave the premises; and
 - v. Any relevant representations.
- g) Conditions will, so far as possible, reflect local crime prevention strategies, and the Licensing Authority will also have regard to the views of the local Crime and Disorder Reduction Partnership.
- h) Crime and disorder in the vicinity of the premises: this may include the crime and disorder risks arising from persons queuing to enter the premises; persons exiting the premises and customers smoking eating or drinking in outdoor areas and on the highway outside the premises. This can also include crime arising from pickpockets and bag snatchers, particularly in open spaces or crowded areas where alcohol is being consumed.
- j) CCTV - using CCTV inside and/or outside the premises together with appropriate procedures and having staff properly trained to use CCTV equipment.
- k) dispersal procedures - establishing appropriate dispersal procedures to minimise the potential for crime and disorder when customers are leaving the premises.

5.6 Annex 1 pages 38 to 40 of the SLP in relation to the prevention of public nuisance states that the Licensing Authority will particularly consider the following matters where they are material to the individual application:

- ii. The proximity of residential accommodation;
- iii. The type of use proposed, including the likely numbers of customers, proposed hours of operation and the frequency of activity;
- v. The steps taken or proposed to be taken by the applicant to prevent disturbance by customers arriving at or leaving the premises.
- viii. The steps taken or proposed to be taken by the applicant to prevent queuing (either by pedestrian or vehicular traffic). If some queuing is inevitable then queues should be diverted away from neighbouring premises or be otherwise managed to prevent disturbance or obstruction;
- ix. The steps taken or proposed to be taken by the applicant to ensure staff leave the premises quietly;
- x. The arrangements made or proposed for parking by patrons, and the effect of parking by patrons on local residents;
- xi. The provision for public transport in the locality (including taxis and private hire vehicles) for patrons;
- xii. The level of likely disturbance from associated vehicular and pedestrian movement to and from the premises;
- xiii. The delivery and collection areas and delivery/collection times;
- xv. The arrangements for refuse disposal, storage and the prevention/tidying of litter (including fly posters and illegal placards);
- xix. Any other relevant activity likely to give rise to nuisance;

xx. Any representations made by the Police, or other relevant agency or representative;

The following provides a non-exhaustive list of risks associated with the public nuisance objective that applicants may want to consider when preparing their Operating Schedule:

j) **Deliveries/collections** – noise from deliveries to and/or collections (e.g. refuse) from the premises are another common source of complaint. Consider the times of such deliveries/collections and make sure you specify to any contractors that deliveries/collections should not be made at anti-social times. As a guide, the Noise and Nuisance Service recommend that deliveries/collections should only be made between the hours of 7:30am and 9:00pm, depending on the proximity of residential and/or other noise sensitive properties.

k) **Late night refreshment** - applicants in respect of late night takeaways should demonstrate that they have assessed the risk of persons congregating in large numbers in the vicinity of their premises. Where appropriate, applicants should demonstrate suitable measures to address this problem.

l) **Light pollution** – this is an increasingly common source of complaint, particularly from illuminated signs and external security lighting. Where provided, illuminated signs should not cause glare to neighbouring properties, ideally being turned off at night, and external lighting should be angled and/or diffused to also prevent nuisance.

p) **Queue management** - establishing appropriate procedures to avoid the need for customers to queue before entering the premises or, where queuing cannot be avoided, to manage queues so as to minimise the potential for crime and disorder or public nuisance by customers who are queuing.

r) **Waste** – consider how and where waste will be stored/disposed of at the end of trading hours, particularly if trading until late at night. This is important because the disposal of glass and/or cans to outside bin areas can be very noisy and give rise to complaints, so it may be necessary to store such items and other non-degradable refuse inside the premises until the next trading day. Consideration should also be given to the time of deliveries to minimize disruption to local residents.

s) **Litter** – for example, litter patrols for late night take-away premises

6. DETERMINATION

6.1 In determining this application, the Committee must have regard to the representations and take such of the following steps as it considers necessary for the promotion of the licensing objectives. The steps are:

(a) Grant the application in full

(b) Grant the application in part – modifying the proposed hours, activities or conditions.

(c) Reject the application

It is the Council's duty under the Licensing Act 2003 ("The Act") to determine applications with a view to promoting the four licensing objectives; Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance and the Protection of Children from Harm.

In reaching a decision the Council shall consider the details of any relevant representations received; the applicant's Operating Schedule; the Council's adopted Statement of Licensing Policy and the guidance issued by the Secretary of State under section 182 of the Act.

If the Committee is minded to grant the application conditions may be attached to the licence to alleviate the concerns raised through the representations.

Annex 1 – Mandatory Conditions

1. Mandatory Condition

1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

- (a) a holographic mark, or
- (b) an ultraviolet feature.

2. Mandatory Condition

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purposes of the condition set out in paragraph 1—

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(b) "permitted price" is the price found by applying the formula—

$$P = D + (D \times V)$$

where—

(i) P is the permitted price,

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4(1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

3. Mandatory Condition

(1) No supply of alcohol may be made under the premises licence—

(a) at a time when there is no designated premises supervisor in respect of the premises licence, or

(b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

(2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Annex 2 – Conditions consistent with the operating Schedule

4. Alcohol shall not be sold or supplied except during the following permitted hours

(a) Weekdays, other than Christmas Day and Good Friday, 8am to 11pm

(b) Sundays, other than Christmas Day, 10am to 10:30pm

(c) Christmas Day, 12 noon to 3pm and 7pm to 10:30pm

(d) Good Friday, 8am to 10:30pm.

Subject to the following exceptions no person shall, except during the permitted hours listed above, sell or supply alcohol or take alcohol from the premises. The exceptions are:

i. During the first 20 minutes after the above hours the taking of the alcohol from the premises , provided it is not taken in an open container;

- ii. The ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- iii. The sale of alcohol to a trader or club for the purposes of the trade or club;
- iv. The sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of her Majesty's naval, military or air forces.

5. Alcohol shall not be sold in an open container or be consumed in the licensed premises.

I writing in my capacity as Chair of the Parsons Green and Walham Safer Neighbourhood Ward Panel, Fulham.

The Sub Committee will know that the five Ward Panels in Fulham are now working together to support making Representations for various Licensing Applications. The consequences of Licensing decisions for a Premises are starting to have a deleterious effect all over Fulham, especially when delivery is involved. or could be involved.

We have discussed the increased negative consequences that some residents are experiencing from expanded hours for the sale of alcohol and hot food which in turn is leading to more loitering, littering, noise, nuisance, public safety issues on our pavement and noise nuisance.

I am concerned about certain aspects of this Application and oppose other aspects as detailed below.

1. Hours for alcohol sales.

This Premises at 308 Wandsworth Bridge Road (WBR) is currently a busy hard working Post Office, offering grocery, alcohol and all sorts of things we need/household goods and school supplies. It sells alcohol from 08:00 to 23:00 Mon - Sat and from 10:00-22:30 on Sunday. The reasoning and logic for them seeking to amend those hours from 06:00 and up to midnight is unclear to me. How will selling alcohol from 6am do any good and how will it support the Licensing Objectives?

Wandsworth Bridge Road ("WBR") is about 60 percent residential and 40 percent shops. All the neighbouring roads are purely residential. The extension of the hours for sale of alcohol to 06:00 is likely to only attract those who are already quite well 'refreshed' or even drunk. This can lead to public disorder, Anti-social behaviour (ASB), noise and nuisance.

Extending the hours by one hour to midnight, will cause more people to stop to buy alcohol, from 23:00-midnight, perhaps on their way to a bus stop or before they take a cab home, after having a meal at one of the cafes, restaurants on WBR. More alcohol after a meal with alcohol can lead to public disorder, Anti-social behaviour, noise and nuisance, disruptions of all sorts, arguments on the pavement, in the road etc. Cabbies surely don't buy dearly priced alcohol at night at this type of shop, at least I hope they don't.

On 1st Aug on the NextDoor App there was a post about anti social problems in this area of WBR where people are using laughing gas (NSO with balloons), that needs no encouragement from later trading hours for this shop.

I submit that the current opening hours and the hours for the sale of alcohol are more than adequate for this area of Fulham. The 24-hr shop across the road (Krystals) is enough for the area.

In light of this I oppose the extensions requested as they could cause more anti-social behaviour, noise, and nuisance in, and around the Premises.

2. Hours requested for “Late Night Refreshment”, ie hot food after 23:00 and before 05:00.

This is a residential area/main road with shops and many private front doors, ie victorian terraced houses that are lived in. The residents on WBR don't need more disturbance, noise, nuisance from a shop open for yet another hour.,

3. Floor plan changes

I oppose these because they are not necessary, bar a small area for 'Late Night Refreshment' which I understand will be hot coffee/tea and a microwave, at the moment, prepared Indoors, but taken outdoors to consume as there is no seating, at the moment The small amount of counter space needed for the coffee/tea facility and microwave should be shown on the plan, as so should the Post Office.

The filed plan indicates that they wish the entire floor space to be granted a licence to sell alcohol, rather than the existing space. If this was to be allowed , then potentially the whole character of this shop could quickly be changed to a full off-licence, without any further intervention by the Licensing Authority. Currently there is a balance between the Post Office services, groceries, some fresh veg and soft drinks/alcohol.

Changing the floor plan will allow alcohol to be sold anywhere; school children could be tempted (protecting Children from Harm) and the chances of anyone of any age shoplifting (crime) will increase immediately.

A coffee machine and microwave need to be tended by the shopkeeper so this should be in the area of the counter/till, not all over the shop. The shop can sell coffee and hot food before 23:00 and after 08:00 at present, which is sufficient in all the circumstances

Allowing the entire floor space to be licensed could allow :

- 1) the present Premises to become a bar/cocktail lounge or cafe, or
- 2)the licence being transferred easily to someone who wanted to open a cocktail bar; with no new Conditions put on the licence because the transfer must be allowed without any intervention by the Licensing Authority, under the Licensing Act 2003.

4. Deliveries

The Applicant has said that he is not currently planning on delivering from his premises, but that could change. This is the only opportunity, if you decide to extend hours to midnight to put Conditions on the Premises License regarding deliveries. To avoid noise nuisance, only silent bicycles or silent electric bicycles would support the Council's zero carbon and zero emissions aims. No deliveries before 9am and none after 11pm would help residents within a 2 mile radius to not be disturbed by late night/early morning deliveries.

Summary:

I submit that the opening hours and the hours for sale of alcohol should remain as they are. The floor plan should stay as is, with just a small change to allow the placement of a coffee machine and microwave near the counter/till so that customers can be helped easily by whoever is working the counter/till.

I would also like to point out that on July 29, Westminster Council rejected an application by Greggs bakery/cafe in Leicester Square to expand their trading hours beyond 23:00. Westminster Council has a policy of limiting late night hours for the sale of hot food and alcohol , on the grounds of seeking to reduce crime, disorder, public nuisance and noise problems.

To Whom it May Concern

I write in my role as Chair of the Sands End Ward Panel, Fulham and therefore 308 WBG is within my remit.

I am very concerned about the following in regards to the above proposed licensing application :

1. Hours for alcohol sales.

Proposed Hours (to be open and to sell alcohol off the Premises):

Mondays to Sundays between the hours of 06:00 to 00:00

This is clearly designed to capture the trade from pub goers . As such it is highly likely that those prospective buyers of alcohol and more not less likely to be inebriated and therefore are more not less likely to behaviour in an anti social manner.

Given this is predominately a residential area; I see no reason for the area to trade off residential tranquility at the expense of what is only of minor commercial benefit to the owner, but could be of get detriment to the local residents.

I doubt the police would wish to see the alcohol license extended; given these associated risks. This is no aspersion on the owner of 308, but a realistic judgment on the accompanying effects of extended alcohol licenses in a residential area.

I foresee noise complaints and anti social behaviour, were this license to be extended.

2. Hours requested for "Late Night Refreshment", ie hot food after 23:00 and before 05:00.

I don't believe the perceived demand for such a late night offering if worth the risk to the residents . I'm concerned that dark kitchen may eventually pop up were this to go through licensing and then we would have no control. What is being proposed is likely in my mind to lead to noise - this being cabs, late night revellers and moped deliver drivers and associated talking. This is the wrong area for this type of offering. We are not Soho!

3. Deliveries

Conditions to be placed on applicant for Premises License regarding deliveries. Namely electric bicycles and electric mopeds to be used for deliveries.

I object to any deliveries beyond 11pm.

In conclusion ,

No variation of existing alcohol hours and no variation of existing Late Night Refreshments.

I am agnostic in regards to floor plan layouts, as I don't really understand them.

Kindly acknowledge receipt and send me dates and any zoom link, in regards to the License Committee time and place.

Representation

I write as a frequent user of Wandsworth Bridge Road shops, cafes, restaurants, shops for tiles, furniture, lighting, ironmongery and all sorts, as it is a quick 5 minute silent bicycle ride for me to get there. I write also as a member of the Police/Community Town Ward Panel (soon to be the Walham Green Ward Panel) and working together with the Parsons Green Ward Panel and Sands End Ward Panel as well as the Fulham Broadway Ward Panel (soon to merge into the new Walham Green Ward Panel); we are in contact now also with Munster Ward Panel but licensing is a new topic for them, they told us last night at our Town Ward Panel meeting, which they attended.

The Sub Committee will know that these five Ward Panels in Fulham are now working together to support making Representations for various Licensing Applications. The consequences of Licensing decisions for a Premises are starting to have, in many cases, very negative effects all over Fulham, especially when The Delivery Economy is involved, or could be involved.

On 2 Aug, we had our local Ward Panel meeting with Police and discussed the increased negative consequences that residents are experiencing from extended licensing hours; expanded hours for the sale of alcohol and hot food are leading to more loitering, littering, noise, nuisance, public safety issues on our pavements and in our roads, and psychological harm of children who can't get to sleep at night, or are awoken by noise, people loitering, motorcycles zooming down residential roads to make deliveries. The truth is that Police and even the new LBHF Law Enforcement Teams can do very little about all these problems; 'bad actors' might be given a warning here and there.

I am concerned about certain aspects of this Application and oppose other aspects. Having spoken with many people about this application it became clear to me how confused people are about Licensing terminology. In fact, I had to point out mistakes made in the Licensing Register, regarding this very Application, which were corrected on 29 July; I do still question why no one was officially advised of these material changes and have asked the Licensing Authority to look into the legalities of this. That is, however, another topic, related as it is, however. So please bear with me as I repeat things a few times as I set out my thoughts below.

1. Hours for alcohol sales.

The positive news is:

This Premises at 308 Wandsworth Bridge Road (WBR) is a hard working Post Office, offering grocery, alcohol and all sorts of things we need/household goods and school supplies. It is allowed to sell alcohol from 08:00 to 23:00 Mon - Sat and from 10:00-22:30 on Sunday.

Why they need to start selling from 06:00 and up to midnight is unclear to me. Perhaps the Sub-Committee could explain to me/us, specifically, how will selling alcohol from 6am do any good for the residents' amenity around this shop, and further afield, and how will it support the Licensing Objectives?

Wandsworth Bridge Road is about 75 percent residential and 25 percent shops, at street level. At certain stretches of this main road is is 90 percent or even 100 percent residential with single family houses or 3 flats in house conversions or 2 flats above a shop. It is a main artery road still with real Victorian terraced houses occupied by real people.

All the neighboring roads are purely residential—literally 100 percent residential, plus open spaces.

Reversing the hours for sale of alcohol back to 06:00 will only attract people who are already quite well 'refreshed' or even drunk. This can lead to public disorder, Anti-social behaviour (ASB), noise and nuisance, all objectives of the Lic Act to be prevented, no encouraged. School children are out walking to school sometimes from as early as 07:30; they don't need to see people drinking alcohol on their walk to school, do they? This goes totally against the Lic Obj Protecting Children from harm.

Extending the hours by one hour from 23:00 to midnight, will cause more people to stop to buy alcohol, from 23:00-midnight, perhaps on their way to a bus stop or before they take a cab home, after having a meal at one of the popular cafes, restaurants on WBR. More alcohol after a meal with alcohol can lead to public disorder, Anti-social behaviour, noise and nuisance, disruptions of all sorts, arguments on the pavement, in the road etc. Cabbies surely don't buy cheaply priced alcohol at night at this type of shop.

Only yesterday, 1st Aug on the NextDoor App someone posted about problems in WBR where people are using laughing gas (NSO with balloons). I attach a screen grab. This is a serious, growing problem leading to crime, ASB, litter; young children are pulled in to sell balloons on the pavement late at night, young underage children use this gas as a social cohesion play. All of this needs no encouragement from later hours for this shop.

It is not illegal to buy the gas and balloons, or use them. This is becoming a huge nuisance around many parts of Fulham, and London. Police can do very little; you cannot call 999 about it. Police Response Teams don't have time to deal with these people congregating and getting dangerously high on sucking in this gas. The newest iteration is sitting inside cars to experience a less oxygen-filled environment. This requires someone to open and slam shut the door several times every few minutes so that a bit of fresh air seeps in. The noise just from the doors banging over and over again is awful. The people inside experiencing euphoria are screaming and yelping, emitting screeching high pitched sounds as they lose oxygen to the brain, to be honest.

And these inhalation sessions go on for 3 to 4 hours; worryingly, they 'drive off' in the cars, finally.

The current hours for opening and the sale of alcohol are more than adequate for this area of Fulham. The 24-hr shop across is enough for the area alcohol sales 7am to 2am Mon to Sat and 07:00 to midnight on Sundays). I am looking into this very point of how and when this Krystals 24-hour shop received permission to operate. I'll add an addendum to my Representation, soon.

I oppose the extensions requested as they could cause more anti-social behaviour, more noise, more nuisance in front of the Premises, and around the Premises and up the WBR as well as at corners in fact the very corners mentioned in the NextDoor post attached.

If 308 WBR sells balloons or NSO (small cylinders or large canisters/tubes) perhaps the Sub Committee could ask them to voluntarily stop selling them. This has been done recently at an off license around Fulham Broadway. Helps a bit, but also attracts outsiders with their re-sell offers.

2. Hours requested for "Late Night Refreshment", ie hot food after 23:00 and before 05:00.

They are asking for 23:00-midnight, ie 1 hour to sell coffee and perhaps a bun to heat up in a microwave, or a soup.

Although this is not a novel idea, I don't see how it will help this shop and I think it best that we not temp 'hours creep'. Today midnight, next year 1am, then 2am, why not 24-hrs?. This is a residential area/main road with shops and many private front doors, ie victorian terraced houses that are lived in. People need to sleep. These very residents on WBR don't need more disturbance, noise, nuisance from a shop open for yet another hour.

3. Suggested/submitted Floor plan: I oppose this layout because it is too general, in the context of the present as well as future use of the Premises.

All that is needed is a floor plan with mention of the Post Office area and a small area for 'Late Night Refreshment', and the present placement of alcohol along walls (behind counters and in refrigerators) which must be shown on the floor plan.. (I understand that the Late Night Refreshment will be hot coffee/tea and a microwave, at the moment, prepared 'Indoors', but taken 'Outdoors' (ie taken away) to consume as there is no seating inside, at the moment—that could change if the entire floor is made the licensable area). The small amount of counter space needed for the coffee/tea facility and microwave can be shown on the plan, if required by the Licensing Act (the Sub Committee will know this).

And so the very handy and very local Post Office area should also be shown clearly. I'd like to see any draft revision of the plan, perhaps before the hearing.

Why not just show the entire floor as licensable?

Were the entire area to be licensed, the character of this shop could quickly or slowly change, dramatically, without any further intervention by the Licensing Authority, so the 2003 Licensing Act. Right now there is a balance between the Post Office services, groceries, some fresh veg and soft drinks/alcohol.

The Subcommittee will be receiving photos from another Ward Panel members.

In the current set up of the shop, Children are kept away from the hard alcohol, at present and other alcohol is in glass refrigerators.

The Floor Plan, as submitted with this Application, will allow alcohol to be sold anywhere—this could be a slow change over time, or a quick change as there would be total flexibility to do anything; school children could be tempted, were more alcohol to be placed in easy to reach places (very much the antithesis of the Licensing Objective to Prevent Children from Harm). As well, the chances of anyone of any age shoplifting (Licensing Objective to Prevent Crime) would increase immediately; a sad fact of life.

The floor plan as submitted with this Application will allow:

- Late Night Refreshment to be sold from anywhere in the shop. A coffee machine and microwave need to be tended by the shopkeeper so this should be in the area of the counter/till, not all over the shop.

- addition of tables and chairs, a bar, whatever

The shop can sell coffee and hot food before 23:00 and after 08:00, at present. I suggest the Subcommittee keep it that way to avoid any nuisance, ASB, early morning drunks coming into the shop and creating disturbance etc.

Allowing the entire floor space to be licensed would also allow 1) the present Premises to become a bar/cocktail lounge or cafe, or 2)the licence could be transferred easily to someone who wanted to open a cocktail bar; with no new Conditions put on the licence because the transfer must be allowed without any intervention of anyone, so the 2003 Licensing Act. The Licensing Authority has confirmed this very point to me.

4. Deliveries

The Applicant has explained to some neighbours that he is not planning on delivering from his premises, but that could change. Now is the opportunity, and only now is the opportunity, if the Subcommittee decides to extend hours to midnight (but please not from 6am!) to put Conditions on the Premises License regarding deliveries.

To avoid noise nuisance, and thus uphold the Licensing Objective to Prevent Noise and Nuisance

- only silent bicycles or silent electric bicycles which would support the Council's zero carbon and zero emissions aims

- no deliveries before 9am and none after 11pm would help residents within a 2 mile radius to not be disturbed by these thousands of deliveries, most of them at night, throughout Fulham. Every delivery in the new Delivery Economy makes noise, causes nuisance, drivers hang out either at the Premises or close by. A sub-world of drug sales by drivers is well known, unfortunately. The problems are growing. These new problems arising from the new Delivery Economy are in direct contradiction to the four licensing objectives.

- Deliveries only to genuine, valid residential and business addresses (not to bus stands, parks, corners, alleyways, front steps of buildings etc)

- The shop owner might tell us tonight that he has no such plans; but the point is that now is the only time to add Conditions to the licence regarding deliveries. I hope that the Subcommittee has been well advised on this.

5. The Nighttime Economy of Wandsworth Bridge Road:

Only last Friday, July 29, Westminster rejected an application by Greggs bakery/cafe in their Flagship shop in Leicester Square to expand hours beyond 23:00. Police and other Responsible Authorities rejected on the grounds of crime and disorder, public nuisance and noise problems. This area of Wandsworth Bridge Road certainly is not Leicester Square, but we all know that the ASB, noise, nuisance,

litter (mainly nighttime) problems on Wandsworth Bridge Road are growing and the Licensing Authority is all too familiar with the case of Jack's on this very road. Again, not to be compared with this Application but a lot is going on on this big road that leads in a straight line from inner Fulham/Parsons Green/Eel Brook Common to the Wandsworth Bridge.

There is a good balance of cafe/restaurant offerings for families, business lunches, evening meals and a few late-ish night establishments. But this night life is still somewhat contained (bar the Jack's official Lic Authority REVIEW, the Premises appeal etc) with relatively civilized licensing hours at most Premises serving food and drink. I spoke with a LBHF LET officer today in person, on the road, and did hear a few horror stories about increased nighttime ASB on Wandsworth Bridge Road and he confirmed the NSO gas problems around the family pizza restaurant, Il Pagliaccio, mentioned in the NextDoor post. I mention all this to give the SubCommittee a flavor of the area, the challenges that are developing, even as they deliberate this Application.

Summary:

In summary, I believe that the opening hours and the hours for sale of alcohol should stay as they are. Residents around this area next to, beside, above, close to and around 308 WBR and its neighboring 100 percent residential roads need their amenity preserved; it certainly won't be enhanced with a later hour from 23:00 to 00:00 and it definitely will be compromised with a rollback from 08:00 to 06:00. Lack of amenity means noise, nuisance, possible crime, children suffering less sleep; all things that the four licensing objectives are supposed to prevent.

Personally, I'd like to see alcohol sold only from say 11am, but that opportunity has been missed, long ago.

The floor plan should reflect the situation as is, with a small change regarding placement of the coffee machine and microwave near the counter/till so that customers can be helped easily by whoever is working the counter/till, showing the Post Office counter, showing exactly where the spirits are behind the counter and well out of reach, and exactly where the alcohol is in refrigerators.

To be clear, the shop is already allowed to sell coffee and hot food before 23:00 and after 08:00 Mon-Sat and from 08:00 on Sundays, as no 'Late Night Refreshment Licence is needed between the hours of 05:00-23:00.

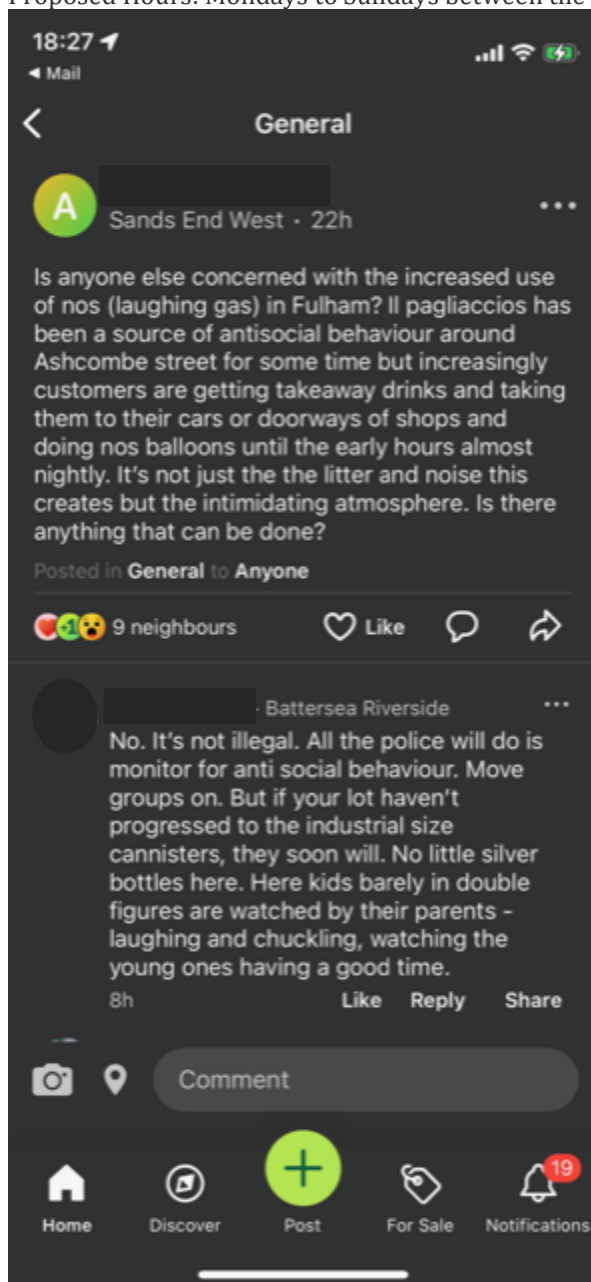

As Chair of the Town Ward Panel working in conjunction with the other local Ward Panels I wish to raise various issues in connection with this application, as applications of this type are negatively impacting residents.

1. Hours for alcohol sales.

This Premises at 308 Wandsworth Bridge Road (WBR) is a hard working Post Office, offering grocery, alcohol and all sorts of things we need/household goods and school supplies. It sells alcohol from 08:00 to 23:00 Mon - Sat and from 10:00-22:30 on Sunday. It is unreasonable and unnecessary to sell alcohol to sell alcohol at 6am.

Wandsworth Bridge Road is about 60 percent residential and 40 percent shops. All the neighboring roads are purely residential. Extending the hours for sale of alcohol back to 06:00 will only attract people who are already quite well 'refreshed' or even drunk. This can lead to public disorder, Anti-social behaviour (ASB), noise and nuisance.

Extending the hours by one hour to midnight, will cause more people to stop to buy alcohol, from 23:00-midnight, perhaps on their way to a bus stop or before they take a cab home, after having a meal at one of the cafes, restaurants on WBR. More alcohol after a meal with alcohol can lead to public disorder, Anti-social behaviour, noise and nuisance, disruptions of all sorts, arguments on the pavement, in the road etc. Cabbies surely don't buy dearly priced alcohol at night at this type of shop, at least I hope they don't.

Only yesterday, 1st Aug on the NextDoor App someone posted about problems in this very area of WBR where people are using laughing gas (NSO with balloons). I attach a screen grab. This is a very growing problem of crime, ASB, litter; young children are pulled in to sell balloons on the pavement late at night, young underage children use this gas as a social cohesion play, that needs no encouragement from later hours for this shop.

The current hours for opening and the sale of alcohol are more than adequate for this area of Fulham. The 24-hr shop across is enough for the area. I oppose the extensions requested as they could cause more anti-social behaviour, more noise, more nuisance in front of the Premises, and around the Premises.

If 308 WBR sell balloons or NSO (small cylinders or large canisters/tubes) perhaps the Sub Committee could ask them to voluntarily stop selling them. This has been done recently at an off license around Fulham Broadway.

2. Hours requested for "Late Night Refreshment", ie hot food after 23:00 and before 05:00.

They are asking for 23:00-midnight, ie 1 hour to sell coffee and perhaps a bun to heat up in a microwave, or a soup. This is yet another example of 'hours creep'. Today midnight, next year 1am, then 2am etc.. This is a residential area/main road with shops and many private front doors, ie victorian terraced houses that are lived in. People need to sleep. these very residents on WBR don't need more disturbance, noise, nuisance from a shop open for another hour.

3. Floor plan changes: I oppose these because they are not necessary, expect for a small area for 'Late Night Refreshment' which must be shown on the floor plan (I understand that this will be hot

coffee/tea and a microwave, at the moment, prepared Indoors, but taken Outdoors to consume as there is no seating, at the moment). The small amount of counter space needed for the coffee/tea facility and microwave can be shown on the plan, if required by the Licensing Act (the Sub Committee will know this). And so should the Post Office area be shown.

Why not just show the entire floor as licensable?

Were the entire area to be licensed, the character of this shop could quickly or slowly change, dramatically, without any further intervention by the Licensing Authority. Right now there is a balance between the Post Office services, groceries, some fresh veg and soft drinks/alcohol. The Subcommittee will be receiving photos from another Ward Panel members.

On the current plans, Children are kept away from the hard alcohol, at present and other alcohol is in glass refrigerators.

Changing the floor plan will allow alcohol to be sold anywhere; school children will be tempted (protecting Children from Harm) and the chances of anyone of any age shoplifting (crime) will increase immediately.

Changing the floor plan will allow Late Night Refreshment to be sold from anywhere in the shop. A coffee machine and microwave need to be tended by the shopkeeper so this should be in the area of the counter/till, not all over the shop.

The shop can sell coffee and hot food before 23:00 and after 08:00 at present. I suggest the Subcommittee keep it that way to avoid any nuisance, ASB, early morning drunks coming into the shop and creating disturbance etc.

counter/till. The shop is already allowed to sell coffee and hot food before 23:00 and after 08:00 Mon-Sat and from 08:00 on Sundays.
