#### SUMMARY OF DECISION

The Committee has considered an application for the grant of a premises licence under the Licensing Act 2003 for the performance of live music, playing of recorded music and sale of alcohol only ("the Application")

In summary, the Committee has decided, after taking into account all of the individual circumstances of this case and the promotion of the four licensing objectives to:

1. Grant the Application for a time limited for 6 months only for one or two weeks in the period between September and November as follows:

# Performance of Live and Recorded Music - Indoors Only

Thursday 17:00 - 21:45 Friday 17:00 - 22:00 Saturday 11:00 - 22:00 Sunday 12:30 - 19:00

# Sale of Alcohol On the Premises

Thursday 16:00 - 22:00 Friday 16:00 - 22:00 Saturday 11:00 - 22:30 Sunday 12:30 - 19:00

2. The hours the Premises is open to public are as follows:

# Hours Open to the Public

Thursday 16:00 - 22:30 Friday 16:00 - 22:30 Saturday 11:00 - 23:00 Sunday 12:30 - 19:30

- 3. The licence is subject to any mandatory conditions.
- 4. The licence is subject to the conditions imposed by the Police and agreed by the Applicant.
- 5. The licence is subject to conditions imposed by the Committee.

This licence becomes operational with immediate effect. If problems are experienced, then an application for a review of the premises licence can be made.

A copy of this Committee's full decision including its reasons and the full text of the conditions added to the licence will be sent to the parties forthwith.

If the Applicant is unhappy with the decision, they are entitled to appeal to the magistrates' court within 21 days from the date of notification of the full decision.
