### **SUMMARY OF DECISION**

The Committee has considered an application for a new premises licence for the sale of alcohol off the premises to be granted, in respect of the Premises under the Licensing Act 2003 (“the Application”).

In summary, the Committee has decided, after taking into account all of the individual circumstances of this case and the promotion of the four licensing objectives to

1. To Grant the Application for the new Licence with the conditions agreed with the Police.
2. To add three additional conditions imposed by the Committee;
  1. All staff responsible for selling alcohol shall receive relevant training before making any unsupervised sales.
  2. All staff shall be trained in how to identify drunk or drug impaired customers.
  3. To operate a 'Challenge 25' age-restricted sales policy.

This licence becomes operational with immediate effect. If problems are experienced, then an application for a review of the premises licence can be made.

A copy of this Committee's full decision including its reasons and the full text of the conditions added to the licence will be sent to the parties forthwith.

If the Applicant is unhappy with the decision they are entitled to appeal to the magistrates' court within 21 days from the date of notification of the full decision.

### **SUMMARY OF DECISION**

No deliveries of stock to be received on Sundays
