1. THE APPLICATION

On 4 November 2022, DFSI M25 LTD ("the applicant") submitted an application to vary their premises licence in respect of the premises known as Papa Johns Pizza, 63 Walham Grove London SW6 1QR.

The premises currently benefit from a premises licence. The current premises licence permits the following:

Provision of late night refreshment - indoors only

Monday to Sunday 23:00 - 23:30

A copy of the current premises licence and plan can be seen on pages **12-17** of this report.

1.2 Application Requested

The applicant has applied to vary the hours for all licensable activities on the premises licence and add, remove and vary some conditions as outlined below:

Provision of late night refreshment - indoors and outdoors

Monday to Sunday 23:00 - 02:00

Hours open to the public

Monday to Sunday 11:00 - 02:00

A copy of the application form can be seen on pages 18-28 of this report.

1.3 Applicants Operating Schedule

The applicant has not proposed any additional steps to promote the four licensing objectives if the application is granted.

On the 01 December 2022, following correspondence received from the Police, the applicant agreed to reduce hours and add extra conditions to their licence if granted. A copy of this amendment and relevant correspondence can be seen on pages **29-33** of this report.

Agreed Hours:

The provision of late night refreshment - Both Indoors and Outdoors

Sunday- Thursday 23:00 - 00:00 Friday and Saturday 23:00 - 00:30

Hours open to the public

Sunday-Thursday 11:00 - 00:00 Friday and Saturday 11:00 - 00:30

Agreed conditions:

- 1. Signs shall be prominently displayed reminding patrons that there are residents living nearby and instructing them to respect neighbours and to conduct their behaviour accordingly.
- 2. Notices shall be prominently displayed at all exits used by delivery drivers requesting them to respect the needs of local residents and leave the area quietly
- 3. After 23:00 hours, drivers shall wait inside the premises between deliveries/for deliveries
- 4.Delivery drivers/riders will be given clear, written instructions to use their vehicles in a responsible manner so as to not cause nuisance to any residents or generally outside the licensed premises; not to leave engines running when the vehicle is parked; and not to obstruct the highway. The licence holder will positively encourage delivery drivers/riders to use quieter vehicles that are less likely to cause a nuisance such as bicycles

2. BACKGROUND

The main access to the premise's unit is located on Walham Grove at its junction with North End Road. There is a mixture of both residential and commercial premises within the area. A map showing the location of the premises and neighbouring licensed premises can be seen on pages **34-36** of this report.

There are several options for transport away from the area including buses and taxis which run from in and around the North End Road and Fulham Road area. Fulham Broadway tube station is a 5-minute walk away and Parsons Green tube station is a 10-minute walk away.

3. CONSULTATION

A public notice was displayed at the premises for 28 days. The application was advertised in a local circular and all statutory consultees were notified as required by the Regulations. The Council has served written notice of hearing upon the applicant and all those parties that have made representations in respect of the application.

3.1. Relevant Representations

The Licensing section received one representation from Cllr Ben Coleman objecting to the licence application. A copy of this representation can be seen on page **37** of this report.

The licensing section received fifteen representations from local residents objecting to the licence application. A copy of the representations can be seen on pages **38-59** of this report.

4. OTHER INFORMATION

4.1 Enforcement History

On the 27 October 2022, a warning letter was issued in response to a failed test purchase undertaken on the 21 October 2022 ascertaining unauthorised late night refreshment.

4.2 Temporary Event Notices ("TENs")

No TENs have been submitted in respect of this premises in the past twelve months.

5. POLICY CONSIDERATIONS

- **5.1** Section 5 pages 12 and 13 of the Statement of Licensing Policy ("SLP") states that in order to ensure the promotion of the four Licensing Objectives the Licensing Authority will require applicants to detail in their operating schedule:
 - the steps proposed to promote the licensing objective of the prevention of crime and disorder on, and in the vicinity of, the premises, having regard to their location, character, condition, the nature and extent of the proposed use and the persons likely to use the premises;
 - the steps proposed to ensure the physical safety of people using the relevant premises or place;
 - how they intend to prevent nuisance arising, prevent disturbance and protect amenity so far as is appropriate to ensure that the Licensing Objectives are met. Where there is a relevant representation regarding extended hours, the Licensing Authority will not permit an extension unless it is satisfied that the Licensing Objectives would be met;
 - the measures and management controls in place to protect children from harm. Where appropriate a written childcare policy should be available and be incorporated in the induction of staff.
- **5.2** Policy 1 page 18 confirms that The Secretary of State's Guidance states that applicants are expected to obtain sufficient information to enable them to demonstrate, the steps they propose to take to promote the licensing objectives; and that they understand the layout of the local area and physical environment including:
- a) crime and disorder hotspots;
- b) proximity to residential premises;
- c) proximity to areas where children may congregate;
- d) any risk posed to the local area by the applicants' proposed licensable activities; and
- e) participation in any local initiatives (for example, local crime reduction initiatives or voluntary schemes, such as 'Ask for Angela', local taxi-marshalling schemes, street pastors and other schemes) which may help to mitigate potential risks.

Applicants are expected to include positive proposals in their application on how they will manage any potential risks.

The Guidance goes on to state that 'Applicants are expected to provide licensing authorities with sufficient information in this section to determine the extent to which their proposed steps are appropriate to promote the licensing objectives in the local area. Applications must not be based on providing a set of standard conditions to promote the licensing objectives and applicants are expected to make it clear why the steps they are proposing are appropriate for the premises.'

The Licensing Authority notes the contents of these paragraphs from the Secretary of State's Guidance and, in particular, the use of the word 'expected'. Licence

applications that do not in any way address the contents of these paragraphs in their operating schedules may be returned to the applicant as 'incomplete'.

- **5.3** Policy 3 page 21 of the SLP states that where there is a relevant representation, the Licensing Authority will consider each particular case on its merits having regard in particular to the following matters:
- a) Whether the licensed activities are likely to have an adverse impact especially on local residents and, if there is potential to have an adverse impact, what, if any, appropriate measures will be put in place to prevent it;
- b) Whether there will be a substantial increase in the cumulative adverse impact from these or similar activities, on an adjacent residential area;
- c) Whether there is a suitable level of public transport accessibility to and from the premises at the appropriate times;
- d) Whether the activity will be likely to lead to a harmful and unmanageable increase in car parking demand in surrounding residential streets suffering high levels of parking stress or on roads forming part of the Strategic London Road Network or the London Bus Priority Network leading to a negative impact on the Licensing Objectives relating to the prevention of crime, disorder, anti-social behaviour (ASB), nuisance and vehicle emissions:
- e) Whether there have been any representations made by Responsible Authorities, or other relevant agency or representative.

The Licensing Authority will closely scrutinise extended hours applications to ensure that the Licensing Objectives are met. In determining an application the licensing committee might decide that the circumstances are such that a restriction on hours is the only appropriate means to achieve the Licensing Objectives. If an 'hours' restriction is imposed, the Licensing Authority will normally require that customers should be allowed a minimum of thirty minutes to consume alcohol.

To act as a guide for new or existing operators we have set out the suggested closing times for licensed premises below:

5.4 Policy 4 pages 22 and 23 of the SLP states that in determining an application where there has been a relevant representation the Licensing Authority will, where appropriate, take into account the cumulative effect of the number, type and density of licensed premises already existing in the area. Consideration will be given to the proximity to any drug and alcohol treatment site, A&E department or homeless hostel in a local area type remit ie applicants need to make the case for how they would not increase further problems for residents/clients nearby.

In coming to any decision regarding cumulative impact the Licensing Authority will consider other mechanisms outside of the licensing regime which may also be available to address this issue, these include but are not limited to:

- Police and other enforcement of the normal law concerning disorder and anti-social behaviour.
- Police powers to close down instantly any licensed premises or temporary events on grounds of disorder, the likelihood of disorder or excessive noise emanating from the premises, for up to 24 hours.
- The power of the police, other responsible authorities, a local resident, business or Councillor to seek a review of the licence or certificate in question.
- Police and Local Authority power to issue a Closure Notice for up to 48 hours where serious antisocial behaviour is taking place at licensed premises under the Anti-social Behaviour, Crime and Policing Act 2014.
- To ensure that residents are protected from the negative impact of late-night local licensing activities the Licensing Authority may decide to adopt an Area Specific Cumulative Impact Policy in relation to a specific area; where the number, type and density of premises providing licensable activities is having a serious negative impact on the local community and local amenities.
- **5.5** Policy 11 page 30 of the SLP states that Licensing law is not the primary mechanism for the general control of nuisance and anti-social behaviour caused by people once they are away from the licensed premises and, therefore, beyond the direct control of the licensee. However, licensing is a key aspect of such control and licensing law is part of a holistic approach to the management of the night time economy.

As a matter of policy the council expects every holder of a licence, certificate or permission, to accept and be responsible for minimising the impact of their activities and anti-social behaviour by their patrons within the vicinity of their premises by taking appropriate measures and action consistent with that responsibility.

Licensees and certificate holders should take reasonable steps to prevent the occurrence of crime and disorder and public nuisance immediately outside their premises, for example on the pavement, in a beer garden or in a smoking area, to the extent that these matters are within their control.

Population densities in this borough are high, with many residential premises located above or in close proximity to licensed premises. This means that the public nuisance and crime and disorder objectives will be of paramount concern when evaluating Operating Schedules. Licensing Committees will place high regard on the control measures put in place by the applicant to ensure that our residents are protected from the potential detrimental effects of any licensed premises.

- **5.6** Policy 14 pages 32 and 33 of the SLP in relation to delivery services states that the Licensing Authority has concerns with the potential for the following:
 - Age verification at both purchase point and delivery point;
 - The safety of delivery drivers at the point of delivery;
 - Safety of the premises from which orders are taken and sent out for deliver; and, Possible public nuisance and anti-social behaviour (ASB) caused by delivery drivers collecting deliveries from the licensed premises.

The Licensing Authority is likely to place the following conditions on to a premises licence for delivery services where it is appropriate and relevant to the individual licence application:

- A standard age verification check shall be undertaken on entering the website.
- A signature at the point of delivery must be obtained. No delivery shall be left without a signature.
- Alcohol shall only be delivered to a residential or business address and not to a public place.
- Every third-party courier delivery box shall be labelled with the words "Age Restricted Product".
- Any delivery driver or third-party courier will be required to have appropriate age verification training, particularly they will be required to have training in refusal of supply where age verification is not provided.
- A refusals log will be maintained for deliveries.
- Appropriate security will be in place at the premises as agreed with Police.
- Measures for minimising noise and disturbance and anti-social behaviour (ASB) caused by the dispatch of deliveries to be identified in the operating schedule. In particular applicants are expected to consider the use of electric vehicles to minimise air pollution and noise. The Licensing Authority expects that applicants will make arrangements for all deliveries after 8 pm to be made using electric vehicles or non motorised vehicles i.e. bicycles.
- A requirement for a specific delivery collection area to be made clear to any third party delivery service. This area may not be directly outside the licensed premises to take account of any residential accommodation close by or obstructing the pavement/highways.
- **5.7** Annex 1 pages 35 and 36 of the SLP in relation to the prevention of crime and disorder states licence applicants will be expected to demonstrate the following in their operating schedules:
- a) Measures to control excessive consumption and intoxication.
- b) Consideration of any additional measures or restrictions that may be placed on alcohol sales to prevent binge drinking and promote 'sensible drinking'.
- e) Measures to demonstrate compliance Home Office guidance 'Safer Clubbing' in relation to the control of illegal drugs on their premises. They should agree a protocol with the Licensing Authority and the police on the handling of illegal drugs found on their premises.
- g)Conditions will, so far as possible, reflect local crime prevention strategies, and the Licensing Authority will also have regard to the views of the local Crime and Disorder Reduction Partnership.
- h) **Crime and disorder in the vicinity of the premises**: this may include the crime and disorder risks arising from persons queuing to enter the premises; persons exiting the premises and customers smoking eating or drinking in outdoor areas and on the highway outside the premises. This can also include crime arising from pickpockets and bag snatchers, particularly in open spaces or crowded areas where alcohol is being consumed.
- j) **CCTV** using CCTV inside and/or outside the premises together with appropriate procedures and having staff properly trained to use CCTV equipment
- I) dealing with and reporting crime and disorder training for staff and door security aimed at reducing crime and disorder in the premises and its vicinity and dealing with and reporting incidents if they occur.
- p) **local schemes** joining and attending local Pubwatch meetings and participating in the Behave or Be Banned Scheme (BOBB) and/or signing up and using the Council's Safety Net Radio scheme.
- q) **prevention of theft** using bag hooks and signage to warn customers of pickpockets and bag snatchers.

- **5.7** Annex 1 pages 38 to 40 of the SLP in relation to the prevention of public nuisance states that the Licensing Authority will particularly consider the following matters where they are material to the individual application:
- i. The Licensing Authority recommends that primarily alcohol led premises such as nightclubs and pubs, located close to any residential premises, implement a dispersal policy at their venue. All relevant staff should be trained on any policy, and all Page 39 reasonable steps should be taken to ensure it is fully implemented and adhered to at all times.
- ii. The proximity of residential accommodation;
- iii. The type of use proposed, including the likely numbers of customers, proposed hours of operation and the frequency of activity;
- iv. The steps taken or proposed to be taken by the applicant to prevent noise and vibration escaping from the premises, including music, noise from ventilation equipment, and human voices. Such measures may include the installation of soundproofing, air conditioning, acoustic lobbies and sound limitation devices;
- v. The steps taken or proposed to be taken by the applicant to prevent disturbance by customers arriving at or leaving the premises.
- viii. The steps taken or proposed to be taken by the applicant to prevent queuing (either by pedestrian or vehicular traffic). If some queuing is inevitable then queues should be diverted away from neighbouring premises or be otherwise managed to prevent disturbance or obstruction;
- ix. The steps taken or proposed to be taken by the applicant to ensure staff leave the premises quietly;
- x. The arrangements made or proposed for parking by patrons, and the effect of parking by patrons on local residents;
- xi. The provision for public transport in the locality (including taxis and private hire vehicles) for patrons;
- xii. The level of likely disturbance from associated vehicular and pedestrian movement to and from the premises;
- xiii. The delivery and collection areas and delivery/collection times;
- xv. The arrangements for refuse disposal, storage and the prevention/tidying of litter (including fly posters and illegal placards);
- xviii. The generation of odour, e.g. from the preparation of food;
- xix. Any other relevant activity likely to give rise to nuisance;
- xx. Any representations made by the Police, or other relevant agency or representative;

The following provides a non-exhaustive list of risks associated with the public nuisance objective that applicants may want to consider when preparing their Operating Schedule:

- j) **Deliveries/collections** noise from deliveries to and/or collections (e.g. refuse) from the premises are another common source of complaint. Consider the times of such deliveries/collections and make sure you specify to any contractors that deliveries/collections should not be made at anti-social times. As a guide, the Noise and Nuisance Service recommend that deliveries/collections should only be made between the hours of 7:30am and 9:00pm, depending on the proximity of residential and/or other noisesensitive properties.
- k) Late night refreshment applicants in respect of late night takeaways should demonstrate that they have assessed the risk of persons congregating in large numbers in

the vicinity of their premises. Where appropriate, applicants should demonstrate suitable measures to address this problem.

- I) **Light pollution** this is an increasingly common source of complaint, particularly from illuminated signs and external security lighting. Where provided, illuminated signs should not cause glare to neighbouring properties, ideally being turned off at night, and external lighting should be angled and/or diffused to also prevent nuisance.
- o) **Odour** odour from cooking is a common source of complaint, particularly from restaurants and fast[1]food takeaways. The Council's Noise and Nuisance Service may therefore require evidence that the kitchen ventilation and/or extract systems are regularly maintained and serviced to ensure that it is operating efficiently and with minimal nuisance to neighbours arising from odour and also noise. This includes the siting of BBQs.
- p) **Queue management** establishing appropriate procedures to avoid the need for customers to queue before entering the premises or, where queuing cannot be avoided, to manage queues so as to minimise the potential for crime and disorder or public nuisance by customers who are queuing.
- q) **Ventilation** where regulated entertainment is to be provided there may be a requirement to keep doors and/or windows closed during its provision to limit noise breakout, consider therefore the provision of air conditioning for the comfort of your customers if doors and windows have to be closed during the summer. However, also note air conditioning can be the source of noise complaints in itself, so careful consideration also needs to be given to the siting of this equipment.
- r) **Waste** consider how and where waste will be stored/disposed of at the end of trading hours, particularly if trading until late at night. This is important because the disposal of glass and/or cans to outside bin areas can be very noisy and give rise to complaints, so it may be necessary to store such items and other non-degradable refuse inside the premises until the next trading day. Consideration should also be given to the time of deliveries to minimize disruption to local residents.
- s) Litter for example, litter patrols for late night take-away premises

6. DETERMINATION

- **6.1** In determining this application, the Committee must have regard to the representations and take such of the following steps as it considers necessary for the promotion of the licensing objectives. The steps are:
- (a) Grant the application in full
- (b) Grant the application in part modifying the proposed hours, activities or conditions.
- (c) Reject the application

It is the Council's duty under the Licensing Act 2003 ("The Act") to determine applications with a view to promoting the four licensing objectives; Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance and the Protection of Children from Harm.

In reaching a decision the Council shall consider the details of any relevant representations received; the applicant's Operating Schedule; the Council's adopted Statement of Licensing Policy and the guidance issued by the Secretary of State under section 182 of the Act.

If the Committee is minded to grant the application conditions may be attached to the licence to alleviate the concerns raised through the representations.



My name is Kris Cardwell, I am one of two Police Licensing Officers that cover the Borough of Hammersmith and Fulham, the other is my colleague Nicole Sondh. I can confirm that the Metropolitan Police are in receipt of the premises licence application for Papa John's Pizza 63 Walham Grove London SW6 1QR as detailed below:-

It is also situated at the end of a residential street and is the gathering place for a number of delivery riders who park their vehicles directly opposite the premises. These later hours of licensable activity would undoubtedly create general issues that may disrupt local residents. I have copied in Noise and Nuisance Officers from the Local Authority for any comment.



Most shocking is that this cheap food outlet and its cusomers do not care about the environment.. Papa John's has little indoor-seating, customers eat in their car (radio on!) and alhough there is a bin on the corner of Walham Grove, food rests and pizza cartons are left in the street. A street sweeper told us having seen mice around Papa John's many bins along their Walham Grove facade that remain there for days.

Nightly hours attract all sorts of people and I can testify that Walham Grove has become a drug street.

I had a drug dealer and his customer inside my front garden who menaced me with breaking in, torture and even death (sic) when I asked him to leave the premises. I emailed the police but got no reply.

In 2016 there was a deadly shooting in front of the Jerky Kitchen, drug related? and there are regularly incidents (disorder, ASB) around Papa John's. We regularly find big laughing gas cylinders on our doorstep left by gangs of youngsters gathering there late at night/early in the morning. We are obliged to lock the front garden gate from Thursday night till Monday morning as we fear for our safety (we are 70+).

In the light of the above comment, we therefore object the application, as it constitutes an unneighbourly demand to extend nightly opening hours and respectfully request the Council that it be refused.

Papa John's 63 Walham Grove SW6 1QR APPLICATION 2022/01816/LAPR to extend hours for 'Late Night Refreshment' - hot food only (not alcohol) from the present allowed 23:30, to 02:00, Mon-Sun.

Dear Chair,

I am, and have been for 20 years, a resident of Tournay Road in Fulham (address given below). The purpose of this email to you is to, in the clearest terms, object to this application - 2022/01816/LAPR.

Background

Walham Grove is a fully residential road except for a couple of shops at the junction with the North End Road. It is typical of the vast majority of roads in this heavily and predominantly residential area. Tournay Road, where I live, is the same. This means that within metres of these premises are houses, flats, apartments, homes to people of all ages, backgrounds, and families. Tournay Road is a two-minute walk from the Applicant's site.

Public Nuisance

The last three years have seen the rise of the delivery economy and with-it huge numbers of delivery/dispatch motorbike rider on the streets. In this area of Fulham this has led to large numbers of such riders congregating on our roads from very early in the morning to late at night. This development has brought with is an immense number of problems principally 7 days a week noise and nuisance and a range of anti-social behaviour. Just yesterday I witnessed one such rider, dismount his motorbike, urinate next to an old phone box on Tournay Road before walking to Greggs to collect a delivery. We have had problems because they ride their bikes on the pavements, litter constantly after they have eaten and before jumping to take the next job (they have not time to find a bin), and because the ethnic minorities that typically account for the majority of this segment of the workforce do not always see eye to eye and scuffles and fights have all been witnessed by me and my children in the last 12 months. As you will appreciate the roads that we are talking about are double parked. Residents have had their cars scratched and dented by dispatch riders taking risks and playing a game of speed roulette as the refuse to stop and refuse to drive with due care and attention through small gaps and spaces.

However, the undoubted core problem is noise. Leaving aside that the dispatch riders rarely comply with the 20 mph speed limit (which is never enforced by speed camaras), ignoring that none (literally zero) are electric bikes and very few are bicycles, ignoring the desperate rush that the riders are in as they are rewarded for delivering in under 20 minutes and earn bonuses by fulfilling deliveries in the quickest possible time, the real issue is that after our children have gone to bed, when the elderly are trying to rest and after we adults have gone to bed, roads like

Walham Grove and Tournay Road are the regular runs for these dispatch riders. Time and time again, night after night they wake up residents, school age children, the elderly and those other adults who have returned home after a (often long) day at work expecting the simple right to rest and sleep. Children are a particular issue and concern here especially as regards the impact on school and educational attainment.. They need a simple but guaranteed amount of sleep if they are perform at school and lead a healthy lifestyle. Broken sleep deprives them of the deep unbroken sleep that their brains and bodies need to develop. The science to support this is, I understand, undeniable.

Please also note that we have submitted noise and nuisance complaint earlier this year regarding Papa Johns (reference LBHF FS-Case 457 456 110 (9/10/22). This related to the fact that they already trade beyond their permitted hours and wilfully disregard the rules and the position of residents. There is evidence that online they already breach the existing licence and I have witnessed the sale of hot food after 23:30 without a licence. Sadly, I have witnessed the reality that the Applicant cannot encourage nor enforce best practice where they use third party delivery companies to fulfil their orders i.e. use of electric motorbikes. Nor is there any space inside (it is very restricted) the premises for delivery drivers who wait to collect orders. Preventing noise and nuisance in these circumstances is just not feasible. This is also relevant to issues of Public Disorder.

Crime and Public Disorder

The simple truth is that extended hours will create, and add to, unacceptable disturbance, noise, nuisance, anti-social behaviour, and crime in our road and beyond. I have not focussed on crime, but I have witnessed that where the riders meet and congregate there is also an attendant following of sellers and young people, groups form, and loud and aggressive language can be heard whilst we lie awake in our beds. I have seen drivers open the very packages that they are entrusted to deliver, and which punters have paid for, to take out and eat the contents before that drive off. This week, when road works are being caried on the road (so the road is closed) I have witnessed numerous dispatch riders drive dangerously at speed along the pavements – very few/virtually none dismount and walk their motorbikes. The facts speak for themselves:

- In 2016 we had a deadly shooting outside JK Kitchen, just down from Papa John's; In 2018 the offender was jailed for life;
- Our part (the North End Road) of Fulham continues to suffer from a high amount of crime and disorder and anti-social behaviour, mainly at night. The local Ward police attest to this, and Licensing Police continue to confirm this in recent applications on and around North End Road and Fulham Broadway.

Against this backdrop as residents, we welcome and embrace LBHF's efforts to revive the North End Road market including plans for daytime and some early evening events (we have a Christmas market taking place in the next fortnight). Critically there is no plan by LBHF to even begin to establish a night-time economy in this area. Why would they as it is dominated by a residential area? This means that the majority of those who live here are entitled to expect actions consistent with there being no development of a late night and early hours economy.

Extended hours run counter to and fly in the face of this policy, the safety of residents and the quiet enjoyment of a fundamentally residential area.

MacDonalds (that has a record of engaging "bouncer-like" staff at peak night times because of the numerous disturbances that have occurred outside their site). They stay open until midnight, which we think is already too late for residents trying to sleep, especially children. The attendant crime issues are a continual worry for all of us in a fundamentally residential area.

The Applicant has not outlined any specific or general noise, nuisance, or ASB mitigation measures in the application. What will they take responsibility for? They simply ask for hours to 02:00 without any consideration of or regard to the impact of those who live "on the doorstep". This cannot be right in a residential area and I submit that a balanced and proportionate view must be taken by them with regard to all relevant interest.

Please reject this application on the grounds of inability to promote the four licensing objectives, especially considering the already high levels of crime, noise nuisance, emissions nuisance, and anti-social behaviour in and around Walham Grove. I rely heavily on the precedent set by the decision of the Licensing Sub-Committee on 27 July 2022 in the case of Selekt Chicken at 349 North End Road. The issues raised above remain the case as regards any extension past 23:30 (it makes no difference if the time runs to 02:00 or even 01:00). Our real concerns remain. This generates grave concerns about the Applicants integrity and honesty.

If a hearing is held for the LBHF Licensing Sub-Committee to consider this Application, and I am unable to attend, please note that I yield my five minutes to my fellow residents Charlotte Dexter or Lucilla Royden or her representative as the case may be.

We are writing to object to the request for hours to be extended for Late Night Refreshment (not alcohol) from the existing 23:30 to 02:00 on the grounds of crime, ASB, noise nuisance, emissions nuisance, vehicle collision nuisance, and public safety.

This area of North End Road has a lot of Crime and ASB, especially as the night and early morning draw on.

It has been confirmed to us that it is up to 'other interested parties' to use the hearing process as the ONLY valid means to alert the LBHF Licensing Committee, through its Sub-Committee convened for a specific hearing, of reasonable and proportionate concerns that affect 100 percent Fulham residential roads in the immediate area as well as within an approximate 10-20-minute motorbike delivery ride of the Premises at 63 Walham Grove/at Vanston Place and North End Road.

1) Existing 4 conditions no longer robust enough

The existing licence has four very minimal conditions, as below. These are no longer robust enough for hours after 23:30.

Unfortunately, the Applicant has not addressed the severe crime problems around this area, and right at their front door, especially the undercurrent of drug deals and resale of shoplifted items directly on the pavement.

The Applicant has simply applied for longer hours; valid, but very concerning to neighbours all around that the Applicant has suggested nothing from its side.

Existing conditions:

- 1. All staff shall be trained to understand the four licensing objectives.
- 2. Notices shall be displayed requesting customers to leave the premises quietly.
- 3. Regular litter patrols shall take place around the external area of the premises.
- 4. CCTV systems shall be in operation at the premises.

We have been in conversation with Responsible Authorities asking them to suggest more robust conditions, were the hours to be extended.

For that matter, even at the existing closing time of 23:30 more robust conditions re cctv are needed to monitor actual closing times (we hear from neighbours and police that there are known breaches of this closing time), as well as to help police investigations in the area as this very corner location sits at three roads intersecting the borders of Fulham Broadway. Could the Sub-Committee pls consider this and itself suggest more robust Conditions?

2) Area suffers much crime, ASB

The police continue to acknowledge in recent and ongoing Applications for nearby premises on North End Road as well as Fulham Road that this area suffers from much crime and ASB especially towards the hours of midnight and beyond. We ask the Sun-Committee to take this into account.

3) Closing doors to a takeaway from 23:00?

I would remind the Committee that Domino's Pizza not far away at the intersection of North End Road with Fulham Road voluntarily closes its doors to takeaway at 23:00 due to the dangers, ASB and crime they have experienced of drunk people being overly aggressive inside, threatening staff, not paying, physical fights ensuing etc. Would the Applicant consider similar?

4) Noise nuisance, Emissions nuisance, Vehicle collision nuisance

These are escalating problems that are growing by the day, and night. Very specifically to the road named Walham Grove, delivery motorbikes use it as a convenient rat run, zooming at great speed. Those needing to go more in the opposite direction zoom down Tournay Road at lightning speed. The later the hour, the clearer the roads are of moving traffic (and pavement is void but for a few residents returning home or walking dogs) and so, the faster and noisier they zoom to their delivery address further beyond Tournay Road.

Vehicle collision nuisance:

This is a new-found problem, never anticipated by the 2003 Licensing Act as delivery motorbikes have fun banging car mirrors shut as they zoom along, or clipp ng sides of cars etc. Their creativity is endless.

The Walham Grove as well as Tournay Road residents will be explaining in detail and Env noise/nuisance will be commenting.

I reserve my right to comment further as information is being gathered for a possible hearing on this Application.
