SUMMARY OF DECISION

The Committee has considered an application for a new premises licence for the sale of alcohol both on and off the premises and late-night refreshment indoors under the Licensing Act 2003 ("the Application").

In summary, the Committee has decided, after taking into account all of the individual circumstances of this case and the promotion of the four licensing objectives to

1. Grant the Application
2. Subject the licence to the conditions imposed by the Police, conditions agreed by the Applicant and the following conditions added by the Committee:

No service to be provided externally Monday to Friday before 6pm during the term time of Sacred Heart High School. Tables and chairs to be removed outside of the Licensed hours.

This licence becomes operational with immediate effect. If problems are experienced, then an application for a review of the premises licence can be made.

A copy of this Committee's full decision including its reasons and the full text of the conditions added to the licence will be sent to the parties forthwith.

If the Applicant is unhappy with the decision, they are entitled to appeal to the magistrates' court within 21 days from the date of notification of the full decision.

SUMMARY OF DECISION

The Committee has considered an application for the variation of a premises licence to amending conditions 37, 45 and 46 of the existing Licence under the Licensing Act 2003 ("the Application").

In summary, the Committee has decided, after taking into account all of the individual circumstances of this case and the promotion of the four licensing objectives to

1. Grant the Application in part by amending conditions 37 and 45 of the Premises Licence
2. Modify the conditions as set out below:-

Condition 37 - The number of persons seated in the external customer areas of the premises shall be limited to 68.

Condition 45 - Alcohol shall not be sold on the Premises otherwise than to persons taking table meals there or to persons participating in or attending events, films, productions or exhibitions at the Premises. No vertical drinking shall be permitted in the external restaurant area.

This licence becomes operational with immediate effect. If problems are experienced, then an application for a review of the premises licence can be made.

A copy of this Committee's full decision including its reasons and the full text of the conditions added to the licence will be sent to the parties forthwith.

If the Applicant is unhappy with the decision, they are entitled to appeal to the magistrates' court within 21 days from the date of notification of the full decision.
