## 2. DECLARATIONS OF INTEREST

If a Councillor has a disclosable pecuniary interest in a particular item, whether or not it is entered in the Authority's register of interests, or any other significant interest which they consider should be declared in the public interest, they should declare the existence and, unless it is a sensitive interest as defined in the Member Code of Conduct, the nature of the interest at the commencement of the consideration of that item or as soon as it becomes apparent.

# 1. THE APPLICATION

On 20<sup>th</sup> February 2023 Matthew Phipps of TLT Solicitors submitted an application on behalf of Yummy Pubs Limited ("the applicant") for a new premises licence to be granted in respect of the premises known as the 206-208 Hammersmith Road, London, W6 7DH

#### 1.1 Application Requested

The applicant has applied for a new premises licence for the sale of alcohol both on and off the premises and late night refreshment indoors as detailed below:

#### Licensable activities sought

<u>The Sale of Alcohol - Both On and Off the Premises</u> Mondays to Sundays between the hours of 10:00 to 00:00

<u>Provision of Late Night Refreshment - Indoors Only</u> Mondays to Sundays between the hours of 23:00 to 00:00

Non Standard Timings: From the end of permitted hours on New Year's Eve until 02.00 hours on New Year's Day.

<u>Opening Hours of the Premises</u> Mondays to Sundays between the hours of 08:00 to 00:30

A copy of the application form, plan and business proposal can be seen on pages 14-54 of this report.

#### **1.2 Applicants Operating Schedule**

The applicant has proposed a number of steps to promote the four licensing objectives if the application is granted. A copy of the proposed conditions can be seen on page 17-18 of this report.

On 7<sup>th</sup> March 2023, following correspondence received from the Police, the applicant agreed to add one further condition to the licence, if granted. A copy of this correspondence can be seen on pages 54-56 of this report.

#### 2. BACKGROUND

The premises proposes to operate as bar/ restaurant. The main access to the premises is located on Hammersmith Road. There is a mixture of both residential and commercial premises within the area. A map showing the location of the premises and neighbouring licensed premises can be seen on pages 57-61 of this report.

There are several options for transport away from the area including buses and taxis which run from in and around the Hammersmith Broadway area. Hammersmith tube

stations are a 2-minute walk away, Ravenscourt Park and Barons Court tube stations are a 14-minute walk away.

# 3. CONSULTATION

A public notice was displayed at the premises for 28 days. The application was advertised in a local circular and all statutory consultees were notified as required by the Regulations. The Council has served written notice of hearing upon the applicant and all those parties that have made representations in respect of the application.

# 3.1. Relevant Representations

The licensing section received 1 representation from Sacred Heart School, objecting to the licence application. A copy of this representation can be seen on pages 62-64 of this report.

# 4. OTHER INFORMATION

### 4.1 Enforcement History

There have not been any warnings, simple cautions or prosecutions given in respect of the premises during the past three years.

# 4.2 Temporary Event Notices ("TENs")

No TENs have been submitted in respect of this premises in the past twelve months.

# 5. POLICY CONSIDERATIONS

**5.1** Section 5 pages 12 and 13 of the Statement of Licensing Policy ("SLP") states that in order to ensure the promotion of the four Licensing Objectives the Licensing Authority will require applicants to detail in their operating schedule:

- the steps proposed to promote the licensing objective of the prevention of crime and disorder on, and in the vicinity of, the premises, having regard to their location, character, condition, the nature and extent of the proposed use and the persons likely to use the premises;
- the steps proposed to ensure the physical safety of people using the relevant premises or place;
- how they intend to prevent nuisance arising, prevent disturbance and protect amenity so far as is appropriate to ensure that the Licensing Objectives are met. Where there is a relevant representation regarding extended hours, the Licensing Authority will not permit an extension unless it is satisfied that the Licensing Objectives would be met;
- the measures and management controls in place to protect children from harm. Where appropriate a written childcare policy should be available and be incorporated in the induction of staff.

5.2 Policy 1 page 18 of the SLP states that applicant are to undertake a local risk assessment as part of the licence application. The Secretary of State's Guidance states that applicants are expected to obtain sufficient information to enable them to

demonstrate, the steps they propose to take to promote the licensing objectives; and that they understand the layout of the local area and physical environment including:

a) crime and disorder hotspots;

b) proximity to residential premises;

c) proximity to areas where children may congregate;

d) any risk posed to the local area by the applicants' proposed licensable activities; and

e) participation in any local initiatives (for example, local crime reduction initiatives or voluntary schemes, such as 'Ask for Angela', local taxi-marshalling schemes, street pastors and other schemes) which may help to mitigate potential risks.

Applicants are expected to include positive proposals in their application on how they will manage any potential risks.

The Guidance goes on to state that 'Applicants are expected to provide licensing authorities with sufficient information in this section to determine the extent to which their proposed steps are appropriate to promote the licensing objectives in the local area. Applications must not be based on providing a set of standard conditions to promote the licensing objectives and applicants are expected to make it clear why the steps they are proposing are appropriate for the premises.

**5.2** Policy 3 page 21 of the SLP states that where there is a relevant representation, the Licensing Authority will consider each particular case on its merits having regard in particular to the following matters:

a) Whether the licensed activities are likely to have an adverse impact especially on local residents and, if there is potential to have an adverse impact, what, if any, appropriate measures will be put in place to prevent it;

b) Whether there will be a substantial increase in the cumulative adverse impact from these or similar activities, on an adjacent residential area;

c) Whether there is a suitable level of public transport accessibility to and from the premises at the appropriate times;

d) Whether the activity will be likely to lead to a harmful and unmanageable increase in car parking demand in surrounding residential streets suffering high levels of parking stress or on roads forming part of the Strategic London Road Network or the London Bus Priority Network leading to a negative impact on the Licensing Objectives relating to the prevention of crime, disorder, anti-social behaviour (ASB), nuisance and vehicle emissions;

e) Whether there have been any representations made by Responsible Authorities, or other relevant agency or representative.

The Licensing Authority will closely scrutinise extended hours applications to ensure that the Licensing Objectives are met. In determining an application the licensing committee might decide that the circumstances are such that a restriction on hours is the only appropriate means to achieve the Licensing Objectives. If an 'hours' restriction is imposed, the Licensing Authority will normally require that customers should be allowed a minimum of thirty minutes to consume alcohol.

To act as a guide for new or existing operators we have set out the suggested closing times for licensed premises below:

Type of premises		Residential areas
Restaurants and cafes	Mon - Thurs 01:00	 Fri – Sat 23:00 Sun – 22:00
Public houses, bars, or other drinking establishments	Mon - Thurs 01:00	Fri – Sat 23:00 Sun – 22:00

**5.3** Policy 4 pages 22 and 23 of the SLP states that in determining an application where there has been a relevant representation the Licensing Authority will, where appropriate, take into account the cumulative effect of the number, type and density of licensed premises already existing in the area. Consideration will be given to the proximity to any drug and alcohol treatment site, A&E department or homeless hostel in a local area type remit ie applicants need to make the case for how they would not increase further problems for residents/clients nearby.

In coming to any decision regarding cumulative impact the Licensing Authority will consider other mechanisms outside of the licensing regime which may also be available to address this issue, these include but are not limited to:

- Planning controls (where development or change of use is involved, or where trading hours are limited by planning conditions)
- Police and other enforcement of the normal law concerning disorder and antisocial behaviour.
- Police powers to close down instantly any licensed premises or temporary events on grounds of disorder, the likelihood of disorder or excessive noise emanating from the premises, for up to 24 hours.
- The power of the police, other responsible authorities, a local resident, business or Councillor to seek a review of the licence or certificate in question.
- Police and Local Authority power to issue a Closure Notice for up to 48 hours where serious antisocial behaviour is taking place at licensed premises under the Anti-social Behaviour, Crime and Policing Act 2014.
- To ensure that residents are protected from the negative impact of late-night local licensing activities the Licensing Authority may decide to adopt an Area Specific Cumulative Impact Policy in relation to a specific area; where the number, type and density of premises providing licensable activities is having a serious negative impact on the local community and local amenities.

**5.4** Policy 11 page 30 of the SLP states that Licensing law is not the primary mechanism for the general control of nuisance and anti-social behaviour caused by people once they are away from the licensed premises and, therefore, beyond the direct control of the licensee. However, licensing is a key aspect of such control and licensing law is part of a holistic approach to the management of the night time economy.

As a matter of policy the council expects every holder of a licence, certificate or permission, to accept and be responsible for minimising the impact of their activities and anti-social behaviour by their patrons within the vicinity of their premises by

taking appropriate measures and action consistent with that responsibility. Licensees and certificate holders should take reasonable steps to prevent the occurrence of crime and disorder and public nuisance immediately outside their premises, for example on the pavement, in a beer garden or in a smoking area, to the extent that these matters are within their control.

Population densities in this borough are high, with many residential premises located above or in close proximity to licensed premises. This means that the public nuisance and crime and disorder objectives will be of paramount concern when evaluating Operating Schedules. Licensing Committees will place high regard on the control measures put in place by the applicant to ensure that our residents are protected from the potential detrimental effects of any licensed premises.

**5.5** Policy 15 page 33 of the SLP in relation to drink spiking issues states that licensees and licence applicants are encouraged to establish a clear approach to preventing, identifying and addressing drink spiking in their operating schedules. This should include, but is not limited to:

• Training for door and bar staff to identify where drink spiking may be taking place, how to respond to any reported or observed instances of drink spiking, and how to report to Police.

• Offering drink spiking preventative measures, such as drink covers, serving drinks direct to customers (not leaving these unattended before being provided to customers), and keeping an eye on or clearing drinks left unattended.

• Providing customers with information on keeping safe from drink spiking.

• Operating schemes such as 'Ask for Angela' to encourage customers to seek help if they suspect drink spiking has occurred.

• Requiring the production of a drink spiking risk assessment and procedure for dealing with any such incidents.

• Displaying posters in visible locations at the premises to explain what to do in the event of a spiking incident / what a spiked drink looks like.

**5.6** Policy 16 pages 33 and 34 of the SLP in relation to the safety of women and girls in licensed settings states the Licensing Authority will use its powers to regulate the night-time economy, both with specific regard to spiking incidents and more generally in relation to violence against women and girls. This may include:

a) Using the Licensing Authority's powers to impose conditions or revoke premises licenses, where venues do not take sufficient measures to protect and provide support to customers in spiking incidents;

b) Considering the prevalence, prevention and reporting of sexual harassment and misconduct and gender-based violence in licensed premises.

c) Requiring the presence of suitably trained and accredited door staff,

d) Require presence of CCTV, or to introduce entry searches for example.

Licence applicants and existing licence holders are encouraged to include in their operating schedules clear polices relating to potential abuse or violence against women and girls.

This would include, but is not limited to the 'Ask for Angela' programme, Welfare and Vulnerability Engagement' training package (WAVE) for staff to identify and assist women and girls being at risk or being subjected to violence, and the implementation

of clear policies in the premises on preventing and addressing violence against women and girls

**5.7** Annex 1 pages 35 and 36 of the SLP in relation to the prevention of crime and disorder states licence applicants will be expected to demonstrate the following in their operating schedules:

a) Measures to control excessive consumption and intoxication.

b) Consideration of any additional measures or restrictions that may be placed on alcohol sales to prevent binge drinking and promote 'sensible drinking'.

e) Measures to demonstrate compliance Home Office guidance 'Safer Clubbing' in relation to the control of illegal drugs on their premises. They should agree a protocol with the Licensing Authority and the police on the handling of illegal drugs found on their premises.

g) Conditions will, so far as possible, reflect local crime prevention strategies, and the Licensing Authority will also have regard to the views of the local Crime and Disorder Reduction Partnership.

h) **Crime and disorder in the vicinity of the premises**: this may include the crime and disorder risks arising from persons queuing to enter the premises; persons exiting the premises and customers smoking eating or drinking in outdoor areas and on the highway outside the premises. This can also include crime arising from pickpockets and bag snatchers, particularly in open spaces or crowded areas where alcohol is being consumed.

j) **CCTV** - using CCTV inside and/or outside the premises together with appropriate procedures and having staff properly trained to use CCTV equipment.

k) dispersal procedures - establishing appropriate dispersal procedures to minimise the potential for crime and disorder when customers are leaving the premises.

I) **dealing with and reporting crime and disorder** - training for staff and door security aimed at reducing crime and disorder in the premises and its vicinity and dealing with and reporting incidents if they occur.

m)**door staff** - considering whether the premises employs a sufficient number of SIA registered door staff, whether Door Premises Supervisors check the legitimacy of the badges and whether SIA staff display their badges prominently. (Note: All door supervisors must be Security Industry Authority (SIA) registered).

n) **drugs and weapons** - ensuring compliance with relevant guidance regarding illegal drugs and weapons. Attention should be paid to search procedures, procedures for the safe storage and surrender of seized drugs and weapons and drug awareness issues, designing out the ability to take drugs in the premises, etc.

o) **excessive drinking** - training for staff to recognise when customers are becoming drunk and adopting appropriate 'cut off' procedures for drunken customers, so as to reduce the likelihood of fights or aggressive behaviour.

p) **local schemes** – joining and attending local Pubwatch meetings and participating in the Behave or Be Banned Scheme (BOBB) and/or signing up and using the Council's Safety Net Radio scheme.

**5.8** Annex 1 pages 37 to 38 of the SLP in relation to public safety states that the Licensing Authority will require the applicant to demonstrate the steps proposed to ensure the physical safety of people using the relevant premises or place. This does not cover the separate need for applicants to provide relevant public safety requirements dealt with by Environmental Health. This is expected to include:

a) Maximum occupancy limits will be specified on the licence only where necessary for the promotion of public safety or the prevention of disorder. Where a capacity limit is already specified in a fire risk assessment, the Licensing Authority will not normally include that limit as a licence condition.

c) The Licensing Authority will, where appropriate, attach conditions to a licence to ensure public safety, dealing with, but not limited to. the following:

i. Checks on equipment at specified intervals, e.g. gas safety checks;

ii. Standards to be maintained, e.g. temporary electrical installations to comply with British Standards;

iii. The number of people on the premises to ensure it is appropriate having regard to the activities taking place and reliable ways of counting the number;

iv. The steps taken to manage the risk from glass, the use of bottle bins, glass collectors and door supervisors to prevent glass being taken off the premises;

v. The use of door supervisors to manage the entrance and exit from the premises and to protect public safety as customers leave the premises;

vi. The provision of air conditioning and ventilation;

vii. Measures to protect against overcrowding; and

viii. Implement access/support needs for disabled people

The following provides a non-exhaustive list of risks associated with the public safety objective that applicants may want to consider when preparing their Operating Schedule:

e) **incident and occurrence book** – keeping an incident book on the premises so staff can record any instances of crime, disorder, refused sales, ejections and intimidating behaviour.

g) **getting home safely -** providing information to customers and staff (including contact telephone numbers) regarding safer options available for travelling home late at night - including night buses, licensed taxis and private hire (mini-cabs).

h) **overcrowding** - developing policies and procedures regarding capacity to prevent overcrowding and patrons possibly becoming aggressive.

i) **premises environment -** applicants should consider the physical environment of the premises and have regard to issues that could increase the likelihood of patrons becoming agitated or aggressive. This may include procedures regarding door supervision, identification and management of drunken customers and issues of overcrowding and capacity, which may result in patrons becoming aggressive or rowdy.

**5.9** Annex 1 pages 38 to 40 of the SLP in relation to the prevention of public nuisance states that the Licensing Authority will particularly consider the following matters where they are material to the individual application:

i. The Licensing Authority recommends that primarily alcohol led premises such as nightclubs and pubs, located close to any residential premises, implement a dispersal policy at their venue. All relevant staff should be trained on any policy, and all reasonable steps should be taken to ensure it is fully implemented and adhered to at all times.

ii. The proximity of residential accommodation;

iii. The type of use proposed, including the likely numbers of customers, proposed hours of operation and the frequency of activity;

iv. The steps taken or proposed to be taken by the applicant to prevent noise and vibration escaping from the premises, including music, noise from ventilation

equipment, and human voices. Such measures may include the installation of soundproofing, air conditioning, acoustic lobbies and sound limitation devices;

v. The steps taken or proposed to be taken by the applicant to prevent disturbance by customers arriving at or leaving the premises.

viii. The steps taken or proposed to be taken by the applicant to prevent queuing (either by pedestrian or vehicular traffic). If some queuing is inevitable then queues should be diverted away from neighbouring premises or be otherwise managed to prevent disturbance or obstruction;

ix. The steps taken or proposed to be taken by the applicant to ensure staff leave the premises quietly;

x. The arrangements made or proposed for parking by patrons, and the effect of parking by patrons on local residents;

xi. The provision for public transport in the locality (including taxis and private hire vehicles) for patrons;

xii. The level of likely disturbance from associated vehicular and pedestrian movement to and from the premises;

xv. The arrangements for refuse disposal, storage and the prevention/tidying of litter (including fly posters and illegal placards);

xix. Any other relevant activity likely to give rise to nuisance;

xviii. The generation of odour, e.g. from the preparation of food;

xix. Any other relevant activity likely to give rise to nuisance;

xx. Any representations made by the Police, or other relevant agency or representative;

The following provides a non-exhaustive list of risks associated with the public nuisance objective that applicants may want to consider when preparing their Operating Schedule:

j) **Deliveries/collections** – noise from deliveries to and/or collections (e.g. refuse) from the premises are another common source of complaint. Consider the times of such deliveries/collections and make sure you specify to any contractors that deliveries/collections should not be made at anti-social times. As a guide, the Noise and Nuisance Service recommend that deliveries/collections should only be made between the hours of 7:30am and 9:00pm, depending on the proximity of residential and/or other noise sensitive properties.

I) **Light pollution** – this is an increasingly common source of complaint, particularly from illuminated signs and external security lighting. Where provided, illuminated signs should not cause glare to neighbouring properties, ideally being turned off at night, and external lighting should be angled and/or diffused to also prevent nuisance.

m)**Noise and/or vibration** breakout from the provision of regulated entertainment, particularly from (but not limited to) live music – consider what type of entertainment is to be provided, in what room/area of the premises and the suitability of the construction of this room/area to contain sound. Windows are a particular weak-point for noise break-out so consider providing regulated entertainment in a room without windows or with as few windows as possible, particularly windows that face towards nearby 40 residential properties. Where suitable, install a lobby to prevent spillage of noise each time an entrance/exit door is opened.

o) **Odour** – odour from cooking is a common source of complaint, particularly from restaurants and fastfood takeaways. The Council's Noise and Nuisance Service may therefore require evidence that the kitchen ventilation and/or extract systems are regularly maintained and serviced to ensure that it is operating efficiently and with

minimal nuisance to neighbours arising from odour and also noise. This includes the siting of BBQs.

p) **Queue management** - establishing appropriate procedures to avoid the need for customers to queue before entering the premises or, where queuing cannot be avoided, to manage queues so as to minimise the potential for crime and disorder or public nuisance by customers who are queuing.

q) **Ventilation** – where regulated entertainment is to be provided there may be a requirement to keep doors and/or windows closed during its provision to limit noise breakout, consider therefore the provision of air conditioning for the comfort of your customers if doors and windows have to be closed during the summer. However, also note air conditioning can be the source of noise complaints in itself, so careful consideration also needs to be given to the siting of this equipment.

r) **Waste** – consider how and where waste will be stored/disposed of at the end of trading hours, particularly if trading until late at night. This is important because the disposal of glass and/or cans to outside bin areas can be very noisy and give rise to complaints, so it may be necessary to store such items and other non-degradable refuse inside the premises until the next trading day. Consideration should also be given to the time of deliveries to minimize disruption to local residents.

s) Litter – for example, litter patrols for late night take-away premises.

5.10 Annex 1 pages 40 to 41 of the SLP in relation to the protection of children from harm states that the Licensing Authority will require operating plans to specify the measures and management controls in place to protect children from harm. Where appropriate a written childcare policy should be available and be incorporated in the induction of staff. This is expected to include:

a) The legislation recognises the right of licence holders (serving alcohol) to allow accompanied children into their premises at any time. The Licensing Authority will not normally seek to limit their access (above that specified in the Act) to any premises unless it is necessary for the prevention of physical, moral or psychological harm, or where there are concerns about child sexual exploitation. Where this is considered likely, upon consideration of a relevant representation, conditions will be imposed that restrict children from entering all or part of licensed premises: i. At certain times of the day; ii. When certain licensable activities are taking place; iii. Under certain ages, e.g. 16 or 18; iv. Unless accompanied by an adult.

b) The Licensing Authority will particularly consider whether:

i. There is entertainment or services of an adult nature commonly provided;

ii. There have been convictions, Penalty Notices for Disorder (PND) or cautions for serving alcohol to minors or premises with a reputation for under-age drinking;

iii. There is a known association with drug taking or dealing;

iv. There is a significant element of gambling on the premises;

v. There is a presumption that children under 18 should not be allowed (e.g. to nightclubs, except when under 18 discos are being held);

vi. There are licensable activities that are likely to appeal to minors/children under 16 taking place during times when children under 16 may be expected to be attending compulsory full-time education;

vii. There have been representations from police, the Local Safeguarding Children Board, Trading

viii. Standards or other relevant agency or representative.

ix. There are measures/training for staff on how to deal with suspected truanting school children on the premises and how to recognize signs of potential child sexual exploitation.

c) The sale of alcohol to a minor is a criminal offence and Trading Standards officers will conduct appropriate covert test purchasing exercises and will take account of any complaints and intelligence. The Act permits the use of children under the age of 18 to undertake test purchases when they have been directed to do so by a duly authorised officer.

g) The Licensing Authority will expect operating plans to specify the measures and management controls in place to prevent alcohol being served to children, other than in those limited circumstances permitted by the Act. The Council's Trading Standards officers have a role to play in the protection of children from harm, and proof of age schemes, and are able to provide advice in relation to measures that can be taken to help prevent the sale of alcohol to underage children. Potential licence holders should also be aware of the Proof of Age London (PAL) Scheme hosted by Southwark Council.

# 6. DETERMINATION

**6.1** In determining this application, the Committee must have regard to the representations and take such of the following steps as it considers necessary for the promotion of the licensing objectives. The steps are:

(a) Grant the application in full

#### a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

- All staff who have direct dealings with customers shall be trained in the following:

a) The premises licence and its conditions

b) Licensing Law; in particular, relating to the sale of alcohol.

A record shall be kept of this training which will be refreshed no less than every 6 months and this record shall be available for inspection by the Licensing Authority or Police upon request.

- a minimum of 70% of the available customer floor space of the premises shall be laid out to tables and chairs at any one time.

- Food in the form of substantial table meals will be available until at least 22:00 hours or 90 minutes prior to closing.

#### b) The prevention of crime and disorder

- A digital hard drive CCTV system shall be in operation to cover the premises.

- All CCTV recorded images shall have sufficient clarity/definition to enable facial recognition.

- CCTV footage shall be kept in an unedited format for a period of 31 days.

- Managers responsible for the operation of the premises shall be trained in the use of any such CCTV equipment and able to produce/download/burn CCTV images upon request by an authorised officer from a Responsible Authority- subject to the relevant data protection laws.

- An incident and refusals log (the Log) will be kept and maintained at the premises and all incidents and refusals of sales of alcohol shall be recorded in it. As a minimum, the log will record the date and time of the incident/refusal, the name of the person making the entry, the nature of the incident/ refusal and any actions taken. The Log will be made available to officers from the responsible Authorities on request.

- The premises licence holder or designated manager will risk assess whether door supervisors will be employed at the premises. The risk assessment will be in writing. The risk assessment will be re-visited and updated in light of intelligence provided by the Metropolitan Police of following a serious incident of crime or disorder. The risk assessment will be made available to officers from the metropolitan Police on request.

#### c) Public safety

The DPS/Manager will undertake a weekly inspection of the public areas of the premises to identify anything might present an identifiable risk to public safety. Any risks identified that are deemed to be unreasonable must be rectified at the earliest opportunity.

#### d) The prevention of public nuisance

- A sign will be displayed at each exit from the premises asking customers to respect the rights of nearby residents not to be disturbed.

- Bottles bins shall not be emptied into external bins after 22.00 hours or before 08.00.

- Deliveries of alcohol to the premises will not take place between 22.00 hours and 08.00 hours.

- The premises licence holder will ensure that any waste management company contracted to remove waste from the premises is required to do so between the hours of 08.00 and 22.00

- No deliveries or collections relating to licensable activities at the premises will take place between the hours of 22.00 hours and 10.00 hours.

- The DPS/Manager must instruct delivery riders and drivers not to cause a noise nuisance when collecting orders for delivery or making deliveries.

- Delivery of alcohol will only be as part of a substantial food offer.
- Delivery drivers/riders will be given clear, written instructions to use their vehicles in a responsible manner so as to not cause nuisance to any residents or generally outside the licensed premises; not to leave engines running when the vehicle is parked; and not to obstruct the highway. The licence holder will positively encourage delivery drivers/riders to use quieter vehicles that are less likely to cause a nuisance such as bicycles.

#### e) The protection of children from harm

- A challenge 25 policy (the Policy) shall operate in the premises in relation to the sale of alcohol. Acceptable forms of ID will be those specified by the Home Office for the purposes of age verification for sales of alcohol.

- The DPS/Manager shall ensure that all employees of any third party engaged for the purposes of delivery of alcohol have also been trained by their employers regarding the Challenge 25 policy. This training should be documented.

- All staff shall be aware of the law regarding the refusal of service to any person who is drunk or is underage and shall be aware of how to seek ID from anyone who appears to be underage.

- Children are to be supervised by a responsible adult at all times.

### Objection to Premises Licence Application in respect of 206- 208 Hammersmith Road, London, W6 7DH (formerly Villagio restaurant)

Dear Sirs,

We act on behalf of our client Sacred Heart High School which sits directly alongside the proposed premises at 212 Hammersmith Road, London, W6 7DG. **Our client objects to the application on the following four grounds:** 

- The prevention of crime and disorder
- Public safety
- Prevention of public nuisance
- The protection of children from harm

#### Background

The Sacred Heart High School is state funded Catholic Comprehensive girl's school, with approximately 1200 pupils in the age range 11 – 18 years. Originally founded in the 19<sup>th</sup> century by St Madeleine Sophie Barat. Since then, the school has been a leading in all educational fields and is currently placed within the top 3% nationally. The school opens at 7am; but also offers numerous extracurricular activities the majority of which happen outside of regular 'teaching hours' with students leaving regularly post 7pm. Above all else, Sacred Heart is committed to keeping children safe.

Previously 206-208 Hammersmith Road was occupied by the Villagio restaurant which held a premises licence. However, this site predominantly operated as an Italian style restaurant which was reflected within the licensed conditions which included:

- Alcohol shall only be served by waiter/ waitress service
- The supply of alcohol on the ground floor shall only be to persons taking a substantive meal
- Food and non-intoxicating beverages shall be available in all parts of the premises where alcohol is sold or supplied for consumption on the premises.

However even with the above conditions in place The Villagio premises did cause some issues to the school. These issues included noise and disturbance from emptying bottles into bins during classroom hours; and blocking the school fire exit with bins and gates.

The proposed premises licence application is for a pub: predominantly an alcohol-led venture, with the Sale of Alcohol being proposed from 10:am until 00:00 (mid-night). This is a significant change from the previous restaurant use.

Our clients would like to emphasise that the proposed operators have made no attempt to engage with the school prior to the submission of the premises licence application, and so have missed an opportunity to address our client's concerns.

#### The prevention of Crime and Disorder.

Alcohol is a main cause of anti-social behaviour, nuisance and disturbances throughout the Hammersmith area. Allowing another predominantly wet-led licensed venue within a mile of numerous other licensed premises (Hop Holes, The William Morris, The Swan, Belushi's) will only increase the likelihood of individuals becoming drunken and disorderly, which in turn will increase pressure on the already drained resources of the metropolitan police services.

Our clients are very concerned at the proposed close proximity of a wet-led venue to the school. It is detailed in the LBHF licensing policy, at Theme 3: A safe licensing environment and night-time economy (page 9) that the licensed sector should be managed well in order to protect children, young people and vulnerable people - including the prevention of underage sales of alcohol. It seems to us that to for a premises to be granted such a licence within a 5-metre walking distance of a school would represent a conflict with that policy.

#### Public Safety.

The proposed premises is situated on the A315, with a very narrow pedestrian footpath from the entrance of the premises to the road. It is conceivable that an individual who has had too much to drink would stumble directly into on-coming traffic. Additionally, the site is a small sized venue, it is likely that large groups of individuals may stand on the pavement whilst drinking causing pedestrians to be forced to the edge of the footway, close to the road.

It is also considered that individuals having a drink whilst standing outside the premises would be in direct conflict with the movements of several hundred parents and children leaving at the end of the school day. This congestion would be of grave concern to the school.

We believe the previous premises had a tables and chairs application rejected due to concerns of the tables blocking the first exit of the rear of the school. It is foreseeable if this licence is granted a similar issue would arise.

#### The prevention of Public Nuisance.

If this premises licence is granted, the venue would have the ability to hold live music events under the Live Music Act 2012, 7 days a week, from 8am until 11pm for 500 people. The premises will be afforded the opportunity to hold live bands, DJ's and recorded music all of which could have detrimental effects to school teachings taking place within the school grounds. Unfortunately, these concerns cannot be remedied by adding conditions to the licence. The school operates regularly until 7pm.

The site will be able to hold the screening of regular sporting events which usually leads to an increase in footfall within licensed premises. Again, this raises concerns as to the noise emanating from the venue while these events are taking place with students, or children trying to study next door.

Emptying of bottles bins and deliveries being taken during school hours - which has historically been an issue associated with the previous licence holders - only further adds to these concerns.

#### Protection of children from harm

Placing an alcohol led venue directly next to a school is a significant cause for concern. It would significantly increase the chances of under-age individuals entering the premises and attempting to purchase alcohol. It is stated in the LBHF licensing policy, the Licensing Authority will require operating plans to specify the measures and controls put in place to protect children from harm. As of yet we have seen no evidence of any conditions or undertakings which would alleviate these concerns.

Historically, there have been incidents of individuals 'cat-calling;' and aggressive behaviour near the school grounds. The addition of an alcohol-based premises risks adding to these existing problems. We are concerned for the students leaving the school directly next to a venue filled with intoxicated individuals.

The premises proposed operating hours is for the entire duration of the school day and after, there are worries that this will enable young children the ability to enter and frequent the premises during the school day. It is simply not be appropriate for a venue of this nature to be directly next to a school.

While it is appreciated the proposed operator will attempt to alleviate the concerns raised above. It must be noted that this premise licence if granted will not be bound specifically to this operator. There may in the future be the opportunity for the licence to be transferred to a differing operator, who may attempt to utilise the proposed licence in an entirely different way.

It is for the reasons above that we ask the Licensing Authority to reject this premises licence application.

#### 1. THE APPLICATION

On 27<sup>th</sup> February 2023, Riverside Trust ("the applicant") submitted an application for a variation to the premises licence to be granted in respect of the premises known as The Riverside Studios, 101 Queen Caroline Street, London, W6 9BN.

#### **1.1 Current Hours of Operation**

The premises currently benefit from a premises licence. The current premises licence permits the following:

Performance of Dance -Indoors OnlyMonday to Sunday09:00 - 00:30Exhibition of a Film - Indoors Only

Monday to Sunday 09:00 - 00:30

Performance of Live Music -Indoors Only

Entertainment Similar to Music or Dance -Indoors Only

Monday to Sunday 09:00 - 00:30

Performance of a Play -Indoors Only

Monday to Sunday 09:00 - 00:30

Sale of Alcohol On the PremisesMonday to Sunday11:00 - 23:00

#### The opening hours of the premises

Monday to Sunday 07:00 - 01:00

A copy of the current premises licence and plan can be seen on pages 73-93of this report.

#### **1.2 Application Requested**

The applicant has applied to vary their licence to amending conditions 37, 45 and 46 on the premises licence.

#### Condition 37

Current Condition

The number of persons permitted in the bakery external area shall be limited to 32 (excluding staff) and the number of persons permitted in the restaurant external area shall be limited 36 (excluding staff) at any one time.

#### Proposed Variation

The number of persons seated in the external customer areas of the premises shall be limited to 75.

#### **Rationale**

The variation would allow us to accommodate a total number of patrons outside of 75, an increase of 7 from the current permitted level. This would allow us to more flexible in our seating arrangements. The current provision means we have to restrict people to groups of no more than 4 patrons seated together which means we cannot accommodate, for example, a group of 6 at a table.

#### **Condition 45**

#### Current Condition

Alcohol shall not be sold on the Premises otherwise than to persons taking table meals there and for consumption by such a person as an ancillary to his meal.

#### Proposed Variation

Alcohol shall not be sold on the Premises otherwise than to persons taking table meals there or to persons participating in or attending events, films, productions or exhibitions at the Premises. No vertical drinking shall be permitted in the external restaurant area.

#### Rationale

The present formulation of this condition restricts us from selling alcohol to theatre and cinemagoers; or from hosting private functions which sometimes may not include a "table meal". All such activities take place inside the building and access/egress is carefully managed in line with other conditions in the licence. The wording of the proposed variation has been developed after extensive discussions with residents at our quarterly residents meeting and aims to meet the dual objective of allowing Riverside to trade sensibly and responsibly, while still not detracting from the Resident's enjoyment of their homes.

#### **Condition 46**

#### Current Condition

In the hatched and cross hatched areas on the licensing plan, all licensable activities will end at 20.30 each day and the area shall be cleared of patrons, tables and chairs by 21:00.

#### Proposed Variation

In the cross hatched areas on the licensing plan, all licensable activities will end at 21:30 each day and the area shall be cleared of patrons, and the tables and chairs rendered unusable by 22:00.

#### **Rationale**

The proposed additional hour would make our licence consistent with that which is allowed to other similar businesses in the vicinity, such as Sam's; The Gate and Chancellors. The extra hour of trade will make a substantial difference to our viability, particularly in the summer trading period.

A copy of the application form can be seen on pages 94-104 of this report.

#### **1.3 Applicants Operating Schedule**

The applicant has proposed steps to promote the four licensing objectives if the application is granted. A copy of these can be seen on pages 100-101 of this report.

#### 2. BACKGROUND

The premises operates as an arts and entertainment venue with a restaurant, bar and cafe. The main access to the premises is located on the Thames Path at its junction with Queen Caroline Street. There is a mixture of both residential and commercial premises within the area. A map showing the location of the premises and neighbouring licensed premises can be seen on pages 105-107 of this report.

There are options for transport away from the area including buses and taxis which run from in and around the Hammersmith Broadway and Fulham Palace Road area. Hammersmith tube stations are a 9-minute walk away. Ravenscourt Park tube is a 14-minute walk away.

#### 3. CONSULTATION

A public notice was displayed at the premises for 28 days. The application was advertised in a local circular and all statutory consultees were notified as required by the Regulations. The Council has served written notice of hearing upon the applicant and all those parties that have made representations in respect of the application.

#### 3.1. Relevant Representations

The licensing section received 6 representations from residents objecting to the licence application. A further 2 comments were received in response to the application. A copy of these can be seen on pages 108 - 117 of this report.

#### 4. OTHER INFORMATION

#### 4.1 Enforcement History

On the 01 August 2022 a warning letter was issued following a breach of condition 45 on 31 July 2022, Alcohol shall not be sold on the Premises otherwise than to persons taking table meals there and for consumption by such a person as an ancillary to his meal.

On 7<sup>th</sup> December 2021 a verbal warning was issued due to a breach of condition 10 (c) which outlines that CCTV must cover any external area of the premises. (Areas used by customers).

On 10<sup>th</sup> September 2021 following a licensing inspection conducted an inspection sheet was left as a warning letter for the following breaches: Condition 10 - CCTV check log not available and CCTV not covering full external area; Condition 15 and Condition 16 - Written records of training not available; Condition 36 - No sign displayed at the bar.

#### 4.2 Event Notices ("TENs")

The premises have had eighteen TENs which have been submitted in respect of this premises in the past twelve months. A list of the TENs submitted can be seen on pages 118 - 122 of this report.

#### 5. POLICY CONSIDERATIONS

**5.1** Section 5 pages 12 and 13 of the Statement of Licensing Policy ("SLP") states that in order to ensure the promotion of the four Licensing Objectives the Licensing Authority will require applicants to detail in their operating schedule:

- the steps proposed to promote the licensing objective of the prevention of crime and disorder on, and in the vicinity of, the premises, having regard to their location, character, condition, the nature and extent of the proposed use and the persons likely to use the premises;
- the steps proposed to ensure the physical safety of people using the relevant premises or place;
- how they intend to prevent nuisance arising, prevent disturbance and protect amenity so far as is appropriate to ensure that the Licensing Objectives are met. Where there is a relevant representation regarding extended hours, the Licensing Authority will not permit an extension unless it is satisfied that the Licensing Objectives would be met;
- the measures and management controls in place to protect children from harm. Where appropriate a written childcare policy should be available and be incorporated in the induction of staff.

**5.2** Policy 3 page 21 of the SLP states that where there is a relevant representation, the Licensing Authority will consider each particular case on its merits having regard in particular to the following matters:

a) Whether the licensed activities are likely to have an adverse impact especially on local residents and, if there is potential to have an adverse impact, what, if any, appropriate measures will be put in place to prevent it;

b) Whether there will be a substantial increase in the cumulative adverse impact from these or similar activities, on an adjacent residential area;

c) Whether there is a suitable level of public transport accessibility to and from the premises at the appropriate times;

d) Whether the activity will be likely to lead to a harmful and unmanageable increase in car parking demand in surrounding residential streets suffering high levels of parking stress or on roads forming part of the Strategic London Road Network or the London Bus Priority Network leading to a negative impact on the Licensing Objectives relating to the prevention of crime, disorder, anti-social behaviour (ASB), nuisance and vehicle emissions;

e) Whether there have been any representations made by Responsible Authorities, or other relevant agency or representative.

The Licensing Authority will closely scrutinise extended hours applications to ensure that the Licensing Objectives are met. In determining an application the licensing committee might decide that the circumstances are such that a restriction on hours is the only appropriate means to achieve the Licensing Objectives. If an 'hours' restriction is imposed, the Licensing Authority will normally require that customers should be allowed a minimum of thirty minutes to consume alcohol.

In determining representations to an application which incorporates an external area to the premises, the licensing committee might decide that the circumstances are such that a restriction on hours in that area is the only appropriate means to achieve the promotion of the Licensing Objectives.

**5.3** Policy 11 page 30 of the SLP states that population densities in this borough are high, with many residential premises located above or in close proximity to licensed premises. This means that the public nuisance and crime and disorder objectives will be of paramount concern when evaluating Operating Schedules.

Licensing Committees will place high regard on the control measures put in place by the applicant to ensure that our residents are protected from the potential detrimental effects of any licensed premises.

**5.4** Annex 1 pages 35 and 36 of the SLP in relation to the prevention of crime and disorder states licence applicants will be expected to demonstrate the following in their operating schedules:

a) Measures to control excessive consumption and intoxication.

b) Consideration of any additional measures or restrictions that may be placed on alcohol sales to prevent binge drinking and promote 'sensible drinking'.

g) Conditions will, so far as possible, reflect local crime prevention strategies, and the Licensing Authority will also have regard to the views of the local Crime and Disorder Reduction Partnership.

h) Crime and disorder in the vicinity of the premises: this may include the crime and disorder risks arising from persons queuing to enter the premises; persons exiting the premises and customers smoking eating or drinking in outdoor areas and on the highway outside the premises. This can also include crime arising from pickpockets and bag snatchers, particularly in open spaces or crowded areas where alcohol is being consumed.

j) CCTV - using CCTV inside and/or outside the premises together with appropriate procedures and having staff properly trained to use CCTV equipment.

k) dispersal procedures - establishing appropriate dispersal procedures to minimise the potential for crime and disorder when customers are leaving the premises.

I) dealing with and reporting crime and disorder - training for staff and door security aimed at reducing crime and disorder in the premises and its vicinity and dealing with and reporting incidents if they occur.

m)door staff - considering whether the premises employs a sufficient number of SIA registered door staff, whether Door Premises Supervisors check the legitimacy of the badges and whether SIA staff display their badges prominently. (Note: All door supervisors must be Security Industry Authority (SIA) registered).

n) drugs and weapons - ensuring compliance with relevant guidance regarding illegal drugs and weapons. Attention should be paid to search procedures, procedures for the safe storage and surrender of seized drugs and weapons and drug awareness issues, designing out the ability to take drugs in the premises, etc.

o) excessive drinking - training for staff to recognise when customers are becoming drunk and adopting appropriate 'cut off' procedures for drunken customers, so as to reduce the likelihood of fights or aggressive behaviour.

p) local schemes – joining and attending local Pubwatch meetings and participating in the Behave or Be Banned Scheme (BOBB) and/or signing up and using the Council's Safety Net Radio scheme. q) prevention of theft - using bag hooks and signage to warn customers of pickpockets and bag snatchers.

**5.5** Annex 1 pages 38 to 40 of the SLP in relation to the prevention of public nuisance states that the Licensing Authority will particularly consider the following matters where they are material to the individual application:

ii. The proximity of residential accommodation;

iii. The type of use proposed, including the likely numbers of customers, proposed hours of operation and the frequency of activity;

v. The steps taken or proposed to be taken by the applicant to prevent disturbance by customers arriving at or leaving the premises.

vi. Limiting the number of people permitted to use a garden or other open-air areas, including those for the use of smoking, at any one time.

vii. Restricting the use of a garden or other open-air areas, including those for the use of smoking, after a particular time e.g. 11:00pm (or such earlier time as may be considered appropriate).

viii. The steps taken or proposed to be taken by the applicant to prevent queuing (either by pedestrian or vehicular traffic). If some queuing is inevitable then queues should be diverted away from neighbouring premises or be otherwise managed to prevent disturbance or obstruction;

ix. The steps taken or proposed to be taken by the applicant to ensure staff leave the premises quietly;

x. The arrangements made or proposed for parking by patrons, and the effect of parking by patrons on local residents;

xi. The provision for public transport in the locality (including taxis and private hire vehicles) for patrons;

xii. The level of likely disturbance from associated vehicular and pedestrian movement to and from the premises;

xiii. The delivery and collection areas and delivery/collection times;

xiv. The siting of external lighting, including security lighting that is installed inappropriately;

xv. The arrangements for refuse disposal, storage and the prevention/tidying of litter (including fly posters and illegal placards);

xvi. The history of previous nuisance complaints proved against the premises, particularly where statutory notices have been served on the present licence holder; xvii. The history of the applicant in controlling anti-social behaviour and preventing nuisance; xviii. The generation of odour, e.g. from the preparation of food;

xix. Any other relevant activity likely to give rise to nuisance;

xx. Any representations made by the Police, or other relevant agency or representative;

The following provides a non-exhaustive list of risks associated with the public nuisance objective that applicants may want to consider when preparing their Operating Schedule:

j) **Deliveries/collections** – noise from deliveries to and/or collections (e.g. refuse) from the premises are another common source of complaint. Consider the times of such deliveries/collections and make sure you specify to any contractors that deliveries/collections should not be made at anti-social times. As a guide, the Noise and Nuisance Service recommend that deliveries/collections should only be made between the hours of 7:30am and 9:00pm, depending on the proximity of residential and/or other noise sensitive properties.

k) Late night refreshment - applicants in respect of late night takeaways should demonstrate that they have assessed the risk of persons congregating in large numbers in the vicinity of their premises. Where appropriate, applicants should demonstrate suitable measures to address this problem.

I) **Light pollution** – this is an increasingly common source of complaint, particularly from illuminated signs and external security lighting. Where provided, illuminated signs should not cause glare to neighbouring properties, ideally being turned off at night, and external lighting should be angled and/or diffused to also prevent nuisance.

n) External Areas – External areas such as gardens can be the source of noise disturbance to surrounding premises. Consider limiting the use of the garden to a reasonable time and number of people.

o) Odour – odour from cooking is a common source of complaint, particularly from restaurants and fast food takeaways. The Council's Noise and Nuisance Service may therefore require evidence that the kitchen ventilation and/or extract systems are regularly maintained and serviced to ensure that it is operating efficiently and with minimal nuisance to neighbours arising from odour and also noise. This includes the siting of BBQs.

p) **Queue management** - establishing appropriate procedures to avoid the need for customers to queue before entering the premises or, where queuing cannot be avoided, to manage queues so as to minimise the potential for crime and disorder or public nuisance by customers who are queuing.

r) **Waste** – consider how and where waste will be stored/disposed of at the end of trading hours, particularly if trading until late at night. This is important because the disposal of glass and/or cans to outside bin areas can be very noisy and give rise to complaints, so it may be necessary to store such items and other non-degradable refuse inside the premises until the next trading day. Consideration should also be given to the time of deliveries to minimize disruption to local residents.

s) Litter – for example, litter patrols for late night take-away premises

#### 6. DETERMINATION

**6.1** In determining this application, the Committee must have regard to the representations and take such of the following steps as it considers necessary for the promotion of the licensing objectives. The steps are:

(a) Grant the application in full

(b) Grant the application in part – modifying the proposed hours, activities or conditions.

(c) Reject the application

It is the Council's duty under the Licensing Act 2003 ("The Act") to determine applications with a view to promoting the four licensing objectives; Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance and the Protection of Children from Harm.

In reaching a decision the Council shall consider the details of any relevant representations received; the applicant's Operating Schedule; the Council's adopted Statement of Licensing Policy and the guidance issued by the Secretary of State under section 182 of the Act.

If the Committee is minded to grant the application conditions may be attached to the licence to alleviate the concerns raised through the representations.

## Annex 1 – Mandatory Conditions

1. Mandatory Condition

(1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

(d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

(e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

### 2. Mandatory Condition

The responsible person shall ensure that free potable water is provided on request to customers where it is reasonably available.

### 3. Mandatory Condition

1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

(a) a holographic mark, or

(b) an ultraviolet feature.

4. Mandatory Condition

The responsible person must ensure that—

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

(i) beer or cider: <sup>1</sup>/<sub>2</sub> pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml;

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

5. Mandatory Condition

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purposes of the condition set out in paragraph 1-

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(b) "permitted price" is the price found by applying the formula—

$$\mathsf{P} = \mathsf{D} + (\mathsf{D} \times \mathsf{V})$$

where-

(i) P is the permitted price,

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-

paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4.(1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

### 6. Mandatory Condition

(1) No supply of alcohol may be made under the premises licence-

(a) at a time when there is no designated premises supervisor in respect of the premises licence, or

(b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

(2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

### 7. Mandatory Condition

Admission of children must be restricted in accordance with any recommendation made by the film classification body specified in the licence, or,

where the licensing authority has notified the holder of the licence that it considers a classification is necessary then,

admission of children must be restricted in accordance with any recommendation made by that licensing authority.

### In this section -

"children" means persons under the age of 18; and

"film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

### 8. Mandatory Condition

Where this licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each individual must be licensed by the Security Industry Authority, with the following exceptions:

a) premises where the premises licence authorises plays or films

b) any occasion mentioned in paragraph 8(3)(b) or (c) of Schedule 2 to the Private Security Industry Act 2001 (premises being used exclusively by a club with a club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or

c) any occasion within paragraph 8(3)(d) of Schedule 2 to the Private Security Industry Act 2001.

## Annex 2 – Conditions consistent with the operating Schedule

9. SIA registered door supervisors shall be provided when required as per a written risk assessment. This risk assessment shall be made available to the Police and Licensing Authority officers.

10. High Definition CCTV shall be installed, operated and maintained at all times that the premises are open for licensable activities and;

a) shall be checked every two weeks to ensure that the system is working properly and that the date and time are correct. A record of these checks, showing the date and name of the person checking, shall be kept and made available to Police or authorised Council officers on request,

b) one camera shall show a close-up of the entrance/s to the premises to capture a clear, full length image of anyone entering,

c) shall cover any external area of the premises accessible to the public,

d) recordings shall be in real time and stored for a minimum period of 31 days with date and time stamping,

e) footage shall be provided free of charge to Police or authorised council officers within 24 hours of a request,

f) a staff member from the premises that is conversant with the operation of the CCTV system shall be on the premises at all times. This staff member shall be able to show Police or authorised officers of the Licensing Authority recent data footage with the minimum of delay when requested. This data or footage reproduction shall be almost instantaneous.

11. Polycarbonate glasses shall be used where drinks are permitted into the cinema and studios.

12. Membership of the local Pub Watch scheme shall be entered into when in operation.

13. Alcohol shall not be consumed other than during the permitted hours for the sale of alcohol and during a 30 minute period immediately following the permitted hours.

14. Appropriate signage shall be displayed in prominent positions, informing customers they are being recorded on CCTV.

15. All relevant staff responsible for selling alcohol shall receive regular training in the Licensing Act 2003 in terms of the licensing objectives, offences committed under the Act and conditions of the Premises Licence. Written records of this training shall be retained and made available to police and authorised officers of the Licensing Authority on request.

16. All relevant staff shall be trained in how to manage a crime scene and crime scene preservation. This training shall be repeated at least once a year and written records of the training kept on the premise and made available to Police and authorised officers of the Licensing Authority on request.

17. The premises shall apply with the 'Technical Standards of Places of Entertainment'.

18. Safety checks will be carried out and recorded prior to admission of the public.

19. Regular checks and maintenance is to be carried out on all equipment, electrical installations, emergency lighting and fire alarms to ensure compliance with current British Standards.

20. Any special effects machines are to be risk assessed and documented and, if necessary, prior approval shall be obtained from the Licensing Authority.

21. Ushers shall be provided for all shows/events/performances/films.

22. Unless prior written consent is obtained from the Council, the number of persons accommodated at any one time shall not exceed the following: Studio one = 550 Studio two = 450 Studio three = 250 Cinema = 220 Screening Room = 50 Events Space = 200 Rehearsal Room = 60 Office accommodation = 200 Café/bar = 160 (plus additional 40 people in the bakery) with the cinema and screening room audiences catered for in the cinema foyer bar.

23. No music or amplified sound shall be generated within the Premises so as to give rise to nuisance within neighbouring dwellings.

24. No noise or vibration associated with the operation of plant at the Premises shall give rise to a nuisance to the occupiers of neighbouring properties.

25. No smells generated from the cooking processes at the Premises shall give rise to nuisance to occupiers of neighbouring properties.

26. SIA registered security or trained members of front of front of house staff shall properly control customers outside the Premises so that they leave quickly and quietly and do not congregate on the pavement outside the premises causing noise and nuisance to residents living in the vicinity.

27. The premises shall operate a written traffic policy which will apply to all tenants and visitors which will include a requirement not to block surrounding highways and ensure that residents are disturbed as well as for SIA registered door staff to maintain orderly queuing outside of the premises

28. After the premises closes to the public, the outside area and up to 20 meters away from the premises shall be cleared of litter and other refuse associated with the operation of the premises.

29. Rubbish including bottles or cans shall not be deposited outside the Premises and refuse collections and deliveries shall not take place between 23:00 hours and 07:00 hours the following day.

30. No scenery, property or equipment shall be delivered to or removed from the premises by heavy goods vehicles between the hours of 00:30 and 07:00 without the prior written consent of the council.

31. The licence holder shall make available to all residents a dedicated telephone number that shall be staffed at all times when the premises are operating to which complaints of any noise or disturbance may be addressed. The number shall be circulated to all residents with close proximity to the premises on at least one occasion every three months.

32. The licence holder shall keep a record of complaints received, including the complainant's name, the date and time, nature of the incident complained of and subsequent remedial action undertaken. This record shall be kept available for inspection at all reasonable times by the Council's licensing officers.

33. A notice displaying the conditions of the premises licence shall be displayed in prominent position at the premises where they can be easily seen and read by staff members.

34. Film classifications shall be displayed inside and outside the premises.

35. Risk assessments shall be undertaken when children are taking part in performances.

36. The premises shall operate a Challenge 25 age restricted sales policy and shall display appropriate signage advising customers of this policy.

37. The number of persons permitted in the bakery external area shall be limited to 32 (excluding staff) and the number of persons permitted in the restaurant external area shall be limited 36 (excluding staff) at any one time.

38. Customers and staff shall be prohibited from accessing the alleyway and using the restaurant alleyway exit/entry after 22:00

39. The premises licence holder shall erect an awning over the terrace area (as delineated on the plan) in order to minimise noise emanating from customers.

40. The premises licence holder shall ensure that adequate sound proofing is installed in the restaurant.

41. Smoking shall be prohibited in the restaurant external seating area.

42. The premises shall operate a written dispersal policy and all relevant staff shall be trained in its implementation.

## Annex 3 – Conditions attached after a hearing by the licensing authority

43. The Licence Holder or Designated Premises Supervisor shall organise and accommodate quarterly meetings per calendar year to discuss the operation of the premises with residents. The meeting shall be advertised before its due date to residents and residents' associations in the locality.

44. Alcohol shall only be sold (by waiter or waitress service) for consumption by customers seated in the external bakery and external restaurant area.

45. Alcohol shall not be sold on the Premises otherwise than to persons taking table meals there and for consumption by such a person as an ancillary to his meal.

46. In the hatched and cross hatched areas on the licensing plan, all licensable activities will end at 20.30 each day and the area shall be cleared of patrons, tables and chairs by 21:00.

47. A minimum of two SIA licensed door supervisors shall be on duty at the premises in the hatched and cross hatched areas on the licensing plan during the hours of 19:00 - 21:00 on Thursdays to Sundays.

48. The outside seating area shall be separated from the public highway by a screen, rope barrier or other means of demarcation from the public highway while licensable activities are taking place.

Riverside Studios has a national reputation for being one of the country's leading television studios and arts centres. Complying with the licensing objectives is as essential to us and our reputation as the quality of our operations is - it would be fundamentally damaging to our business and stakeholder relations if we were negligent in upholding these objectives, and we take the enforcement thereof very seriously. In our theatres we employ global best practice when it comes to health and safety for performers and audiences, and this includes ensuring that they are safe as they arrive and leave the venue.

b) The prevention of crime and disorder

Our Premises is well covered by CCTV cameras, as required by our Premises Licence, and we maintain good relationships with local police and the Pub Watch scheme. Our staff are trained in crime scene preservation, as required by the licence conditions.

In the last three years of operation we have had no complaints to the police about operations at the venue, and strive to keep a clean record in this regard.

c) Public safety

Whenever we host large numbers of patrons (500+) we provide fully trained SIA officers on the premises and a large team of front of house staff. As our venue is predominantly a theatre and cinema, it strives to be family-friendly and accessible, and as such anti-social behaviour is not tolerated. Full Risk Assessments are compiled for all shows and events at the venue, and the highest levels of health and safety compliance is enforced.

d) The prevention of public nuisance

Access and egress from the building is carefully controlled, particularly late at night, with trained SIA officers on duty to ensure that our traffic dispersal policy is enforced.

e) The protection of children from harm

Riverside prides itself on being a family-friendly venue. We frequently host events, shows and films for young people, for schools and school groups, for families and for young people with autism and other challenges. In all instances we deploy suitably trained and DBS-checked staff and work closely with carers and parents to ensure that groups coming to the building are well managed and supervised.

Our bar and restaurant operates a strict 'Challenge 25' policy.







I have tried numerous times to submit my comments and keep getting a message back that there is a system error resulting in my comments not being submitted. I have therefore had to resort to mailing you my comments and as I don't have access to the email address for the case officer. I would be grateful if you could acknowledge receipt by return mail and confirm that my comments will be taken into account when considering this application.

Condition 37 - for the number of seated persons permitted in the external bakery area and restaurant area increasing from a combined total of 68 to a total of 75. This was requested in a previous variation sought and rightly rejected as it would increase noise and encourage more anti-social behaviour to the detriment of residents living in apartments in both Queens Wharf and the adjacent blocks. The reasons for refusal have not changed - the numbers must be limited to those originally agreed.

Condition 46 - for the hours of all licensable activities in the hatched and cross hatched area to amend from ending at 20h30 each day with the area cleared of patrons/tables/chairs by 21h00 to ending all licensable activities at 21h30 each day and the area cleared of patrons and tables/chairs rendered unusable by 22h00. The licence holder does not currently adhere to the conditions of no vertical drinking outside and not serving alcohol unless it is ancillary to a meal. Vertical drinking in the area with no food served, with this often taking place beyond permitted hours has been observed on many occasions. Increasing licensable activities by an hour would exacerbate this and also be to the detriment of residents of Queens Wharf and neighbouring apartments. Noise levels/disturbance are already a problem and would increase, as would anti-social behaviour.

Condition 45 - variation that alcohol can be sold on the premises to anyone participating in or attending events/films/productions or exhibitions at the premises. This will allow for large scale vertical drinking inside in the restaurant/bakery area resulting in it becoming a glorified pub/drinking hole. The surrounding area is already well populated by several pubs and this variation would again negatively impact residents of Queens Wharf and adjacent apartments in terms of noise, disturbance, and anti-social behaviour.

When Riverside studios were redeveloped it was done so with the full knowledge that there would be apartments above the studios and that the needs of residents within Queens Wharf and those adjacent to it would need to be considered. As you are aware the license holder has attempted on various occasions to vary the license conditions – particularly conditions 37 and 46. Both have been

fully considered by council and rejected by council based on sound reasoning – there is no basis for why this should not remain the case. Lastly the primary purpose of Riverside studios is the operation of the studios to provide indoor performances of live and recorded music, events, films, productions and exhibitions. The provision of additional external seating with extended operating hours and the provision of alcohol for vertical drinking in the restaurant and bakery area is not germane to this. The impact on residents in Queens Wharf and those in close proximity needs to be fully considered.

The noise and disturbance emanating from Riverside Studios is already problematic, particularly as patrons and customers arrive and exit the premises before and after performances. We therefore object to any variations that would simply exacerbate the problem.

Any variation to condition 45 as regards alcohol consumption in conjunction with food will simply mean that Riverside Studios will be yet another pub in an area that is already extremely well catered for in this respect. I would suggest that the existing licence conditions as regards vertical drinking are currently openly flouted, as are the requirements that alcohol is only supplied with food. We have frequently witnessed this - with alcohol also being openly consumed along the railings of the Thames Path. Riverside Studios were obviously aware from the outset that the complex of Queens Wharf is an important residential development and I believe that the interest of the residents must take precedence over providing greater numbers of people more time and more opportunity to eat and drink.
