2. DECLARATIONS OF INTEREST

If a Councillor has a disclosable pecuniary interest in a particular item, whether or not it is entered in the Authority's register of interests, or any other significant interest which they consider should be declared in the public interest, they should declare the existence and, unless it is a sensitive interest as defined in the Member Code of Conduct, the nature of the interest at the commencement of the consideration of that item or as soon as it becomes apparent.

1. THE APPLICATION

On 25th July 2023, Walaiti Rathore of Licensing Law Consultancy, submitted an application on behalf of PJ Corp Stores Limited ("the applicant") to vary their premises licence in respect of the premises known as Papa Johns Pizza, 63 Walham Grove London SW6 1QR.

The premises currently benefit from a premises licence. The current premises licence permits the following:

Provision of late night refreshment – indoors only

Monday to Sunday

23:00 - 23:30

A copy of the current premises licence and plan can be seen on pages **13-18** this report.

1.2 Application Requested

The applicant has applied to vary the hours for late night refreshment and to add a condition as outlined below:

Provision of late night refreshment - indoors and outdoors

Monday to Sunday

23:00 - 05:00

Non-Standing Timings: an additional hour to the standard and non-standard times on the day when British summertime commences.

From the standard start timing on 31st December to the standard start time on the 1st January.

Hours open to the public

Monday to Sunday

00:00 - 00:00

Condition: The premises shall close to the public after 02:00 and shall then operate solely as a delivery service until 05:00

A copy of the application form can be seen on pages **19-38** of this report.

1.3 Applicants Operating Schedule

The applicant has proposed additional steps in the applications operating schedule to promote the four licensing objectives if the application is granted. A copy of these can be seen on pages **34** of this report.

On the 21 August 2023, following correspondence received from the Police, the applicant agreed to reduce hours and add four extra conditions to their licence if granted. A copy of this amendment and relevant correspondence can be seen on pages **39-40** of this report.

Agreed Hours:

The provision of late night refreshment - Both Indoors and Outdoors

Sunday- Thursday 23:00 - 00:00 Friday and Saturday 23:00 - 01:00

Hours open to the public

Sunday-Thursday 10:00 - 00:00 Friday and Saturday 10:00 - 01:00

Agreed conditions:

- 1. Signs shall be prominently displayed reminding patrons that there are residents living nearby and instructing them to respect neighbours and to conduct their behaviour accordingly.
- 2. Notices shall be prominently displayed at all exits used by delivery drivers requesting them to respect the needs of local residents and leave the area quietly
- 3. After 23:00 hours, drivers shall wait inside the premises between deliveries/for deliveries
- 4.Delivery drivers/riders will be given clear, written instructions to use their vehicles in a responsible manner so as to not cause nuisance to any residents or generally outside the licensed premises; not to leave engines running when the vehicle is parked; and not to obstruct the highway. The licence holder will positively encourage delivery drivers/riders to use quieter vehicles that are less likely to cause a nuisance such as bicycles.

2. BACKGROUND

The main access to the premise's unit is located on Walham Grove at its junction with North End Road. There is a mixture of both residential and commercial premises within the area. A map showing the location of the premises and neighbouring licensed premises can be seen on pages **41-46** of this report.

There are several options for transport away from the area including buses and taxis which run from in and around the North End Road and Fulham Road area. Fulham Broadway tube station is a 5-minute walk away and Parsons Green tube station is a 10-minute walk away.

3. CONSULTATION

A public notice was displayed at the premises for 28 days. The application was advertised in a local circular and all statutory consultees were notified as required by the Regulations. The Council has served written notice of hearing upon the applicant and all those parties that have made representations in respect of the application.

3.1. Relevant Representations

The Licensing section received fifty representations in total objecting to the application. Of these representations, one was received from Councillor Campbell-Simon objecting to the licence application. A copy of this representation can be seen on page **47-48** of this report.

The licensing section received one representation on behalf of the Vanston Place Management Company with a petition attached, one representation on behalf of the Barclay Road Conservation Area Neighbour Hood Watch, and forty-seven representations from local residents objecting to the licence application. A copy of the representations can be seen on pages **49-175** of this report.

On the 24 August 2023 the licensing team informed all representors of the amendments to the licensable hours and agreed conditions in section 1.3 of the report. A copy of the correspondence and comments can be found on pages **176-193** of this report.

The licensing section also received comments from the Planning team. A copy of the comments can be seen on page **194-198** of this report.

4. OTHER INFORMATION

4.1 Enforcement History

On the 27 October 2022, a warning letter was issued in response to a failed test purchase undertaken on the 21 October 2022 ascertaining unauthorised late-night refreshment.

A further three on site test purchases were attempted on the 25 and 26 November 2022 and 27 January 2023. All three passed.

An online test purchase was attempted on the 17 March 2023 and the premises passed.

4.2 Temporary Event Notices ("TENs")

No TENs have been submitted in respect of this premises in the past twelve months.

4.3 Premises Licence History

On the 06 July 2023 an application was submitted to transfer the premises licence with immediate effect from DFSI M25 Ltd to PJ Corp Stores Limited.

On the 4 November 2022 a variation of the premises licence was submitted by the previous licence holder DFSI M25 Ltd. This was rejected by the committee on the 14 February 2023.

4.4 Other Correspondence

On the 29 August 2023, the applicant's agent, Walati Rathore of Licensing Law Consultancy copied in the licensing authority to an email requesting a meeting with residents. A copy of the correspondence can be seen on pages **199-200** of the report.

5. POLICY CONSIDERATIONS

- **5.1** Section 5 pages 12 and 13 of the Statement of Licensing Policy ("SLP") states that in order to ensure the promotion of the four Licensing Objectives the Licensing Authority will require applicants to detail in their operating schedule:
 - the steps proposed to promote the licensing objective of the prevention of crime and disorder on, and in the vicinity of, the premises, having regard to

- their location, character, condition, the nature and extent of the proposed use and the persons likely to use the premises;
- the steps proposed to ensure the physical safety of people using the relevant premises or place;
- how they intend to prevent nuisance arising, prevent disturbance and protect amenity so far as is appropriate to ensure that the Licensing Objectives are met. Where there is a relevant representation regarding extended hours, the Licensing Authority will not permit an extension unless it is satisfied that the Licensing Objectives would be met;
- the measures and management controls in place to protect children from harm. Where appropriate a written childcare policy should be available and be incorporated in the induction of staff.
- **5.2** Policy 1 page 18 confirms that The Secretary of State's Guidance states that applicants are expected to obtain sufficient information to enable them to demonstrate, the steps they propose to take to promote the licensing objectives; and that they understand the layout of the local area and physical environment including:
- a) crime and disorder hotspots;
- b) proximity to residential premises;
- c) proximity to areas where children may congregate;
- d) any risk posed to the local area by the applicants' proposed licensable activities; and
- e) participation in any local initiatives (for example, local crime reduction initiatives or voluntary schemes, such as 'Ask for Angela', local taxi-marshalling schemes, street pastors and other schemes) which may help to mitigate potential risks.

Applicants are expected to include positive proposals in their application on how they will manage any potential risks.

The Guidance goes on to state that 'Applicants are expected to provide licensing authorities with sufficient information in this section to determine the extent to which their proposed steps are appropriate to promote the licensing objectives in the local area. Applications must not be based on providing a set of standard conditions to promote the licensing objectives and applicants are expected to make it clear why the steps they are proposing are appropriate for the premises.'

The Licensing Authority notes the contents of these paragraphs from the Secretary of State's Guidance and, in particular, the use of the word 'expected'. Licence applications that do not in any way address the contents of these paragraphs in their operating schedules may be returned to the applicant as 'incomplete'.

- **5.3** Policy 3 page 21 of the SLP states that where there is a relevant representation, the Licensing Authority will consider each particular case on its merits having regard in particular to the following matters:
- a) Whether the licensed activities are likely to have an adverse impact especially on local residents and, if there is potential to have an adverse impact, what, if any, appropriate measures will be put in place to prevent it;
- b) Whether there will be a substantial increase in the cumulative adverse impact from these or similar activities, on an adjacent residential area;

- c) Whether there is a suitable level of public transport accessibility to and from the premises at the appropriate times;
- d) Whether the activity will be likely to lead to a harmful and unmanageable increase in car parking demand in surrounding residential streets suffering high levels of parking stress or on roads forming part of the Strategic London Road Network or the London Bus Priority Network leading to a negative impact on the Licensing Objectives relating to the prevention of crime, disorder, anti-social behaviour (ASB), nuisance and vehicle emissions;
- e) Whether there have been any representations made by Responsible Authorities, or other relevant agency or representative.

The Licensing Authority will closely scrutinise extended hours applications to ensure that the Licensing Objectives are met. In determining an application the licensing committee might decide that the circumstances are such that a restriction on hours is the only appropriate means to achieve the Licensing Objectives. If an 'hours' restriction is imposed, the Licensing Authority will normally require that customers should be allowed a minimum of thirty minutes to consume alcohol.

To act as a guide for new or existing operators we have set out the suggested closing times for licensed premises below:

5.4 Policy 4 pages 22 and 23 of the SLP states that in determining an application where there has been a relevant representation the Licensing Authority will, where appropriate, take into account the cumulative effect of the number, type and density of licensed premises already existing in the area. Consideration will be given to the proximity to any drug and alcohol treatment site, A&E department or homeless hostel in a local area type remit ie applicants need to make the case for how they would not increase further problems for residents/clients nearby.

In coming to any decision regarding cumulative impact the Licensing Authority will consider other mechanisms outside of the licensing regime which may also be available to address this issue, these include but are not limited to:

- Police and other enforcement of the normal law concerning disorder and anti-social behaviour.
- Police powers to close down instantly any licensed premises or temporary events on grounds of disorder, the likelihood of disorder or excessive noise emanating from the premises, for up to 24 hours.
- The power of the police, other responsible authorities, a local resident, business or Councillor to seek a review of the licence or certificate in question.
- Police and Local Authority power to issue a Closure Notice for up to 48 hours where serious antisocial behaviour is taking place at licensed premises under the Anti-social Behaviour, Crime and Policing Act 2014.
- To ensure that residents are protected from the negative impact of late-night local licensing activities the Licensing Authority may decide to adopt an Area Specific

Cumulative Impact Policy in relation to a specific area; where the number, type and density of premises providing licensable activities is having a serious negative impact on the local community and local amenities.

5.5 Policy 11 page 30 of the SLP states that Licensing law is not the primary mechanism for the general control of nuisance and anti-social behaviour caused by people once they are away from the licensed premises and, therefore, beyond the direct control of the licensee. However, licensing is a key aspect of such control and licensing law is part of a holistic approach to the management of the night time economy.

As a matter of policy the council expects every holder of a licence, certificate or permission, to accept and be responsible for minimising the impact of their activities and anti-social behaviour by their patrons within the vicinity of their premises by taking appropriate measures and action consistent with that responsibility.

Licensees and certificate holders should take reasonable steps to prevent the occurrence of crime and disorder and public nuisance immediately outside their premises, for example on the pavement, in a beer garden or in a smoking area, to the extent that these matters are within their control.

Population densities in this borough are high, with many residential premises located above or in close proximity to licensed premises. This means that the public nuisance and crime and disorder objectives will be of paramount concern when evaluating Operating Schedules. Licensing Committees will place high regard on the control measures put in place by the applicant to ensure that our residents are protected from the potential detrimental effects of any licensed premises.

- **5.6** Policy 14 pages 32 and 33 of the SLP in relation to delivery services states that the Licensing Authority has concerns with the potential for the following:
 - Age verification at both purchase point and delivery point;
 - The safety of delivery drivers at the point of delivery;
 - Safety of the premises from which orders are taken and sent out for deliver; and, Possible public nuisance and anti-social behaviour (ASB) caused by delivery drivers collecting deliveries from the licensed premises.

The Licensing Authority is likely to place the following conditions on to a premises licence for delivery services where it is appropriate and relevant to the individual licence application:

- A standard age verification check shall be undertaken on entering the website.
- A signature at the point of delivery must be obtained. No delivery shall be left without a signature.
- Alcohol shall only be delivered to a residential or business address and not to a public place.
- Every third-party courier delivery box shall be labelled with the words "Age Restricted Product".
- Any delivery driver or third-party courier will be required to have appropriate age verification training, particularly they will be required to have training in refusal of supply where age verification is not provided.
- A refusals log will be maintained for deliveries.
- Appropriate security will be in place at the premises as agreed with Police.

- Measures for minimising noise and disturbance and anti-social behaviour (ASB) caused by the dispatch of deliveries to be identified in the operating schedule. In particular applicants are expected to consider the use of electric vehicles to minimise air pollution and noise. The Licensing Authority expects that applicants will make arrangements for all deliveries after 8 pm to be made using electric vehicles or non motorised vehicles i.e. bicycles.
- A requirement for a specific delivery collection area to be made clear to any third party delivery service. This area may not be directly outside the licensed premises to take account of any residential accommodation close by or obstructing the pavement/highways.
- **5.7** Annex 1 pages 35 and 36 of the SLP in relation to the prevention of crime and disorder states licence applicants will be expected to demonstrate the following in their operating schedules:
- a) Measures to control excessive consumption and intoxication.
- b) Consideration of any additional measures or restrictions that may be placed on alcohol sales to prevent binge drinking and promote 'sensible drinking'.
- e) Measures to demonstrate compliance Home Office guidance 'Safer Clubbing' in relation to the control of illegal drugs on their premises. They should agree a protocol with the Licensing Authority and the police on the handling of illegal drugs found on their premises.
- g)Conditions will, so far as possible, reflect local crime prevention strategies, and the Licensing Authority will also have regard to the views of the local Crime and Disorder Reduction Partnership.
- h) **Crime and disorder in the vicinity of the premises**: this may include the crime and disorder risks arising from persons queuing to enter the premises; persons exiting the premises and customers smoking eating or drinking in outdoor areas and on the highway outside the premises. This can also include crime arising from pickpockets and bag snatchers, particularly in open spaces or crowded areas where alcohol is being consumed.
- j) **CCTV** using CCTV inside and/or outside the premises together with appropriate procedures and having staff properly trained to use CCTV equipment
- I) dealing with and reporting crime and disorder training for staff and door security aimed at reducing crime and disorder in the premises and its vicinity and dealing with and reporting incidents if they occur.
- p) **local schemes** joining and attending local Pubwatch meetings and participating in the Behave or Be Banned Scheme (BOBB) and/or signing up and using the Council's Safety Net Radio scheme.
- q) **prevention of theft** using bag hooks and signage to warn customers of pickpockets and bag snatchers.
- **5.7** Annex 1 pages 38 to 40 of the SLP in relation to the prevention of public nuisance states that the Licensing Authority will particularly consider the following matters where they are material to the individual application:
- i. The Licensing Authority recommends that primarily alcohol led premises such as nightclubs and pubs, located close to any residential premises, implement a dispersal policy at their venue. All relevant staff should be trained on any policy, and all Page 39 reasonable steps should be taken to ensure it is fully implemented and adhered to at all times.
- ii. The proximity of residential accommodation;

- iii. The type of use proposed, including the likely numbers of customers, proposed hours of operation and the frequency of activity;
- iv. The steps taken or proposed to be taken by the applicant to prevent noise and vibration escaping from the premises, including music, noise from ventilation equipment, and human voices. Such measures may include the installation of soundproofing, air conditioning, acoustic lobbies and sound limitation devices;
- v. The steps taken or proposed to be taken by the applicant to prevent disturbance by customers arriving at or leaving the premises.
- viii. The steps taken or proposed to be taken by the applicant to prevent queuing (either by pedestrian or vehicular traffic). If some queuing is inevitable then queues should be diverted away from neighbouring premises or be otherwise managed to prevent disturbance or obstruction;
- ix. The steps taken or proposed to be taken by the applicant to ensure staff leave the premises quietly;
- x. The arrangements made or proposed for parking by patrons, and the effect of parking by patrons on local residents;
- xi. The provision for public transport in the locality (including taxis and private hire vehicles) for patrons;
- xii. The level of likely disturbance from associated vehicular and pedestrian movement to and from the premises;
- xiii. The delivery and collection areas and delivery/collection times;
- xv. The arrangements for refuse disposal, storage and the prevention/tidying of litter (including fly posters and illegal placards);
- xviii. The generation of odour, e.g. from the preparation of food;
- xix. Any other relevant activity likely to give rise to nuisance;
- xx. Any representations made by the Police, or other relevant agency or representative;

The following provides a non-exhaustive list of risks associated with the public nuisance objective that applicants may want to consider when preparing their Operating Schedule:

- j) **Deliveries/collections** noise from deliveries to and/or collections (e.g. refuse) from the premises are another common source of complaint. Consider the times of such deliveries/collections and make sure you specify to any contractors that deliveries/collections should not be made at anti-social times. As a guide, the Noise and Nuisance Service recommend that deliveries/collections should only be made between the hours of 7:30am and 9:00pm, depending on the proximity of residential and/or other noisesensitive properties.
- k) Late night refreshment applicants in respect of late night takeaways should demonstrate that they have assessed the risk of persons congregating in large numbers in the vicinity of their premises. Where appropriate, applicants should demonstrate suitable measures to address this problem.
- l) **Light pollution** this is an increasingly common source of complaint, particularly from illuminated signs and external security lighting. Where provided, illuminated signs should not cause glare to neighbouring properties, ideally being turned off at night, and external lighting should be angled and/or diffused to also prevent nuisance.
- o) **Odour** odour from cooking is a common source of complaint, particularly from restaurants and fast[1]food takeaways. The Council's Noise and Nuisance Service may therefore require evidence that the kitchen ventilation and/or extract systems are regularly maintained and serviced to ensure that it is operating efficiently and with minimal nuisance to neighbours arising from odour and also noise. This includes the siting of BBQs.

- p) **Queue management** establishing appropriate procedures to avoid the need for customers to queue before entering the premises or, where queuing cannot be avoided, to manage queues so as to minimise the potential for crime and disorder or public nuisance by customers who are queuing.
- q) **Ventilation** where regulated entertainment is to be provided there may be a requirement to keep doors and/or windows closed during its provision to limit noise breakout, consider therefore the provision of air conditioning for the comfort of your customers if doors and windows have to be closed during the summer. However, also note air conditioning can be the source of noise complaints in itself, so careful consideration also needs to be given to the siting of this equipment.
- r) **Waste** consider how and where waste will be stored/disposed of at the end of trading hours, particularly if trading until late at night. This is important because the disposal of glass and/or cans to outside bin areas can be very noisy and give rise to complaints, so it may be necessary to store such items and other non-degradable refuse inside the premises until the next trading day. Consideration should also be given to the time of deliveries to minimize disruption to local residents.
- s) Litter for example, litter patrols for late night take-away premises

6. DETERMINATION

- **6.1** In determining this application, the Committee must have regard to the representations and take such of the following steps as it considers necessary for the promotion of the licensing objectives. The steps are:
- (a) Grant the application in full
- (b) Grant the application in part modifying the proposed hours, activities or conditions.
- (c) Reject the application

It is the Council's duty under the Licensing Act 2003 ("The Act") to determine applications with a view to promoting the four licensing objectives; Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance and the Protection of Children from Harm.

In reaching a decision the Council shall consider the details of any relevant representations received; the applicant's Operating Schedule; the Council's adopted Statement of Licensing Policy and the guidance issued by the Secretary of State under section 182 of the Act.

If the Committee is minded to grant the application conditions may be attached to the licence to alleviate the concerns raised through the representations.



Further to previous communications, I am pleased to confirm that your proposal for the revised hours and conditions are agreed (subject to a minor tweak to the start time) as follows:

The provision of late night refreshment - Both Indoors and Outdoors Sunday- Thursday between the hours of 23:00 to 00:00 Friday and Saturday 23:00-01:00 Proposed Opening Hours:
Sunday-Thursday 10:00-00:00 Friday and Saturday 10:00-01:00

- 1. Signs shall be prominently displayed reminding patrons that there are residents living nearby and instructing them to respect neighbours and to conduct their behaviour accordingly.
- 2.Notices shall be prominently displayed at all exits used by delivery drivers requesting them to respect the needs of local residents and leave the area quietly
- 3. After 23:00 hours, drivers shall wait inside the premises between deliveries/for deliveries

I am writing to formally object to the licensing application submitted by Papa John's for the extension of their opening hours at 63 Walham Grove, London, SW6 1QR.

As a local councillor representing the neighbouring ward (Walham Green) this is really a cross ward issue which is further reinforced by the number of emails against this application I have received in my inbox.

I along with my constituents are deeply concerned about the potential negative impacts such an extension (till 5am) will have on the residents and the overall neighborhood if granted.

In accordance with the licensing objectives outlined in the 2003 Act, I believe that the proposed extension of opening hours for Papa John's fails to meet these objectives. I would like to outline my objections based on each licensing objective:

- 1. Prevention of Crime and Disorder: The extension of operating hours until 5am will likely result in an increased likelihood of crime and disorder within the area, especially during late hours. This could include disturbances, public intoxication, and anti-social behaviour. The potential for such incidents would negatively impact the safety and well-being of the community.
- 2. Prevention of Public Nuisance: The proposed extension will result in amplified noise levels during late hours/ early morning disrupting the peace and tranquility of nearby residents, especially with regards to takeaway riders as they will be the sole service from 2am until 5am. The application is for the extension in hours Monday to Sunday and it is wholly unacceptable for residents to be subjected to this increase in noise 7 days a week.

The noise generated by increased commercial activity late at night/early hours of the morning would have detrimental effects on the quality of life and general well-being of the community, there are many other takeaway restaurants on the north end road and from my knowledge none of these

spots have opening hours until 5am, if granted this will set a dangerous precedent for other takeaway spots to apply for an extension for later operating hours.

Given these concerns, I strongly believe that granting an extension of opening hours to Papa John's at this location would be contrary to the aforementioned licensing objectives.

It is crucial to safeguard the interests and well-being of our community by maintaining a balance that ensures the safety, peace, and quality of life of our residents.

I respectfully request that the licensing authority considers these objections and conducts a comprehensive evaluation of the potential adverse effects associated with extending the opening hours of Papa John's at 63 Walham Grove, London, SW6 1QR.

Thank you for your attention to this matter. I trust that you will carefully consider this objection and make a well-informed decision that upholds the licensing objectives and prioritises the interests and well-being of the community.

I am writing on behalf of Vanston Place Management Company, who look after the interests of the residents of Dungannon House, a block of 42 residential apartments fronting onto Vanston Place and running back parallel with Walham Grove where Papa Johns is situated. The block consists of 8 floors, approximately half of which have balconies looking towards the applicants property as well as 32 bedrooms, and 23 living rooms facing Papa Johns.

We strongly object to an increase of hours in this application, to in effect 24 hours, on the ground of noise and nuisance in this primarily residential road. Also it would be a dangerous precedent that could lead to numerous demands from nearby businesses wanting similar hours.

Many of our residents overlooking the back of the two restaurants - Papa Johns and its neighbour, Jerk Kitchen are already troubled by the noise and smells that emanate from them. Our building, which is ten years old, has been built to current building specs and thus very well insulated. Our residents have to open windows to allow air in, even in winter, otherwise they will overheat. If Papa Johns cooks throughout the night the smells and noise will continue and interfere what we believe is a human right of a good nights sleep. I believe you are already in receipt of the document showing Hammersmith and Fulham residents are considered to be the most sleep deprived of residents in London. Attached again for reference.

At the front of the premises, all the food cooked throughout the night will have to be sent out using motor scooters. This will result in noise as the drivers arrive/depart or congregate waiting for deliveries. This is currently a quiet area in the early hours or the morning and all noise like this is loud and troublesome. One main route the scooters will take is past the front of our building along Vanston Place, cutting through the pedestrianised section beside Vagabond (illegally) and onto the Broadway. There are no other establishments that work throughout the night in this vicinity at present, and we would like to keep it that way.

As local residents we already have to contend with piles of rubbish and litter from Papa Johns around that corner of the street, if their hours of operation increase, the volume of rubbish will increase. They state in their application Section M, clause d. 'Arrangements for the storage and disposal of refuse will not cause a nuisance'. However they clearly do cause a nuisance as regularly rubbish is left out overnight leaving it open to be strewn around by foxes etc. The attached picture is from yesterday (Sunday 3pm) showing rubbish and litter left out on Saturday night and not collected. This is not an isolated case, it happens most days as I believe the Committee is aware of.

I would now like the Committee to be aware of two pertinent comments from past planning/license applications:

Firstly some information shared by Papa John's in Tower Hamlets stating in bullet point 3 on page one of the 2-page pdf attached of a Lic Hearing on 4/12/19 that it takes two hours to close/shut down a Papa John's Pizza Shop.

One assumes this refers to end of day or end of night/small hours closing and that this entails cleaning, rubbish organisation, lights on, staff in the shop and moving out onto the pavement doing various, doors opening and closing to the street or rear areas etc. I enclose the 2-pg pdf of the decision.

Although each Licence Application must be considered on its own merits, this 2-hour window seems like a company-wide procedure that would also be similar at the existing Premises at 63 Walham Grove. This would be important to note as it means there will be noise and possible ongoing movement nuisance of rubbish onto the pavement during sleeping hours. If granted 24-hr when would these cleaning procedures take place?

Secondly, at the appeal with the Planning Inspectorate regarding the change of use for this building, they quite rightly took into consideration any adverse effect it would have on people living nearby as a result of noise and disturbance. In making their decision they put a condition on the approval of the application regarding closing times - keeping it in line with neighbouring establishments. Currently the nearest neighbouring similar establishments, The Cock Tavern, Jerk Kitchen and Fouberts (now called Vanston Cafe) close at 12am, 11pm and 11pm respectively. Papa Johns is currently in keeping with these so according to this condition there should be no further increase in these hours. Earlier this year they requested an increase of hours, which has already been declined. This is a residential area, not an industrial estate where night time working would be more easily tolerated.

One resident here has recently reported to me that 'way after 12.00' they had pulled the shutters down appearing to be closed, but were still operating their business. Perhaps this was within their 2-hour shutting down?, but there were taking money and trading way past their approved hours. This flagrant disregard for the law is of concern.

I have noted that there are two branches of Papa Johns, Hammersmith and Putney, which are both within easy reach, particularly on empty roads at night. Both of these are far better suited to run a Night Kitchen, as they are surrounded by similar establishments, restaurants, cafes and takeaways, rather than at the end of a quiet residential road like Walham Grove. Both are on major arterial roads, and Putney even has off street parking for scooters. Papa Johns is a nationwide chain and could easily run this new venture from another branch, in a less residential setting.

If this extension is granted it will set a precedent and we are fearful of this. A vibrant mixed community is one thing during the days and into late evenings, but residents are also a vital part of the mix and their nightimes need to be protected. Our building is surrounded by similar establishments and it would be intolerable if they all decided to request similar working hours.

We respectfully request that all the current variations to the license be rejected.

I have put the originals in the post just now (first class) addressed to you.



Minutes

At the request of the Chair, Ms Lavine Miller-Johnson, Licensing Officer, introduced the report which detailed the application for a variation of a premises licence for Papa John's Pizza, 6 Cotal Street, London E1 8JG, It was noted that objections had been received by local residents.

At the request of the Chair, Mr Harris Sarwar, Applicant's representative explained that the application sought was to provide a late night opportunity for customers to buy pizza. He explained that they had 20 members of staff, the company valued the local community and their main aim was to serve the local community. He stated that there had been no complaints of crime and disorder at the premises.

It was noted that a silencer had been added to the extractor fan to reduce noise, exhaust silencers had also been added to the delivery vehicles and they were currently looking at the waste policy to make bags more durable.

It was noted that the objectors were not present at the meeting and therefore the Sub-Committee noted and considered the written objections contained in the agenda pack.

In response to Members' questions, the following was noted;

- A takeaway order usually takes 20-25 minutes.
- The incident referred to in the objection, where the premises was seen to be open beyond trading hours, occurred when staff were waiting for a customer to collect their order.
- It can take up to two hours to close down the premises.
 There were other premises on Cable Street which also used delivery drivers and vehicles.

 It can take up to two hours to close down the premises.
- Papa John's staff and motor vehicles could easily be identified by their uniform/logos.
- They had purchased new bikes with built in silencers to help reduce noise.
- Since opening, they had been taking extra precautions and measures – and were willing to adopt any new conditions the Sub-Committee felt necessary and proportionate.

- A silencer had been added to the extractor fan and seven new vehicles with exhaust silencers had been purchased to help reduce noise.
- Staff had been re-trained.
- Staff cleaned the outside of the premises regularly each day.
- Signs asking customers to leave quietly and respect the needs of local residents were displayed in the premises.

Members adjourned the meeting at 6.20pm for deliberations and reconvened at 6.35pm.

The Licensing Objectives

In considering the application, Members were required to consider the same in accordance with the Licensing Act 2003 (as amended), the Licensing Objectives, the Home Office Guidance and the Council's Statement of Licensing Policy and in particular to have regard to the promotion of the four licensing objectives:

- 1. The Prevention of Crime and Disorder;
- 2. Public Safety:
- 3. The Prevention of Public Nuisance; and
- 1. The Protection of Children from Harm.

Consideration

Each application must be considered on its own merits. The Sub-Committee carefully considered all of the evidence before them including the application and written objections contained in the agenda pack and the representations at the meeting from representatives on behalf of the Applicant.

The Sub-Committee considered the objectors' concerns about the likely increase in noise, public nuisance, crime and anti-social behaviour if the application were to be granted.

The Sub-Committee considered that there was insufficient evidence in the application and operating schedule to demonstrate or satisfy the Sub-Committee that the granting of the application would promote the licensing objectives, in particular the prevention of public nuisance.

The Sub-Committee was not satisfied that conditions would adequately mitigate the risk of public nuisance caused by noise from staff, customers and delivery drivers at late night in an increasing densely populated residential area.

Accordingly, the Sub-Committee unanimously:-

RESOLVED

That the application for a variation of the Premises Licence for Papa John's, 6 Cable Street, London E1 8JG be **REFUSED**.

- I have been appointed by the Secretary of State for the Environment to determine this appeal. The appeal is against the failure of the Council of the London Borough of Hammersmith and Fulham to give within the prescribed period notice of their decision in respect of an application for the conversion of the existing ground floor bakery use to a fish and chip take-away restaurant at 63A Walham Grove, Fulham. have considered the written representations made by you and by the Council and also those made by interested persons, including those representations made directly to the Council which have been forwarded to me. As you know, I inspected the site on 31 January 1994.
- The Council resolved that had it been empowered to do so, it would have refused your clients' application on the grounds that: 1) it would give rise to customer parking and manoeuvring which would be prejudicial to highway safety; and 2) the proposal would result in an increase in noise and disturbance, thereby harming the amenities of nearby residents.
- The building is within the Walham Green Conservation Area and under the provisions of Section 72(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990 there is a duty to pay special attention to the desirability of preserving or enhancing the character or appearance of such areas.
- The Council have formulated and published guidelines forrestaurant uses which complement policies contained in the adopted Borough Local Plan and the emerging Unitary Development Plan (UDP). Policy SH12 in the emerging UDP



indicates that when considering proposals for food and drink establishments, account will be taken of their effect on residential amenities, their impact on traffic and the cumulative effect of the introduction of new A3 Uses. The Council's guidelines for restaurant uses highlight factors such as location and access requirements and the potential detrimental effects.

- 5. The appeal property is a prominent 3 storey corner building situated on the junction of Walham Grove and Vanstone Place. It is included in the Council's local register of buildings of merit. The application relates to the ground floor of the premises, which was formerly a bakers shop, but is now vacant. In addition to the proposed change of use of the shop to a hot food take-away, the development involves the installation of a new shop front and the fixing of an external ventilation duct to the rear elevation of the building.
- 6. From what I have read in the representations and seen during my inspection of the site and its surroundings, I consider there are three main issues in this case. These are: firstly, the effect on the character and appearance of the Walham Green Conservation Area; secondly, whether the development would adversely affect the amenities of people living nearby as a result of noise and disturbance; and thirdly, whether it would be detrimental to highway safety.
- The appeal site is a short distance from Fulham Broadway and the locality is typical of a town centre location, with the buildings containing a mixture of commercial uses at ground floor level and residential accommodation on the upper floors. The proposed use would not be very dissimilar to the previous use which also involved the preparation, cooking and sale of foodstuffs. I noticed that there is a street market in North End Road and the character of the area is one of a busy vibrant shopping centre. I therefore consider the proposal to be entirely in keeping with this character and the new shop front is typical of many in the area. The proposed ventilation ducting would be positioned on the rear elevation of the building, where it would not be widely seen and it is proposed to be painted in a dark colour to minimize its visual impact. I thus conclude the development would preserve the character and appearance of the Walham Green Conservation Area.
- 8. Turning to the second issue, I noted during my visit that the appeal premises are close to a busy road junction and adjoin a launderette which operates until 10pm every day. There is a public house opposite and several other catering premises in the vicinity which also remain open late into the evening. Having regard to the commercial nature of the locality and the very high volume of vehicular and pedestrian traffic, I found the area to be quite noisy. Whilst I accept that the proposed use would also attract night-time customers, the ambient noise levels are such that I consider it would be most unlikely for residents in the neighbourhood to be

disturbed by additional noise attributable to customers of the proposed fish and chip shop. Furthermore, I am satisfied that I can prevent any customer noise at unsociable hours, by attaching a condition to restrict the operation of the premises to opening times similar to those of comparable nearby establishments. In these circumstances, I conclude the development would not adversely affect the amenities of people living nearby as a result of noise and disturbance.

- 9. I now turn to the third issue. The appeal site, in common with many of the other properties in the locality, has no off-street parking facilities. Additionally, I noted that there are double yellow lines in front of the premises and in Walham Grove there is kerbside parking for residents and meters for the general public. I have seen no evidence to suggest that customers attracted to the proposed fish and chip shop would add unacceptably to the already high traffic flows, or place undue strain on the available roadside parking in the area. I am therefore not persuaded the proposal would result in a significant increase in pedestrian and vehicular movements. I therefore conclude the development would not be detrimental to highway safety in the locality.
- 10. The Council have suggested a number of conditions, which I have considered in the context of the criteria set out in Circular 1/85. I also note that the final submitted drawings followed extensive negotiations with officers of the Council and their report to the Sub-Committee indicates that the details contained therein meet with their approval and I see no need for conditions which reiterate the specifications shown on the drawings. In addition to the standard time condition, I therefore only propose to attach conditions relating to hours of operation and the installation of the ventilation system prior to the use commencing.
- 11. I have considered all the other matters raised in the representations including the presence of other A3 uses in the locality, but I have found no other matter of such weight as those upon which I have formed my conclusions and which lead to my decision.
- 12. For the above reasons and in exercise of powers transferred to me, I hereby allow this appeal and grant planning permission for the conversion of the existing ground floor bakery use to a fish and chip take-away restaurant at 63A Walham Grove, Fulham, in accordance with the terms of the application No 93/00026, dated 11 January 1993 and the plans submitted therewith, subject to the following conditions:
 - 1. the development hereby permitted shall be begun before the expiration of 5 years from the date of this letter;

The use hereby permitted shall not take place other than between 0900 hours and 2330 hours from Monday to Saturday and between 1130 hours and 2230 hours on Sundays; The fume extraction system hereby permitted shall be fully installed and operational before the use is commenced. An applicant for any consent, agreement or approval required by a condition of this permission has a statutory right of appeal to the Secretary of State if consent, agreement or approval is refused or granted conditionally or if the authority fail to give notice of their decision within the prescribed period. 14. The developer's attention is drawn to the enclosed note relating to the requirements of the Building Regulations 1991 with respect to access for disabled people.

15. This letter does not convey any approval or consent which may be required under any enactment, bye-law, order or regulation other than Section 57 of the Town and Country Planning Act 1990.

16. Your attention is drawn to the provisions of Section 74 of the Planning (Listed Buildings and Conservation Areas) Act 1990 which requires consent to be obtained prior to the demolition of buildings in a conservation area.

Sleep Disturbances



Is there a better feeling than waking up after having a good night's sleep? For some people around the UK, it's been far too long since they managed to experience this, and the idea of a long and perfect sleep is something only dreams are made of.

There are a number of reasons why our sleep can be disturbed, such as a baby, nearby parties, old pillows and duvets that desperately need replacing, or even a barking dog.

That's why our experts at Sleepseeker have looked into which places in the UK have made the most noise complaints, and what the most common type of noise complaint is. We've also found out what worries are keeping us up at night, and how you can rediscover what a good night's sleep feels like.

We've looked at which UK local authorities outside of London have made the most noise complaints in the 2021 calendar year.



1 - Aberdeen City Council - 2,245 noise complaints per 100,000

Aberdeen takes first place with 2,245 noise complaints per 100,000. Aberdeen had a total of 4,459 noise complaints, with the majority of these because of loud music. Aberdeen also had the second highest complaints about anti-social behaviour, with 711.

2 - Southampton City Council - 2,007 noise complaints per 100,000

Southampton takes second place with 2,007 noise complaints per 100,000. Southampton had a total of just over 5,000 noise complaints, with almost 2,000 of these complaints being about loud music. Southampton was also the only city to complain about noise from the docks.

3 - Belfast City Council - 1,943 noise complaints per 1000,000

Belfast completes our top three with 1,943 noise complaints. The capital of Northern Ireland had almost 600 more complaints per 100,000 than fourth-placed Swansea, as well as the third-highest total complaints with 6,644.

The Least Sleep-Disturbed Places Outside of London

We've looked at which local authorities have filed the fewest noise complaints to discover the least sleep-disturbed people in the UK.



1 - Norwich City Council - 70 noise complaints per 100,000

Crowned our least sleep-deprived place in the UK is Norwich with just 70 noise complaints per 100,000 people. Norwich also recorded the fewest total noise complaints with just under 100 noise complaints during 2021. Exactly half of Norwich's total noise complaints were a result of loud music.

2 - Bolton Metropolitan Borough Council - 105 noise complaints per 100,000


Bolton takes second place with just over 100 noise complaints per 100,000. Bolton also had the second-fewest total noise complaints in the UK with 301. Like Norwich, most of Bolton's noise complaints were because of loud music. Bolton also recorded the most complaints about fireworks, with 14 noise complaints.

3 - City of Edinburgh Council - 116 noise complaints per 100,000

Completing our top three is the capital of Scotland, Edinburgh, who recorded 116 noise complaints per 100,000. Edinburgh's grand total was 614, with over half of these coming from commercial noise. Edinburgh also had 129 complaints about alarms.

The Most Sleep-Disturbed London Borough

London is the most populated city in the UK, made up of 32 boroughs. We wanted to find out which of these London boroughs filed the most noise complaints in 2021.



1 - Hammersmith and Fulham Borough Council - 5,536 noise complaints per 100,000

Hammersmith and Fulham takes the top spot with just over 5,536 noise complaints per 100,000 people. The

most frequent complaint was due to loud music, followed by domestic complaints, and parties. Interestingly, Hammersmith and Fulham had one of the lowest populations out of the London boroughs, with just three below them, as well as the third most noise complaints in total.

2 - Newham Borough Council - 4,202 noise complaints per 100,000


Newham takes second place with 4,202 noise complaints per 100,000. In the east part of inner London, Newham's residents have made a total of 14,753 noise complaints in 2021. Most of these complaints were because of people, which made up over 9,000 Newham's total. Newham also has one of the highest populations out of the London boroughs.

3 - Lambeth Borough Council - 3,784 noise complaints per 100,000

Completing our top three is Lambeth which filed 3,784 noise complaints per 100,000 people. The South London Borough made just over 12,000 noise complaints in total during the course of 2021, the second-highest total in our list.

Most Common Noise Complaints in the UK

We've looked at the different types of noise complaints filed by residents to discover the most common reason people complain about noise.



1 - Music - 35,643 noise complaints

Music was the most common reason people filed noise complaints, with over 35,000 complaints. Listening to music is great, especially in social circumstances or when helping time pass by at work. However, being cautious with volume is important when considering neighbours close by.

2 - Domestic - 17,851 noise complaints


Domestic noise was the second most frequent complaint with almost 18,000 cases in 2021. Domestic noise covers several different complaints, localised in someone's house. Similar to complaints about people, domestic includes raised voices, banging, loud televisions and radios, and DIY activities.

3 - People - 15,628 noise complaints

Completing our top three is complaints against people, with 15,628 complaints made about the noise of people. This includes a number of complaints, such as raised voices, banging, noise from housework etc. A lot of these complaints came from Newham who recorded over 9,000 complaints in this category.

The Most Common Worries that Keep you up at Night

It's not always the external noise that can keep you up at night. Life is stressful and some of these worries can have a detrimental effect on your sleep. That's why we've conducted a survey to find out what worries are keeping you up at night.



1 - Your career or work - 52.8% of people can't sleep worrying about this

Your career or work takes up a large part of your life, and as much as you might love your job, it's natural for things not to go your way in the workplace. This stress was the most sleep-restricting worry with 52.8% of people experiencing this.

2 - Money - 50.4% of people can't sleep worrying about this

Money closely follows in second place with exactly 50.4% of people struggling to sleep worrying about their finances. This is completely understandable, especially with the cost-of-living crisis making times harder for everyone.

3 - The Future - 45.9% of people can't sleep worrying about this

Thinking about your future can be incredibly daunting. However, it's an important thing to think about, whether it's your career, the next step in your life, or relationships. This intimidating feeling completes our top three with 45.9% of people struggling to sleep with this worry.

Most Common Financial Worries Keeping People Up at Night

With financial worries being one of the most common reasons people can't sleep at night, we've looked into the specifics to find out the areas of finances that stop people from sleeping.



1 - Energy Bills - 52.5% of people can't sleep worrying about this

Energy bills are getting more and more expensive, so it's no surprise that this takes the top spot. 52.5% of people are struggling to sleep as a result of the rising energy costs despite prices being fixed. The current energy price cap stands at 34p per kWh for households.

2 - Low Savings - 49.4% of people can't sleep worrying about this

Low savings are the second most common financial worry that keeps people awake at night, with 49.4% of people experiencing this. As important as saving is, it's more difficult than ever with prices and bills becoming more expensive.

3 - Rent/mortgage payments - 40.6% of people can't sleep worrying about this

Completing our top three is rent and mortgage payments, where 40.6% of people are struggling to sleep because of this worry. How Does Sleep Affect People

Using the same survey, we've looked at the effects of poor sleep, what helps people get to sleep and what distracts them, and what type of sleep conditions people suffer from.



How poor sleep affects your life: Concentration - 74.1%

A bad night's sleep can affect your life in a number of ways. The most frequent answer was concentration which was chosen by 74% of our respondents. Motivation, productivity, and overall happiness followed behind with over 60% of respondents choosing these answers too.

The most common method people use to help them get to sleep: Full Darkness - 44.6%

Almost 50% of people chose full darkness as the method which helps them get to sleep. This was followed by reading, and avoiding screen time which was chosen by 32% and 28% of respondents respectively.

The most common distraction whilst trying to sleep: Temperature (too hot) - 75.5%

Warm temperatures were the most common distraction whilst trying to sleep, with over 75% of our respondents choosing this answer. This was followed by light, chosen by 63.3% of respondents, and outside noise, chosen by 57.4% of respondents.

Most common sleep condition: Snoring - 47.7%

Snoring was the most common sleep condition people suffer from, with almost half of our respondents snoring whilst they sleep. This was followed by nightmares and sleep talking which was chosen by 35.9% and 20.9% of respondents respectively.

How to Sleep through Noises and Worries

If you're someone who's struggling to sleep due to noises and worries, then we've got some tips to help you get that good night's sleep you deserve.



1 - Get out of bed!

If you're in bed and struggling to sleep, then get out and do something relaxing until you feel sleepy again. Try doing something in dim lighting, such as reading a book, doing a puzzle, or listening to relaxing music. However, if you are to try this, avoid going on your phone or computer, or watching television.

2 - Don't check the time.

Have you ever been in bed, struggling to sleep and checking the time thinking about how much sleep you could get if you fall asleep then and there? Well, this will not

help you fall asleep any quicker, or take your mind off any worries you may have. Instead, this will just increase your stress levels worrying about how little sleep you could end up getting.

3 - Move your bed

If the noise is stopping you from sleeping, then try moving and positioning the bed as far away from the noise as possible, and away from any outside walls. This might seem like a small change, but it could make a difference to your sleep quality and quantity. You could also try moving heavy furniture next to the wall as a way of blocking the noise out.

4 - Earplugs

They might take a bit of time to get used to, but a good pair of earplugs could help reduce the background noise that's stopping you from sleeping. However, if you are to invest in some earplugs, avoid getting earplugs which block out noise higher than 32 decibels as this will allow you to hear important noises like alarms and crying children.

5 - Avoid caffeine late in the day

Caffeine can stay in your system for up to ten hours, so having a caffeinated drink with dinner, or having a cup of coffee or tea with dessert can make it more difficult to sleep when it comes to bedtime.

Helpful Charities

It might feel like you are alone in your struggles, however, times are tough for everybody. There is help out there and talking to someone may ease those stresses. Below are three helpful organisations which can give you advice and guidance to assist you during these uncertain times

1 - Step Change Debt Charity

If you are someone who struggles to sleep due to financial difficulties such as debt, then Step Change Debt Charity may be able to help you. Step Change offer incredibly useful advice for a number of different financial situations, whether it's help with debt, or paying your mortgage. As well as advice, Step Change offer schemes and plans to help you manage.

2 - National Debt Line

Similar to Step Change, National Debt Line is a charity that offers guidance and advice for dealing with debt. They also offer tips on dealing with the cost of living crisis, as well as support in making the most of your money. They also offer free

tools to help you pay off debts in a sustainable way. Budgeting can be a difficult and daunting task, however, the advice offered can make it more manageable.

3 - Mental Health Foundation

As we revealed earlier, 61.2% of people's overall happiness is affected by poor sleep. Sleep deprivation coupled with the stresses life can bring, can cause your mental health to spiral. Methodology

We sent out an FOI request to the top 50 most populated local authorities, as well as all the local authorities in London, regarding the total number of noise complaints, as well as the different types of complaints they had received during the 2021 calendar year.

We used this information to reveal the most sleep-disturbed places and the most common noise complaints in the UK.


Some local authorities will be missing. This is because they either didn't respond or did not have the information. Each local authority categorised the complaints differently.




Finally, we used Harrison Spinks and Sharp for tips on how to sleep through worries and noise.








Objection 2023/01216/LAPR FULL VARIATION

Papa Johns 63 Walham Grove for 24-hr delivery and 21-hour in person collection/takeaway

We oppose the application for all the same reasons given at the February 14 2023 hearing for a very similar application 2021/00867/LAPR, and for new reasons. This NEW Application 2023/01216/LAPR adds more hours to attempt to accomplish

a possible first in Fulham, namely

24-hr delivery of takeaway, and

21-hr collection in person of takeaway products from this Premises (from 5am through the day and night until 2am).

On the grounds of all four licensing objectives not being able to be promoted, we ask the Lic Committee to reject the application in full.

Many residents will be explaining in detail why things are just as they were when residents opposed the previous application 2022/00867/LAPR

on 14 February 2023.

The Premises has changed ownership (which we have learned at previous hearings has no bearing on a Premises Licence), but this Papa John's is the same Papa John's, at the same address as the last application to extend hours. **Only six months ago that application was rejected.**

What's new?

Nothing has been done since the 14 Feb hearing to address any of the concerns of residents, nor the concerns of the Council. This application therefore borders on being vexatious, and may well be determined as vexatious at the hearing.

We respectfully suggest the Committee must consider this point. Much time and money is being wasted here by the Council (and we would like to know those costs) as well as hundreds of hours by residents who are doing everything possible to collect evidence, yet again, for the Committee to refuse this application in full, yet again.

Over time, we have learned that The LBHF Licensing Authority does not build a case for the Lic Committee regarding an Application (we note that other Lic Authorities do build such cases).

In fact, the Lic Authority remains neutral unless so much evidence can be presented by them that they feel legally compelled to make a Representation against the Application, usually for an official Review of s Licence (this could be the case when they have evidence from Police of alcohol being sold multiple times to under age persons, or hot food being sold multiple times beyond the hours licensed for hot food sales at a specific Premises).

This is very rare in our borough. The permissive vs restrictive Licensing Act 2003 encourages a 'Light Touch' approach. The goal is not to rack up evidence of complaints, most of which, we are told, cannot be validated or proven, but to give the benefit of the doubt in favour of the Premises License Holder.

We have come to realise that much of local evidence gathering, as well as desk research, falls to residents, as Police and the Lic Authority have too little time and resource for pro-active oversight of Premises.

We would like to remind the Licensing Committee that the heartbeat of The Borough of Hammersmith and Fulham is its residents. LBHF Residents have no access to inbuilt legal support as do Councillors, the Licensing Authority, Met Police, Environmental officers etc. All Responsible Authorities may and often do call on internal or external legal counsel to support them. Residents are discriminated against in this regard. Residents must hire and pay for legal counsel to relate arguments and evidence that must be robust enough to be upheld at a possible appeal. Nothing less is useful to the Licensing Committee. Well meant complaining counts for nothing in these legal licensing proceedings. Residents are at a great disadvantage at these licensing hearings without proper legal support.

A Licensing hearing is a legal hearing, a legal proceeding; it is not a mere discussion or meeting of interested parties.

Prevention of nuisance

Fulham residents' amenity is greatly compromised by The burgeoning Delivery Economy which is overtaking our roads, road corners, pavements and even private front gardens and doorsteps where delivery riders hang out, do drug deals and use these areas as open toilets. This was explained in great, unappealing graphic detail on Feb 14 and the photos submitted are still relevant as we are not aware that anything has improved.

We are advised that all the documents for that hearing must be submitted for this hearing so that they are 'read into the record'. We commend them to you from the LBHF Committee register of meetings February 2023.

Why is Barclay Road, with Effie Road concerned and opposing this new application?

Papa John badged two-wheelers regularly enter Barclay Road to cut through to Effie Road and Harwood Road. These then turn left into Moore Park Road to avoid the traffic lights and cameras/yellow boxes at Harwood/New Kings Road. Or they illegally cut through the pleasant green expanse of Eel Brook Common to get over to the thousands of residents on and around Wandsworth Bridge Road.

Anything for a shorter journey.

Riders also mount the pavement on Effie Road to avoid the APRC cameras at the traffic restriction gate that they are prohibited from passing through in either direction, but they have developed their own workaround by mounting the pavement.

All this Rat Running also happens in reverse as the riders return to 63 Walham Grove.

Moore Park Road offers further Rat Running in various directions, going out and returning ultimately to 63 Walham Grove SW6.

Rat Running through residential roads and even mounting the pavements e.g. to avoid traffic gate cameras or to speed up the pace of delivery, is critically important for drivers to arrive at their destination far more quickly, and depart as quickly as possible as well.

Crime & disorder

Rat Running is:

- -illegal,
- -dangerous,
- -and causes much nuisance, constantly, just about in every road but especially in roads around Fulham Broadway. We ask the Committee to embrace this vital point under the Lic Objective 'Crime and disorder.

The Premises License holder must prove he is able to promote the Prevention of crime & disorder. He cannot. His hot pizza goods are on the two/three-wheeler, in transit, but he cannot control where and how his drivers drive, or third party drivers, where they drive etc.

The sale completes at handover of goods. In the meantime, the licensed Premises is literally in transit, figuratively expanding its walls, touching the lives of hundreds and sometimes thousands of humans and their domestic pets, causing much grief via noise, disturbance, nuisance etc.

Are the delivery vehicles set to the maximum speed limit of 20mph? Is a gesture being made by this Premises to our environmentally proud Council to ONLY use electric vehicles?

Are all vehicles owned by Papa John and badged at all times with logos? We see that orders/deliveries are also made for PapaJohn's on/by Deliveroo, UberEats etc.

Also, there seem to be many non-badged drivers with motorbikes waiting around 63 Walham Grove as well.

Nuisance abounds

Litter and lack of orderly rubbish is an ongoing problem at this Premises. We believe that the Premises was fined at least twice very recently and given further warnings by the Council. We are gathering proof of this.

The Premises could consider adding into their operating schedule meeting their immediate neighbours on an ongoing basis and being in touch with them very regularly to come to, and reiterate monthly, orderly, friendly agreements regarding rubbish from and around the entire address of 63 Walham Grove. In short, initiate a Neighbourhood effort that makes a difference, daily. Of course this would be a self-inflicted gesture of sorts but it would show a bit of community spirit, something totally lacking from this Premises.

Fulham is residential

Most importantly, Fulham is almost 100 percent residential with several shopping parades in a few main roads, including the extensive DAYTIME North End Road Market, and some office-type buildings as well.

The Council and its Licensing Committee has an excellent opportunity with this application to:

- 1) say yes to less sleep disturbance and
- 2) say yes to decreasing, not increasing, nuisance of all kinds at anytime of day but especially from 11pm to 8am

when the vast majority of residents and especially their children are trying to sleep, in order to maintain basic good health, be alert at school and be alert for work.

Nutrition for children

Further, the Council is pushing vital partnerships for providing nutritional food programmes, especially for children. What does pizza before 12 noon add to the Council's aims? Does this Premises really need to be open before lunchtime? The Mayor of London has successfully called on Planning Authorities to not allow takeaways within a 400 meters of schools, youth clubs etc. We will submit further evidence on this important point for the health of our children.

We are confident that residents will be presenting more than enough evidence for the Licensing Committee to reject the application 2023/01216/LAPR in full, giving the Lic Committee full confidence that their decision will be upheld, should an appeal be lodged by the Applicant.

We reserve our right to submit further evidence before the licensing hearing takes place for 2023/01216/LAPR (date to be determined).

Walham Grove is a residential street in a Conservation Area and was a quiet and safe street when we moved in 18 years ago. Unfortunately, things have changed, starting with the opening of Papa Johns, followed by the Jerky Kitchen (a deadly shooting in front in 2016) and Café Olé.

Papa Johns delivery services repair and test their bikes causing noise and nuisance day and night. There is urinating against railing and in front gardens. Many of the delivery guys are a real nuisance as they are often on their speaker phone, yelling etc. Most shocking is that this cheap outlet and its customers do not care about the environment. Papa Johns has little indoor seating, customers eat in their cars (radio on) and although there is a bin on the corner of Walham Grove; food rests and cartons are left in the street.. A street sweeper told us having seen mice around Papa Johns many bins along their Walham Grove facade that remain there for days and we found a dead rat in our front garden.

Cheap food outlets attract all kinds of people: police tell us that there are regularly incidents (drug dealing, disorder, ASB) around Papa Johns. We often find big laughing gas cylinders on our doorstep left by gangs of youngsters gathering late at night/early in the morning, pizza in hand!. I even had a drug dealer and his client in my front garden who threatened me with torture en even death, We are obliged to lock the front garden at night as we fear for our safety. Extending hours of light refreshments will add to the noise, nuisance, anti-social behaviour in our street and beyond.

In the light of the above comment, we therefor object the application as it constitutes an unneighbourly demand to extend nightly opening hours and respectfully request the Council that it be refused.





The man's wife told us: "They were arranging coins on our doorstep, we could see them from inside. So, my husband opened the door and asked if they were dealers and then told them to leave the premises.

"The man got up and said 'I will come into your house. I will break in, I will torture you and I will kill you' and then they left."

Dealers are known to hide in front gardens to avoid police, according to residents. Another resident claimed dealers dump packages in front bushes for users to "Uber in" and fish them out.

The road has been described as a 'public loo' on match days with residents often complaining about punters peeing in their garden or dumping empty beer cans and half-eaten food.

This has meant the street has become somewhat of a haven for rats and other pests, one resident said. But while those issues typically occur on match days, drug dealing and antisocial behaviour are an everyday occurrence, residents claim.

He said: "When there is dealing going on, people stand much closer than when you're having a conversation. When you see someone standing close to someone else that's because they don't want to be seen handling something."

He slammed what he claimed was the police's 'light-hand' approach to drug dealers. He said: "It appears that if people are caught with drugs you're then let off with a caution, unless you've got a large amount. It's almost like there's no jeopardy."

However the Met Police said it's cracking down on dealing, and targeting those higher up the chain, and in some cases vulnerable children who are recruited as dealers are supported to get help rather than being criminalised.

According to the Sentencing Council, sentences for drug supply range from a community order or fine to life imprisonment depending on the amounts and circumstances.

The government last year announced a 10-year strategy for tackling drug use and supply, which aims to crack down on County Lines, introduce new penalties for recreational drug users, and provide support for people trying to come off drugs.

In Walham Grove, it has been claimed dealers are sometimes dressing up as food delivery drivers to hide their criminal activity and make it look like they have a legitimate reason to be hanging around.

Meanwhile, businesses on North End Road say the local McDonald's has become a hotbed of antisocial behaviour.

Javad Tabeh, 50, who works at nearby Al Baydar grocers, said: "I have seen delivery drivers fight with each other, swearing and yelling."

Aga Sznura, 47, a store manager at the charity Royal Trinity Hospice, said teens often kick off outside McDonald's in the evening. She said she's never witnessed any drug dealing.

Dispute this, residents claim many of the take-away shops are attracting the wrong crowd and are worried their plans to stay open will turn the area into a "Soho lite".

One resident said: "The problem we have is there are too many shops trying to stay open into the early hours."

She still remembers finding Salim Coulter's dead body near her home. The woman, who does not want to be identified, said: "There was a loud bang so I came out and then I saw a big crowd around the Jerk shop and when I walked up, I saw him there, dead next to the car."

Coulter, a 24-year-old trainee gas engineer and drug dealer, was **shot dead in Walham Grove** on November 5, 2016 in front of his friend after having had a meal with them.

He had been dining at Jerky's Jamaican restaurant when he was shot in the head by a man in a hoodie at point-blank range as he returned to his friend's car.

Two years later, **Omar Hutson was found guilty** of Coulter's murder and sentenced to life in prison.

McDonald's said it wouldn't comment but pointed out that it was one of a number of businesses experiencing antisocial behaviour issues in the surrounding area.

They say this is being committed by one or two groups of teenagers and that Fulham McDonald's has been proactively working with the Police and Fulham BID (Business Improvement District) to try to resolve these issues.

In the interim, the restaurant has introduced a temporary security presence to help maintain a family-friendly atmosphere and staff have also reached out to the local neighbourhood teams to see what else can be done.

Hammersmith and Fulham council's deputy leader Ben Coleman, who represents the ward, said drug dealing is a challenge all councils across the capital face and that he would be speaking with the council's Law Enforcement Team (LET) to step up patrols in the area.

He acknowledged past problems with McDonald's on North End Road and vowed to work with the local manager to tackle ABS and litter issues.

He said the council was fully committed to turning North End Road into a more attractive place to shop but urged traders to engage with residents more often.

Mr Coleman said: "I think it's very important for any business that wants to trade on or near North End Road to understand the area it is in and to take the trouble to talk to residents and in the submission that they make, to show they've addressed residents' concerns. "From experience, that isn't always the case and inevitably that means a great deal of time can be wasted."

He added: "Don't just come to an area like a spaceship and drop yourself down and ignore the fact there are local people living in residential roads nearby, who could be affected by what you're doing.

"Anyone who takes a sort of spaceship approach on North End Road or the roads off it and doesn't choose to engage with the residents is probably not

doing themselves any favours." He said the council would access late-night licence applications on a case-by-case basis.

The Met Police said it made more than 200 arrests and seized over one million pounds worth of drugs during a week-long crackdown on County Lines gangs earlier this year.

They said in several cases, vulnerable children were preyed on by offenders and used as a commodity, placing them into an incredibly dangerous environment. Instead of criminalising these children, officers work with Rescue and Response to ensure they are safeguarded and supported.

Between Monday, 27 February and Sunday, 5 March officers seized 8.3kgs of Class A drugs and 37.6 kilograms Class B drugs, £652,214 in cash and five firearms and 51 weapons including knives, machetes and swords.

Detective Superintendent Rick Sewart, Lead Responsible Officer for County Lines in the Met, said: "The Met is committed to relentlessly pursue those responsible for County Lines drug supply, bringing them to justice for their abhorrent crimes."

In the last 48 hours I have tried unsuccessfully to register my comment objecting to the above application. I am either timed out or am told an "error" has occurred. As the deadline is tomorrow, please find below the text of my objection. Please acknowledge safe receipt, my details are:

OBJECTION

I live a moped ride from the site and huge numbers of dispatch/delivery drivers use the road I live on as a base and cut-through road. I strongly object to the application for the following reasons

- (1) residents' lives are blighted by the numbers of late-night dispatch riders the noise of which wakes up all, young, and old and which deprives us of a night's sleep;
- (2) the site has a history of non-compliance, everything from opening after licensed hours and appalling litter; to allow the extended night hours would effective overrule/reverse the recent earlier decision against the last application for this site, rendering it pointless
- (3) recent decisions of the committee (including in relation to Papa Johns) have fully recognised that last night opening hours close to 100% residential roads are incompatible with the statement of licensing objectives,
- (4) there is no plan for 24-hour late-night economy on the North End Road;
- (5) the North End Road (NER) is a well-documented crime hotspot and tragically the site has a history that evidences the need to restrict late night places to congregate.

Drugs are a major issue on the NER. Dealers operate near open venues and are regularly abusive and threatening to residents. In addition some delivery riders are abusive and aggressive toward women walking home at night;

- (6) the highly residential area is home to large numbers of children. All the anti-social behaviour found in and around the NER is highly undesirable for children of any age. The impact for residents and their families will be untold late-night misery; and
- (7) I reserve the right to make further representations.

Of course we want good trading conditions to attract all trades (not just allow take ways to dominate) during reasonable business hours but that do not impact negatively on the lives of normal residents or promote/allow commercial activities 24/7 and in which traders contribute to the community they are located in. 22/08/2023 4:14 PM I am shocked that Papa Johns could seek to revive this application so soon after the hearing earlier this year and I object on the grounds of noise and nuisance. Also, I endorse the detailed objection submitted by the Barclay Road Residents.

The premises was plagued with trash on the streets, making life miserable for residents and street cleaners facing daily piles of rubbish and empty pizza boxes.

The applicant is seeking to elevate his own business interests above those of the vast majority of his neighbours who keep normal hours and must be up for work in the morning.

Delivery drivers hurtling throughout Fulham is already a nuisance, with them flouting the highway code and not caring about neighbours, and careering down residential roads such as Moore Park Road and Barclay Road, often on loud, poorly maintained machines spewing out pollution.

The applicant should demonstrate that he can manage noise and nuisance, and the potential for crime outside his shop, rather than opportunistically seek to exploit permissive licensing arrangements without care or consideration for his neighbours or the community at large.

- I have been appointed by the Secretary of State for the Environment to determine this appeal. The appeal is against the failure of the Council of the London Borough of Hammersmith and Fulham to give within the prescribed period notice of their decision in respect of an application for the conversion of the existing ground floor bakery use to a fish and chip take-away restaurant at 63A Walham Grove, Fulham. have considered the written representations made by you and by the Council and also those made by interested persons, including those representations made directly to the Council which have been forwarded to me. As you know, I inspected the site on 31 January 1994.
- The Council resolved that had it been empowered to do so, it would have refused your clients' application on the grounds that: 1) it would give rise to customer parking and manoeuvring which would be prejudicial to highway safety; and 2) the proposal would result in an increase in noise and disturbance, thereby harming the amenities of nearby residents.
- The building is within the Walham Green Conservation Area and under the provisions of Section 72(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990 there is a duty to pay special attention to the desirability of preserving or enhancing the character or appearance of such areas.
- The Council have formulated and published guidelines for restaurant uses which complement policies contained in the adopted Borough Local Plan and the emerging Unitary Development Plan (UDP). Policy SH12 in the emerging UDP



indicates that when considering proposals for food and drink establishments, account will be taken of their effect on residential amenities, their impact on traffic and the cumulative effect of the introduction of new A3 Uses. The Council's guidelines for restaurant uses highlight factors such as location and access requirements and the potential detrimental effects.

- 5. The appeal property is a prominent 3 storey corner building situated on the junction of Walham Grove and Vanstone Place. It is included in the Council's local register of buildings of merit. The application relates to the ground floor of the premises, which was formerly a bakers shop, but is now vacant. In addition to the proposed change of use of the shop to a hot food take-away, the development involves the installation of a new shop front and the fixing of an external ventilation duct to the rear elevation of the building.
- 6. From what I have read in the representations and seen during my inspection of the site and its surroundings, I consider there are three main issues in this case. These are: firstly, the effect on the character and appearance of the Walham Green Conservation Area; secondly, whether the development would adversely affect the amenities of people living nearby as a result of noise and disturbance; and thirdly, whether it would be detrimental to highway safety.
- 7. The appeal site is a short distance from Fulham Broadway and the locality is typical of a town centre location, with the buildings containing a mixture of commercial uses at ground floor level and residential accommodation on the upper floors. The proposed use would not be very dissimilar to the previous use which also involved the preparation, cooking and sale of foodstuffs. I noticed that there is a street market in North End Road and the character of the area is one of a busy vibrant shopping centre. I therefore consider the proposal to be entirely in keeping with this character and the new shop front is typical of many in the area. The proposed ventilation ducting would be positioned on the rear elevation of the building, where it would not be widely seen and it is proposed to be painted in a dark colour to minimize its visual impact. I thus conclude the development would preserve the character and appearance of the Walham Green Conservation Area.
- 8. Turning to the second issue, I noted during my visit that the appeal premises are close to a busy road junction and adjoin a launderette which operates until 10pm every day. There is a public house opposite and several other catering premises in the vicinity which also remain open late into the evening. Having regard to the commercial nature of the locality and the very high volume of vehicular and pedestrian traffic, I found the area to be quite noisy. Whilst I accept that the proposed use would also attract night-time customers, the ambient noise levels are such that I consider it would be most unlikely for residents in the neighbourhood to be

disturbed by additional noise attributable to customers of the proposed fish and chip shop. Furthermore, I am satisfied that I can prevent any customer noise at unsociable hours, by attaching a condition to restrict the operation of the premises to opening times similar to those of comparable nearby establishments. In these circumstances, I conclude the development would not adversely affect the amenities of people living nearby as a result of noise and disturbance.

- 9. I now turn to the third issue. The appeal site, in common with many of the other properties in the locality, has no off-street parking facilities. Additionally, I noted that there are double yellow lines in front of the premises and in Walham Grove there is kerbside parking for residents and meters for the general public. I have seen no evidence to suggest that customers attracted to the proposed fish and chip shop would add unacceptably to the already high traffic flows, or place undue strain on the available roadside parking in the area. I am therefore not persuaded the proposal would result in a significant increase in pedestrian and vehicular movements. I therefore conclude the development would not be detrimental to highway safety in the locality.
- 10. The Council have suggested a number of conditions, which I have considered in the context of the criteria set out in Circular 1/85. I also note that the final submitted drawings followed extensive negotiations with officers of the Council and their report to the Sub-Committee indicates that the details contained therein meet with their approval and I see no need for conditions which reiterate the specifications shown on the drawings. In addition to the standard time condition, I therefore only propose to attach conditions relating to hours of operation and the installation of the ventilation system prior to the use commencing.
- 11. I have considered all the other matters raised in the representations including the presence of other A3 uses in the locality, but I have found no other matter of such weight as those upon which I have formed my conclusions and which lead to my decision.
- 12. For the above reasons and in exercise of powers transferred to me, I hereby allow this appeal and grant planning permission for the conversion of the existing ground floor bakery use to a fish and chip take-away restaurant at 63A Walham Grove, Fulham, in accordance with the terms of the application No 93/00026, dated 11 January 1993 and the plans submitted therewith, subject to the following conditions:
 - 1. the development hereby permitted shall be begun before the expiration of 5 years from the date of this letter:

The use hereby permitted shall not take place other than between 0900 hours and 2330 hours from Monday to Saturday and between 1130 hours and 2230 hours on Sundays; The fume extraction system hereby permitted shall be fully installed and operational before the use is commenced. An applicant for any consent, agreement or approval required by a condition of this permission has a statutory right of appeal to the Secretary of State if consent, agreement or approval is refused or granted conditionally or if the authority fail to give notice of their decision within the prescribed period. The developer's attention is drawn to the enclosed note relating to the requirements of the Building Regulations 1991 with respect to access for disabled people. 15. This letter does not convey any approval or consent which may be required under any enactment, bye-law, order or regulation other than Section 57 of the Town and Country Planning Act 1990. Your attention is drawn to the provisions of Section 74 of the Planning (Listed Buildings and Conservation Areas) Act 1990 which requires consent to be obtained prior to the demolition of buildings in a conservation area.

Thank you for your reply.

I did not receive any direct contact from the licensing authority with any request to contact you.

I do recall you calling me and I think we may have different recollections of the same conversation, or at least the summary you have presented in your email below suffers from being selective and or a misinterpretation.

Your call very much came out of the blue, and you very quickly resorted to speaking in a very interrogatory manner; and the premise of some of your questions were not fair, relevant or conducive to having a helpful conversation.

I stated that if you have concerns about a licensing application then you were entitled to make a representation, the same way a new applicant is entitled to make new application and have it determined on its own merits regardless of any previous applications by a different applicant.

I understand that there are a number of representations that will be forwarded to me in the next few weeks. The point is that I still have not seen those representations and therefore, I am not aware of your objections specific to our representation.

Also, the last date for representations is not a cut off date for mediation meetings to take place. In fact, it is quite common for productive meetings to take place between the last date for representations and the date of the hearing; especially in a case like this where the representations are not shared with the applicant until after the end of the 28 day consultation period. Therefore, this is not late in the date and in many ways very much at the start of the process for mediation; late in the day would be a few days before the hearing.

Therefore, I would ask once again, if you/the residents would like to meet before the hearing to hopefully resolve this matter by reaching an agreement which could work for everyone then please let me know. There is more than enough time for this. I understand that the hearing will not be listed until around the end of September.

As to your contention that the residents' resentment is "justified", this is not a determination for you to make and will be decided by the committee at a hearing if an agreement cannot be reached.

As alluded to above, any previous decision is not binding on the committee at a hearing and they are perfectly entitled to determine this application on it's own merits and based on the information presented. They are equally entitled to reach a different decision on the same basis.

- 4.Delivery drivers/riders will be given clear, written instructions to use their vehicles in a responsible manner so as to not cause nuisance to any residents or generally outside the licensed premises; not to leave engines running when the vehicle is parked; and not to obstruct the highway. The licence holder will positively encourage delivery drivers/riders to use quieter vehicles that are less likely to cause a nuisance such as bicycles.

We are hoping that this can be agreed with the residents too.

In the interest of full transparency and to enable this email to be included in the hearing bundle if an agreement cannot be reached, I am copying in the licensing authority.
