SUMMARY OF DECISION

The Committee has considered an application to extend the hours for the sale of alcohol off the premises only and amend the closing hours under the Licensing Act 2003 (“the Application”)

In summary, the Committee has decided, after taking into account all of the individual circumstances of this case and the promotion of the four licensing objectives to:

1. Grant the Application in part as follows:

The sale of alcohol off the premises only

Mondays to Sundays 09:00 to 23:00

2. The opening hours of the premises are
Mondays to Sundays 06:30 to 23:00
3. The licence is subject to any mandatory conditions.
4. The licence is subject to the conditions volunteered by the Applicant in the operating schedule.

This licence becomes operational with immediate effect. If problems are experienced, then an application for a review of the premises licence can be made.

A copy of this Committee’s full decision including its reasons and the full text of the conditions added to the licence will be sent to the parties forthwith.

If the Applicant or any person who has made a relevant representation is unhappy with the decision, they are entitled to appeal to the magistrates’ court within 21 days from the date of notification of the full decision.

SUMMARY OF DECISION

The Committee has considered an application for a new premises licence for the following licensable activities:

The exhibition of films – Both indoors and outdoors
The performance of live music – Indoors only
The playing of recorded music – Indoor only
Provision of late-night refreshment – Indoors only
The sale of alcohol – On the premises only

under the Licensing Act 2003 (“the Application”)

In summary, the Committee has decided, after taking into account all of the individual circumstances of this case and the promotion of the four licensing objectives to:

1. Grant the Application as follows:

The exhibition of films – Both indoors and outdoors

- From 10:00 until 23:00 Monday to Saturday
- From 10:00 until 22:00 Sunday
- From the end of permitted hours on New Year's Eve to the start of permitted hours on New Year's Day

The performance of live music – Indoors only

- From 23:00 until 01:00 on Friday and Saturday only
- From the end of permitted hours on New Year's Eve to the start of permitted hours on New Year's Day

The playing of recorded music – Indoor only

- From 23:00 until 01:00 on Friday and Saturday only
- From the end of permitted hours on New Year's Eve to the start of permitted hours on New Year's Day

Provision of late-night refreshment – Indoors only

- From 23:00 to 23:30 Sunday to Thursday
- From 23:00 to 01:00 Friday and Saturday
- From the end of permitted hours on New Year's Eve to the start of permitted hours on New Year's Day

The sale of alcohol – On the premises only

- From 11:00 to 23:00 Monday to Thursday
- From 11:00 to 01:00 Friday and Saturday
- From 12:00 to 23:00 Sunday
- From the end of permitted hours on New Year's Eve to the start of permitted hours on New Year's Day

2. The opening hours of the premises are

- From 06:00 to 23:30 Sunday to Thursday
- From 06:00 to 01:30 Friday and Saturday
- From the end of permitted hours on New Year's Eve to the start of permitted hours on New Year's Day

3. The licence is subject to any mandatory conditions

4. The licence is subject to the conditions volunteered by the Applicant in the operating schedule

5. The licence is also subject to four conditions imposed by the Committee

(1) A responsible member of staff shall organise and accommodate meetings to discuss the operation of the premises with residents at least once every 6 months. The meeting shall be advertised at least 14 days before its due date by letter to residents and residents' associations in the locality as well as to the Licensing Authority

(2) A responsible member of staff shall take the minutes of meetings with residents that shall be circulated to all attendees and to the Licensing Authority and copies shall be readily available at the premises on request

(3) A risk assessment shall be carried out prior to each event held at the Premises and acoustic mitigation measures shall be implemented where appropriate

(4) A schedule of events should be made available on request from the local residents

This licence becomes operational with immediate effect. If problems are experienced, then an application for a review of the premises licence can be made.

A copy of this Committee's full decision including its reasons and the full text of the conditions added to the licence will be sent to the parties forthwith.

If the Applicant or any person who has made a relevant representation is unhappy with the decision, they are entitled to appeal to the magistrates' court within 21 days from the date of notification of the full decision.
