2. DECLARATIONS OF INTEREST

1. THE APPLICATION

On the 11th March 2024, Mr Siddharth Chauhan ("the applicant") submitted an application for a new premises licence to be granted in respect of the premises known as Booze Delivery Limited, Unit 4606, 21 Effie Road, London, SW6 1EN.

1.1 Application Requested

The applicant has applied for a new premises licence for the sale of alcohol off the premises as outlined below, and proposes to operate as online alcohol delivery service:

Licensable activities sought:

The Sale of Alcohol - Off the Premises Only

Mondays to Sundays between the hours of 00:00 to 00:00

Opening hours:

Premises is not open to the general public.

A copy of the application form and plan can be seen on pages 14-21 f this report.

1.2 Applicants Operating Schedule

The applicant has proposed a number of additional steps to promote the four licensing objectives if the application is granted. A copy of this can be seen on pages **17** of this report.

On the 25th March 2024, following correspondence from the Police Licensing team, the applicant agreed to add 2 conditions to licence, if granted. The conditions are as follows:

Agreed Conditions

- 1. Deliveries shall only be made to bona fide residential or business addresses.
- 2. Any alcohol sold for consumption off the premises shall be sold in a sealed container.

A copy of the relevant correspondence can be seen on pages 22-24 of this report.

On the 12th April 2024, the Licensing section received one representation from the Planning Team objecting to the licence application. On the 18th July 2024, following correspondence with the Licensing team, the applicant agreed to reduce the licensable hours applied for, to align with the current permitted planning permission for the premises. The reduced licensable hours sought are as follows:

Licensable activities sought:

The sale of alcohol - Off the Premises Only

Mondays to Fridays between the hours of 07:00 to 22:00

Saturdays between the hours of 08:00 to 22:00

Sundays and bank holidays between the hours 08:00 to 20:00

On the 19th July 2024, following the reduction in hours to align with the permitted planning permission of the premises, detailed in section 1.2, the Planning team withdrew their representation.

A copy of the relevant correspondence can be seen on pages **25-36** of this report.

2. BACKGROUND

The main access to the premises is located on Effie Road. There is a mixture of both residential and commercial premises within the area. A map showing the location of the premises and neighbouring licensed premises can be seen on pages **37-40** of this report.

There are several options for transport away from the area including buses and taxis which run from in and around the Fulham Broadway area. Fulham Broadway underground station is a 3-minute walk away, Parson Green tube station is a 13-minute walk away and West Brompton and Imperial Wharf overgrounds stations are an 18-minute walk away.

3. CONSULTATION

A public notice was displayed at the premises for 28 days. The application was advertised in a local circular and all statutory consultees were notified as required by the Regulations. The Council has served written notice of hearing upon the applicant and all those parties that have made representations in respect of the application.

3.1. Relevant Representations

The licensing section received one representation on behalf of the Seagrave Residents Association, one representation on behalf of the Barclay Road Neighbourhood Watch, one on behalf of the Vanston Place Management Company and fifteen representations from local residents, all objecting to the licence application. A copy of these representations can be seen on pages **41-78** of this report.

On the 16th July 2024, the Licensing Team informed all objectors of the reduction in licensable hours sought from the previous amended hours. A copy of the correspondence and responses can be seen on pages **79-85** of this report.

The Barclay Road Neighbourhood Watch have submitted further evidence to support their original representation. A copy of this evidence can be seen on pages **86-133** of this report.

4. OTHER INFORMATION

4.1 Enforcement History

There have not been any warnings, simple cautions or prosecutions given in respect of the premises during the past three years.

4.2 Temporary Event Notices ("TENs")

No TENs have been submitted in respect of this premises in the past twelve months.

4.3 Additional Information

The Licensing team contacted Access Storage, who confirmed that alcohol is not permitted to be stored within the units. A copy of the correspondence from the storage company and the applicant can be seen on pages **134-137** of the report.

5. POLICY CONSIDERATIONS

5.1 Section 2 pages 7-10 of the Statement of Licensing Policy ("SLP") states the Licensing Authority is keen to support the licensed sector and leisure offer within the borough, with a particular focus on business resilience and growing a robust and thriving cultural and leisure sector.

To achieve this the Licensing Authority has identified three key themes of the Licensing Policy and the Licensing Authority's approach to implementing it. These are:

- A sustainable, well-run licensed sector;
- Hammersmith & Fulham as a good place to live, work and enjoy leisure; and,
- A safe licensing environment and night-time economy.
- **5.2** Section 5 pages 12 and 13 of the SLP states that to ensure the promotion of the four Licensing Objectives the Licensing Authority will require applicants to detail in their operating schedule:
 - the steps proposed to promote the licensing objective of the prevention of crime and disorder on, and in the vicinity of, the premises, having regard to their location, character, condition, the nature and extent of the proposed use and the persons likely to use the premises;
 - the steps proposed to ensure the physical safety of people using the relevant premises or place;
 - how they intend to prevent nuisance arising, prevent disturbance and protect amenity so far as is appropriate to ensure that the Licensing Objectives are met.
 Where there is a relevant representation regarding extended hours, the Licensing Authority will not permit an extension unless it is satisfied that the Licensing Objectives would be met;

- the measures and management controls in place to protect children from harm. Where appropriate a written childcare policy should be available and be incorporated in the induction of staff.
- 5.3 Section 7 page 15 of the SLP states that for sales of alcohol for consumption off the premises applicants in respect of off licences and other premises selling alcohol for consumption off the premises may need to consider whether:
 - there are shutters to prevent alcohol from being selected in non-licensed periods.
 - there are appropriate numbers of staff on duty to deal with possible 'intimidation' to sell alcohol.
 - there are restrictions required on the sale of low price, high strength alcohol and drink promotions.
 - an incident log book is available to record incidents.
 - there are measures in place necessary to prevent underage sales. (See Annex 1)
 - there are measures in place necessary to prevent alcohol from being sold outside permitted hours where the operating hours of the premises exceed those for the sale of alcohol.
 - there are procedures in place to prevent sales of alcohol to intoxicated persons (with particular attention to street drinkers) or individuals leaving premises in the vicinity such as a late night bar; where there is evidence to suggest this is a problem the Licensing Authority may require a temporary cessation of alcohol sales during high risk times.
- **5.4** Policy 1 page 18 confirms that The Secretary of State's Guidance states that applicants are expected to obtain sufficient information to enable them to demonstrate, the steps they propose to take to promote the licensing objectives; and that they understand the layout of the local area and physical environment including:
 - a) crime and disorder hotspots;
 - b) proximity to residential premises;
 - c) proximity to areas where children may congregate;
 - d) any risk posed to the local area by the applicants' proposed licensable activities; and
 - e) participation in any local initiatives (for example, local crime reduction initiatives or voluntary schemes, such as 'Ask for Angela', local taximarshalling schemes, street pastors and other schemes) which may help to mitigate potential risks.

Applicants are expected to include positive proposals in their application on how they will manage any potential risks.

The Guidance goes on to state that 'Applicants are expected to provide licensing authorities with sufficient information in this section to determine the extent to which their proposed steps are appropriate to promote the licensing objectives in the local area. Applications must not be based on providing a set of standard conditions to promote the licensing objectives and applicants are expected to make it clear why the steps they are proposing are appropriate for the premises.'

The Licensing Authority notes the contents of these paragraphs from the Secretary of State's Guidance and, in particular, the use of the word 'expected'. Licence applications that do not in any way address the contents of these paragraphs in their operating schedules may be returned to the applicant as 'incomplete'.

- **5.5** Policy 3 page 21 of the SLP states that where there is a relevant representation, the Licensing Authority will consider each particular case on its merits having regard in particular to the following matters:
- a) Whether the licensed activities are likely to have an adverse impact especially on local residents and, if there is potential to have an adverse impact, what, if any, appropriate measures will be put in place to prevent it;
- b) Whether there will be a substantial increase in the cumulative adverse impact from these or similar activities, on an adjacent residential area;
- c) Whether there is a suitable level of public transport accessibility to and from the premises at the appropriate times;
- d) Whether the activity will be likely to lead to a harmful and unmanageable increase in car parking demand in surrounding residential streets suffering high levels of parking stress or on roads forming part of the Strategic London Road Network or the London Bus Priority Network leading to a negative impact on the Licensing Objectives relating to the prevention of crime, disorder, anti-social behaviour (ASB), nuisance and vehicle emissions;
- e) Whether there have been any representations made by Responsible Authorities, or other relevant agency or representative.

It will be the normal policy of the Licensing Authority to allow shops, stores and supermarkets to provide sales of alcohol for consumption off the premises at any times (in line with permitted planning hours) when the retail outlet is open for shopping unless there are good reasons based on the Licensing Objectives for restricting those hours. Should there be evidence regarding street drinking issues, child protection issues, cumulative impact, anti-social behaviour (ASB), issues in relation to public nuisance and disorder in the vicinity of this type of premises, the Licensing Authority may restrict the hours of the sale of alcohol or decide to review the licence. To act as a guide for new or existing operators we have set out the suggested closing times for licensed premises below:

Type of premises	Town centres	Mixed use areas	Residential areas
Off-licences and alcohol sales in supermarkets	23:00 daily	23:00 daily	22:00 daily

5.6 Policy 4 pages 22 and 23 of the SLP states that in determining an application where there has been a relevant representation the Licensing Authority will, where appropriate, take into account the cumulative effect of the number, type and density of licensed premises already existing in the area. Consideration will be given to the proximity to any drug and alcohol treatment site, A&E department or homeless hostel in a local area type remit ie applicants need to make the case for how they would not increase further problems for residents/clients nearby.

In coming to any decision regarding cumulative impact the Licensing Authority will consider other mechanisms outside of the licensing regime which may also be available to address this issue, these include but are not limited to:

- Planning controls (where development or change of use is involved, or where trading hours are limited by planning conditions)
- Police and other enforcement of the normal law concerning disorder and antisocial behaviour.
- Prosecution or other enforcement of any personal licence holder or member of staff at such premises who is selling alcohol to people who are drunk
- Prosecution or other enforcement of any personal licence holder or member of staff at such premises who is selling to underage persons or selling illegal alcohol or tobacco
- Police powers to close down instantly any licensed premises or temporary events on grounds of disorder, the likelihood of disorder or excessive noise emanating from the premises, for up to 24 hours.
- The power of the police, other responsible authorities, a local resident, business or Councillor to seek a review of the licence or certificate in question.
- Police and Local Authority power to issue a Closure Notice for up to 48 hours where serious antisocial behaviour is taking place at licensed premises under the Anti-social Behaviour, Crime and Policing Act 2014.
- To ensure that residents are protected from the negative impact of late-night local licensing activities the Licensing Authority may decide to adopt an Area Specific Cumulative Impact Policy in relation to a specific area; where the number, type and density of premises providing licensable activities is having a serious negative impact on the local community and local amenities.
- **5.7** Policy 11 page 30 of the SLP states that Licensing law is not the primary mechanism for the general control of nuisance and anti-social behaviour caused by people once they are away from the licensed premises and, therefore, beyond the direct control of the licensee. However, licensing is a key aspect of such control and licensing law is part of a holistic approach to the management of the night-time economy.

As a matter of policy, the council expects every holder of a licence, certificate or permission, to accept and be responsible for minimising the impact of their activities and anti-social behaviour by their patrons within the vicinity of their premises by taking appropriate measures and action consistent with that responsibility. Licensees and certificate holders should take reasonable steps to prevent the occurrence of crime and disorder and public nuisance immediately outside their premises, for example on the pavement, in a beer garden or in a smoking area, to the extent that these matters are within their control.

Population densities in this borough are high, with many residential premises located above or in close proximity to licensed premises. This means that the public nuisance and crime and disorder objectives will be of paramount concern when evaluating Operating Schedules. Licensing Committees will place high regard on the control measures put in place by the applicant to ensure that our residents are protected from the potential detrimental effects of any licensed premises.

5.8 Policy 13 pages 31 and 32 of the SLP state that despite Licensing and Planning being under different legislation, the Licensing Authority will ensure that the licensing regime is in line with the planning regime in Hammersmith & Fulham as far as is possible.

The local planning authority has powers to control opening times of all new establishments seeking planning permission, where harm might occur. Licensing applications will not be a re-run of the planning application.

If the licensing committee grants any variation of a licence which involves a material alteration to a building, the applicant still needs to apply for planning permission, or building regulation control, where appropriate. Where an applicant is granted a premises licence with operating hours that are different to the hours permitted by the premises planning permission, the applicant must observe the earlier closing time. Premises operating in breach of their planning permission would be liable to prosecution under planning law. We would suggest that the applicant contacts Planning apply to vary their conditions.

- **5.9** Policy 14 pages 32 and 33 of the SLP in relation to delivery services states that the Licensing Authority has concerns with the potential for the following:
 - Age verification at both purchase point and delivery point;
 - The safety of delivery drivers at the point of delivery;
 - Safety of the premises from which orders are taken and sent out for deliver; and.
 - Possible public nuisance and anti-social behaviour (ASB) caused by delivery drivers collecting deliveries from the licensed premises.

The Licensing Authority is likely to place the following conditions on to a premises licence for delivery services where it is appropriate and relevant to the individual licence application:

- Appropriate security will be in place at the premises as agreed with Police.
- A signature at the point of delivery must be obtained. No delivery shall be left without a signature.
- Alcohol shall only be delivered to a residential or business address and <u>not</u> to a public place.
- Every third-party courier delivery box shall be labelled with the words "Age Restricted Product".
- Any delivery driver or third-party courier will be required to have appropriate age verification training, particularly they will be required to have training in refusal of supply where age verification is not provided.
- A refusals log will be maintained for deliveries.
- Appropriate security will be in place at the premises as agreed with Police.
- Measures for minimising noise and disturbance and anti-social behaviour (ASB) caused by the dispatch of deliveries to be identified in the operating schedule. In particular applicants are expected to consider the use of electric vehicles to minimise air pollution and noise. The Licensing Authority expects that applicants will make arrangements for all deliveries after 8 pm to be made using electric vehicles or non motorised vehicles i.e. bicycles.

- A requirement for a specific delivery collection area to be made clear to any third party delivery service. This area may not be directly outside the licensed premises to take account of any residential accommodation close by or obstructing the pavement/highways.
- **5.10** Annex 1 pages 35 and 36 of the SLP in relation to the prevention of crime and disorder states licence applicants will be expected to demonstrate the following in their operating schedules:
- c) Operators of off-licences in areas problems relating to street drinking and underage drinking are prevalent, measures should be outlined to strictly monitor the way alcohol is sold, specifically where the premises are located close to schools and hostels and similar premises that provide shelter or services to alcohol dependent persons.
- d) It is important to ensure that staff working at off licences are suitably trained and receive appropriate refresher training in their responsibilities under the Act and can discharge their duties in full compliance with the licence conditions and requirements of the Act. This includes the ability to competently check a customer's age with acceptable forms of identification where necessary. The Licensing Authority will particularly consider the following matters where they are material to the individual application:
 - I. The likelihood of any violence, public order or policing problem if the licence is granted;
- II. The measures taken to control admission to the premises, and to take reasonable steps to prevent the occurrence of crime and disorder and public nuisance immediately outside the premises, where and to the extent that these matters are within their control.
- III. Past conduct and prior history of complaints against the premises;
- IV. Whether a dispersal policy has been prepared to minimise the potential for disorder as customers leave the premises; and
- V. Any relevant representations.
- g) Conditions will, so far as possible, reflect local crime prevention strategies, and the Licensing Authority will also have regard to the views of the local Crime and Disorder Reduction Partnership.
- h) **Crime and disorder in the vicinity of the premises**: this may include the crime and disorder risks arising from persons queuing to enter the premises; persons exiting the premises and customers smoking eating or drinking in outdoor areas and on the highway outside the premises. This can also include crime arising from pickpockets and bag snatchers, particularly in open spaces or crowded areas where alcohol is being consumed.
- j) **CCTV** using CCTV inside and/or outside the premises together with appropriate procedures and having staff properly trained to use CCTV equipment.
- I) dealing with and reporting crime and disorder training for staff and door security aimed at reducing crime and disorder in the premises and its vicinity and dealing with and reporting incidents if they occur.
- p) **local schemes** joining and attending local Pubwatch meetings and participating in the Behave or Be Banned Scheme (BOBB) and/or signing up and using the Council's Safety Net Radio scheme.

- **5.11** Annex 1 pages 38 to 40 of the SLP in relation to the prevention of public nuisance states that the Licensing Authority will particularly consider the following matters where they are material to the individual application:
- ii. The proximity of residential accommodation;
- iii. The type of use proposed, including the likely numbers of customers, proposed hours of operation and the frequency of activity;
- v. The steps taken or proposed to be taken by the applicant to prevent disturbance by customers arriving at or leaving the premises.
- ix. The steps taken or proposed to be taken by the applicant to ensure staff leave the premises quietly;
- x. The arrangements made or proposed for parking by patrons, and the effect of parking by patrons on local residents;
- xii. The level of likely disturbance from associated vehicular and pedestrian movement to and from the premises;
- xiii. The delivery and collection areas and delivery/collection times;
- xiv. The siting of external lighting, including security lighting that is installed inappropriately;
- xv. The arrangements for refuse disposal, storage and the prevention/tidying of litter (including fly posters and illegal placards);
- xix. Any other relevant activity likely to give rise to nuisance;
- xx. Any representations made by the Police, or other relevant agency or representative;

The following provides a non-exhaustive list of risks associated with the public nuisance objective that applicants may want to consider when preparing their Operating Schedule:

- j) **Deliveries/collections** noise from deliveries to and/or collections (e.g. refuse) from the premises are another common source of complaint. Consider the times of such deliveries/collections and make sure you specify to any contractors that deliveries/collections should not be made at anti-social times. As a guide, the Noise and Nuisance Service recommend that deliveries/collections should only be made between the hours of 7:30am and 9:00pm, depending on the proximity of residential and/or other noise sensitive properties.
- l) **Light pollution** this is an increasingly common source of complaint, particularly from illuminated signs and external security lighting. Where provided, illuminated signs should not cause glare to neighbouring properties, ideally being turned off at night, and external lighting should be angled and/or diffused to also prevent nuisance.
- m)Noise and/or vibration breakout from the provision of regulated entertainment, particularly from (but not limited to) live music consider what type of entertainment is to be provided, in what room/area of the premises and the suitability of the construction of this room/area to contain sound. Windows are a particular weak-point for noise break-out so consider providing regulated entertainment in a room without windows or with as few windows as possible, particularly windows that face towards nearby 40 residential properties. Where suitable, install a lobby to prevent spillage of noise each time an entrance/exit door is opened.
- r) **Waste** consider how and where waste will be stored/disposed of at the end of trading hours, particularly if trading until late at night. This is important because the disposal of glass and/or cans to outside bin areas can be very noisy and give rise to complaints, so it may be necessary to store such items and other non-degradable

refuse inside the premises until the next trading day. Consideration should also be given to the time of deliveries to minimize disruption to local residents.

- s) Litter for example, litter patrols for late night take-away premises
- **5.12** Annex 1 pages 40 to 41 of the SLP in relation to the protection of children from harm states that the Licensing Authority will require operating plans to specify the measures and management controls in place to protect children from harm.

The 'Responsible Authority' in relation to the protection of children from harm is the council's Local Safeguarding Children Board. The Trading Standards service will also have certain responsibilities particularly in relation to the underage sales of age restricted products and providing advice about measures that can be taken to reduce the risk of alcohol sales to under eighteens. The following provides a non-exhaustive list of risks associated with the protection of children from harm objective that applicants may want to consider when preparing their Operating Schedule:

i) Where premises are subject to age-restrictions, the procedures in place to conduct age verification checks. The Council will expect premises only to accept current passports, driving licences or documents bearing the national PASS logo, such as Citizencard. The Proof of Age Standards Scheme (PASS) is the UK's national guarantee scheme for proof-of- age cards as endorsed by the Home Office. More information can be found on The Proof of Age Standards Scheme (PASS) website.

6. DETERMINATION

- **6.1** In determining this application, the Committee must have regard to the representations and take such of the following steps as it considers necessary for the promotion of the licensing objectives. The steps are:
- (a) Grant the application in full
- (b) Grant the application in part modifying the proposed hours, activities or conditions.
- (c) Reject the application

It is the Council's duty under the Licensing Act 2003 ("The Act") to determine applications with a view to promoting the four licensing objectives; Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance and the Protection of Children from Harm.

In reaching a decision the Council shall consider the details of any relevant representations received; the applicant's Operating Schedule; the Council's adopted Statement of Licensing Policy and the guidance issued by the Secretary of State under section 182 of the Act.

If the Committee is minded to grant the application conditions may be attached to the licence to alleviate the concerns raised through the representations.



I and on behalf of Seagrave Road Residents Association strongly object to this and believe this proposed license would be extremely harmful to the ambiance and safety of Fulham neighbourhood streets. It will also be detrimental to the local businesses that sell alcohol and pay council tax business rates – it's difficult enough for small businesses to make a living, sanctioning this license will only further lead to shop vacancies in the borough due to unfair advantage of this applicant not having overheads.

What's become abundantly clear from the applicants email to the council and a fellow residents conversation with Access Storage is the applicant is only requiring the "licensed address" to gain position/higher ranking for SW6 area with the likes of Uber Eats and Deliveroo. This will ultimately lead to unfairly compete with licensed 24 alcohol shops (that have strict conditions) and have far larger overheads than this applicant - by using a clever loophole here and only having to pay around £50-100 a month for the sub-letting a storage unit.

On the grounds of Noise & Nuisance & Public Safety: People that buy delivery alcohol in early hours of the morning are either partying or likely have a drinking problem. Sanctioning a 24 hours license will only further contribute to problems. Note: H&F has been noted as the most sleep deprived borough in London in recent research – part of the key problem of this was late night parties. Lastly, the planning hours on this is very clear and what it states in the H&F licensing own documents that licensing hours cannot supersede planning hours. I am emailing you my comments as I have been trying to submit online but it keeps rejecting the submission. Please confirm receipt of this on 16th April, ie the cut off date.

I am writing on behalf of Vanston Place Management Company, who look after the interests of the residents of Dungannon House, a block of 42 residential apartments fronting onto Vanston Place.

I am very frustrated by this application, as this is the third time in 2 years the local residents have been asked to comment on such a business format, and you, the Council having to fund resources to administer the application, and potential Hearing. The first two applications were rejected for a variety of reasons that are still valid, but primarily the sound reason of potential noise and nuisance to local residents. Those residents are still there, and the threat of increased activity - deliveries, bikes, vans, doors and gates opening/closing people talking and general business transactions taking place at all hours continues to be concerning for them. This is a noisy business, one not suited to the Access storage units. Each delivery of bottles, tins, crates, perhaps barrels will be numerous, even if there is only one outward loading of a van per day as the applicant states. I would also add that noise in such an enclosed area is exaggerated as we can attest from here in Dungannon House where noise echos around the triangular area surrounding the Church and appears much louder than if there were empty spaces all around.

In a nutshell the noise and potential nuisance for all the residents of 1-27 Barclay Road (odd numbers) and all the neighbouring residential roads - Broadway mansions in Effie Road, Flats at the back of the Old Bank Building, and Broadway cambers at Fulham Broadway, plus the new flats in Argon mews would be immense. It is on these grounds that we object strongly.

When planning permission was granted *ref.2015/04542/FUL* for these premises condition 22 was imposed stating the operating/opening hours of the self storage facility are listed to *7am and 10pm, Monday to Friday, 8am-10pm on Saturday and 8am-8pm on Sunday and Bank Holidays,* with no deliveries outside of these times, primarily in consideration of the close proximity to the surrounding residents. Planning appreciated that residents should be taken into consideration when allowing new businesses into Fulham. This application far exceeds what Planning had intended.

Therefore based on the hours Planning granted above we do not see how the applicant can request longer opening hours to those planning have approved as they would not be (legally) allowed to enter their premises. The maximum operating hours should be as planning dictated.

Another aspect to this that worries us and that is a having a business that is offering 24hour alcohol in Fulham. There is so much alcohol related crime in the area as it is, a business offering to send 'Booze' in at any time cannot be a good thing. Would drivers recognise serious alcohol abuse, would

they care.? There are so many more safeguards in place in pubs/restaurants, but we believe this application could lead to further Crime and disorder in Fulham.

Also with regard to the safeguarding of children could the applicant absolutely guarantee that children wouldn't be able to order alcohol. Would there be full training for all drivers and would they be able to refuse to delivery without it impacting on their job prospects or pay? It seems to be a proposal that would so easily be taken advantage of. So another reason for objecting is to protect children from harm.

Although not a licensing objective, I think if this business went ahead as planned it would actually be in breach of the Access storage Terms and conditions as they clearly state that their premises should not be used as a Business address. The applicant is using this address in this application! Also they clearly state that they must not offer anything (including, without limitation, alcohol) for sale at the facility, - well this business is storing and delivering alcohol.

Plus they should not connect or provide utilities or services to the Unit. There must be electricity and refridgeration.

All three of these points would breach their contract, indeed even making this application is already in breach as they state the Access storage is their business address, and I do not believe Licensing should be further party to it.

An aside. There is a reason why industrial estates are set up, where these sorts of activities can carry on without impacting on the sleep of residents. I suggest the applicant looks to one of these to set up a 24/7 business., rather than the back yard (literally) of many residents.

If this reaches a Hearing and I cant attend I would like to reserve the right to nominate a representative on my behalf.

Apologises for the email but I have tried unsuccessfully on several occasions today to submit this written objection by using the LBHF website. Please acknowledge receipt.

Please accept this as my objection to Application (16 April deadline) LAPR 2024/00422 21 Effie Road on the grounds that it does not promote one or more of the licensing objectives. I am a resident of Fulham and my family have lived in Fulham for 24 years.

I have two opening remarks. First, my wife and I walk along Effie Road virtually everyday on the way to walk our dog on Eel Brook Common. At no point since the Application was made and I was notified of it by email have we seen the required Blue Notice at the site. I had thought that this was a requirement to notify residents. Perhaps it has been placed by mistake at a different location but I do think that Applicants must adhere to these rules if a fair and open licensing due process is to be achieved. If no blue notice has been fixed at the site or the perimeter of it then I suggest that the Application is flawed and should not proceed/must be withdrawn.

Secondly, my understanding is that the Applicant (Booze Delivery Limited) seeks a premises licence for a <u>self-storage</u> unit that may be as small as about 1.2 square metres (you can only store a very small amount of alcohol in such a unit). From this we can deduce that the purpose of the Application is not to complete sales of alcohol to the public <u>from that unit</u> but rather to allow that Applicant to register an address for business with sales and delivery operators (Uber Eats, Just Eat, Deliveroo etc.). This would permit the Applicant to fill a van (or vans) with alcohol and then wait for online orders (made at any time 24/7) via the operators. In brief, the purpose of the Application is to pay scant regard to licensing laws and the licensing authority by securing a cheap business registered address to rank higher for 'near you' status or accreditation being a key criterion required by the operator to use the Applicant to fulfil contracts/orders placed in areas of London.

In addition to the two fundamental points made above, I am deeply concerned that (1) noise nuisance from and in an area that is specifically conditioned in the relevant planning permission. The site is overlooked by residential houses, (2) noise nuisance caused by the inevitable increase in delivery dispatch riders operating throughout the day and night collecting and delivering orders from the unit (not permitted under the business terms with Access and if permitted effectively allowing alcohol sales from storage units) or, when the storage unit closes, from the van(s) well outside permitted licensing hours and parked on the immediate and local residential or semi-residential roads in the Borough, and (3) public safety issues and possible crime developing with use of the Access Self Storage building, the parking area and two separate double gates being used 24 hours a day and at the point where delivery/dispatch riders congregate all night near the vans known to be full of alcohol/cigarettes etc. The Police are under-resourced as it is and all residents know that they

and their families will be left unprotected to experience the immediate reality of such arrangements on their road's night after night, 364 days a year and all during the essential hours required for sleep.

In support of the above please note:

- planning permission for this site is for self-storage, not for a commercial/business facility operating out of a self-storage unit, as described by the Applicant. See the permission at 2015/04542/FUL;
- 2 Condition 22 of the planning permission states the condition that the operating/opening hours of the self-storage facility are limited to between 7am and 10pm, Monday to Friday, 8am-10pm on Saturday and 8am-8pm on Sunday and Bank Holidays. Not 24/7 as wanted by the Applicant;
- The Applicant's proposed times of 24/7 sales of alcohol are significantly outside the times/hours permitted by the Statement of Licensing Policy (SLP). In addition, if granted the times would entail unconditional unregulated sales of alcohol to the public (private or commercial) with no limitations on where the sales will take place (so on residential roads), the volume of sales transacted, where the alcohol is stored (it can't all be kept in one 1.2sm unit) or where the vans re-fill from/operate, no CCTV recordings at the vans. This all leads to a transformational change for residents but on terms of the risk of night time crime in areas that are already crime hotspots and all-night noise nuisance from dispatch and delivery drivers. None of this can be within the purpose or intention of the Licensing Act 2003 and SLP to allow it would be a massive legal loophole to allow unregulated sales of alcohol to the public in contravention of section 1(1)(a) of the Licensing Act 2003;
- the Access Self Storage terms and conditions (January 2024), state under the heading "Things you must not do", "10.2 Use the Unit as offices or living accommodation or as a home <u>or business address</u>, use the address of the Facility or the Unit for receiving or sending mail, <u>or use the address as Your company registered address"</u> (my underlining added). This is precisely what the Applicant plans to do;
- the same terms and conditions at 10.2 prevent the "offering of anything (including, without limitation, alcohol) for sale from the Facility"; and
- this is not the first time that 24/7 alcohol sales from the Access Self Storage site have been applied for. At a Licensing hearing held on January 13th, 2022, regarding a similar application, the Committee rejected the application. See 2021/01376/LAPR Access Self Storage 21 Effie Road. I see no reason why the Committee should do anything other than reject this Application consistent with the previous decision.

I am aware that there may be an issue about where the sale of the alcohol takes place or the place that needs to be licensed considering that the Applicant has confirmed they intend to store, select and despatch alcohol from Unit 4606 21 Effie Road in breach of the contractual terms set by Access..

I understand that the place where the order for alcohol, or payment for it, takes place may not be the same as the place where the alcohol is appropriated to the contract (i.e. the place where it is identified and specifically set apart for delivery to the purchaser). This position can arise when sales are made online, by telephone, or mail order. Section 190 of the 2003 Act provides that the sale of alcohol is to be treated as taking place where the alcohol is appropriated to the contract. It will be the premises at this location which needs to be licensed; for example, a call centre receiving orders for alcohol would not need a licence but the warehouse (but what if it is on a van) where the alcohol is stored and specifically selected for, and despatched to, the purchaser, would need to be licensed.

These licensed premises will, as such, be subject to conditions including the times of day during which alcohol may be sold. The premises licence will also be subject to the mandatory licence conditions. If the Applicant is specifically selecting and despatching alcohol from a van/car to deliver to customers then it would be this place (or each place) where the van/car is permanently or temporarily parked that needs to hold a premises licence.

Applying this to an example, where is the alcohol appropriated to the contract if a sale is made online at, say, 11.30pm (a time when the Storage Unit is closed). At that time the alcohol, if I have understood this correctly, is stored, selected, and dispatched from a van somewhere in the Borough. It cannot be stored, selected, and dispatched from the storage unit as the unit is closed. Based on the above it is not the tablet, smartphone, or website server where the contract is formed (the equivalent of the call centre in the paragraph above) that needs a licence but the place "where the alcohol is stored and specifically selected for, and despatched to, the purchaser would need to be licensed" i.e. in this example the van. I do not think that licensing vans in this way is within the intention, purpose or scheme of the 2003 Act or the SLP nor that the Committee should see any merit in permitting, or be empowered to, permit, roving mobile-off licences, unlimited, 24/7, unregulated alcohol pop-up vans retailing alcohol anywhere in the Borough. It is simply not reasonable nor enforceable to licence everywhere a van may park.

For the reasons stated above I would ask the Committee to reject in full the Application. I reserve the right to comment further on this Application and submit supporting evidence prior to any hearing.

Booze Delivery out of Effie Road. In reality, there appears to be no intention of delivering booze from the premises, not least because the premises' owners won't permit it. The booze will be stored in a van

and then driven to the people ordering it.

The application, therefore, is premised on a sham and sharp business practice. In my opinion, it would be irrational for the LBHF licensing to grant a license to premises whose owner explicitly prohibits the

storage and sale of booze.

At face value, the license is a shockingly bad idea: 24-hour Booze delivery out of a residential area. I make the following points:

Deliveries outside daytime hours, especially early in the morning and late evening or night, may cause a public nuisance at the delivery

point.

The late-night delivery service of alcohol is likely to be for immediate

consumption.

Persons ordering alcohol for late-night delivery have likely already been drinking.

Unsupervised drinking in the home in the early hours of the morning can impact others living in the home and neighbours, as well as the well-being and health of the person consuming alcohol.

In a domestic context, this also exposes children to the risk of harm.

It is not realistic to expect a courier, eager for the next job, to wait for a customer to produce ID documents or to establish that the recipient is the same person as the one who placed the original order.

It would be a brave delivery person who decided that the recipient was already drunk enough and refused to hand over the alcohol.

Residential roads are likely to be used as cut-throughs, eg Moore Park Road.

This application is cynically using us to gain an edge for its online booze-ordering business. It brings no amenity to the area and pays no council tax. It should be turned down at face value and thrown out totally for its lack of transparency and cogency.



Any such changes shall be carried out in accordance with the approved details.
 - To ensure a satisfactory external appearance and to prevent harm to the amenities of the occupiers of neighbouring residential properties, in accordance with Policies DC1, DC4, and HO11 of the Local Plan 2018.
- 12) Notwithstanding the provisions of the Town and Country Planning (General Permitted Development) (England) Order 2015 (or any Order revoking or re-enacting that Order with or without modification) no extensions or other form of enlargement to the development hereby permitted, nor erection of porches, outbuildings, hardstandings, storage tanks, gates, fences, walls or other means of enclosure, shall take place without the prior written permission of the Council.
 - Due to the limited size of the site, proximity to neighbouring properties and proposed design of the building on the site, the Council would wish to exercise future control over development which may affect residential amenity or appearance of the area, in accordance Policies DC1, DC4, DC8 and HO11 of the Local Plan 2018.
- 13) The use shall not commence until details of the measures proposed to ensure the

safety and security of users of the site, particularly late at night and when staff are not present on the premises. These shall include details of lighting and the number and location of proposed CCTV cameras, and details of how access to the premises is to be controlled and restricted to authorized persons only. The development shall be carried out in full accordance with the approved details.

To ensure that the development incorporates suitable design measures to minimise opportunities for, and the perception of, crime, in accordance with Policy D11 of the London Plan (2021), and Policies DC1 and DC4 of the Local Plan 2018.

To ensure safe and accessible pedestrian access in accordance with Policy T4 of the Local Plan (2018) and Key Principle - TR17 of the Planning Guidance Supplementary Planning Document (2018).

Details of design and appearance of the entrance gates on the Argon Mews and Effie Road frontages, and the system by which these gates will be managed and operated, shall be submitted to and approved in writing by the Council prior to the commencement of the relevant part of the development. In addition, the gates to the Effie Road entrance are required to be located 10m from the property boundary/footpath to allow for the safe queueing of vehicles. No walls, fences, railings or other means of enclosure shall be erected around the roofs, and no alterations shall be carried out to the approved building (including the permitted roof terrace enclosures) to form access onto these roofs.

To ensure a satisfactory external appearance and so that the use of the buildings does not harm the amenities of the existing neighbouring residential properties and future residential occupiers of the development as a result of overlooking, loss of privacy and noise and disturbance, in accordance with Policies DC1, HO11 and CC11 of the Local Plan (2018).

21) No advertisements shall be displayed on or within the development or on the external elevations of the buildings hereby approved without details of the advertisements having first been submitted to and approved in writing by the Council.

To ensure a satisfactory external appearance and to preserve the integrity of the design of the building, in accordance with Policies DC1, DC4, and DC8 of the Local Plan 2018.

The operating/opening hours of the self storage/office facility are limited to between 7am and 10pm, Monday to Friday, 8am-10pm on Saturday and 8am-8pm on Sunday and Bank Holidays, unless otherwise agreed in writing with the Council. The Class E floorspace hereby permitted shall only be used as office space (Class E (G)(i)), and for no other purpose (including any other separate purpose in Class E of the Schedule to the Town and Country Planning (Use Classes) Order 1987, as amended, (or in any provision equivalent to that Class in any statutory instrument revoking and re-enacting that Order with or without modification).

In granting this permission, the Council has had regard to the special circumstances of the case. Reason(s) for granting planning permission:

1) 1) Land Use

The proposal would enable the efficient and orderly development of the site with the provision of additional residential accommodation and office space in an appropriate location close to services and public transport. The residential accommodation and expansion of the B1 and B8 floor area is consistent with Policies CF1, HO1, HO4, HO11, E2 and E4 of the Local Plan (2018).

2) Design

The residential dwellings would be a high quality development which would make a positive contribution to the urban environment in this part of the Borough, accord with the predominant form of surrounding development and contribute to the conservation

area. The extensions to the office building are likewise sympathetic to the surrounding built form and are acceptable. The development would therefore be in accordance with the London Plan policies D4 and HC1 which seek a high quality in design and architecture, requiring new developments to have regard to the pattern and grain of existing development. The proposal would not result in any harm to the Barclay Road Conservation Area in accordance with Policy DC8.

3) Traffic and Transport

The impact of the proposal on the highway network and local parking conditions would be acceptable. The site has good local public transport accessibility and provision would be made for cycle parking for the offices and storage uses. With the use of conditions, officers are satisfied that use of the building would not result in any unacceptable traffic flows or pedestrian-vehicular conflict or any significant increase in car parking demand. The development would therefore be acceptable in accordance with the Local Plan (2018) Policies T1, T3, T4, T5 and T7 as well as CC7 and London Plan (2021) Policies T4, T5 and T6.

4) Residential Amenity and Impact on Neighbouring Properties
The impact of the proposed development upon adjoining occupiers is considered acceptable with no significant or unacceptable worsening of noise, overlooking, loss of sunlight, daylight or outlook to cause undue detriment to the amenities of neighbours. In this regard, the development would respect the principles of good neighbourliness and would be acceptable in accordance with Policies HO11 and DC4 of the Local Plan (2018).

5) Accessibility

The development includes acceptable levels of accessibility for car parking and pedestrian access, for residents within the residential units and for visitors to the office spaces. The proposed development therefore accords with Policies DC1, DC2, HO6 and HO11 of the Local Plan (2018) and Policies D7 of the London Plan (2021).

6) Flood Risk

A Flood Risk Assessment has been submitted and has considered risks of flooding to the site and adequate preventative measures have been identified. Details of SUDS will be secured by condition. In this respect, the proposal is in accordance with the Local Plan (2018) Policies CC3 and CC4.

7) Land Contamination

Conditions will ensure that the site would be remediated to an appropriate level for the sensitive residential and office uses. The proposed development therefore accords with Local Plan (2018) Policies CC9.



The Committee held a hearing on 19 April 2023 to consider an application for the grant of the premises licence for the sale of alcohol off the premises as follows:

The sale of alcohol - Off the premises only Mondays to Sundays 09:00 to 18:00 The opening hours of the premises Not open to the public

The Decision

At the hearing the Committee decided to reject the whole Application

Rectification

Since the date of the decision it has been noted that minor changes need to be made to the decision letter as follows:

 Remove the wording "via an online grocery store" from the first sentence at page 1 of the decision letter.

The Application considered by Committee is for the sale of alcohol online via delivery service therefore reference to online grocery store is not correct. The first sentence of the decision letter should read as follows

"The Committee has considered an application for the grant of a new premises licence for the sale of alcohol off the premises from 09:00-18:00 (Monday – Sunday) under the Licensing Act 2003 (the Application).

2. Amend paragraph 5 of the Decision letter as follows:

"5. One representation was received in objection to the Application by Seagrave Road Residents Association (SGRA) on the grounds of public nuisance, prevention of crime and disorder and public safety. The decision letter states that no representatives of the Seagrave Road Residents Association attended the hearing. It is a sin attendance and spoke on behalf of the Residents

This letter should be read in conjunction with the decision letter

Association.

Point 4 Alcohol Virgin - Decision Notice, published 10 May 2023

The London Borough of Hammersmith and Fulham

Decision of the Licensing Sub-Committee ("the Committee") 19 April 2023

Alcohol Virgin located at Unit 3054, 29 Seagrave Road, London, SW6 1RP ("the Premises")

The Committee has considered an application for the grant of a new premises licence for the for the sale of alcohol off the premises via an online grocery store from 09:00-18:00 (Monday – Sunday) under the Licensing Act 2003 (the Application).

The Committee has considered the committee papers and the submissions made by all of the parties, both orally and in writing.

In reaching its decision the Committee has had regard to the relevant legislation, the Secretary of State's Guidance ("Guidance") and the Authority's Statement of Licensing Policy ("SLP")

In summary, the Committee has decided, after taking into account all of the individual circumstances of this case and the promotion of the four licensing objectives to reject the Application.

Procedural Matters

1. On 23 February 2023, Arlene Auf Der Mauer submitted an initial application on behalf of Parth Anilbhai Patel ("the Applicant) as follows:

The sale of alcohol - Off the premises only Mondays to Sundays 19:00 to 06:00 The opening hours of the premises Not open to the public

2. On the 07 March 2023, the applicant submitted amendments to the licensable hours for the sale of alcohol as follows:

The sale of alcohol - Off the premises only Mondays to Sundays 09:00 to 18:00 The opening hours of the premises Not open to the public

- 3. The Metropolitan Police, a responsible authority, did not object to the Application but during the consultation period suggested 6 conditions to be added to the Licence in the event that it was going to be granted by the Committee which were agreed by the Applicant, as follows:
 - A Challenge 21 or Challenge 25 proof of age scheme shall be operated at the premises where the only
 acceptable forms of identification are recognised photographic identification cards, such as a driving licence,
 passport or proof of age card with the PASS Hologram.
 - A warning shall be displayed on the digital platform on which an order is placed informing customers that they must be aged 18 or over to make a purchase of alcohol and notifying customers that the delivery rider will carry out age verification on delivery. The customer will be asked to provide ID to prove their age in accordance with Challenge 25 scheme. If the rider is not satisfied then the alcohol in the order will be withheld.

 3. A record shall be kept detailing all refused sales of alcohol upon delivery. The record should include the date
 - and time of the refused sale and the name of the member of staff who refused the sale. The refusals log shall be made available for inspection upon request by the Licensing Team, Police or Trading Standards.
 - 4. Any alcohol sold for consumption off the premises shall be sold in a sealed containers.
 - Deliveries shall only be made to bona fide residential or business addressesMembers of the public will not be permitted to enter the premises.

- Thirteen representations objecting to the Application were received by local residents on the grounds of prevention of crime and disorder, prevention of public nuisance, public safety and protection of children from harm soal residents attended the hearing.

- One representation was received in objection to the Application by Seagrave Road Residents Association on the grounds of public nuisance, prevention of crime and disorder and public safety. No representatives of the Residents Association attended the hearing.
- 6. One representation was received in objection to the Application on behalf of Lillie Square Residential Development (LSRD) on the grounds of public nuisance, prevention of crime and disorder and public safety. No one attended the hearing on behalf of LSRD. Lorna McKenna, licensing officer clarified at the hearing that LSRD is not a residents' group but a large residential development within the area.
- 7. The Applicant attended the hearing.
- A supplementary agenda containing additional information from the objectors was published and circulated to all parties on 18 April 2023.

Reasons

- In making its decision the Committee has taken into account all relevant sections of its SLP and the Guidance as well as local knowledge.
- 10. The Committee was mindful that Section 4 of the Licensing Act 2003 imposes a duty on the Licensing Authority, when carrying out its functions to determine the application with a view to promoting the licensing objectives.
- 11. When considering the objections the Committee noted that local residents were concerned regarding the use of a self-storage unit to sell alcohol online which was in breach of the lease and terms and conditions of SafeStore, the storage company. They were also concerned about the fact that the Applicant was not living in the Borough and was not paying business rates to the Council. These issues are not relevant licensing considerations and cannot be taken into account when considering the Application.
- 12. The Committee took into account the local residents' concerns of noise and nuisance caused in the area by delivery vehicles, drivers congregating near the Premises and the the fact that there were no parking spaces near SafeStore for delivery drivers to wait to collect the orders.
- 13. At the hearing the Applicant confirmed that the sale of alcohol will take place through online platforms such as Deliveroo and Uber-eats and orders would be delivered mainly by their drivers, using electric bikes. Mr Patel also reassured the Committee that he also was willing to deliver orders and maybe employ a delivery driver in the future. The Committee took into account the fact that no conditions could be imposed on the licence to require third party delivery drivers to use electric bikes as they will not be enforceable.
- 14. The Committee took into account. Policy 14 of the Council's SLP, which requires the Applicant to consider how to reduce public nuisance caused by delivery drivers and ensure the security of both the Premises and the delivery drivers. Although the Committee noted that the Premises would not be open to the public it was concerned of the fact that the Applicant could not provide a safe area to deliver the orders to the drivers due to lack of parking spaces at the building. The Applicant explained that he intended to hand over the orders at the gate of SafeStore. This will not only obstruct the public pavement but will increase the risk of anti-social behaviour and will put the safety of the drivers at risk. The Committee heard that the there will be no CCTV camera installed at the Premises but the Applicant would rely instead on the security system operated by SafeStore for the whole building in case of any incidents. Taking all this into account it was the Committee's considered opinion that this will increase the risk of anti-social behaviour in the area which will cause noise and nuisance to residents living nearby. This will have a negative impact on the licensing objectives of prevention of public nuisance, public safety and prevention of crime and disorder.

- 15. The Committee took into account the objector's concerns regarding anti social behaviour associated with the sale of alcohol. When considering the options available in determining the Application, the Committee noted that the Applicant amended the initial proposed licensable hours and agreed to the six conditions proposed by the Police as referred at paragraph 3 above.
- 16. The Committee noted that the Police proposed a Challenge 25 condition, a condition for the Applicant to keep a book recording refusals of the sale of alcohol, a warning to be displayed on the online platforms that alcohol can be bought by person aged 18 or over only. The Police also proposed conditions for alcohol to be sold to residential and business addresses only and for delivery drivers to check IDs. The Committee took into account the fact that alcohol will be sold and delivered mainly via third parties companies and that it will be very difficult for the Applicant to comply with these proposed conditions as the Applicant will not be in control of the sale or the delivery of alcohol. Taking into account the nature of the business, it was the Committee's considered opinion that the imposition of these conditions would not be sufficent to promote the licensing objective of prevention of crime and disorder and protection of children from harm.
- 17. The Committee took into account the concerns of the objectors regarding the licensable hours and noted that although they were amended from 19:00-06:00 to 09:00-18:00 (Monday to Sunday) they were still not in line with the opening hours of SafeStore for Sundays which were 10:00-16:00. The Committee welcomed the Applicant's proposal to further amend the licensable hours from Monday to Saturday 10:00-17:00 and closed on Sundays. However in accordance with section 5 of the Council's SLP the Committee took into consideration the location, the character and the nature of the proposed use of the unit. It was the Committee's considered opinion that the Applicant was not able to demonstrate or propose any steps that will deal with the concerns of the objectors, ensure the physical safety of the people using the Premises and promote the licensing objectives.
- 18. Taking all of the above into account, it was the Committee's considered opinion that granting the Application will undermine the licensing objectives and in particular the licensing objectives of prevention of crime and disorder, prevention of public nuisance and public safety. Therefore the Committee considered that it was appropriate and proportionate to refuse the whole Application.
- 19. If any of the parties are unhappy with the decision, they are entitled to appeal to the magistrates' court within 21 days from the date of notification of this decision.

The Committee has considered an application for the grant of a new premises licence for the supply of alcohol for consumption off the premises from 00:00 - 24:00 under the Licensing Act 2003 (the Application)

The Committee has considered the committee papers and the submissions made by all of the parties, both orally and in writing.

In reaching its decision the Committee has had regard to the relevant legislation, the Secretary of State's Guidance ("Guidance") and the Authority's Statement of Licensing Policy ("SLP").

In summary, the Committee has decided, after taking into account all of the individual circumstances of this case and the promotion of the four licensing objectives as follows:

i) To refuse the Application

Procedural Matters

- On the 9th November 2021, Mr Stewart Gibson ("the agent") submitted the Application on behalf of Mr Aarat Patel ("the applicant").
- 2. The Licensing Authority received the following representations:
 - (i) One representation from the Planning Authority objecting to the licence application.
 - (ii) One representation from the Noise and Nuisance Authority objecting to the licence application.
 - (iii) One representation from the Safeguarding, Review and Quality Assurance Authority objecting to the licence application.
 - (iv) One representation from the Shottendane Road Residents Association objecting to the licence application.
 (v) One representation from the Barclay Road Residents Group objecting to the licence application.
 - (vi) Twenty-one representations from local residents objecting to the licence application.
- 3. The Applicant attended the hearing and was represented by

Reasons

- In making its decision the Committee has taken into account all relevant sections of its SLP and the Guidance as well as local knowledge.
- The Committee was mindful that Section 4 of the Licensing Act 2003 imposes a duty on the Licensing Authority, when carrying out its functions to determine the application with a view to promoting the licensing objectives.
- 6. The Committee heard from the Council's Noise and Nuisance Officer who expressed concerns regarding the unacceptable noise and nuisance impacts on residents created by the operation of the premises, in particular delivery drivers coming to and from the premises. It was his opinion that the noise would have a detrimental impact on the residents, in particular impacting on sleep during the summer months when residents would have windows open and in the evening when the background noise is lower. This would be a direct contravention of Paragraph 10.1 of the SLP in regards to the prevention of nuisance on the amenity of the area. It was his view that noise and nuisance should have been a key point which was addressed in the operating schedule, however this issue had not been addressed by the applicant.
- 7. Section 15.2 SLP requires applicants to consult with the appropriate authorities to prevent any dispute arising. It was noted there had been a number of emails sent by the officer to the applicant, in an attempt to agree conditions in respect of hours of operation and for the use of silent vehicles, however they were rejected by the applicant in writing.

- 8. The Committee heard evidence from residents and their representatives regarding the proximity of the premises to residential properties and concerns about the noise impacts. Concerns has been raised about the lack of supporting information submitted with the application, in particular paragraph 3.9 of the SLP which requires the applicant to consider the Licensing Act. Regulations and SLP when preparing an application to demonstrate an understanding of the licensing objectives and local area risk. There was no traffic management plan or operation plan in respect of the premises.
- 9. Further, concerns were heard from residents and their representatives at the hearing regarding the impact of noise on residents caused by vehicles and the extent of the traffic that would be coming and going from the premises. It was suggested that the premises would be locked at 6pm, however this was an application for a 24 hour licence. Other concerns were in relation to the noise created from bottles and machinery emanating from the unit. Also, sound echoes off the houses in that area.
- 10. It was noted that a representation had been made from the Council's Planning Officer as the hours of operation would fall outside of the permitted hours. Under the planning permission, the operating/opening hours of the self-storage facility are limited to between 7am and 10pm, Monday to Friday, 8am-10pm on Saturday and 8am-8pm on Sunday and Bank Holidays. Further there had been no correspondence from the owner of the premises confirming that they agreed to the use of the premises for the sale of alcohol.
- 11. The Committee heard from the applicant and his agent who confirmed during the hearing they would agree to the conditions proposed by the Council's Noise and Nuisance Officer. In terms of the operation of the premises, orders would be placed on the website, via Deliveroo and Just Eat, the applicant would employ his own riders for deliveries and there would be 24 hours access to the storage facility. He confirmed that he would have no control over the times the orders are made but there would be no noise nuisance as he would directly employ his own drivers who would use silent vehicles such as pedal cycles for deliveries. The applicant confirmed that he did not know at this stage if the business would be viable as the permises was only a small rented unit. Further, his staff would be fully trained, there would be a challenge 25 policy in place, a drugs policy and he would use pedal cycles to prevent noise nuisance.
- 12. He confirmed that access to the premises was via two sets of large steel gates that are locked, he confirmed that he expected around 7-8 deliveries up to midnight this is because there were other premises open in the area and delivery is more expensive that collecting alcohol from the shop. However, after midnight he expected there would be an increase in deliveries.
- 13. When asked if he was familiar with the area. Mr Patel confirmed that he was not familiar with the area. Mr Verma had visited the premises once at 7:30 pm for the purposes of putting the Notice up.
- 14. Members noted that during the course of the hearing the applicant subsequently verbally agreed to the conditions proposed by the Noise and Nuisance Officer which would fall in line with the hours permitted by the planning permission, however it was felt that the applicant had not taken the concerns of the officer seriously because despite the verbal assurances given there was still a lack of sound evidence presented with the application which could be relied on to demonstrate how the licensing objective of public nuisance would be promoted by the applicant which was contrary to paragraph 10.1 and 10.2 of the SLP.
- 15. Paragraph 5.4 of the SLP states that it would be beneficial for a lawful use to be established, however this had not been confirmed by the applicant prior to the hearing despite the number of representations raised on this point. Given the comments made by the applicant regarding the increase in deliveries after 12pm it was not clear how the business would operate if it was restricted to the permitted hours. Further, there was a lack of understanding of cumulative impact by the applicant and from the evidence provided there were concerns about the number of premises operating in the area. It was noted that paragraph 15.6 of the SLP requires applicants to provide a description of the local area and the impacts, however the applicant had never visited the area itself. This did not give Members any confidence that the applicant understood the requirments of the SLP. Paragraph 14.8 of the SLP states that the Licensing Authority may refuse to grant a licence if a representation from the Planning Department has been received and one or more of the licensing objectives would not be promoted. Although the applicant confirmed that he would now agree to reduce the hours of operation no evidence had been provided about how the impacts would be mitigated during these hours.

- 16. In accordance with paragraph 10.3 of the SLP Members gave significant weight to the evidence given by the residents and their representatives. Further, Members gave significant weight to the representation from the Head of Safeguarding who expressed concerns about the impact on children who lived adjacent to the premises and in the surrounding area. It was noted that the applicant had failed to demonstrate how they would protect children from harm and nor had they provided any evidence or mitigation in response to the objection, therefore this was in contravention with paragraph 11 of the SLP. Further, in applying paragraph 15.11 of the SLP it was clear that there was a lack of information in the operating schedule confirming how the deliveries and collections would operate, what type of vehicles would be used and the impact of noise on the residential area and how the external areas would be used. Further no traffic management plan had been submitted. Therefore, the licensing objective of Public Nuisance or the Protection of Children from Harm had not been promoted.
- 17. In regards to the suitability of the premises the Committee heard evidence from residents and their representatives about the suitability of the premises for the sale of alcohol. In particular, it was noted that there wasn't sufficient evidence in the operating schedule to confirm the layout of the site or where the staff would be located, it was a small lockup in a storage unit which would be operating as all day and night sales. Further, no information had been submitted about how it would mitigate the impacts on the local area.
- 18. It was noted that the applicant has made no attempt to contact residents to address the number of concerns raised and it was considered that operating this business from the premises would pose a risk to the local area. Members asked the applicant questions about how the business would operate, however they considered the applicant hadn't made it clear about how it would operate or how staff welfare would be adressed. There was no evidence of employment contracts or how staff would use and access the unit. It was considered that in accordance with paragraph 9.6 of the SLP public safety concerns could not be overcome due to the physical limitation of the premises. The premises was a storage lockup and not considered a suitable venue for a premises licence operating for the sale of alcohol, further there were concerns about ventilation and heat in the premises. Members gave weight to the evidence presented during the hearing in regards to the premises being unsuitable for this type of business. Therefore, the application did not promote the licensing objective of Public Safety.
- 19. Further, taking into account all of the evidence provided Members considered that the applicant had failed to promote the licensing objective of the prevention of Crime and Disorder, in particular in accordance with paragraph 8.1 and 8.9 of the SLP they would expect to see details in the operating schedule about how they would prevent crime and concerns had been raised about the operation of this business, how secure the site was given its location in a residential area and that CCTV would not be sufficient to prevent problems arising. There had been a lack of consideration for residents, and this undermined paragraph 22 of the SLP which requires applicants to demonstrate exactly what measures they will have in place to protect residents from the potential detrimental effects of any licenced premises. Further, it was understood there was a high level of ASB in the area and street drinkers. Therefore, the application did not promote the licensing objective of the Prevention of Crime and Disorder.
- 20. It is noted that paragraph 15 of the SLP requires applications to be unambiguous and for applicants to be clear about what they intend to achieve. However despite questions of the applicant. Members did not have any clarity or confidence in how the business was intending to operate. Paragraph 15.7 of the SLP requires applicants to consider government guidance. In particular, applicants should prepare local risk assessments to demonstrate that they will promote the licensing objectives, that they understand the setting and layout of the premises, how they will manage any potential risks including proximity to residential premises and risks posed to the local area by the premises. However the applicant had not complied with paragraph 15.
- Taking all of the above into account it was the Committee's considered opinion that the Application should be refused.
- 22. If any of the parties are unhappy with the decision, they are entitled to appeal to the magistrates' court within 21 days from the date of notification of this decision.

Our liability for, and Your responsibility to insure, the Contents

- We do not accept liability for loss of or damage to the Contents other than a) where the Unit Licence Agreement Indicates that Contents Protection applies, in which case our liability will be limited in accordance with Section 1 of the Additional Conditions and Information or b) where the loss or damage results from Our negligence or breach of contract, in which case Our liability to You will be limited in accordance with Clause 21. Subject to the foregoing:
- You shall be responsible for and bear the risk of any and all theft, damage to, and deterioration of the Contents caused by Normal Perils;
- 20.2 You advnowledge and agree that We do not insure the Contents and promise and assure Us that-
- 20.2.1 prior to bringing the Contents onto the Facility You have insured or will insure the Contents against all Normal Perlis and will not cause or allow that insurance cover to lapse whilst the Contents or any of them remain. on the Facility:
- 20.2.2 Your insurance cover will not be for a sum which is lower than the true replacement value of the Contents stored in the Unit from time to time;
- 20.2.3 You will supply the store manager at the Facility with a letter from Your insurance provider with proof of a valid contract of insurance with a

Our liability for all other matters

- In addition to Clause 21.1, We exclude all liability to You in respect of:-

- 21.4 Nothing in this Agreement will be deemed to exclude or limit Our liability for physical injury to or the death of any person that is caused by Our negligence or wifful default or that of Our agents and/or employees, for fraud or fraudulent misrepresentation, or for any other type of loss that cannot legally be excluded or limited.

Your liability to Us

You will reimburse Us an amount equal to all claims, demands, liabilities, damages, costs and expenses incurred by Us or by any of Our servants, or agents or which We have incurred towards other unit users or persons on the Facility as a result of any improper or unauthorised use of the Unit or the Facility by You or any of Your servants, agents or invitees or which arise out of Your negligence or the breach of this Agreement by You.

Circumstances beyond Our Control

We shall not have any liability under or be deemed to be in breach of this Agreement for any delay or failure in performance of this Agreement which results from circumstances beyond Our reasonable control. Such circumstances include any Act of God, riot, strike or lockout, trade dispute or labour disturbance, accident, breakdown of plant or machinery, fire, flood, shortage of labour, materials or transport, electrical power failures, threat of or actual terrorism or environmental or health emergency or hazard, or entry into any Unit including the Unit or the Facility, or arrest or setzure or confiscation of Contents, by competent authorities.

Termination

- This Agreement shall expire on the Termination Date or:-
- 24.1 either You or We may terminate this Agreement:
- 24.2 by giving not less than seven days written notice to the other,

termination will take effect from that date, which shall be the Termination Date: or

- 24.3 Immediately by giving written notice to the other if the other party commits a serious breach of any term of this Agreement and lin the case of a breach capable of being remedied shall have falled within fourteen days from the date the notice was served to remedy the breach. The Termination Date shall be the date the notice is effectively served by one party or the other in accordance with Clause 28.8
- 24.4 notwithcranding the seven day notice period required to terminate this Agreement under Clause 24.2, You may terminate this Agreement on giving Us less than 7 days' notice of Your Intention to do so, You will incur a rental charge for the remaining days (up to a maximum of 7 days' notice; this does not include service or other charges). No interest will acarue on any money held by Us for You. Where any payments are atll outstanding from You, You must pay Us in full induding any outstanding rental, insurance and/or administration charges before We will release the Contents to You.

Your duty to inspect the Contents on removal from the Unit 26. You agree to examine the Contents carefully upon removing them from the Unit and You must notify Us at the time of discovery of the loss of or damage to the Contents or at the time of removal of the Contents from the Unit, whichever is the soonest. We will not be liable under this Agreement for loss or damage to the Contents that are not reported in accordance with this clause.

- 28.2 every provision in this Agreement is severable and distinct from every other provision and if at any time one or more of such provisions is or becomes invalid, lifegal or unenforceable, the validity, legality and enforceability of the remaining provisions will not be affected in any way.
- 28.3 You should not rely upon any promises, representations, or daims made by any of Our employees, agents or contractors which are not also contained within this Agreement. Any changes to this Agreement which are agreed between Us and You must be recorded in writing and it is Our practice to ensure that such documents are signed on Our behalf by one of Our directors.
- 8.4 You may not assign any of Your rights under this Agreement, or transfer Your right to access the Unit, or part with possession of the Contents whilst they are on the Facility to any other person, firm or company. - 28.9 before taking any court proceedings for anything artsing out of this Agreement liapart from emergency court proceedings), the parties may decide to attempt to resolve the matter informally, in which case the complaining party should inform the other person in writing of the dispute in as much detail as possible and You and We may agree to try informal conciliation. If the dispute cannot be resolved informally within a reasonable period of time, You and We may agree to use the Centre for Effective Dispute Resolution to try to resolve the dispute amicably by using a recognised attemptive dispute resolution procedure before taking any other step. If the dispute is not recolved to mutual satisfaction within a reasonable period of time, You or We can submit the dispute to the Court. This Clause does not prevent or otherwise restrict either You or Us from referring any dispute between Us directly to the Court without first houting tried to resolve the matter informally, nor does it affect the right of either You or Us to terminate this Agreement.

- Please park in the designated areas and allow reasonable space for fellow customers
- . Return trolleys to the areas provided
- Minimise noise levels
- Do not dispose of Your waste at the Facility. In some cases the storage facility staff may be able to arrange the removal of waste including pallets. Please enguire at reception for details

Things You cannot store

For the safety of all customers and their property, the following cannot be stored:

- Explosives, gas canisters, firearms or ammunitions
- Hazardous, taxic or radioactive materials, and aerosol cans
- Pollutants, contaminated items or waste
- illegal tiems, cash or securities
- · Perishable tiems, food, live animals or plants
- Very precious or high value tiems, unless already agreed with us in writing

For full details of the things You cannot store please refer to Clause 9 of the Terms and Conditions.

Please also ensure that any fuel tanks (e.g. lawnmowers or cars), are fully drained. Refrigeration equipment should be defrosted, and along with washing machines, left dip, and with the door open to allow air circulation and prewent mould.

Activities which are not acceptable at the storage facility

Many of our storage facilities offer customer parking as well as areas for visitors and loading / unloading. Please park in the designated areas with consideration for other customers. Parking on storage facility premises is only allowed whilst visiting Your unit or reception, unless a parking contract has been arranged.

PIN code entry procedure

At move in You will be given instructions on how to access the storage facility and Your unit, if applicable. Your expected frequency of visits will allow staff to explain the procedure to follow and what responsibilities You and Your authorized users have, it is important to note that if these procedures are not followed at any time, You may be charged for false

Always use Your PIN code to enter the Facility, as this provides information of who is on site in case of an emergency.

- Your PIN code also controls Your unit's alarm, where applicable.

Alarms and Security call outs

Blocking or holding gates and doors open may result in the activation of an alarm and a member of the security team attending the storage facility. Should this occur, We reserve the right to recover the cost of the call out from You. Additionally, any damage caused by blocking sensors, gates or shutters even unintentionally will incur costs against You for the repair - see Clauses 10.8 and 22 of the full Terms and Conditions
- Alarms will also be activated by leaving the building via any unauthorised exits such as a fire Door (in non-emergency situations), or by failing to enter the PIN code at an entry keypad
- Please keep Your unit door open when You are in Your room so that the alarm does not re-set
- Lock the unit door correctly and always reset Your unit alarm when leaving the storage facility, by re-entering Your PIN code at the exit gate

- . Under exceptional droumstances, the out of hours call centre may be suspended for technical, security or safety reasons. This service is provided free of charge and, as such, You will not be entitled to compensation or refund

Emergency assistance

in the event of an emergency, a help phone is located in the lift lobbies on all floors. In addition, an intercom on the outside of the main gate with instructions on how to contact Our out of hours call centre. There is a sign on the help phone and in the lift which states Your storage location and gives a storage facility number for ease of identification. If You are unclear on the location / operation of these devices please visit reception and a member of staff will demonstrate them to You. Access staff are only available for the opening times stated at each storage facility location, even where You can access the storage facility outside these hours.

The help phane or intercom provided is for calling reception during office hours or the out of hours call centre and not the Emergency

Situations such as forgotten PtN codes, non payment, over locked units, or if You are unable to enter the compound due to mechanical failure, cannot be answered. The issue will be resolved by storage facility staff at reception during reception opening hours.

If an intercom phone is not available, please contact Your storage facility team in reception.

It is advisable that You carry a mobile phone with You if You access the storage facility outside the reception opening hours.

Lifts and their use

- In the unlikely event of lift malfunction, please follow the procedures outlined on the wall of the lift car to summon help
- Please refroin from placing items in the path of the lift doors to hold them open. Should You require the lift to be held open for a lengthy period, please arrange this with a member of Your Access storage facility team.
- . Lifts are NOT to be used in emergency evacuation of the building

Lighting

Lighting is either controlled by the storage facility team or by sensors. Should the lights dim whilst You are in Your unit, simply return to the contidor to reactivate the sensor.

First Aid

A first aid box is kept within the facility. Please contact the storage facility team if required.

Trolleys and moving property

Trolleys are for use by all customers and please therefore use them with consideration.

- Return trolleys to the areas provided and do not leave them in Your unit
- Do not overload traileys, ride them, or allow children to operate them
- Do not use pallet trucks unless You have been shown how
- Exercise good common sense and consideration when stacking or manoeuvering items. Access Self Storage will accept no responsibility for injury caused by unsafe actions on the part of customers, or damage to property.

Support for customers and visitors with disabilities

Customers with a disability that may affect their use of the storage facility or unit are asked to make this known to the storage facility team, to ensure We provide safe access in and around the storage facility. - Move outs can only be processed during office hours
- On moving out You are requested to remove Your padiock, leave Your unit clean and tidy with any possessions and rubbish removed. Please recycle rubbish where possible.
- You will receive a refund for any unused rental period providing there are no outstanding charges. Please inform Us if Your mailing address changes from that shown on Your Unit Ucence Agreement, so that any monies can be returned to the correct address, or via the bank if You pay by Direct Debit.

Terms and Conditions

Contents Protection

Applicability

This section will apply only where You have paid an additional sum in respect of Contents Protection.

We will pay compensation in respect of Contents Protection only where this is indicated on the Unit Uoence Agreement, subject to payment of the appropriate fee on or before each Due Date and provided always that You have compiled with all the provisions of the Agreement.

Our Contents Protection

Where Contents Protection is applicable in accordance with the previous paragraphs, We will accept liability, as set out in this section, where all or part of Your Contents is lost, damaged or destroyed as a result of one or more of the following:

- handling by Our personnel
- fire
- explosion
- storm
- bursting and/or leaking pipes
- water or other liquids entering the Unit
- moths, insects or vermin
- theft by force and violent entry into or out of the Unit or the Facility
- malicious damage, or
- Impact by vehicles

Limit of Liability

Notwithstanding clause 21 of the Terms and Conditions, but subject to the remaining provisions of this section We will be liable for the replacement value of the Contents (or the relevant part thereof) or the value of the Contents as set out in the Unit Licence Agreement, whichever is lower, less the sum of £150.

If it is established that the total value of the Contents exceeds the replacement value indicated on the Unit Licence Agreement, Our liability will be reduced pro rata to the proportion of the declared value as compared to the actual value of the Contents.

in calculating Our liability hereunder, the replacement value of the Contents shall be the value of a new item that is as similar as possible to the value of the lost or damaged item, and will not include:

- Sentimental or non-financial value in any Contents; and/or
- any additional value which an item has by reason of it being part of a pair or set.

Notifying us of loss or damage to Contents

- You must inform Us of the loss or damage to Your Contents as soon as possible following discovery (and in any event within 24 hours of discovery), either in person at the storage facility reception or by calling or emailing Us using the contact details set out in Your Unit Licence Agreement.
- We will provide You with a form that You must complete.
- You must provide such information and evidence as reasonably requested to Us or to an agent appointed by Us to investigate Your claim.

Limitation and exclusion of liability

Notwithstanding Clause 21 of the Terms and Conditions, Our total liability under this section will be limited (in the aggregate for the term of the Agreement) to GBP 55,000.
