#### 2. DECLARATIONS OF INTEREST

If a Councillor has a disclosable pecuniary interest in a particular item, whether or not it is entered in the Authority's register of interests, or any other significant interest which they consider should be declared in the public interest, they should declare the existence and, unless it is a sensitive interest as defined in the Member Code of Conduct, the nature of the interest at the commencement of the consideration of that item or as soon as it becomes apparent.

Councillors are not obliged to withdraw from the meeting where a dispensation to that effect has been obtained from the Standards Committee.

# 1. THE APPLICATION

On 7<sup>th</sup> June 2024, the Licensing Authority received a valid application for a new premises licence in respect of the premises known as Eel Brook Common, New Kings Road, London, SW6 4QD submitted by A1 Hospitality Ltd.

# 1.1 Application Requested

The applicant has applied for a new premises licence for the sale of alcohol on the premises, the performance of live music outdoors only, the playing of recorded music outdoors only, the performance of dance outdoors only, entertainment similar to music or dance outdoors only as outlined below:

<u>The Performance of Live Music – Outdoors Only</u> Saturdays and Sundays 12:00 to 20:30

<u>The Playing of Recorded Music – Outdoors Only</u> Saturdays and Sundays 12:00 to 20:30

<u>The Performance of Dance – Outdoors Only</u> Saturdays and Sundays 12:00 to 20:30

Entertainment similar to Music or Dance - Outdoors Only Saturdays and Sundays 12:00 to 20:30

<u>The Sale of Alcohol - On the Premises Only</u> Saturdays and Sundays 12:00 to 20:00

Opening Hours of the Premises

Saturdays and Sundays 12:00 to 20:30

#### 1.2 Applicants Operating Schedule

The applicant has proposed a number of steps to promote the four licensing objectives if the application is granted. A copy of the proposed conditions can be seen on pages **28-30** of this report.

On 12<sup>th</sup> June 2024, following correspondence with the Licensing Team, the applicant confirmed the application was only for one weekend (Saturday and Sunday) a year in August or September and agreed to add a condition to the licence if granted reflecting this. On the 17<sup>th</sup> June 2024, the applicant submitted a resident action plan, which stated that the event one be for one weekend (Saturday and Sunday) a year in August or September only and provided details of additional ways the applicant proposes to promote the licensing objectives. A copy of the resident action plan and relevant correspondence can be seen on pages **32-44** of this report.

On 17<sup>th</sup> July 2024, following correspondence with the applicant and Licensing Team, the Police agreed to withdraw their representation as the applicant agreed to add 29

conditions to the licence, if granted. A copy of the agreed conditions and relevant correspondence can be seen on pages **45-48** of this report.

On 17<sup>th</sup> July 2024, following correspondence with the applicant and Licensing Team, the Environmental Protection Team agreed to withdraw their representation as the applicant agreed to add 6 conditions to the licence, if granted. A copy of the relevant correspondence can be seen on pages **49-50** of this report.

#### 2. BACKGROUND

The several access points to the common which is located on New King's Road, Musgrave Cresent and Musgrave Cresent. The applicant intends to operate the licence as a Food Festival on part of Eel Brook common, on the New King's Road side. There mainly residential premises within the area. A map showing the location of the premises and neighbouring licensed premises can be seen on page **51** of this report.

There are several options for transport away from the area including buses and taxis which run from in and around the New King's Road and the Fulham Broadway area. Fulham Broadway tube station is an 8-minute walk away, Parsons Green tube station is a 14-minute walk away.

#### 3. CONSULTATION

A public notice was displayed at the premises for 28 days. The application was advertised in a local circular and all statutory consultees were notified as required by the Regulations. The Council has served written notice of hearing upon the applicant and all those parties that have made representations in respect of the application.

#### 3.1. Relevant Representations

The licensing section received sixty-seven representations objecting to the licence application being granted, and one representation in support of the application, during the consultation period.

One representation was received on behalf of the Licensing Authority objecting to the premises licence application. On 13<sup>th</sup> September 2024, following the agreement with the Police conditions outlined in section 1.2 of the report, the Licensing Authority withdrew their representation. A copy of the representation and correspondence can be seen on pages **52-53** of this report.

One representation was received from the Police Licensing Team objecting to the premises licence application. On 18<sup>th</sup> July 2024, following the agreement with the conditions outlined in section 1.2 of the report, the Police Licensing Team withdrew their representation. A copy of the representation and correspondence can be seen on pages **54-55** of this report.

One representation was received from the Environmental Protection Team objecting to the licence application. On 18<sup>th</sup> July 2024, following the agreement with the six conditions outlined in section 1.2 of the report, the Environmental Protection Team withdrew their representation. A copy of the representation and correspondence can be seen on pages **56-58** of this report.

Two representations were received from the Parsons Green and Sandford Local Ward Councillors, Councillor Alfonso and Councillor Pascu-Tulbure objecting to the licence application. A copy of the representations can be seen on pages **59-60** of this report.

One representation was received on behalf of the Eel Brook Common Residents Association, one representation was received on behalf of the Barclay Road Neighbourhood Watch, and fifty-nine on behalf of a local residents, all objecting to the licence application. A copy of these representations can be seen on pages **61-151** of this report.

One representation was received on behalf of a local resident supporting the grant of the licence application. A copy of the representation a can be seen on pages **152-153** of this report.

On the 27<sup>th</sup> June 2024, the licensing team circulated the resident pack and informed of the time limited nature of the application mentioned in section 1.2 of this report, nine residents withdrew their objections. #### 5. POLICY CONSIDERATIONS

**5.1** Section 2 pages 7 and 8 of the Statement of Licensing Policy ("SLP") states the Licensing Authority is keen to support the licensed sector and leisure offer within the borough, with a particular focus on business resilience and growing a robust and thriving cultural and leisure sector.

To achieve this the Licensing Authority has identified three key themes of the Licensing Policy and the Licensing Authority's approach to implementing it. These are:

- A sustainable, well-run licensed sector;
- Hammersmith & Fulham as a good place to live, work and enjoy leisure; and,
- A safe licensing environment and night-time economy.
- **5.2** Section 5 pages 12 and 13 of the SLP states that in order to ensure the promotion of the four Licensing Objectives the Licensing Authority will require applicants to detail in their operating schedule:
  - the steps proposed to promote the licensing objective of the prevention of crime and disorder on, and in the vicinity of, the premises, having regard to their location, character, condition, the nature and extent of the proposed use and the persons likely to use the premises;
  - the steps proposed to ensure the physical safety of people using the relevant premises or place;
  - how they intend to prevent nuisance arising, prevent disturbance and protect amenity so far as is appropriate to ensure that the Licensing Objectives are met.
     Where there is a relevant representation regarding extended hours, the Licensing Authority will not permit an extension unless it is satisfied that the Licensing Objectives would be met;
  - the measures and management controls in place to protect children from harm. Where appropriate a written childcare policy should be available and be incorporated in the induction of staff.
- **5.3** Section 7 pages 13 to 15 of the SLP states that operating schedules for premises licences are the key to ensuring compliance with the four Licensing Objectives. The measures proposed in the operating schedule will normally be converted into conditions to be attached to the premises licence and should therefore fulfil the following criteria:
- (I) Be precise and enforceable
- (ii) Be unambiguous
- (iii) Not duplicate other statutory provisions
- (iv)Be clear in what they intend to achieve, and
- (v) Be appropriate, proportionate and justifiable

Operators of licensed premises will have to comply with planning, environmental health, trading standards, fire safety, licensing and building control legislation when opening or adapting licensed premises. The Licensing Authority will seek to avoid confusion and duplication by not imposing licence conditions relating to matters that are required or controllable under other legislation, except where they can be exceptionally justified to promote the Licensing Objectives.

- **5.4** Policy 1 page 18 confirms that The Secretary of State's Guidance states that applicants are expected to obtain sufficient information to enable them to demonstrate, the steps they propose to take to promote the licensing objectives; and that they understand the layout of the local area and physical environment including:
- a) crime and disorder hotspots;
- b) proximity to residential premises;
- c) proximity to areas where children may congregate;
- d) any risk posed to the local area by the applicants' proposed licensable activities; and
- e) participation in any local initiatives (for example, local crime reduction initiatives or voluntary schemes, such as 'Ask for Angela', local taxi-marshalling schemes, street pastors and other schemes) which may help to mitigate potential risks.

Applicants are expected to include positive proposals in their application on how they will manage any potential risks.

The Guidance goes on to state that 'Applicants are expected to provide licensing authorities with sufficient information in this section to determine the extent to which their proposed steps are appropriate to promote the licensing objectives in the local area. Applications must not be based on providing a set of standard conditions to promote the licensing objectives and applicants are expected to make it clear why the steps they are proposing are appropriate for the premises.'

The Licensing Authority notes the contents of these paragraphs from the Secretary of State's Guidance and, in particular, the use of the word 'expected'. Licence applications that do not in any way address the contents of these paragraphs in their operating schedules may be returned to the applicant as 'incomplete'.

- **5.4** Policy 3 page 21 and 22 of the SLP states that where there is a relevant representation, the Licensing Authority will consider each particular case on its merits having regard in particular to the following matters:
- a) Whether the licensed activities are likely to have an adverse impact especially on local residents and, if there is potential to have an adverse impact, what, if any, appropriate measures will be put in place to prevent it;
- b) Whether there will be a substantial increase in the cumulative adverse impact from these or similar activities, on an adjacent residential area;
- c) Whether there is a suitable level of public transport accessibility to and from the premises at the appropriate times;
- d) Whether the activity will be likely to lead to a harmful and unmanageable increase in car parking demand in surrounding residential streets suffering high levels of parking stress or on roads forming part of the Strategic London Road Network or the London Bus Priority Network leading to a negative impact on the Licensing Objectives relating to the prevention of crime, disorder, anti-social behaviour (ASB), nuisance and vehicle emissions:
- e) Whether there have been any representations made by Responsible Authorities, or other relevant agency or representative.

The Licensing Authority will closely scrutinise extended hours applications to ensure that the Licensing Objectives are met. In determining an application, the licensing committee might decide that the circumstances are such that a restriction on hours is the only appropriate means to achieve the Licensing Objectives. If an 'hours' restriction is imposed, the Licensing Authority will normally require that customers should be allowed a minimum of thirty minutes to consume alcohol.

**5.5** Policy 2 page 20 of the SLP states that the Licensing Authority acknowledges that it is unique in the fact that it has 3 major football clubs within its boundaries. Given the size of our borough and the raised level of risk of crime and disorder occurring on match days, any premises in the vicinity of our football grounds will be expected to robustly deal with this issue in their operating schedule.

Where a relevant representation is made by the Police, another Responsible Authority, or 'other person' in respect of an application made by a licence holder, the Licensing Authority may apply enhanced "match day" conditions to ensure the Licensing Objectives are promoted. This may include, but is not limited to, the following conditions:

- a) Restriction of hours in the run up to and after 'Kick Off'
- b) Restriction of sales of alcohol in glass bottles or the use of glassfor any drinks on match days
- c ) Conditions for premises to robustly control the spillage of customers onto the highway through overcrowding
- d) Conditions to prevent customers from drinking or taking alcohol out onto the street outside the premises on match days
- e) The ability for the Police or Licensing Authority to require the premises to close on grounds of Public Safety if required to do so
- f) Having door supervisors on duty
- g) Having a Designated Premises Supervisor (DPS) / Personal Licence Holder on the premises
- h) Using display cabinets with shutters for alcohol
- i) Conditions to support the prevention of violence against women and girls and other vulnerable people on match days

Similar conditions may also be applied on 'victory day' or similar large crowd parades.

It has also been the experience of the Licensing Authority that at times it may be required to completely close 'off' and 'on' licensed premises depending on the information received by the Football Intelligence Unit. In order to ensure this can be effectively controlled the Licensing Authority and the Football Intelligence Unit will liaise with relevant premises operators at the earliest opportunity in order to discuss closure. Informal cooperation will always be preferred. However, review proceedings will necessarily follow when a Magistrates' Court has made a closure order under section 80 of the Anti-Social Behaviour, Crime and Policing Act 2014, or the Crown Court has made a closure order on appeal under section 84 of that Act.

**5.6** Policy 4 pages 22 and 23 of the SLP states that in determining an application where there has been a relevant representation the Licensing Authority will, where appropriate, take into account the cumulative effect of the number, type and density of licensed

premises already existing in the area. Consideration will be given to the proximity to any drug and alcohol treatment site, A&E department or homeless hostel in a local area type remit ie applicants need to make the case for how they would not increase further problems for residents/clients nearby.

In coming to any decision regarding cumulative impact the Licensing Authority will consider other mechanisms outside of the licensing regime which may also be available to address this issue, these include but are not limited to:

- Police and other enforcement of the normal law concerning disorder and anti-social behaviour
- Prosecution or other enforcement of any personal licence holder or member of staff at such premises who is selling alcohol to people who are drunk
- Prosecution or other enforcement of any personal licence holder or member of staff at such premises who is selling to underage persons or selling illegal alcohol or tobacco
- Police powers to close down instantly any licensed premises or temporary events on grounds of disorder, the likelihood of disorder or excessive noise emanating from the premises, for up to 24 hours.

The power of the police, other responsible authorities, a local resident, business or Councillor to seek a review of the licence or certificate in question.

- Police and Local Authority power to issue a Closure Notice for up to 48 hours where serious antisocial behaviour is taking place at licensed premises under the Anti-social Behaviour, Crime and Policing Act 2014.
- To ensure that residents are protected from the negative impact of late-night local licensing activities the Licensing Authority may decide to adopt an Area Specific Cumulative Impact Policy in relation to a specific area; where the number, type and density of premises providing licensable activities is having a serious negative impact on the local community and local amenities.
- **5.7** Policy 5 pages 24 to 26 of the SLP states where appropriate, the Licensing Authority will consider to what extent applications are aligned and show support for other council policies and strategies that support the four licensing objectives and key themes and principles in this Statement of Licensing Policy.

The council recognises that as part of implementing cultural strategies, account needs to be taken of the need to encourage and promote a broad range of entertainment, particularly live music, dancing, street arts and theatre for the wider cultural benefit of the community.

The Licensing Authority will monitor the impact of licensing on the provision of regulated entertainment, and particularly live music and dancing. Only appropriate, proportionate and reasonable licensing conditions will be imposed on such events.

Arrangements will be made for the licensing committee and other key stakeholders to receive, when appropriate, reports on the status and identified needs for a safe and accessible nighttime economy.

**5.8** Policy 8 pages 26 and 27 of the SLP states that applicants planning large outdoor events need to particularly consider measures to ensure the prevention of public nuisance

and promotion of public safety as part of planning. Applicants are also strongly encouraged to engage with the appropriate Council services.

Public safety and the prevention of public nuisance at large outdoor events is of paramount importance to the Licensing Authority. Applications for large events that are normally temporary in nature may not be suitable for licensing under the TENs process. Events will be licensed under a time limited Premises Licence lasting for the duration of the event. Applicants are encouraged to make applications for a new Premises Licence and should therefore ensure that they apply in good time. Applicants are recommended to speak to the relevant Responsible Authorities, and in particular, the Police at the first step of planning large events. This could be as much as 18 months or two years prior to the event taking place, dependent on the type and size of event proposed.

Applicants for such events must also consider the following Event Safety information published by the Health and Safety Executive, on all aspects of arranging and staging events: Event Safety

Applications for large temporary events may be scrutinised by a Safety Advisory Group (SAG) as well as the licensing committee. The SAG will consist of officers from Responsible Authorities such as the Police, Licensing Officers, Environmental Health, Fire Authority, and may include officers from other relevant departments and agencies such as the London Ambulance Service, Transport for London (TFL) and Highways.

The Safety Advisory Group allows officers to question applicants about the operation of their event to ensure it will be a "safe" event and will minimise disruption to traffic management and nuisance.

The SAG will not determine licence applications. It may recommend conditions. The Licensing Authority will expect applicants and organisers of large temporary events to produce a satisfactory Event Management Plan for their event and to comply with any recommendations made by the SAG.

The Licensing Authority recommends that for significant events and the use of promoters as defined in the glossary, a comprehensive risk assessment is undertaken by premises licence holders to ensure that crime and disorder and public safety matters are identified and addressed.

Accordingly, for premises that wish to stage promotions or events the Licensing Authority recommends that applicants address the Risk Assessment and debrief processes in their operating schedule.

Generally, applicants are advised to offer only the following conditions in their Operating Schedule.

 The Licensee shall comply with the Event Management Plan submitted to and approved by the Licensing Authority.  The Event shall be run in accordance with the site plan submitted to, and approved by, the Licensing Authority. No changes shall be made to the site plan without the prior written consent of the Licensing Authority.

This approach allows the event organiser flexibility to make changes to the layout of the event or to specific activities without the need to make a fresh application for a Premises Licence or an application to vary the Premises Licence already granted. Without this approach, any changes made could be unauthorised and possibly result in enforcement action.

The council may itself seek premises licences for appropriate public spaces within the borough; and will be subject to the same scrutiny as other applicants. This will make it easier for people to organise suitable cultural events. We will consider any request for permission to use such public spaces for cultural activities having regard to the promotion of the four licensing objectives.

**5.9** Policy 11 pages 30 and 31 of the SLP states that Licensing law is not the primary mechanism for the general control of nuisance and anti-social behaviour caused by people once they are away from the licensed premises and, therefore, beyond the direct control of the licensee. However, licensing is a key aspect of such control and licensing law is part of a holistic approach to the management of the nighttime economy.

As a matter of policy, the council expects every holder of a licence, certificate or permission, to accept and be responsible for minimising the impact of their activities and anti-social behaviour by their patrons within the vicinity of their premises by taking appropriate measures and action consistent with that responsibility.

Licensees and certificate holders should take reasonable steps to prevent the occurrence of crime and disorder and public nuisance immediately outside their premises, for example on the pavement, in a beer garden or in a smoking area, to the extent that these matters are within their control.

Population densities in this borough are high, with many residential premises located above or in close proximity to licensed premises. This means that the public nuisance and crime and disorder objectives will be of paramount concern when evaluating Operating Schedules. Licensing Committees will place high regard on the control measures put in place by the applicant to ensure that our residents are protected from the potential detrimental effects of any licensed premises.

- **5.10** Policy 12 pages 30 and 31 of the SLP states that we are committed to the Regulators Code and supporting businesses.
- i) We will work with businesses in our borough and provide the advice you need to help you comply with the law. This may be through meeting with you at your premises or at our offices, providing written advice in an email or letter or verbally over the telephone.
- ii) We will usually confirm any technical/ legal advice in writing. For applicants and agents, we also offer a pre-application advice service. Further details about this service can be found on our website.

- iii) We will attend pub watch meetings and work with local businesses, including the Hammersmith Business Improvement District (BID) and Fulham BID, to help facilitate the sharing of information and advice amongst licensees in our borough.
- iv) We are continuously working to improve our online application process for a range of licence permissions. If you want to know what services are available or you want to make an application online, please check our website for further details.
- v) We want to ensure that businesses comply with the law. Where this has not been possible through advice and education, we will carry out enforcement action in accordance with our enforcement policy and as part of our commitment to the Regulators Code.
- vi) We want local businesses in our borough to thrive and survive. We recognise that the law can be complex at times and that despite trying to resolve issues through discussion in the first instance, enforcement will be necessary on some occasions. We also recognise that attitudes, circumstances and personnel often change over time.

Where enforcement action has been taken against a business in the past, relevant Responsible Authorities will be mindful of this when considering any new applications. However, all new applications e.g. variations to hours or licensable activities will be decided on their merits and the information provided to demonstrate promotion of the four licensing objectives. Where a premises licence or club premises certificate has previously been reviewed or the business has been prosecuted for licensing offences, licensees are advised to discuss any new/proposed changes with the Licensing Authority and/or the relevant Responsible Authority e.g. The Police, to resolve any ongoing concerns and/or issues.

**5.11** Policy 15 page 33 of the SLP states that the Licensing Authority expects licence applications to outline measures in their operating schedules to prevent, identify and address drink spiking. Any establishment where drink spiking is reported will be supported to address future cases, and where there are several cases occurring a review may be initiated.

Licensees and licence applicants are encouraged to establish a clear approach to preventing, identifying and addressing drink spiking in their operating schedules. This should include, but is not limited to:

- Training for door and bar staff to identify where drink spiking may be taking place, how to respond to any reported or observed instances of drink spiking, and how to report to Police.
- Offering drink spiking preventative measures, such as drink covers, serving drinks direct to customers (not leaving these unattended before being provided to customers), and keeping an eye on or clearing drinks left unattended.
- Providing customers with information on keeping safe from drink spiking.
- Operating schemes such as 'Ask for Angela' to encourage customers to seek help if they suspect drink spiking has occurred.
- Requiring the production of a drink spiking risk assessment and procedure for dealing with any such incidents.
- Displaying posters in visible locations at the premises to explain what to do in the event of a spiking incident / what a spiked drink looks like.

- **5.9** Annex 1 pages 35 and 36 of the SLP in relation to the prevention of crime and disorder states licence applicants will be expected to demonstrate the following in their operating schedules:
- a) Measures to control excessive consumption and intoxication.
- b) Consideration of any additional measures or restrictions that may be placed on alcohol sales to prevent binge drinking and promote 'sensible drinking'.
- f) Robust measures in place to avoid the presence of weapons on their premises and should agree a protocol with the Licensing Authority and the police on the handling of weapons found on their premises.
- g) Conditions will, so far as possible, reflect local crime prevention strategies, and the Licensing Authority will also have regard to the views of the local Crime and Disorder Reduction Partnership.

The Police and the Licensing Authority will need to work closely together in order to ensure that this important objective of the Act is fulfilled by any applicants/operators. As a result, the Licensing Authority and the Police have signed a Memorandum of Understanding. This document provides an outline of how the Licensing Authority will liaise, communicate and work to ensure full and proper consultation and effective joint working with this key responsible authority.

It is recommended that applicants discuss the crime prevention procedures in their premises with the Licensing Authority and the Police before making a formal application. Licences for any form of regulated entertainment will be subject to conditions to prohibit entertainment (including film exhibitions) which are likely to lead to disorder or stir up hatred or incite violence towards any section of the public on the grounds of colour, race, ethnic or national origin, disability, religious beliefs, sexual orientation or gender.

To assist potential licence applicants the Council now offers a pre-application advice service. Details of this service can be found on the licensing pages of the LBHF website.

h) The following provides a non-exhaustive list of risks associated with the crime and disorder objective that applicants may want to consider when preparing their Operating Schedule:

Crime and disorder in the vicinity of the premises: this may include the crime and disorder risks arising from persons queuing to enter the premises; persons exiting the premises and customers smoking eating or drinking in outdoor areas and on the highway outside the premises. This can also include crime arising from pickpockets and bag snatchers, particularly in open spaces or crowded areas where alcohol is being consumed.

- alternative to glass bottles and glasses restricting the use of glass bottles and beer glasses to customers in preference for containers made from polycarbonate materials.
- **j) CCTV** using CCTV inside and/or outside the premises together with appropriate procedures and having staff properly trained to use CCTV equipment.
- **k) dispersal procedures** establishing appropriate dispersal procedures to minimise the potential for crime and disorder when customers are leaving the premises.
- I) dealing with and reporting crime and disorder training for staff and door security aimed at reducing crime and disorder in the premises and its vicinity and dealing with and reporting incidents if they occur.
- **m)** door staff considering whether the premises employs a sufficient number of SIA registered door staff, whether Door Premises Supervisors check the legitimacy of the badges and whether SIA staff display their badges prominently. (Note: All door supervisors must be Security Industry Authority (SIA) registered).

- **o) drugs and weapons** ensuring compliance with relevant guidance regarding illegal drugs and weapons. Attention should be paid to search procedures, procedures for the safe storage and surrender of seized drugs and weapons and drug awareness issues, designing out the ability to take drugs in the premises, etc.
- **p) excessive drinking** training for staff to recognise when customers are becoming drunk and adopting appropriate 'cut off' procedures for drunken customers, so as to reduce the likelihood of fights or aggressive behaviour.
- q) **prevention of theft** using bag hooks and signage to warn customers of pickpockets and bag snatchers.
- r) Event type in some cases the type of regulated entertainment proposed could attract elements which increase the possibility of violence and/or disorder occurring in, or in the vicinity of, the premises. For example, some externally promoted live music events carry an increased risk of violent crime and disorder. It may be appropriate to carry out a risk assessment of the activities proposed, however this would be in a guidance capacity to help support the business in question. Any such assessments should be emailed to: (AWMailbox.Licensing@met.police.uk) before the event is agreed. Where a large outdoor event is planned this Authority and the Police recommend that the organisers consult with 'relevant parties' as early in the planning stages as possible. 'Relevant parties' would include local residents, local businesses, schools, charitable organisations, responsible authorities and relevant local authority departments. Consideration of timing of events should be given in relation to football matches and other large pre-planned annual events within the locality and surrounding boroughs.
- **5.10** Annex 1 page 37 and 38 of the SLP states the Licensing Authority will require the applicant to demonstrate the steps proposed to ensure the physical safety of people using the relevant premises or place. This does not cover the separate need for applicants to provide relevant public safety requirements dealt with by Environmental Health. This is expected to include:
- a) Maximum occupancy limits will be specified on the licence only where necessary for the promotion of public safety or the prevention of disorder. Where a capacity limit is already specified in a fire risk assessment, the Licensing Authority will not normally include that limit as a licence condition.
- b) Safe capacities will be imposed where necessary for the promotion of public safety or the prevention of disorder on the relevant premises. If no safe capacity has been imposed through other legislation, a responsible authority may consider it necessary for a new capacity to be attached to the premises which would apply at any material time when the licensable activities are taking place and may make representations to that effect. The types of premises that may be subject to safe capacities will be the following;
- i. Nightclubs
- ii. Cinemas
- iii. Theatres
- iv. Other premises where regulated entertainment is being provided within the meaning of the Act, e.g. open public spaces
- c) The Licensing Authority will, where appropriate, attach conditions to a licence to ensure public safety, dealing with, but not limited to. the following:
- i. Checks on equipment at specified intervals, e.g. gas safety checks;

- ii. Standards to be maintained, e.g. temporary electrical installations to comply with British Standards:
- iii. The number of people on the premises to ensure it is appropriate having regard to the activities taking place and reliable ways of counting the number;
- iv. The steps taken to manage the risk from glass, the use of bottle bins, glass collectors and door supervisors to prevent glass being taken off the premises;
- v. The use of door supervisors to manage the entrance and exit from the premises and to protect public safety as customers leave the premises;
- vi. The provision of air conditioning and ventilation;
- vii. Measures to protect against overcrowding; and
- viii. Implement access/support needs for disabled people

The following provides a non-exhaustive list of risks associated with the public safety objective that applicants may want to consider when preparing their Operating Schedule:

- d) special effects whether music and dance venues and performance venues will use equipment or special effects, e.g. moving equipment, vehicles, pyrotechnics, strobe lights, smoke machines, etc.
- e) incident and occurrence book keeping an incident book on the premises so staff can record any instances of crime, disorder, refused sales, ejections and intimidating behaviour.
- f) risks associated with special promotions/events ensuring compliance with guidance from the Metropolitan Police relating to specific event risk assessments for externally promoted live music events well in advance of the event. Risk assessment forms can be obtained from the Metropolitan Police Licensing Officer.
- g) getting home safely providing information to customers and staff (including contact telephone numbers) regarding safer options available for travelling home late at night including night buses, licensed taxis and private hire (mini-cabs).
- h) overcrowding developing policies and procedures regarding capacity to prevent overcrowding and patrons possibly becoming aggressive.
- i) premises environment applicants should consider the physical environment of the premises and have regard to issues that could increase the likelihood of patrons becoming agitated or aggressive. This may include procedures regarding door supervision, identification and management of drunken customers and issues of overcrowding and capacity, which may result in patrons becoming aggressive or rowdy.
- **5.11** Annex 1 pages 38 to 40 of the SLP in relation to the prevention of public nuisance states that the Licensing Authority will require the applicant to demonstrate within the operating plan how they intend to prevent nuisance arising, prevent disturbance and protect amenity so far as is appropriate to ensure that the Licensing Objectives are met.

This is expected to include:

a) In considering an application, the Licensing Authority will consider the adequacy of proposed measures to remove or effectively manage the potential for public nuisance and anti-social behaviour and any Public Spaces Protection Orders (PSPOs) in place.

- b) Licensing Authority will particularly consider the following matters where they are material to the individual application:
- ii. The proximity of residential accommodation;
- iii. The type of use proposed, including the likely numbers of customers, proposed hours of operation and the frequency of activity;
- iv. The steps taken or proposed to be taken by the applicant to prevent noise and vibration escaping from the premises, including music, noise from ventilation equipment, and human voices. Such measures may include the installation of soundproofing, air conditioning, acoustic lobbies and sound limitation devices;
- v. The steps taken or proposed to be taken by the applicant to prevent disturbance by customers arriving at or leaving the premises.
- viii. The steps taken or proposed to be taken by the applicant to prevent queuing (either by pedestrian or vehicular traffic). If some queuing is inevitable then queues should be diverted away from neighbouring premises or be otherwise managed to prevent disturbance or obstruction;
- ix. The steps taken or proposed to be taken by the applicant to ensure staff leave the premises quietly;
- x. The arrangements made or proposed for parking by patrons, and the effect of parking by patrons on local residents;
- xi. The provision for public transport in the locality (including taxis and private hire vehicles) for patrons;
- xii. The level of likely disturbance from associated vehicular and pedestrian movement to and from the premises;
- xiii. The delivery and collection areas and delivery/collection times;
- xv. The arrangements for refuse disposal, storage and the prevention/tidying of litter (including fly posters and illegal placards);
- xvi. The history of previous nuisance complaints proved against the premises, particularly where statutory notices have been served on the present licence holder;
- xvii. The history of the applicant in controlling anti-social behaviour and preventing nuisance:
- xviii. The generation of odour, e.g. from the preparation of food;
- xix. Any other relevant activity likely to give rise to nuisance;

The following provides a non-exhaustive list of risks associated with the public nuisance objective that applicants may want to consider when preparing their Operating Schedule:

- I) Light pollution this is an increasingly common source of complaint, particularly from illuminated signs and external security lighting. Where provided, illuminated signs should not cause glare to neighbouring properties, ideally being turned off at night, and external lighting should be angled and/or diffused to also prevent nuisance.
- m) Noise and/or vibration breakout from the provision of regulated entertainment, particularly from (but not limited to) live music consider what type of entertainment is to be provided, in what room/area of the premises and the suitability of the construction of this room/area to contain sound. Windows are a particular weak-point for noise break-out so consider providing regulated entertainment in a room without windows or with as few windows as possible, particularly windows that face towards nearby residential properties. Where suitable, install a lobby to prevent spillage of noise each time an entrance/exit door is opened.

- n) External Areas External areas such as gardens can be the source of noise disturbance to surrounding premises. Consider limiting the use of the garden to a reasonable time and number of people.
- o) Odour odour from cooking is a common source of complaint, particularly from restaurants and fast-food takeaways. The Council's Noise and Nuisance Service may therefore require evidence that the kitchen ventilation and/or extract systems are regularly maintained and serviced to ensure that it is operating efficiently and with minimal nuisance to neighbours arising from odour and also noise. This includes the siting of BBQs.
- p) Queue management establishing appropriate procedures to avoid the need for customers to queue before entering the premises or, where queuing cannot be avoided, to manage queues so as to minimise the potential for crime and disorder or public nuisance by customers who are queuing.
- r) Waste consider how and where waste will be stored/disposed of at the end of trading hours, particularly if trading until late at night. This is important because the disposal of glass and/or cans to outside bin areas can be very noisy and give rise to complaints, so it may be necessary to store such items and other non-degradable refuse inside the premises until the next trading day. Consideration should also be given to the time of deliveries to minimize disruption to local residents.
- s) Litter for example, litter patrols for late night take-away premises
- **5.12** Annex 1 pages 40 and 41 of the SLP in relation to the protection of children from harm states the Licensing Authority will require operating plans to specify the measures and management controls in place to protect children from harm. Where appropriate a written childcare policy should be available and be incorporated in the induction of staff. This is expected to include:
- c) The sale of alcohol to a minor is a criminal offence and Trading Standards officers will conduct appropriate covert test purchasing exercises and will take account of any complaints and intelligence. The Act permits the use of children under the age of 18 to undertake test purchases when they have been directed to do so by a duly authorised officer.
- d) Where a sale of alcohol has been made on the same premises to a minor on two or more different occasions within a period of three months the premises licence could be suspended for a defined period.
- g) The Licensing Authority will expect operating plans to specify the measures and management controls in place to prevent alcohol being served to children, other than in those limited circumstances permitted by the Act. The Council's Trading Standards officers have a role to play in the protection of children from harm, and proof of age schemes, and are able to provide advice in relation to measures that can be taken to help prevent the sale of alcohol to underage children. Potential licence holders should also be aware of the Proof of Age London (PAL) Scheme hosted by Southwark Council.
- i) Where premises are subject to age-restrictions, the procedures in place to conduct age verification checks. The Council will expect premises only to accept current passports, driving licences or documents bearing the national PASS logo, such as Citizencard. The Proof of Age Standards Scheme (PASS) is the UK's national guarantee scheme for proof-of-age cards as endorsed by the Home Office. More information can be found on The Proof of Age Standards Scheme (PASS) website.

#### 6. DETERMINATION

- **6.1** In determining this application, the Committee must have regard to the representations and take such of the following steps as it considers necessary for the promotion of the licensing objectives. The steps are:
- (a) Grant the application in full
- (b) Grant the application in part modifying the proposed hours, activities or conditions.
- (c) Reject the application

It is the Council's duty under the Licensing Act 2003 ("The Act") to determine applications with a view to promoting the four licensing objectives; Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance and the Protection of Children from Harm.

In reaching a decision the Council shall consider the details of any relevant representations received; the applicant's Operating Schedule; the Council's adopted Statement of Licensing Policy and the guidance issued by the Secretary of State under section 182 of the Act.

If the Committee is minded to grant the application conditions may be attached to the licence to alleviate the concerns raised through the representations.

#### b) The prevention of crime and disorder

For any event planned for over 500 people, so far as is reasonably practicable the premises licence holder shall ensure that the event is run in accordance with the event management plan.

The premises licence holder or nominated representative shall ensure that at all times when the "premises" are open for any licensable activity, there are sufficient competent staff on duty at the premises for the purpose of fulfilling the terms and conditions of the licence and for preventing crime and disorder.

The designated premises supervisor or nominated representative will satisfy themselves that any members of staff dispensing alcohol are fully aware of their legal responsibility in that respect.

All incidents involving door supervisors shall be recorded in a suitable log, including all refused entries. This log will be kept on the premises and made available for inspection by the police or authorised officer at all times when the premises are open.

c) Public safety

The premises licence holder will consult with the Safety Advisory Group on all events involving more than 500 people or where the organiser feels the proposed event may have a detrimental impact on local residents and/or businesses.

The premises licence holder will comply with any additional conditions proposed by the Safety Advisory Group.

The premises licence holder shall ensure that where physical searching of patrons is to be undertaken, there is sufficient numbers of appropriately trained staff to carry out such searches regardless of whether patrons are male or female.

The premises licence holder and designated premises supervisor shall ensure there are effective management arrangements in place to enable them to know how many persons there are in the premises at all times when the premises are open for a licensable activity and must provide this information to any authorised person on request.

Appropriate levels of security and stewarding, first aid/paramedic and fire prevention equipment and personnel will be employed in accordance with the event management plan, risk assessments and the event safety guide.

All recommendations of the Hammersmith and Fulham Fire Service will be acted upon in a timeframe that is agreeable.

The event management plan and accompanying risk assessments will take into account the safety and welfare of the public at all times they are on site.

Specific arrangements will be made for the safety of disabled persons.

Suitable welfare facilities will be provided on-site and will be made available at all events.

Unobstructed exits for the public and access for emergency vehicles will be maintained whilst the premises are open.

When disabled people are present, adequate arrangements must exist to enable their safe evacuation in the event of an emergency.

No open or sealed glass containers will be permitted on the premises when licensable activities are being carried out. All drinks will be dispensed to customers

d) The prevention of public nuisance

The premises licence holder shall notify the parish/town councils for Hammersmith and Fulham at least 2 weeks in advance of an event advising of the nature of the event, operating hours and a contact telephone number operated for the duration of the event for any issues.

Signs displayed will request that departing customers respect the local area and neighbours.

The premises licence holder shall publicise a telephone number to which members of the public can call throughout each event to alert staff of any concerns. This contact number will be displayed on the companies marketing media.

The premises licence holder shall ensure that waste and refuse are removed in a timely manner to a licensed waste disposal facility.

The premises licence holder will ensure that at least 14 days prior to any event scheduled for over 200 people that comprises the playing of amplified live or recorded music, the name and contact number for the person responsible for the management and monitoring of noise levels at the event shall be forwarded to the Hammersmith and Fulham Licensing Authority.


# Residents Action Plan DISCOVER SITE

#### Residents Action Plan

- We have developed a resident action plan to help to mitigate disturbances to residents during our time operating at Eel Brook Common.
- Arrangement and Management of Deliveries: To minimise noise impact, no deliveries or trader setups occur outside the hours of 09:00 18:00 on build days.
- Access and Arrival of Vendors: Vendors arrive onsite between 09:00 and 18:00 on their pre-arranged day of trade. All vendors arrive in vehicles that are removed from the site before the market opens to the public and are parked in legal spaces.
- Parking for Customers and Staff: Most visitors use public transport, walk, or get dropped off by taxi, requiring minimal parking and keeping traffic noise to a minimum.

#### Resident Action Plan (RAP)

- We will develop a comprehensive Resident Action Plan (RAP) to supplement the Event Management Plan (EMP). This RAP provides a detailed account of how we will manage and control the Discover Street Food event during its build and operational hours of operation to ensure high levels of coordination and communication between us and the residents.
- Residents Direct Line: A dedicated telephone number for local residents to engage directly with the Management Team while the event is open. Residents can provide feedback, register complaints, or discuss any other matters related to the operation of the event. Additionally, we have set up an email address that the Management Team will respond to within 24 hours (Monday to Friday).
- Residents Ideas: Discover will provide an email address where residents can make suggestions and get feedback on their suggestions to improve the operation and or the impact the operation has on residents.
- Residents Cleaning Team: A dedicated Residents Cleaning Team (RCT) is pre-arranged to conduct a litter pick during the event operating hours and perform a more extensive litter pick at the end of each day. The RCT will also monitor the cleanliness of the site, identifying any isolated areas of antisocial behaviour, crime, noise, or disturbance. Any incidents will be communicated to and registered with the Management Team, who will implement further mitigatory measures as necessary.

Good Afternoon Harrison,

It was good to meet you virtually last week and discuss the business model for Eel Brook Common and how you propose to operate the event. It was a great relief to establish that you only intend to hold the event one weekend a year. We also discussed that although you have an EMP in place, the Police feel that further conditions need to be added to the premises licence application. I have detailed the recommended conditions below:-

- 1. Unless otherwise agreed, no later than 14 days prior to the event, the Premises Licence holder must ensure an Event Management Plan is presented to Hammersmith & Fulham Police Licensing Team, Noise and Nuisance Team, Hammersmith & Fulham Council, the London Fire Brigade and Emergency Planning Authority for their comments. The Event Management Plan shall include, as a minimum:
- a. Emergency and Evacuation procedures;
- b. Crowd management and stewarding arrangements;
- c. A detailed plan showing site layout and emergency egress points;
- d. A detailed plan showing CCTV locations installed by the Premises License Holder;
- e. Risk Assessments:
- f. A schedule detailing types and locations of emergency equipment;
- g. Sanitary accommodation;
- h. The capacity of fully enclosed locations where alcohol is sold.
- i. A noise management Plan

- 2. The Premises Licence Holder shall ensure that the event is run in accordance with the Event Management Plan
- 3. The licensee shall ensure that:
- (a) All licensed SIA door supervisors and security staff on duty at the event shall be equipped with Body Worn Video (BWV), capable of recording audio and video.
- (b) All recordings shall be stored for a minimum period of 31 days with date and time stamping, and
- (c) the viewing of BWV recordings shall be made available immediately upon the request of Police or authorised officer throughout the preceding 31 day period.
- (d) As a minimum, the following will be recorded where reasonably practicable:
- All searches of members of the public (if not covered by CCTV)
- All incidents of disorder
- Any incident where use of force is required or implied (removing a customer for example)
- Any incident declared as a critical incident.
- 4. A minimum of 10 SIA registered operatives shall be on duty at all times the premises is open for licensable activities. The premises licence holder shall regularly review and risk assess the requirement for additional SIA operatives to be on duty.
- 5. A minimum of 2 SIA licensed door supervisors shall be on duty at the front entrance of the premises at all times the premises are open for licensable activities.6. Where SIA registered door supervisors are used at the premises, a record shall be kept of their SIA registration number and the dates and times when they are on duty.7. All staff engaged outside the entrance to the Premises, or supervising or controlling queues, shall wear high visibility jackets or vests.
- 8. A written search policy will be in place and security staff will be briefed on the provisions of the policy to be aware of their responsibilities and actions required by that policy. The policy will include the procedure for searching prior to entry of customers into the licensed area. All bags will be searched prior to entry to the premises. Body searches will be carried out based on an ongoing dynamic risk assessment. Any customer refusing to permit to the search procedure will be refused entry into the licensed area. Any queues formed at the entrance to the site shall be supervised by security staff to prevent disorder and anti-social behaviour.
- 9. A drugs policy shall be in effect and all necessary staff shall be trained in the implementation of the policy. The policy should be made available to Police and authorised officers of the Licensing Authority on request.
- 10. Any drugs confiscated from customers shall be stored in a locked and secured container. A log shall be maintained and kept with the drugs container. It will contain details of date/time of finding, whom found by, when deposited, when collected by police, and signatures of depositor and collector. The Police shall be contacted to empty the box when necessary.
- 11. A challenge 25 proof of age scheme for the sale of alcohol shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 12. The premises licence holder shall ensure that the management team register

and successfully complete the nationally recognised counter terrorism training product referred to as ACT eLearning package or can demonstrate that the ACT eLearning product has been successfully completed within the preceding 12 months (before the start of the proposed event/open to the public) and that all staff employed by or at the premises complete the "ACT eLearning" training prior to them being employed on the premises.

- 13. There shall be a minimum of one personal licence holder on duty on the premises during operational hours. Details of the personal licence holder (including name and contact number) shall be displayed in a prominent position on site.
- 14. No alcohol shall be taken outside of the boundary of the licensable area. Signage shall be prominently displayed advising customers that drinks are not permitted outside the boundary of the Premises building.
- 15 Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and businesses and leave the area quietly.
- 16. Substantial food and non-intoxicating beverages, including drinking water, shall be available in all parts of the premises where alcohol is sold or supplied for consumption on the premises.
- 17. A refusals record shall be kept at the premises to record details of all refusals to sell alcohol. This record shall contain the date and time of the incident, a description of the customer, the name of the member of staff who refused the sale, and the reason the sale was refused. The record shall be made to police and authorised officer of the Licensing Authority on request.
- 18. All drinks will be sold and supplied in a none glass vessel.
- 19. An incident log shall be maintained by the Licence Holder/DPS/Manager that details incidents that occur in or in the immediate vicinity of the premises. This shall include any incidents of disorder, seizures of drugs or offensive weapons, any faults with the CCTV system and ejections from the premises as a minimum.
- 20. The incident record shall be kept on the premises and be available for inspection by the police or an authorised officer of the Licensing Authority at all times the premises is open.
- 21. The Premises shall operate a dispersal policy and all staff shall be trained in its implementation.
- 22. Signs shall be prominently displayed at the exits from the premises asking patrons to dispose of their waste in litter bins.
- 23. High-Definition CCTV shall be installed, operated and maintained, at all times that the premises are open for licensable activities or customers are on the premises and:
- o shall be checked daily to ensure that the system is working properly and that the date and time are correct. A record of these checks, showing the date and name of the person checking, shall be kept and made available to Police or authorised Council officers on request.
- o at least one camera will show a close-up of the entrance/entrances to the premises, to capture a clear, full length image of anyone entering.
- o shall cover any internal area of the premises where licensable activities take place.

o recordings shall be in real time and stored for a minimum period of 31 days with date and time stamping.

o footage shall be provided to Police or authorised council officer within 24 hours of a request.

o a staff member from the premises that is conversant with the operation of the CCTV system shall be on the premises at all times. This staff member will be able to show police or authorised officers of the Licensing Authority recent data footage with the minimum of delay when requested. This data or footage reproduction shall be almost instantaneous.

- 24. All staff shall be trained in how to manage a crime scene and crime scene preservation. This training shall be repeated at least once a year and written records of the training kept on the premise and made available to Police and authorised officers of the Licensing Authority on request.
- 25. All staff shall be trained in how to identify drunk or drug impaired customers. This training shall be repeated at least biannually and written records of the training kept and made available to police and authorised officers of the Licensing Authority on request.
- 26. All staff working at the event shall be given compulsory training on the following issues: Welfare and Vulnerability engagement (WAVE), Ask for Angela, Drink Spiking and Safeguarding. Written records of this training, and a policy to cover each of these topics, shall be retained and made available to the Police or authorised officers of the Licensing Authority upon request.
- 27. Members of the public shall not be permitted to bring alcohol into the licensed Premises.
- 28. No football, boxing, mixed martial arts or similar events shall be screened at the Premises at any time.
- 29. The event will be held for only one Saturday and Sunday in either August or September.

Dear Licensing Team,

I am writing to register a <u>formal representation</u> in relation to the Eel Brook Common event on ground stated within the Licensing Objectives, namely 'Prevention of Public Nuisance'

Upon the review of the application details, I wish to object to the event in its entirety as the agent has not provided sufficient information to mitigate noise during the event, or have they provided sufficient noise management and control measures to prevent public nuisance should the application be granted. Live stage music is proposed and considering the location of the proposed site and its proximity to many residential properties, a significant adverse impact on the residents seems inevitable on the residents, amongst other sources of environmental nuisance, which includes plants and generators noise, including vehicle fumes and artificial lighting and noise from vendors and their patrons.

However, we will consider withdrawing this representation if the applicant accepts and complies with the following conditions:

- The Premises Licence Holder shall produce a Noise Management and Community Liaison Plan (NMP) at least 7 days prior to the commencement of the event. The final NMP shall be submitted to the Licensing Authority for agreement no later than 30 days prior to the commencement of the event. No alteration to the NMP after this date shall be made by the Premises Licence Holder except with the written consent of the Licensing Authority.
- 2. The final NMP shall contain the methodology which shall be employed to control the sound produced on the premises. The NMP must include all the arrangements for preventing public nuisance and consultation with the local community and shall include:
  - (i) An inventory and location of all sound systems to be used on the site.

- (ii) Management command and communication structure/methods for ensuring that permitted sound system output and finish times are not exceeded.
- (iii) Publication and dissemination of information to the public and arrangements for provision and staffing of a hotline number for dealing with complaints, in an area agreed with the Licensing Authority.
- (iv) Actions to be taken by the Event Organiser following complaints.
- 3. The Premises Licence Holder shall ensure compliance with all aspects of the Noise Management and Community Liaison Plan.
- 4. At least 7 days prior to an event the Premises Licence Holder shall provide to the Licensing Authority and Environmental Public Protection Team a telephone number of the Premises Licence Holder or a nominated representative who shall be contactable anytime should noise complaints arise during the event.
- 5. The music noise level shall not exceed the following levels, at monitoring locations agreed in writing with the Licensing Authority: (i) 60dB LAeq (15 minutes) up to 20:30
- 6. The Premises Licence holder shall appoint a competent noise technician to monitor and record onsite and off-site music noise levels throughout the event to ensure compliance with noise levels required under 5. All monitoring performed shall be made available to the Licensing Authority upon request. Such records shall be kept and be made available to the Environmental Public Protection Team upon request.

We consider that granting the application with such limited information on noise is likely to undermine the licensing objective and cause public nuisance. However, we are happy to review our comments subject to the applicant accepting the above conditions.



I am writing to register a <u>formal representation</u> in relation to the Eel Brook Common event on ground stated within the Licensing Objectives, namely 'Prevention of Public Nuisance'

Upon the review of the application details, I wish to object to the event in its entirety as the agent has not provided sufficient information to mitigate noise during the event, or have they provided sufficient noise management and control measures to prevent public nuisance should the application be granted. Live stage music is proposed and considering the location of the proposed site and its proximity to many residential properties, a significant adverse impact on the residents seems inevitable on the residents, amongst other sources of environmental nuisance, which includes plants and generators noise, including vehicle fumes and artificial lighting and noise from vendors and their patrons.

However, we will consider withdrawing this representation if the applicant accepts and complies with the following conditions:

- 1. The Premises Licence Holder shall produce a Noise Management and Community Liaison Plan (NMP) at least 7 days prior to the commencement of the event. The final NMP shall be submitted to the Licensing Authority for agreement no later than 30 days prior to the commencement of the event. No alteration to the NMP after this date shall be made by the Premises Licence Holder except with the written consent of the Licensing Authority.
- 2. The final NMP shall contain the methodology which shall be employed to control the sound produced on the premises. The NMP must include all the arrangements for preventing public nuisance and consultation with the local community and shall include:
  - (i) An inventory and location of all sound systems to be used on the site.
  - (ii) Management command and communication structure/methods for ensuring that permitted sound system output and finish times are not exceeded.
  - (iii) Publication and dissemination of information to the public and arrangements for provision and staffing of a hotline number for dealing with complaints, in an area agreed with the Licensing Authority.
  - (iv) Actions to be taken by the Event Organiser following complaints.
- 3. The Premises Licence Holder shall ensure compliance with all aspects of the Noise Management and Community Liaison Plan.
- 4. At least 7 days prior to an event the Premises Licence Holder shall provide to the Licensing Authority and Environmental Public Protection Team a telephone number of the Premises Licence Holder or a nominated

- representative who shall be contactable anytime should noise complaints arise during the event.
- 5. The music noise level shall not exceed the following levels, at monitoring locations agreed in writing with the Licensing Authority: (i) 60dB LAeq (15 minutes) up to 20:30
- 6. The Premises Licence holder shall appoint a competent noise technician to monitor and record onsite and off-site music noise levels throughout the event to ensure compliance with noise levels required under 5. All monitoring performed shall be made available to the Licensing Authority upon request. Such records shall be kept and be made available to the Environmental Public Protection Team upon request.

We consider that granting the application with such limited information on noise is likely to undermine the licensing objective and cause public nuisance. However, we are happy to review our comments subject to the applicant accepting the above conditions.

In short: The Applicant should consider withdrawing his application and finding another open space to hold his event; a space that is not designated, protected, ancient Common Land on which such an event will be unnecessarily invasive for the thousands of users of Eel Brook Common on weekends.

I am a daily user, and my neighbours are daily users of Eel Brook Common, situated in the legally designated Parsons Green Conservation Area.

Eel Brook Common is officially recognised Common Land (CL13). We use the Common because it is a protected Common and thus also designated Metropolitan Open Space (MOS) under the Greater London Parks and Open Space Order 1967 and the Commons Act 2006. Its space and its views are protected as stated in the current H&F Local Plan 2018 under SD55-Open Spaces.

#### Prevention of Noise Nuisance cannot be promoted Potential Crime and disorder of 4,999 attendees

Any live music/dance, recorded music channeled through monitors sitting/vibrating on platforms and stationed in the proposed temporary marquees etc, even if ancillary to the food/drink offer of 30 food trucks and many drinks stands, as suggested by the Applicant, will be an unacceptable addition to the main purpose for which I/we use Eel Brook Common and why it is protected by law, namely "for recreation as well as contemplation",

as stated clearly in SD55. Such additional sound will amount to noise nuisance. The mere voices of up to 4,999 attendees will raise the noise level far beyond the daily peace and quiet of Eel Brook Common.

Pickpocketing, stealing food/drink, phones etc; all of this is typical at such festivals--please stop it before it starts. We can hardly mention drug use, but it is rampant, as we all know, at these types of events.

On these noise-intrusive, unpeaceful noise nuisance grounds alone, I ask the Licensing Committee to reject the Application for such commercial activity on Eel Brook Common.

# Prevention of Children from Harm and Promotion of Public Safety

Dogs on leads/all over the Common, and Children anywhere on Eel Brook Common, and especially those in and around the very nearby play area of the Common will be disturbed by the new noise element of this proposed two-day event. Public safety issues will arise with parents needing to protect their children more than usual from the crowds of people. The Applicant's ability to protect children from harm (a licensing objective) is untenable. Eel Brook Common is not the place for this or any proposed two-day, risk-intrusive event.

#### **Speaking with the Applicant**

The Applicant has been kind enough to speak with me twice about his Application.
-I am still waiting for a more precise accurately measured layout/plan of the layout of the proposed fenced-in area in relation to the entire space of Eel Brook Common, as the Committee will definitely need this to assess things more accurately.

-We (Harrison Hyde, Applicant and proposed Premises Licence Holder, and I) also discussed a 'time-limited license' of one year; this would allow residents to see how it goes, were the Licensing Committee to grant a time-limited licence. The Applicant said he would add this to the licence. So far, we are still waiting for the time-limit of one year to be added to the licence. It would seem reasonable and proportionate to add a time-limit to the licence so that a proper assessment could be made during and after the proposed event. We ask the Committee to agree with the Applicant to add the time limit of one year, ending 31 July 2025.

-For the Committee to know--The Applicant placed one blue notice somewhere on the Common. It has taken some time for people to discover it. The S 182 guidance states that notices should be placed every 50 meters around the entire perimeter. I have brought this to the Licensing Authority's attention. Unfortunately, nothing was done to add more

notices around the entire perimeter, even though there are plenty of lampposts which easily accommodate such notices.

- -The Applicant seems unaware of the laws around Common Land and the protected rights of those who use it and are allowed to cross it, unimpeded.
- -The Applicant's website/promotion videos shows events that are crowd-roaring, full of much cacophony and abrasive sound, fireworks, ramping up the vibe, all very foreign to our peaceful, open, unimpeded Eel Brook Common. The Applicant should consider withdrawing his application and finding another less protected open space to hold his event; a space that is not designated, protected, ancient Common Land.

We ask the Licensing Committee, should this application not be withdrawn, to reject the Application based on the the above, on other objections submitted by other neighbours and users of Eel Brook Common, as well as on further evidence relating to the four licensing objectives that we will be providing for a possible hearing.

To whom it may concern,

I am writing to formally object to the application for a new premises license at Eel Brook Common

Park. As a long-term resident of the area, I have several significant concerns regarding the proposed

Food Festivals, which intend to operate with licensable activities including the sale of alcohol and

live entertainment on Fridays and Saturdays.

Key Points of Objection:

1. Noise Pollution: The proposed licensable activities include live music, recorded music, and

performances of dance from 12:00 to 20:30. Such events will inevitably generate excessive noise that will disrupt the peace and quiet of our neighborhood. Eel Brook Common is a family-friendly area, and the intrusion of loud music and public gatherings will negatively impact the quality of life for residents, particularly young children and the elderly.

2. Alcohol Consumption: The sale of alcohol between 12:00 to 20:00 on both days raises

serious concerns about public safety and the character of the park. Eel Brook Common is traditionally a place where families gather, children play, and community members engage in peaceful recreation. The presence of an outdoor bar could attract individuals who may not respect the family-oriented nature of the park, leading to potential antisocial behavior, littering, and public intoxication.

music acts might bring in large crowds, including individuals from outside the immediate community. This influx could lead to an increase in crime rates and antisocial behavior, thus

making the park and surrounding areas less safe for residents. Our neighborhood has worked hard to maintain a safe and welcoming environment, and such events could undermine these efforts.

- 4. Environmental Impact and Infrastructure Strain: The infrastructure required for such events, including marquees, additional toilets, and food vendor setups, could cause significant wear and tear on the park's natural environment. Eel Brook Common is a green space valued for its tranquility and natural beauty. Large-scale events could result in long-term damage to the grass, trees, and general park environment.
- 5. Disruption to Residents' Daily Lives: The proposed opening hours, combined with the setup and dismantling of event infrastructure, will result in extended periods of disruption. Traffic congestion, parking issues, and noise from both the events and their setup/cleanup will interfere with the daily lives of residents. Many residents chose this area for its serene and quiet ambiance, which would be significantly disturbed by such frequent and intrusive events.

In conclusion, while I appreciate the intention to bring cultural and social events to our community,

I strongly believe that Eel Brook Common is not a suitable location for such activities involving the

sale of alcohol and live entertainment. The potential negative impacts on noise levels, public safety,

the environment, and the overall character of our family-friendly neighborhood far outweigh the

proposed benefits.

I encourage all residents who feel the same to put their concerns in writing whilst I urge the

Licensing Department to reject this application and consider alternative locations that are better

A schedule of times for the playing of recorded music or performance of live music and for the sale of alcohol on the premises is given for Saturdays and Sundays only.

Reference is made to Food Festivals over a Friday and Saturday period which will have an outdoor bar and tents for music acts. The schedule does not refer to Fridays.

There is no Event Management Plan supplied.

All of Eel Brook Common is used by families and groups of young people at weekends. It is valued as unstructured open space on which people create their own recreation.

Any interference with the availability of such space for local families is firmly opposed and we object to it.

### More specifically

#### Prevention of crime and disorder:

The risk of crime and disorder is increased by the activities for which a licence is requested.

### **Public safety:**

There is no benefit to public safety. There is heightened risk to public safety if the activities lead to bad behaviour in the vicinity of the site.

### **Prevention of public nuisance:**

The proposals increase the risk of public nuisance as set out above, but also the presence of food on the site risks attracting vermin and disease.

#### Protection of children from harm:

During the hours for which the application is made children are likely to be playing on immediately adjoining ground. The entrance to the Council's Play Area for young children opens onto the path bounding the section of park. The provision of music and dancing and the consumption of alcohol for eight hours during the day and early evening will increase the risk to children.

Thank you for your reply and attachment from the applicant.

We did understand that it would be for one weekend this year, but still have to object to the licence covering future events in coming years. I do not object as such to the IDEA of small events on the common, but this feels as though it will be huge. And to say that it will only cover the South side of Eelbrook Common does not acknowledge that those of us living on this side of the common and New Kings Road will be wholly and completely affected by this event, and the North Side relatively unscathed. It WILL affect parking, so to suggest otherwise is totally disingenuous. Every event has the same affect on the local roads – you could say most football fans take public transport, but no one living in Fulham would agree with that – even the Eid events which are not entirely welcomed by local residents mean there is gridlock in the roads and parking on the local streets bordering Eelbrook Common.

So no, we are not minded to withdraw our objection to this licence to hold an annual event which will have a large impact on the densely residential area around Eelbrook Common. We object to the thought that if the applicant is successful in obtaining a licence that will allow this event every year removes any chance of saying NO, it was not a success in terms of the impact or whatever, and we would be stuck with this happening in years to come. inappropriate use of Common land

Hammersmith and Fulham Council's 2006 Open Space Audit highlighted that the Borough has relatively little open space per person living in the Borough and that more open spaces are required. Eel Brook Common is already exceedingly busy with dog walkers, children playing and families and friends picnicking. It is therefore inappropriate to allow such an event to occupy such a large amount of the open space.

The Council's parks and Open Spaces Strategy 2018 highlights the

deficiency in open spaces and access to nature conservation areas . Work has taken place over the last few years increasing the biodiversity on the Common itself. Inviting thousands of people on to the Common from outside the area will cause harm to the progress already made. Eel Brook Common is subject to a Section 59 Public Spaces protection order that was extended in 2023 to 2025. This restricts the Consumption of Alcohol in public spaces for a reason. How will this be managed with people within the event being allowed to consume alcohol while those sitting outside cannot . It will be impossible to manage and again a wholly inappropriate use of the land so close to so many homes. There is a discussion to be had re the following points:

• Provision of sufficient toilets; many events held in Parsons Green and Eel Brook Common have had insufficient toilets resulting in the use of the surrounding streets as toilets (by men and women)

- Stewards in adjacent streets to Eel Brook Common/Parsons Green to prevent unsociable behaviour, to ensure that streets are not used as public loos and that local residents and their homes are respected
- Build and break days how many.....the event will only be for a weekend but I would imagine that 3 or 4 days prior and 2 days after will be required – so a large part of the park will be off limits to residents for more like a week a year?

I seem to have recieved an email from you promoting this exact licence which I have objected to! Herewith below are some further more properly considered objections all of which are highly relevant. Main point of my objection being that given the heavy use of the park already this open space is not big enough for an extra 5000 people who may imbibe alcohol. My children use this park every weekend and it is not appropriate for them to be using it whilst alcohol is for sale and there may be scores of inebriated people using the space too. It is a family, child friendly space with a children's play park in the middle of it so it is not appropriate for such large event with alcohol sales.

# The event is too big and there is a risk to public safety

The physical size of the event will take up to a third of the available open space on the common and there will be an additional 4,999 people on it all of it taking place next to a busy main road. The common is very heavily used at the weekend, especially by young families. There is a risk of significant overcrowding, spilling onto the road and distress for local users of the common.

In addition, we note that the organisers have been associated with seeking to extend the size of events they have been associated with in other areas (see below).

## There is a risk of public nuisance and crime and disorder

This is a food and drink festival with a strong presence of alcohol vendors. The prospect of 5,000 people on the streets is likely to cause anti-social behaviour and crime and disorder. The applicants have been associated with events in Palmer Park in Reading where unacceptable social behaviour and local disturbance (drunkenness and drug taking) was reported by the BBC in Jan 2024. Despite this they sought to extend this event from a 5,000 to 10,000 capacity.

The risk and repetition of this in a small public space in a family area is unacceptable.

# Protection of children from harm

The site will be next to the children's playground on Eel Brook Common. This is very heavily used and other parts of the common are used for children's parties. An additional 5,000 people on the common, of whom many will have been drinking is unacceptable in this context.

I strongly object to the application to use Eel Brook Common for one or more regular events with up to 4,999 attendees, including the sale of food and alcohol over entire weekends. My family and I live locally and use Eel Brook Common regularly.

The Prevention of Crime and Disorder

If 4,999 people attend these events, many will likely be under the influence of alcohol sold onsite. This can lead to rowdy behaviour, noise, and increased litter, attracting pests like mice and pigeons, which are already a nuisance to residents. We experience similar issues during football events at Stamford Bridge and do not want additional disturbances. Moreover, eventgoers often use bikes and leave them carelessly on pavements. For instance, my neighbour's car was damaged by a fallen bike, and neither the bike company nor the police took responsibility. Public Safety

Most residents will avoid the common if large events are taking place on it because large drunken crowds tend to misbehave. The elderly residents who use the common to relax will be unable to enjoy it amidst large, noisy crowds. The council should ensure the local green spaces are safe and secure for the residents to enjoy.

The Prevention of Public Nuisance

As previously mentioned, abandoned bikes can cause damage and block pavements. My neighbour's car was damaged by a fallen bike, and there was no accountability. With limited police resources, it is unlikely there will be adequate policing at these events. My dog and I enjoy the open space and peaceful nature of Eel Brook Common, especially on weekends. Large, noisy events will significantly detract from our ability to enjoy this space.

The Protection of Children from Harm

It is not safe for young children to be in proximity to intoxicated eventgoers. Therefore, families will be deterred from using the common if such large events take place, impacting children's ability to enjoy the green space.

I am writing with regard to the application for a proposed licence to hold free- ticketed events for up to 4,999 attendees in Eel Brook Common during a weekend in August or September on both Saturday and Sunday from 1200 to 20.30.

I am a local resident who lives nearby and regularly walks the family dog on Eel Brook Common.

I am most concerned that this proposal is an unsuitable and oversized proposal for the use of the Common.

The locals, residents, children and dog owners who use the Common cherish its peace and quiet and green space. It is set in the middle of a residential area and surrounded by family houses and residential flats.

An influx of 4,999 attendees, plus the playing of amplified music and sale of alcohol and food from stalls from 1200- 20.30 on Saturday and 1200-20.00 on Sunday will take over the whole of the Common for the entire weekend. It will exclude the locals, residents, children, dog walkers etc from accessing Eel Brook Common in their usual way.

The proposal is far too large, noisy, instrusive and disruptive in comparison to the relatively small size of the Common and the proposer should seek an alternative location in a larger space elsewhere (there are plenty of other purpose built venues).

I am also concerned about spill-over of attendees to and from Eel Brook Common. The Green is a very small area of green space which is already heavily used and again surrounded by residential streets, so

the whole neighbourhood will become affected by noise, people and rubbish. Toilet facilities temporarily installed onto Eel Brook Common (or Parsons Green) for past events have been insufficient for the demand and there are no public toilet facilities in the vicinity. Previous experience when thousands of people have converged on the area, people have been found urinating and defecating in the front gardens and side alleys of the family houses around the Common and Green, which is awful for residents and a risk to public health.

In addition the Eel Brook Common proposal is open-ended and not time-limited and could continue for years. There is no opportunity for review.

I strongly object to the proposal.

It has recently been brought to my attention that AI Hospitality have applied for a a licence to hold a Food and Drink Festival on Eel Brook Common for up to 10,000 people. We live in Kempson Road that runs into the east side of the park.

This is a residential area where by definition people reside. It is not a commercial area where by definition commerce is carried on. The proposed festival is pure commerce for the benefit of the organisers (and the LBHF) and thus to hold it in a residential park is nothing less than the theft of our residents' rights.

There have been gatherings on the Common before, but those have been for a specific purpose - mostly charitable or religious orientation - and well ordered. This proposed festival of Food and Drink spells disaster with the attendant litter and undoubted drunkeness. We residents pay the top tier of rates to reside in our houses and to enjoy the amenities of the area - particularly Eel Brook Common. It is totally immoral for the LBHF to capitalise on our asset and to cause real harm to our lives with the dangers and disruption of the influx of 10,000 people into a very small space.



Thank you for your email clarifying the licensing proposal for Eel Brook Common. The signs that appeared around the park were very vague and made mention only of 'Saturdays and Sundays' which led me, and all the neighbours I have spoken to, to believe that this was to be a permanent arrangement which I would be completely opposed to. Now it is clear that it is only for one weekend per year, I feel rather differently.

A few months ago there was a similar proposal for a one off event on Eel Brook Common on the August Bank Holiday this year. I actually wrote in to support this one-off event. (I believe this application was subsequently withdrawn). I think that occasional, well run events in the park can be a good thing, just as long as there aren't too many of them.

If this new application is just for one weekend per year, then I would like to withdraw my objections. I wouldn't have objected in the first place had it been clear what was being asked.

My only outstanding comments are:

- 1) Its says that it will only occupy the New King's Road side of the park but the capacity is 4,999 people. The capacity sounds excessive given the scale of that part of the common.
- 2) A licensed food/drink/music festival for almost 5,000 people is new territory for Eel Brook Common. If a license is granted, I think it should be reviewed after year 1 following further consultation with residents.
- 3) I trust there would be a commitment from LBHF to ensure that it is properly policed and controlled. The 'enforcement officers' at the recent EID celebrations were utterly useless.



Thank you for your reply and attachment from the applicant.

We did understand that it would be for one weekend this year, but still have to object to the licence covering future events in coming years. I do not object as such to the IDEA of small events on the common, but this feels as though it will be huge. And to say that it will only cover the South side of Eelbrook Common does not acknowledge that those of us living on this side of the common and New Kings Road will be wholly and completely affected by this event, and the North Side relatively unscathed. It WILL affect parking, so to suggest otherwise is totally disingenuous. Every event has the same affect on the local roads – you could say most football fans take public transport, but no one living in Fulham would agree with that – even the Eid events which are not entirely welcomed by local residents mean there is gridlock in the roads and parking on the local streets bordering Eelbrook Common.

So no, we are not minded to withdraw our objection to this licence to hold an annual event which will have a large impact on the densely residential area around Eelbrook Common. We object to the thought that if the applicant is successful in obtaining a licence that will allow this event every year removes any chance of saying NO, it was not a success in terms of the impact or whatever, and we would be stuck with this happening in years to come. I am unable to withdraw my objections as the proposed event is too big for such a small space creating a risk to public safety, nuisance most likely elevating crime and disorder.

The physical size of the event will take up to a third of the available open space on the common and there will be an additional 4,999 people on it all of it taking place next to a busy main road. The common is very heavily used at the weekend, especially by young families. There is a risk of significant overcrowding, spilling onto the road and distress for local common users.

In addition, we note that the organisers have been associated with seeking to extend the size of events they have been associated with in other areas.

This is a food and drink festival with a strong presence of alcohol vendors. The prospect of 5,000 people on the streets is likely to cause anti-social behaviour and crime and disorder. The applicants have been associated with events in Palmer Park in Reading where unacceptable social behaviour and local disturbance (drunkenness and drug taking) was reported by the BBC in Jan 2024. Despite this, they sought to extend this event from a 5,000 to 10,000 capacity. The risk and repetition of this in a small public space in a family area is unacceptable.

I am additionally concerned about protecting children from harm.

The site will abut the children's playground on Eel Brook Common. This is heavily used and other parts of the common are used for children's parties. An additional 5,000 people on the common, of whom many will have been drinking is unacceptable in this context.
