#### SUMMARY OF DECISION

1. The opening hours of the premises are as follows:

<u>Live Music - Indoors Only</u> Sundays to Tuesdays 10:00 to 00:00 Wednesdays to Saturdays 10:00 to 01:00

Recorded Music - Indoors Only Sundays to Tuesdays 10:00 to 00:00 Wednesdays to Saturdays 10:00 to 01:00

Late Night Refreshment - Both Indoors and Outdoors
Sundays to Tuesdays 23:00 to 00:00
Wednesdays to Saturdays 23:00 to 01:00

The Sale of Alcohol - On the Premises
Sundays to Tuesdays 10:00 to 00:00
Wednesdays to Saturdays 10:00 to 01:00

The Sale of Alcohol -Off the Premises Mondays to Sundays 10:00 to 23:00

2. The hours the Premises is open to the public are:

Mondays to Sundays 00:00 to 00:00

- 3. The licence is subject to any mandatory conditions.
- 4. The licence is subject to the conditions proposed by the Applicant and the Police as agreed by the Applicant.

This licence becomes operational with immediate effect. If problems are experienced, then an application for a review of the premises licence can be made.

A copy of this Committee's full decision including its reasons, and the full text of the conditions added to the licence will be sent to the parties forthwith.

If the Applicant or any person who has made a relevant representation is unhappy with the decision, they are entitled to appeal to the magistrates' court within 21 days from the date of notification of the full decision.

#### SUMMARY OF DECISION

The Committee has considered an application for a variation of the existing premises licence for removing the sale of alcohol off the premises only, and adding to the licence the provision of late night refreshment both indoors and outdoors Sundays to Thursdays 23:00 to 00:00 and Fridays and Saturdays 23:00 to 01:00 under the Licensing Act 2003 ("the Application").

In summary, the Committee has decided, after taking into account all of the individual circumstances of this case and the promotion of the four licensing objectives to:

- 1. Remove from the existing licence the provision for the sale of alcohol off the premises only.
- 2. Remove from the existing licence conditions 4-6 that deal with the sale of alcohol.
- 3. Grant the Provision of Late-Night Refreshment Both Indoors and Outdoors

Monday to Sunday 23:00 to 00:00

4. The hours the Premises is opened to the public would be:

Monday to Sunday 11:00 - 00:00

5. Impose conditions to the licence dealing with training of staff, litter, CCTV, delivery drivers to wait inside the Premises after 23:00, incident log, conditions dealing with odour and ventilations, incident log.
