#### 2. DECLARATIONS OF INTEREST

If a Councillor has a disclosable pecuniary interest in a particular item, whether or not it is entered in the Authority's register of interests, or any other significant interest which they consider should be declared in the public interest, they should declare the existence and, unless it is a sensitive interest as defined in the Member Code of Conduct, the nature of the interest at the commencement of the consideration of that item or as soon as it becomes apparent.

#### 1. THE APPLICATION

On 20<sup>th</sup> September 2024, the Licensing Authority received a valid application for a variation to the premises licence in respect of the premises known as Sainsbury's, 48 - 50 Shepherd's Bush Road, London, W6 7PH submitted by Winckworth Sherwood LLP on behalf of Sainsbury's Supermarkets Ltd ('the applicant').

#### 1.1 Current Hours of Operation

The premises currently benefit from a premises licence which permits the following:

#### Sale of Alcohol - Off the Premises

Monday to Sunday 11:00 - 23:00

#### Opening Hours of the Premises

No restrictions

A copy of the current premises licence and plan can be seen on pages 13-21 this report.

#### 1.2 Application Requested

The applicant has applied to vary the hours for the sale of alcohol off the premises as follows:

#### Sale of Alcohol - Off the Premises

Monday to Sunday 07:00 - 23:00

A copy of the application form can be seen on pages **22-33** of this report.

#### 1.3 Applicants Operating Schedule

The applicant has not proposed any additional steps to promote the four licensing objectives if the application is granted. A copy of the current conditions can be seen on pages **14-17** of this report.

#### 2. BACKGROUND

The main access to the premises is located on Shepherd's Bush Road at its junction with Poplar Grove. There are mainly residential premises within the area. A map showing the location of the premises and neighbouring licensed premises can be seen on pages **34** of this report.

There are several options for transport away from the area including buses and taxis which run from in and around the Shepherd's Bush Road area. Goldhawk Road underground station is a 7-minute walk away, Shepherds Bush tube station is a 9-minute walk away and Shepherd's Bush Market tube stations is a 10-minute walk away.

#### 3. CONSULTATION

A public notice was displayed at the premises for 28 days. The application was advertised in a local circular and all statutory consultees were notified as required by the Regulations. The Council has served written notice of hearing upon the applicant and all those parties that have made representations in respect of the application.

#### 3.1. Relevant Representations

The licensing section received one representation from Councillor Jacolyn Daly objecting to the licence application. A copy of this representation can be seen on page **35** of this report.

The licensing section received thirty-four representations objecting to the licence application from local residents. A copy of these representations can be seen on pages **36-95** of this report.

#### 4. OTHER INFORMATION

#### 4.1 Enforcement History

On 2<sup>nd</sup> March 2022 an inspection sheet was left at the premises as a warning letter as the summary licence was not displayed and condition 16 was breached. Condition 16 requires the premises to have signage requesting customers to leave quietly to be displayed at the premises.

#### 4.2 Temporary Event Notices "TENs")

No TENs have been submitted in respect of this premises in the past twelve months.

#### 5. POLICY CONSIDERATIONS

**5.1** Section 2 pages 7-8 of the Statement of Licensing Policy ("SLP") states the Licensing Authority is keen to support the licensed sector and leisure offer within the borough, with a particular focus on business resilience and growing a robust and thriving cultural and leisure sector.

To achieve this the Licensing Authority has identified three key themes of the Licensing Policy and the Licensing Authority's approach to implementing it. These are:

- A sustainable, well-run licensed sector;
- Hammersmith & Fulham as a good place to live, work and enjoy leisure; and,
- A safe licensing environment and night-time economy.
- **5.2** Section 5 pages 12 and 13 of the SLP states that to ensure the promotion of the four Licensing Objectives the Licensing Authority will require applicants to detail in their operating schedule:
  - the steps proposed to promote the licensing objective of the prevention of crime and disorder on, and in the vicinity of, the premises, having regard to their location, character, condition, the nature and extent of the proposed use and the persons likely to use the premises;

- the steps proposed to ensure the physical safety of people using the relevant premises or place;
- how they intend to prevent nuisance arising, prevent disturbance and protect amenity so far as is appropriate to ensure that the Licensing Objectives are met. Where there is a relevant representation regarding extended hours, the Licensing Authority will not permit an extension unless it is satisfied that the Licensing Objectives would be met;
- the measures and management controls in place to protect children from harm. Where appropriate a written childcare policy should be available and be incorporated in the induction of staff.
- 5.3 Section 7 page 15 of the SLP states that for sales of alcohol for consumption off the premises applicants in respect of off licences and other premises selling alcohol for consumption off the premises may need to consider whether:
  - there are shutters to prevent alcohol from being selected in non-licensed periods.
  - there are appropriate numbers of staff on duty to deal with possible 'intimidation' to sell alcohol.
  - there are restrictions required on the sale of low price, high strength alcohol and drink promotions.
  - an incident log book is available to record incidents.
  - there are measures in place necessary to prevent underage sales.
  - there are measures in place necessary to prevent alcohol from being sold outside permitted hours where the operating hours of the premises exceed those for the sale of alcohol.
  - there are procedures in place to prevent sales of alcohol to intoxicated persons (with particular attention to street drinkers) or individuals leaving premises in the vicinity such as a late night bar; where there is evidence to suggest this is a problem the Licensing Authority may require a temporary cessation of alcohol sales during high risk times.
- **5.4** Policy 1 page 18 confirms that The Secretary of State's Guidance states that applicants are expected to obtain sufficient information to enable them to demonstrate, the steps they propose to take to promote the licensing objectives; and that they understand the layout of the local area and physical environment including:
  - a) crime and disorder hotspots:
  - b) proximity to residential premises;
  - c) proximity to areas where children may congregate;
  - d) any risk posed to the local area by the applicants' proposed licensable activities; and
  - e) participation in any local initiatives (for example, local crime reduction initiatives or voluntary schemes, such as 'Ask for Angela', local taxi-marshalling schemes, street pastors and other schemes) which may help to mitigate potential risks.

Applicants are expected to include positive proposals in their application on how they will manage any potential risks.

The Guidance goes on to state that 'Applicants are expected to provide licensing authorities with sufficient information in this section to determine the extent to which

their proposed steps are appropriate to promote the licensing objectives in the local area. Applications must not be based on providing a set of standard conditions to promote the licensing objectives and applicants are expected to make it clear why the steps they are proposing are appropriate for the premises.'

The Licensing Authority notes the contents of these paragraphs from the Secretary of State's Guidance and, in particular, the use of the word 'expected'. Licence applications that do not in any way address the contents of these paragraphs in their operating schedules may be returned to the applicant as 'incomplete'.

- **5.5** Policy 3 pages 21 and 22 of the SLP states that the Licensing Authority may consider specific restrictions on hours of sale and operation in certain circumstances. Where there is a relevant representation, the Licensing Authority will consider each particular case on its merits having regard in particular to the following matters:
- a) Whether the licensed activities are likely to have an adverse impact especially on local residents and, if there is potential to have an adverse impact, what, if any, appropriate measures will be put in place to prevent it;
- b) Whether there will be a substantial increase in the cumulative adverse impact from these or similar activities, on an adjacent residential area;
- c) Whether there is a suitable level of public transport accessibility to and from the premises at the appropriate times;
- d) Whether the activity will be likely to lead to a harmful and unmanageable increase in car parking demand in surrounding residential streets suffering high levels of parking stress or on roads forming part of the Strategic London Road Network or the London Bus Priority Network leading to a negative impact on the Licensing Objectives relating to the prevention of crime, disorder, anti-social behaviour (ASB), nuisance and vehicle emissions;
- e) Whether there have been any representations made by Responsible Authorities, or other relevant agency or representative.

It will be the normal policy of the Licensing Authority to allow shops, stores and supermarkets to provide sales of alcohol for consumption off the premises at any times (in line with permitted planning hours) when the retail outlet is open for shopping unless there are good reasons based on the Licensing Objectives for restricting those hours. Should there be evidence regarding street drinking issues, child protection issues, cumulative impact, anti-social behaviour (ASB), issues in relation to public nuisance and disorder in the vicinity of this type of premises, the Licensing Authority may restrict the hours of the sale of alcohol or decide to review the licence. To act as a guide for new or existing operators we have set out the suggested closing times for licensed premises below:

Type of premises	Town centres	Mixed use areas	Residential areas

5.6 Policy 4 pages 22 and 23 of the SLP states that the Licensing Authority will have regard to cumulative impact generally during the duration of this policy. In determining an application where there has been a relevant representation the Licensing Authority will, where appropriate, take into account the cumulative effect of the number, type and density of licensed premises already existing in the area. Consideration will be given to the proximity to any drug and alcohol treatment site, A&E department or homeless hostel in a local area type remit ie applicants need to make the case for how they would not increase further problems for residents/clients nearby.

In coming to any decision regarding cumulative impact the Licensing Authority will consider other mechanisms outside of the licensing regime which may also be available to address this issue, these include but are not limited to:

- Planning controls (where development or change of use is involved, or where trading hours are limited by planning conditions)
- Police and other enforcement of the normal law concerning disorder and antisocial behaviour.
- Prosecution or other enforcement of any personal licence holder or member of staff at such premises who is selling alcohol to people who are drunk
- Prosecution or other enforcement of any personal licence holder or member of staff at such premises who is selling to underage persons or selling illegal alcohol or tobacco
- Police powers to close down instantly any licensed premises or temporary events on grounds of disorder, the likelihood of disorder or excessive noise emanating from the premises, for up to 24 hours.
- The power of the police, other responsible authorities, a local resident, business or Councillor to seek a review of the licence or certificate in question.
- Police and Local Authority power to issue a Closure Notice for up to 48 hours where serious antisocial behaviour is taking place at licensed premises under the Anti-social Behaviour, Crime and Policing Act 2014.
- To ensure that residents are protected from the negative impact of late-night local licensing activities the Licensing Authority may decide to adopt an Area Specific Cumulative Impact Policy in relation to a specific area; where the number, type and density of premises providing licensable activities is having a serious negative impact on the local community and local amenities.
- **5.7** Policy 11 page 30 of the SLP states that that the Licensing Authority expects that any licence applicant will give due consideration to the needs of Hammersmith & Fulham residents and any negative impacts from licensable activities and business operations. with reference to taking place in their premises and how these may impact in the direct locality and further afield.

Licensing law is not the primary mechanism for the general control of nuisance and anti-social behaviour caused by people once they are away from the licensed premises and, therefore, beyond the direct control of the licensee. However, licensing is a key aspect of such control and licensing law is part of a holistic approach to the management of the night-time economy.

As a matter of policy, the council expects every holder of a licence, certificate or permission, to accept and be responsible for minimising the impact of their activities

and anti-social behaviour by their patrons within the vicinity of their premises by taking appropriate measures and action consistent with that responsibility.

Licensees and certificate holders should take reasonable steps to prevent the occurrence of crime and disorder and public nuisance immediately outside their premises, for example on the pavement, in a beer garden or in a smoking area, to the extent that these matters are within their control.

Population densities in this borough are high, with many residential premises located above or in close proximity to licensed premises. This means that the public nuisance and crime and disorder objectives will be of paramount concern when evaluating Operating Schedules. Licensing Committees will place high regard on the control measures put in place by the applicant to ensure that our residents are protected from the potential detrimental effects of any licensed premises.

- **5.8** Annex 1 pages 35 and 36 of the SLP in relation to the prevention of crime and disorder states that in order to ensure the promotion of the four Licensing Objectives the Licensing Authority will require applicants to detail in their operating schedule the steps proposed to promote the licensing objective of the prevention of crime and disorder on, and in the vicinity of, the premises, having regard to their location, character, condition, the nature and extent of the proposed use and the persons likely to use the premises; Licence applicants will be expected to demonstrate the following in their operating schedules:
- a) Measures to control excessive consumption and intoxication.
- b) Consideration of any additional measures or restrictions that may be placed on alcohol sales to prevent binge drinking and promote 'sensible drinking'.
- c) Operators of off-licences in areas problems relating to street drinking and underage drinking are prevalent, measures should be outlined to strictly monitor the way alcohol is sold, specifically where the premises are located close to schools and hostels and similar premises that provide shelter or services to alcohol dependent persons.
- d) It is important to ensure that staff working at off licences are suitably trained and receive appropriate refresher training in their responsibilities under the Act and can discharge their duties in full compliance with the licence conditions and requirements of the Act. This includes the ability to competently check a customer's age with acceptable forms of identification where necessary. The Licensing Authority will particularly consider the following matters where they are material to the individual application:
  - I. The likelihood of any violence, public order or policing problem if the licence is granted;
- II. The measures taken to control admission to the premises, and to take reasonable steps to prevent the occurrence of crime and disorder and public nuisance immediately outside the premises, where and to the extent that these matters are within their control.
- III. Past conduct and prior history of complaints against the premises;
- IV. Whether a dispersal policy has been prepared to minimise the potential for disorder as customers leave the premises; and
- V. Any relevant representations.

- g) Conditions will, so far as possible, reflect local crime prevention strategies, and the Licensing Authority will also have regard to the views of the local Crime and Disorder Reduction Partnership.
- h) **Crime and disorder in the vicinity of the premises**: this may include the crime and disorder risks arising from persons queuing to enter the premises; persons exiting the premises and customers smoking eating or drinking in outdoor areas and on the highway outside the premises. This can also include crime arising from pickpockets and bag snatchers, particularly in open spaces or crowded areas where alcohol is being consumed.
- j) **CCTV** using CCTV inside and/or outside the premises together with appropriate procedures and having staff properly trained to use CCTV equipment.
- I) dealing with and reporting crime and disorder training for staff and door security aimed at reducing crime and disorder in the premises and its vicinity and dealing with and reporting incidents if they occur.
- o) excessive drinking training for staff to recognise when customers are becoming drunk and adopting appropriate 'cut off' procedures for drunken customers, so as to reduce the likelihood of fights or aggressive behaviour.
- **5.9** Annex 1 pages 37 to 38 of the SLP in relation to public safety states that the Licensing Authority will require the applicant to demonstrate the steps proposed to ensure the physical safety of people using the relevant premises or place. This does not cover the separate need for applicants to provide relevant public safety requirements dealt with by Environmental Health.

The following provides a non-exhaustive list of risks associated with the public safety objective that applicants may want to consider when preparing their Operating Schedule:

- e) **incident and occurrence book** keeping an incident book on the premises so staff can record any instances of crime, disorder, refused sales, ejections and intimidating behaviour.
- **5.10** Annex 1 pages 38 to 40 of the SLP in relation to the prevention of public nuisance states that the Licensing Authority will require the applicant to demonstrate within the operating plan how they intend to prevent nuisance arising, prevent disturbance and protect amenity so far as is appropriate to ensure that the Licensing Objectives are met. Where there is a relevant representation regarding extended hours, the Licensing Authority will not permit an extension unless it is satisfied that the Licensing Objectives would be met. This is expected to include:
- a) In considering an application, the Licensing Authority will consider the adequacy of proposed measures to remove or effectively manage the potential for public nuisance and anti-social behaviour and any Public Spaces Protection Orders (PSPOs) in place.
- b) The Licensing Authority will particularly consider the following matters where they are material to the individual application:
- ii. The proximity of residential accommodation;
- iii. The type of use proposed, including the likely numbers of customers, proposed hours of operation and the frequency of activity;
- v. The steps taken or proposed to be taken by the applicant to prevent disturbance by customers arriving at or leaving the premises.
- ix. The steps taken or proposed to be taken by the applicant to ensure staff leave the premises quietly;

xv. The arrangements for refuse disposal, storage and the prevention/tidying of litter (including fly posters and illegal placards);

xvii. The history of the applicant in controlling anti-social behaviour and preventing nuisance;

xix. Any other relevant activity likely to give rise to nuisance;

The following provides a non-exhaustive list of risks associated with the public nuisance objective that applicants may want to consider when preparing their Operating Schedule:

- r) **Waste** consider how and where waste will be stored/disposed of at the end of trading hours, particularly if trading until late at night. This is important because the disposal of glass and/or cans to outside bin areas can be very noisy and give rise to complaints, so it may be necessary to store such items and other non-degradable refuse inside the premises until the next trading day. Consideration should also be given to the time of deliveries to minimize disruption to local residents.
- s) Litter for example, litter patrols for late night take-away premises
- **5.11** Annex 1 pages 40 to 41 of the SLP in relation to the protection of children from harm states that the Licensing Authority will require operating plans to specify the measures and management controls in place to protect children from harm. Where appropriate a written childcare policy should be available and be incorporated in the induction of staff. This is expected to include:
- b) The Licensing Authority will particularly consider whether:
- vi. There are licensable activities that are likely to appeal to minors/children under 16 taking place during times when children under 16 may be expected to be attending compulsory full-time education;
- c) The sale of alcohol to a minor is a criminal offence and Trading Standards officers will conduct appropriate covert test purchasing exercises and will take account of any complaints and intelligence. The Act permits the use of children under the age of 18 to undertake test purchases when they have been directed to do so by a duly authorised officer.
- d) Where a sale of alcohol has been made on the same premises to a minor on two or more different occasions within a period of three months the premises licence could be suspended for a defined period.
- g) The Licensing Authority will expect operating plans to specify the measures and management controls in place to prevent alcohol being served to children, other than in those limited circumstances permitted by the Act. The Council's Trading Standards officers have a role to play in the protection of children from harm, and proof of age schemes, and are able to provide advice in relation to measures that can be taken to help prevent the sale of alcohol to underage children. Potential licence holders should also be aware of the Proof of Age London (PAL) Scheme hosted by Southwark Council.

The 'Responsible Authority' in relation to the protection of children from harm is the council's Local Safeguarding Children Board. The Trading Standards service will also have certain responsibilities particularly in relation to the underage sales of age restricted products and providing advice about measures that can be taken to reduce the risk of alcohol sales to under eighteens. The following provides a non-exhaustive

list of risks associated with the protection of children from harm objective that applicants may want to consider when preparing their Operating Schedule:

i) Where premises are subject to age-restrictions, the procedures in place to conduct age verification checks. The Council will expect premises only to accept current passports, driving licences or documents bearing the national PASS logo, such as Citizencard. The Proof of Age Standards Scheme (PASS) is the UK's national guarantee scheme for proof-of- age cards as endorsed by the Home Office. More information can be found on The Proof of Age Standards Scheme (PASS) website.

#### 6. DETERMINATION

- **6.1** In determining this application, the Committee must have regard to the representations and take such of the following steps as it considers necessary for the promotion of the licensing objectives. The steps are:
- (a) Grant the application in full
- (b) Grant the application in part modifying the proposed hours, activities or conditions.
- (c) Reject the application

It is the Council's duty under the Licensing Act 2003 ("The Act") to determine applications with a view to promoting the four licensing objectives; Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance and the Protection of Children from Harm.

In reaching a decision the Council shall consider the details of any relevant representations received; the applicant's Operating Schedule; the Council's adopted Statement of Licensing Policy and the guidance issued by the Secretary of State under section 182 of the Act.

If the Committee is minded to grant the application conditions may be attached to the licence to alleviate the concerns raised through the representations.

#### **Annex 1 – Mandatory Conditions**

- 1. Mandatory Condition
- 1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 2. Mandatory Condition
- 1.A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

- 2. For the purposes of the condition set out in paragraph 1—
- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b)"permitted price" is the price found by applying the formula—

$$P = D + (D \times V)$$

where-

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that subparagraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4(1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.
- 3. Mandatory Condition
- (1) No supply of alcohol may be made under the premises licence-
- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

#### **Annex 2 - Conditions consistent with the operating Schedule**

4. The licence holder shall ensure that the premises benefit from a CCTV system that operates at all times when licensable activities are taking place. The CCTV system is to be to the reasonable satisfaction of the police.

- 5. The system shall incorporate a camera covering each of the entrance doors and the main alcohol display area and shall be capable of providing an image which is regarded as identification standard. The precise positions of the cameras may be agreed, subject to compliance with Data Protection legislation, with the police from time to time.
- 6. The system shall incorporate a recording facility and any recording will be retained and stored in a suitable and secure manner for a minimum of 30 days and shall be made available, subject to compliance with Data Protection legislation, to the police for inspection on request.
- 7. The system must be able to export recorded images to a removable means e.g. CD/DVD and have its own software enabled to allow playback/review.
- 8. A member of staff trained in the use of the CCTV system must be available at the premises at all times that the premises are open to the public.
- 9. The system shall display, on any recording, the correct time and date of the recording.
- 10. Appropriate signage shall be displayed, in a prominent position, informing customers they are being recorded on CCTV.
- 11. A staff member from the premises who is conversant with the operation of the CCTV system will be on the premises at all times that the premises are open to the public. This staff member shall be able to show police recent footage with the minimum of delay when requested. This data or footage reproduction should be given within a reasonable time period.
- 12. No super-strength beer, lagers or ciders of 5.5% ABV (alcohol by volume) or above shall be sold at the premises save for premium beer or ciders in glass bottles.
- 13. There shall be no sale of single cans of beer, lager or cider from the premises and no single bottles of beer, lager or cider in vessels of less than 500ml.
- 14. A member of staff shall be left in charge at all times and able to present themselves to police or a relevant Licensing Authority officer, as the person in charge when the premises are open to the public.
- 15. The premises licence holder shall at all times maintain adequate levels of staff and security. Such staff and security levels shall be disclosed, on request, to the licensing authority and police.
- 16. Signage shall be displayed at the exit of the premises requesting customers leaving the premises late at night to do so quietly and with consideration so as not to disturb nearby residents.
- 17. The premises licence holder shall ensure that an age verification policy will apply to the premises whereby all cashiers shall be trained to ask any customer attempting to purchase alcohol, who appears to be under the age of 25 years (or older if the

licence holder so elects) to produce, before being sold alcohol, identification being a passport or photocard driving licence bearing a holographic mark or other form of identification bearing the customer's photograph, date of birth and the Proof of Age Standards Scheme (or similarly accredited scheme) hologram.


- 18. The designated premises supervisor or store manager shall regularly check the electronic refusals register to ensure it is being consistently used by all staff, and this shall be recorded.
- 19. Any cashier under the age of 18 is required to call a supervisor (who is over the age of 18) to authorise the sale of alcohol and the supervisor must adopt the age verification policy in deciding whether to authorise the sale.
- 20. All cashiers shall be trained to record refusals of sales of alcohol in a refusals register. The register shall contain:
- details of the time and date the refusal was made;
- the identity of the staff member refusing the sale;
- details of the alcohol the person attempted to purchase.

  This register shall be available for inspection by a police officer on request.
- 21. All staff to be engaged or to be engaged in the sale of alcohol on the premises shall receive the following training in age restricted sales:
- Induction training which must be completed and documented prior to the sale of alcohol by the staff member;
- Refresher/reinforcement training at intervals of no more than 6 months. Training records shall be kept at the premises available for inspection by a police officer on request.





Granville Mansions Association OBJECTS to this proposed extension of licensing hours at Sainsbury's supermarket on the grounds that the Council would be failing in its statutory duties if it were to allow it.

Under the Licensing Act 2003, the Council has a statutory duty to carry out its function with a view to promoting the four licensing objectives:

- The prevention of crime and disorder
- Public safety
- The prevention iof public nuisance
- The protection of children from harm

None of these objectives would be met in the granting of this application.

Granville Mansions residents suffer considerable nuisance, noise and disturbance from the activities and behaviour of street drinkers on Shepherds Bush Common and in the area immediately to the South, which includes the application site. Drunken youths often get into our garden, to urinate and/or cause damage. We know well that street drinking leads to other forms of crime including abusive behavior or physical assault. South of the Common is a highly

residential area. Residents here are closer to the application site and would suffer these nuisances more.

It is predominantly single young men, not families, who would take advantage of an early extension of licensing hours. The Council's objectives would not be met by encouraging drunken anti-social behaviour during the hours when children are on their way to school. Far from protecting children, an extension would create new dangers for them.

This extension is not in the interests of the Borough or its residents. It is in the interests of the applicants alone and a retailer's profits should not be considered when the Council makes its decision.

Finally, we remind the Council that the regeneration of Shepherds Bush is hindered by permissions which discourage those developments and businesses which tend to improve the area.

For all the above reasons, we ask the Council to refuse this extension of licensing hours.



I am writing to object to the application by Sainsbury's to 'extend its sale of alcohol to between the hours of 0700 and 2300 daily for consumption off the premises'.

## The Law - Licensing objectives

As explained at page 6 of LBHF's 'Statement of Licensing Policy 2022-2027' the law provides a clear focus on the promotion of four statutory licensing objectives which must be promoted when licensing functions are undertaken. These are:

- The prevention of crime and disorder;
- Public safety;
- The prevention of public nuisance; and
- The protection of children from harm.

#### **Location and Current Situation**

- Sainsbury's location on the Shepherd's Bush Road places it in the middle of a busy residential neighbourhood which also contains many hotels.
- There are numerous pre-nursery, primary and secondary schools within a short walk from the shop. Nearby Pre- and Primary schools include: Lena Gardens Primary, Flora Gardens Primary, Addison Primary, St Mary's Primary, Larmenier Primary, Bute House, École Française Jacques Prevert, One World Montessori, Two Hands Preschool, etc). Most of the children living locally travel to and from home by foot, often unaccompanied. Many other children arrive by bus and finish their journey on foot.
- There are numerous hostels and care centres in and around Shepherd's Bush Road catering for people with mental and addiction problems, the homeless and others.
- The area and its local residents and shops has a significant problem with street drinkers on the Shepherd's Bush Road, in adjacent streets and in larger nearby public areas such as outside the W12 Centre and at Brook Green (where drinking groups have recently established themselves day and night).

• Some local off licences on Shepherd's Bush Road are allowed to sell alcohol from 0800, but none can do so earlier. (Note: this in itself is too early. In 2008 or 2009, local residents and I successfully objected to and prevented any licenses being granted for the sale of alcohol before 1100 by any premises in Shepherd's Bush Road as well as banning the sale of extra strength so-called 'ciders' and 'beers', such as White Lightning. This led to a significant improvement in achieving all the licensing objectives. We are surprised and concerned that LBHF allowed the changes in subsequent applications.)

In view of this situation, I object to the license being granted for the sale of alcohol before 0800 for the following 4 reasons:

## 1st Objection - This license will increase crime and disorder

The 1st statutory licensing objective to prevent crime and disorder cannot be met. The relaxing of licensing hours to allow the sale of alcohol from 0700 is only likely to increase the risk of crime and disorder rather than reduce it.

In speaking with the owners of local premises licensed to sell alcohol from 0800 (which is still too early, in our opinion), they all said that (i) few if any purchasers at that hour were sober, or if they were sober they were seeking to drink immediately, (ii) street drinkers caused them problems, not least by stealing alcohol whenever possible.

Despite LBHF's ban on drinking in public - which is rarely if ever enforced despite numerous daily incidents in this area by the same groups in the same places - people do drink in public, causing crime and disorder. The local police at Hammersmith Police Station can confirm this. Making alcohol available for sale/theft even earlier in the day cannot be reconciled with the objective to prevent public disorder.

# 2nd Objection - This license will be at the expense of public safety

The 2nd statutory licensing objective to promote public safety cannot be met. Local residents and shopkeepers with whom we have spoken confirm that they have been subject to, or have witnessed, provocative and/or aggressive and/or intimidating acts by street drinkers directed at all age groups from young children to elderly residents. Making alcohol available for sale/theft even earlier in the day cannot be reconciled with the objective to ensure public safety.

### 3rd Objection - This license will increase the risk of public nuisance

The 3rd statutory licensing objective to prevent public nuisance cannot be met. Anyone who has lived or stayed in this area, whether for years or days, is aware of the constant nuisance caused by street drinkers. My own personal experience and that of others (including children) includes: seeing people defecating / urinating / vomiting in local

streets regardless of who is around them, drunken abuse, intimidation of children and families walking to and from school, littering in gardens and on the street, genital exposure, aggressive behaviour, swearing, etc. Making alcohol available for sale/theft even earlier in the day cannot be reconciled with the objective to prevent public nuisance.

## 4th Objection - This license does not help to protect children from harm

The 4th statutory licensing objective to protect children from harm cannot be met. 'Harm' is not just restricted to physical harm (which is a crime and would fall under the 1st objection) but also includes psychological harm (e.g., fear, disgust, etc). My personal experience as well as that of local parents is that all our young children have witnessed drinkers locally being abusive and/or aggressive and/or exposing themselves and/or urinating/defecating/vomiting, etc. As stated above, this area benefits from numerous schools and the pupils attending those schools walk there from 0700 (or earlier) in the morning. To add earlier access to alcohol and to increase the risk of further alcohol consumption during this period cannot be reconciled with the objective to protect children from harm.

#### Conclusion

For the reasons above, I object to this license and request that it be refused. I am also disappointed to learn that Sainsbury's is making similar applications for its other outlets nearby and in other boroughs. The only benefit is to Sainsbury's bottom line. It is the local community and the emergency services who would have to pick up the cost and inconvenience if these licenses were approved.



I am also disappointed to learn that Sainsbury's is making similar applications for its other outlets nearby and in other boroughs. The only benefit is to Sainsbury's bottom line. It is the local community and the emergency services who would have to pick up the cost and inconvenience if these licenses were approved.

The reason that the store was prevented from selling alcohol originally before 11am related to the significant number of street drinkers congregating in Shepherds Bush Road. I believe that since then more hostels for the support of homeless people have opened in the vicinity and extending licensing hours works against the support of those vulnerable individuals and the charities running the hostels. The store already appears to have a full time security guard in place which indicates it's own concerns about some

individuals visiting the shop.

My understanding is that the store is also prohibited from selling high strength low price alcohol and I believe that that restriction should be

maintained.

In practice there is no 'need' for the shop to sell alcohol first thing in the

morning, it remains open until late evening so commuters can shop later in the day if necessary.

To allow this shop to extend its licensed hours would also be unfair to the other off-licenses in the locality, particularly sole traders on the Shepherds Bush Road who would still be restricted.

Regarding the use of local Sainsbury's by alcoholics and street drinkers, I comment from personal experience of an alcoholic family member who used a Sainsbury's local store (not this one) to purchase alcohol throughout the day. Restricting sales does not inconvenience those without a troubled relationship with alcohol but does help those people who do have one. This is an area where convenience can go too far.

I am disappointed that Sainsbury's is seeking this licence extension, which does not seem to be in the interest of the local neighbourhood and hope the Council will reject their application.

The licence was originally only granted to sell alcohol from 11am because of the large number of street drinkers that congregate on the Shepherd's Bush Road. There are now more hostels open in the area and on the Shepherd's Bush Road, and an increase in opening hours can only add to the temptations and difficulties of a greater number of those vulnerable people and those who

are trying to support them.

The shop in question is open until 11pm so there is scope for commuters/those going out to work to purchase alcohol at other times of the day and there seems to be no obvious reason to permit alcohol sales

early in the morning.

I note that the shop already employs a security guard at this store which implies that there are already problems, whether from street drinkers or thieves; allowing earlier alcohol sales and the likely greater use of the

store by those with alcohol problems earlier in the day cannot help this. Restrictions on making alcohol available from early in the morning can only help people with a difficult relationship with alcohol, with little impact on others; I say this based on my alcoholic brother's experience with a Sainsbury Local round the corner from him (elsewhere in the UK) where the ready availability of alcohol throughout the day only exacerbated his problems.

I do not believe that this request for an extended licence is in the interests of the local neighbourhood and therefore hope that this will be rejected by the Council.

We am writing as we strongly object to the recent application by Sainsbury's on Shepherd's Bush Road to extend its alcohol sale hours to between 0700 and 2300 daily for consumption off the premises.

We live very close by & believe that granting this extension will have a detrimental impact on our community, & set a concerning precedent and undermine the current balance we have worked hard to maintain in the area.

No other shops along Shepherd's Bush Road are permitted to sell alcohol as early as 7 a.m.

Extending our local Sainsbury's hours would establish a precedent that may encourage others for a similar permission, potentially leading to a proliferation of early-morning alcohol availability, early morning public consumption, loitering, and general anti-social behaviour, (which sadly we already suffer from considerably)

The local area already has its share of alcohol-related disturbances, and we sincerely fear that granting this application would exacerbate such problems as listed above.

On a legal note, the licensing objectives under the Licensing Act 2003 aim to prevent public nuisance, crime, and disorder while promoting public safety and protecting children from harm. I am writing to object against the request for extension in alcohol licence (too sell alcohol from 7 am) for Sainsbury's on the following grounds:

- 1. The supermarket already has an alcohol licence that starts later in the day. Purchasing alcohol at 7 am does not offer community benefit. Residents are able to buy alcohol later in the day and so allowing much earlier purchase at 7 am will only attract antisocial behaviour.
- 2. There is already extensive antisocial behaviour around this shop with people begging and selling drugs (including at the end of Anley Road). Extending earlier licencing will encourage this further.
- 3. Some of the antisocial behaviour around Sainsbury's (e.g. begging) is from residents of Mungo's homeless shelters on Shepherds Bush road and we have extensively complained to them about it.
