#### 1. REVIEW APPLICATION

On the 23<sup>rd</sup> December 2024, an application for a review of a premises licence under Section 51 of the Licensing Act 2003 was served by Licensing and Trading Standard Officer Mr Bill Massini, on behalf of Hammersmith and Fulham Council's Licensing Authority, 45 Beavor Lane, Hammersmith, London, W6 9AR. The review application is in respect of the premises known as the JMB Food and Wine, 143 Askew Road, London, W12 9AU.

The application for a review of the premises licence was made on the grounds of the protection of children from harm, the prevention of crime and disorder and public safety following several incidents at the premises, including the sale of alcohol and nicotine inhaling products to children.

On the 31<sup>st</sup> October 2024, the Trading Standards Team received a complaint claiming the premises had sold alcohol and nicotine inhaling products to five children. On the 05<sup>th</sup> November 2024, the Licensing Team received a complaint outlining the same incident at the premises.

On the 04<sup>th</sup> November 2024, a test purchase was carried out at the premises by the Trading Standards team, where a staff member at the premises sold a disposable vape (nicotine inhaling product) to a 16 year 0-month-old boy who was accompanied by a 16 year and 3-month-old girl.

On the 6<sup>th</sup> November 2024, an officer from the Trading Standard and Licensing Team carried out a joint visit to the premises where numerous breaches of premises licence conditions were identified.

Subsequent visits were made to the premises on the 11<sup>th</sup>, 17<sup>th</sup> and 27<sup>th</sup> November 2024 where outstanding breaches of conditions attached to the premises licence where identified.

On the 9<sup>th</sup> December 2024, the premises licence holder was interviewed under caution by Trading Standards and Licensing officers with respect to the recent incidents at the premises.

Mr Massini, on behalf of the Licensing Authority, explains in the review papers, that the premises licence holder and Designated Premises Supervisor ("DPS), has shown complete disregard for their responsibilities and to those damage by and/or affected by his actions. Mr Massini, therefore, requests that the licensing sub-committee consider a revocation of the licence.

#### 2. CURRENT LICENCE

The premises currently benefit from a premises licence which permits the following licensable activities:

Sale of Alcohol Off the Premises

Monday to Sunday 09:00 – 23:00

Hours Premises Open to the Public

Monday to Sunday 06:30 - 23:00

A copy of the current premises licence and plan can be seen on pages **33-41** of this report.

#### 3. BACKGROUND

Licensing records show that the initial premises licence was granted in respect of the premises on the 18<sup>th</sup> January 2019. On the 6<sup>th</sup> of December 2023, an application to transfer the premises licence and vary the DPS to Mr Subir Singh Bhatia was granted.

On the 23<sup>rd</sup> November 2023, a variation application requesting to extend the opening hours of the premises and hours for the sale of alcohol off the premises was received. The application was heard and determined at a Licensing Sub-Committee hearing on the 14<sup>th</sup> February 2024. A copy of the current premises licence and plan as granted by the Licensing Sub-Committee can be seen on pages **33-41** of this report.

The main access to the premise's is located on Askew Road. The premises operate as a convenience store. There is a mixture of both residential and commercial premises within the area. A map showing the location of the premises and neighbouring licensed premises can be seen on pages **42-63** of this report.

There are several options for transport away from the area including buses and taxis which run from in and around Askew Road area. Stamford Brook tube station is a 15-minute walk away, Ravenscourt Park tube station is a 17-minute walk away and Goldhawk Road tube Station is a 19-minute walk away.

#### 4. CONSULTATION

A public notice was displayed by the Council at and near the premises. A further public notice was displayed by the Council at Hammersmith Town Hall. Details of the application were also published on the Council's web site.

A notice of review was served on the premises licence holder and all the statutory responsible authorities as required by regulation.

#### 4.1 Relevant Representations

The licensing section received one representation from Police Constable ("PC") Nicole Sondh on behalf of the Hammersmith and Fulham Metropolitan Police Licensing team, supporting the review application. A copy of this representation can be seen on pages **64-65** of this report.

The licensing section received one representation from Mr Doug Love on behalf of the Trading Standards team, supporting the review application. A copy of this

representation and supporting documentation can be seen on pages **66-69** of this report.

The licensing section received two representations from local residents supporting the review application. A copy of these representations can be seen on pages **70-73** of this report.

#### 5. OTHER INFORMATION

#### **5.1 Enforcement History**

On the 6<sup>th</sup> November 2024, Trading Standards and Licensing Enforcement officers made a joint visit to the premises with a letter requesting CCTV footage to be produced. A full licensing inspection was carried out and breaches of conditions 9, 10, 12, 13, 14, 18 and 19 attached to the premises were identified. A verbal warning was given, and the inspection sheet was left at the premises as a warning letter.

On the 11<sup>th</sup> November 2024, Licensing Enforcement officer visited the premises accompanied by a Law Enforcement Officer ("LET"). Licensing Enforcement identified breaches of conditions 1, 4, 5, 7, 9, 13, 14, 15, 16 and 18 attached to the premises licence. A verbal waning was given, and the inspection sheet was left at the premises as a warning letter.

On the 9<sup>th</sup> December 2024, a PACE interview under caution was carried out by Licensing and Trading Standard officers with the current premises licence holder and his representative in attendance. The PACE interview was undertaken in relation to an incident which occurred at the premises surrounding sales of alcohol to persons under 18 years old. Following the PACE interview, the premises licence holder has been informed he will be reported for possible prosecution.

#### 5.2 Temporary Event Notice ("TENs")

There have been no TENs submitted in respect of this premises within the past twelve months.

#### 6. POLICY CONSIDERATIONS

- 6.1 It is the Council's duty under the Licensing Act 2003 to determine the review with a view to promoting the four licensing objectives: Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance and the Protection of Children from Harm.
- 6.2 In reaching a decision the Council must have regard to the Council's adopted Statement of Licensing Policy ("SLP") and the guidance issued by the Secretary of State under section 182 Licensing Act 2003.
- 6.3 The revised guidance issued by the Secretary of State under section 182 of the Licensing Act 2003 ("the Guidance") contains advice in paragraphs 11.16 to 11.28 in relation to the review of a premises licence. Paragraphs 11.16 to 11.28 of the revised guidance can be seen on pages **74-78** of this report.

- 6.4 The Council's own SLP gives guidance concerning the review of a premises licence.
- 6.5 Policy 10 pages 28 and 29 of the SLP in relation to reviews states that the Act describes two "groups" that may make representations to applications and may apply for an existing premises licence or club premises certificate to be reviewed by the Licensing Authority. These groups are Responsible Authorities and "Other Persons".

At any stage, following the grant of a premises licence, a Responsible Authority, such as the police or the fire authority, or other persons, may apply for a licence to be reviewed because of a matter arising at the premises in connection with any of the four Licensing Objectives.

A licence may be reviewed where it is alleged that the Licensing Objectives are not being promoted and there is evidence to show this. Guidance on grounds for a review are outlined in Annex 5 of the SLP.

At a hearing held to determine an application for a review of a licence the subcommittee may:

- (a) Take no further action.
- (b) Modify the conditions of the licence.
- (c) Exclude a licensable activity from the scope of the licence.
- (d) Remove the Designated Premises Supervisor.
- (e) Suspend the licence for a period not exceeding three months.
- (f) Revoke the licence.
- 6.6 Policy 11 pages 29 and 30 of the SLP states that in in relation to the consideration of residents, the Licensing Authority expects that any licence applicant will give due consideration to the needs of Hammersmith & Fulham residents and any negative impacts from licensable activities and business operations.

Any review of a licence would need to be evidence based and as such is best supported by evidence from responsible authorities such as the Police or Environmental Health to be successful.

- 6.7 Policy 16 pages 33 and 34 of the SLP in relation to the safety of women and girls in licensed settings states that the Licensing Authority expects licence applications to specifically include measures to ensure the safety of women and girls in licensed premises. The Licensing Authority will use its powers to regulate the night-time economy, both with specific regard to spiking incidents and more generally in relation to violence against women and girls. This may include:
  - a) Using the Licensing Authority's powers to impose conditions or revoke premises licenses, where venues do not take sufficient measures to protect and provide support to customers in spiking incidents;
  - b) Considering the prevalence, prevention and reporting of sexual harassment and misconduct and gender-based violence in licensed premises.
  - c) Requiring the presence of suitably trained and accredited door staff,
  - d) Require presence of CCTV, or to introduce entry searches for example.

Licence applicants and existing licence holders are encouraged to include in their operating schedules clear polices relating to potential abuse or violence against women and girls.

This would include but is not limited to the 'Ask for Angela' programme, Welfare and Vulnerability Engagement' training package (WAVE) for staff to identify and assist women and girls being at risk or being subjected to violence, and the implementation of clear policies in the premises on preventing and addressing violence against women and girls. The Licensing Authority would also encourage off licensed premises to take part in the Ask for Angela scheme in an effort to increase the visible promotion of the scheme in all licensed premises across the borough.

Implementing these measures, particularly for on-licence premises, providing training for staff to increase awareness and provide skills and tools for identifying and assisting when it is at risk of happening or is happening, and having clear policies against violence against women and girls provide a solid basis for addressing the issue when it occurs in licensed premises. Furthermore, having policies on staff reporting incidents to Police and Council officers will help to ensure that these incidents are addressed.

As part of the Government's and the Council's Violence Against Women and Girls Strategy, venues may also wish to consider boosting their security measures e.g. the recruitment and training of additional door security staff, particularly female staff.

The Council are proud supporters of the Women's Night Safety Charter, and we would like to encourage all our licensed premises to consider how you and your business can contribute to making your workplace and H&F a borough where all women feel confident and welcome whenever and wherever they happen to be. The Women's Night Safety Charter is a voluntary pledge to show you take women's safety seriously. By signing the Charter, you show your acknowledgement of the issue and that you're ready to get proactive in improving women's safety.

- 6.8 Annex 4 page 52 of the SLP in relation to the grounds for considering a review states that the Licensing Authority will regard applications for the review of any premises licence particularly seriously where they involve evidence of:
  - a) Use of licensed premises for the sale and distribution of drugs and the laundering of drugs money;
  - b) Use of licensed premises for the sale and distribution of illegal firearms and the laundering of illegal firearms money;
  - c) Evasion of copyright in respect of pirated or unlicensed films and music;
  - d) Underage sales and consumption of alcohol;
  - e) Use of a licensed premises contrary to any emergency legislation requesting its closure:
  - f) Use of licensed premises for prostitution or the sale of unlawful pornography;
  - g) Serious risks to children;
  - h) Use of licensed premises for unlawful gaming and gambling;
  - i) Use of licensed premises as a base for organised criminal activity;
  - j) Use of licensed premises for the organisation of racist, homophobic, sexual abuse, attacks or any discriminatory behaviour;
  - k) Use of licensed premises for storing or selling illegal alcohol or tobacco or smuggled goods;

- I) The use of licensed premises for the sale of stolen goods; m)Incidents of disorder;
- n) Instances of public nuisance where warnings have been disregarded;
- o) Serious risks to public safety which the management is unable or unwilling to correct;
- p) Frequently operating outside permitted hours.
- q) There may be legal implications if activity of child sexual exploitation (CSE) is taking place on licensed premises and there has been a failure to demonstrate due diligence or that adequate safeguards are in place this may lead to prosecution or any of the licensing sanctions detailed in the paragraph below.

#### 7. THE REVIEW HEARING

In determining this application, the Committee must have regard to the representations and take such of the following steps as it considers necessary for the promotion of the licensing objectives. The steps are:

- (a) Take no further action.
- (b) Modify the conditions of the licence.
- (c) Exclude a licensable activity from the scope of the licence.
- (d) Remove the Designated Premises Supervisor.
- (e) Suspend the licence for a period not exceeding three months.
- (f) Revoke the licence.

Where the Committee takes a step mentioned in (b) or (c) above, it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.

In making its decision, the Committee must act with a view to promoting the licensing objectives:

- the prevention of crime and disorder
- the prevention of public nuisance
- public safety
- protection of children from harm

It must also have regard to its own SLP and the Guidance.

If the Committee is minded to amend the licence, conditions may be attached to the licence to alleviate the concerns raised through representations; nevertheless, this is a matter for the Committee to determine in light of the above matters, and any others it considers material.

#### Public Safety -

• Sale of alcohol to children – Licensing Act 2003

#### **Background Information**

A premises licence has been in existence at 143 Askew Road for many years. On 21 November 2023 the premises licence and Designated Premises Supervisor (DPS) was transferred to Subir Singh Bhatia. The licensable hours were 10.00 - 21.00 hours. Two days later a variation was submitted seeking an extension of those hours from 08.00-23.00 hours. There were objections to this application and the matter was heard by the Licensing Sub-committee on 14 February 2024. Mr Bhatia offered up a number of further conditions he would abide by if he was granted these extra hours. The Licensing sub-committee agreed for the hours to be extended from 9.00 - 23.00 hours but added the proposed conditions to the premises licence. These conditions are now conditions 13-19 inclusive in Annex 3 of the Premises Licence (Conditions attached after a hearing by the licensing authority).

On 31 October 2024 Trading Standards received the following complaint. To protect those involved no personal details are disclosed here.

"Thank you for your time on the telephone. On Sunday 27th October at 4:45pm 3 girls purchased 1 bottle of Glens Vodka from NewsMart - 143 Askew road, Shepherds Bush. They went back 10 minutes later (by now 5 girls) entered the shop, pooled their £2.50 each and counted out the coins and bought a second bottle plus 2 vapes. They were not asked for identification. 4 of these girls are 14 and 1 girl is 13 - school years of 9 and 10. Following drinking this vodka and vaping, within 1.5 hours 3 of them were blacked out on the floor where family members found them and all parents were called. Paramedics arrived and reviewed all of their conditions whereupon 3 of the girls were admitted to Chelsea and Westminster A&E by ambulance. Two of those admitted via ambulance went into shock and had to be blue-lighted as were arresting in the ambulance - they did not come around until between 3-4:30am Monday. As I mentioned the girls were aware that 143 Askew Road NewsMart doesn't ask children for proof of identification. Whilst they had never bought vodka there before they had purchased vapes and they had been told via friends/peers that they sell alcohol and do not check for id."

Her daughter was 13 years old. A couple of days after the incident the mother went to the shop and spoke to Mr Bhatia (senior) about this and asked who had been working on the Sunday. He told her it was his son.

On 5<sup>th</sup> November Licensing received the following on-line complaint. Again, to protect those involved no personal details are disclosed here.

#### "Problem details - Licensing

1.Additional information that would help resolve the problem:

On Sunday 27th October at 4.45pm 5 girls were able to buy 2 bottles of vodka, and 2 vapes. They

were aged 13 years and 14 years of age and were not asked for any ID. It resulted in 3 of the girls being blue lighted by ambulance to Chelsea and Westminster where they were treated for high levels of intoxication and were extremely ill.

Location of problem:

2.Askew Road

Additional information that would help locate the problem:

Newsmart - 143 Askew Road, Shepherds Bush,"

Both complaints were from mothers of girls who had bought and drunk the alcohol. They had also bought and vaped nicotine vape pens. They have been spoken to in detail. Further affected mums have contacted the Council and both Trading Standards and Licensing have spoken to them. In correspondence one mother has said

"[X] was in partial shut down when the ambulance came and her blood pressure was dangerously low as we had to pull over on the side of the road in the ambulance to get her blodd pressure back up before we continued with blue lights and sirens to Chelsea and Westminster. She didn't come round until 4am and we left in the ambulance around 7pm! Her temperature was very low so she to be in a special heat blanket in the hospital"

She has since said in correspondence

"It remains a very dark day in my parenting experience and still shudder at the thought of it happening ever again to anyone"

#### **Timeline**

#### 4 November 2024 - underage test purchase sale

Trading Standards carried out an underage test purchase exercise in the Borough, of which one attempt of a disposable nicotine vape was made at this premise by a 16 year 0 months old boy who was accompanied by a 16 year and 3 months girl. He was sold a "Blue Razz" flavoured Crystal SKD disposable vape and was not challenged as to his age. It is an offence under The Children and Families Act 2014 to sell a nicotine inhaling product (of which a disposable vape is one) to anyone under the age of 18 years. The seller was Mr Bhatia. Of the nine premises visited that day this was the only premise to sell. When Trading Standards went into the shop a few minutes later to inform the business of the test purchase he was asked if a refused sales book or register was used. The officer was told there was not. The business operated an EPOS system whereby goods are scanned before sale. Such systems have the facility to activate a prompt requiring the operator to confirm the

purchaser is either over 18, may be 18 or over, in which case ID is required to be produced or the person is under 18 in which case the sale is refused. Checks on the EPOS machine showed age prompt the business had not made it operational for when selling nicotine inhaling products. Mr Bhatia was asked about the CCTV and said it was working but he was unable to view it there and then. The officer said he would notify him of CCTV footage he wanted to view. Since no notices were displayed at the time about Challenge 25 being in operation at the premises, Trading Standards supplied Mr Bhatia with such notices and told him where to display them.

#### 6 November 2024

Trading Standards and Licensing made a joint visit to the shop with a view to handing the Premises Licence Holder & DPS and sole director of JMB Food and Wine Ltd (the legal business operating name), Mr Bhatia, with a letter requiring specified CCTV footage to be produced and to carry out a full inspection to check for compliance with the conditions on the Premises Licence which would include checking the CCTV operation in accordance with condition 13. (see below). Mr Bhatia was not present; just his son (Manveer) was who said he was 18, his birthday being 27 August. He was generally uncooperative and obstructive throughout this visit.

He was unable to produce a copy of the Premises Licence – an offence under s57 Licensing Act. One of the two pages summary was displayed on the shop window.

#### CCTV

#### Condition 13 states:

High- Definition CCTV covering the interior and exterior of the premises shall be installed and shall be kept operational at all times the premises are open to the public. The CCTV:

- a. Shall be capable of taking a head and shoulders shot of persons entering the premises
- b. Shall be capable of storing images for a minimum of 31 days
- c. Shall be accessible by a member of staff who is capable of downloading images for the police or authorised council officers, and shall be on duty at all times the premises are open, The staff member must be able to provide a police or authorised officer copies of recent CCTV images or data with the minimum of delay when requested.

When Licensing asked him to view the CCTV he said there was CCTV but the footage went was held remotely which he could view on his mobile phone and did

forward to Trading Standards via WhatsAPP, footage of the recent test purchase albeit it was not at all clear. There was no date or time stamp on the footage. The footage was of poor quality and non-compliant with the CCTV condition. He was not prepared to find other footage that Trading Standards were requiring though said recordings were available back to 12 October (maximum of 26 days). It was noted there were two "plug in" "Verisure" "domestic" cameras, one at the front of the shop and one at the back. Manveer said these were the cameras being used and they were activated to operate and record only when movement was detected. He said this was the CCTV system. A CCTV system like this allows footage that is to be copied to be easily edited/deleted and not of the standard required. Asked about the other more typical cameras that were secured and positioned around the shop covering the entrance, outside, the till area and throughout the shop, plus the CCTV Monitor (flat screen TV), he said they didn't work and hadn't worked for ages.

The CCTV was not being operated in accordance with condition 13. Licensable activities cannot be conducted where there are breaches of conditions. This is emphasised by another condition – 14 which states:

"Licensable activities shall only be carried out at the premises at times when the CCTV system is fully operational"

Trading Standards gave Manveer a letter to pass on to his father. This related to him attending a formal interview and also dates and times for CCTV footage to be produced. Manveer said that would be produced.

Other matters on this visit:

1. No refused sales book or incident books could be produced when asked, this being in breach of conditions 18 and 9 which state:

Condition 18 "A refusal book shall be kept at the premises and updated as and when required and made available for inspection on request to a Licensing Officer, Police or other responsible authority"

Condition 9 "An incident log shall be kept at the premises, and be made available to the police or an authorised officer of the council upon request, the incident log shall record the following

- a) All crimes reported to the venue
- b) All ejections of patrons
- c) Any complaints received
- d) Any incidents of disorder

- e) Any faults in the CCTV system
- f) Any refusal of the sale of alcohol
- g) Any visit by a relevant authority or emergency service"
- 2. Beers and stout above 5.5% ABV were on display for sale. These included:

Kestrel Super 9%

Perla Mocne 7.1%

Debowe 7%

Carlsberg Special Brew 7.5%

Oranjeboom Imported 8.5%

Lomza Jasne 5.7%

Dragon Stout 7.5%

Guinness Foreign Extra 7.5%

This was in breach of condition 19 which states:

"Beer, lager, cider and stout above 5.5% ABV shall not be displayed or sold"

The sale price of the Kestrel was checked on the till (Electronic point of sale system [EPOS] in operation) as £2.00, this being a low retail price and not much over the UK duty payable. Manveer was shown the illegally displayed alcohol and told it could not be sold because the licence prevented such drinks being sold above 5.5% ABV and they needed to be removed. Licensing put one of each of these drinks on the fridge by the alcohol display, so there could be no misunderstandings of what drinks were illegally displayed for sale and therefore to be removed.

3. No staff training records were produced on request, Manveer Bhatia, saying there were not any, in breach of condition 8 which states:

"Staff shall receive training for their role on induction and refresher training every 6 months. Training shall include identifying persons under 25, making a challenge, acceptable proof of age, making and recording a refusal, proxy sales, avoiding conflict and responsible alcohol retailing. Written training logs shall be kept for all staff and these logs shall be made available to police/local authority upon request".

- 4. Condition 10 requires all alcohol to be covered from view from customers during the hours when the premises are open outside the permitted hours for the sale of alcohol, so between 06:30 and 09:00 hours. This was no evidence as to show how that could possibly be done.
- 5. Condition 12 requires there to be prominently displayed by the exit, notices asking customers to respect nearby residents and to leave quietly, to not

loiter outside the premises, nor drink in the street and to dispose of litter responsibly. No such notices were displayed.

It became obvious this inspection was not going to be completed in Manveer's presence, so he was given the Trading Standards' letter to forward to his father and told a further visit would be made in the very near future. Manveer told the officers if they were to visit again, they needed to bring along a Punjabi interpreter because his father spoke little English.

#### 11 November 2024 - first visit

Licensing enforcement visited the shop with a Punjabi speaking council "LET" officer. They spoke to Subir Bhatia ["SB"]

#### Findings:

- SB said he usually worked Monday to Saturday until around 6pm when his son took over worked in the evenings. He said his wife and son worked Sundays as he needed to rest that day. He said they were the only people who worked in the shop. He later admitted he had not read the conditions on the licence (see below in these findings)
- The CCTV system was still not operational again in breach of conditions 13 and 14. He said it had not been working for quite a while but could not be more precise. Condition 9(e) (refusals and incident required this to have been recorded but since there was no book in operation, this was not recorded anywhere.
- SB said the 2 plug-in cameras worked but he was unable demonstrate them working by showing any footage on his mobile. He tried to speak to his son who appeared to be the only person who could access any recordings from this non compliant CCTV set up. He was clearly in control of all CCTV footage and became angry with his father when he (father) wanted to see the CCTV. Licensing was unable to see any CCTV footage. SB was reminded about the requirement to produce CCTV footage for the times and dates in the Trading Standards' letter.
- There were no notices displayed stating by the entry door and point of service stating that CCTV was in use in breach of condition 4
- Condition 5 requires a Challenge 25 proof of age policy to be operated at the premises. SB was unable to properly explain what Challenge 25 was and thus it is reasonable to conclude that a Challenge 25 policy could not be in use at the premise.
- Still on the area of age verification to prevent children purchasing alcohol,

there is a Mandatory condition at condition 1 on all premises licences where alcohol is permitted to be sold requiring the Premises Licence holder to ensure an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol. The Designated Premises Supervisor must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy. There was no evidence to indicate there is a policy, or if there is such a policy that it was carried out in accordance with it. — in breach of condition 1.

- Condition 6 requires notices to be displayed by the entry and point of service stating a challenge 25 policy is in force at the premises. As stated earlier on 4 November, Trading Standards had supplied "Challenge 25" posters. Still, no such notice was displayed by the entrance to the shop - in breach of this condition.
- There were no notices displayed stating the provisions of The Licensing Act regarding underage and proxy sales breach of condition 7
- SB said there was no refused sale or incident book in operation breach of conditions 9 and 18
- SB said there were no training records breach of condition 8
- The EPOS system was checked. When alcohol was scanned, the product and price were displayed on the screen together with an "age prompt" displayed on the screen which required action to be taken by the till operator before the transaction could be completed. It stated, "Is customer over 18?" and displayed a date of birth, this being the youngest date that someone can legally purchase the item. The operator has three option buttons to choose to answer that question- "YES" (when appears customer is obviously over 25), "PROOF" (when unsure thinks the customer is under 25 and needs to see acceptable form of ID) and "NO" (when obviously under 18 or proof of age is not supplied). Where "NO" is clicked, the operator is prompted for a reason such as "No Id proof" "Under Age", "Already Drunk" or "Policeman in uniform".
- The EPOS did not "prompt" when disposable vapes were seeking to be purchased.
- SB was unable to produce his Premises Licence initially saying he had never received it. When asked why only the first page of the Premises Licence Summary was displayed, he said he had the licence and but on further questioning said he had never read it.
- The cigarettes for sale were inspected. Whilst doing so, Mr Bhatia was asked if anyone who worked there, smoked. He replied that no one smoked in the family. All cigarettes found on the premise were in a draw under the counter

and out of sight from customers, as is required by law. There were only 14 packs of cigarettes in this draw but they included 8 illegal packs of cigarettes – 4 x L&M (Duty Free and not authorised to be sold in the UK), 2 x Marlboro Gold (Duty Free) and 2 x Marlboro Touch (originating from Turkey and a brand not authorised to be sold in the UK). There was also one opened pack (the cardboard top and cellophane missing) thereby exposing the cigarettes inside. There were three missing so 17 still in the pack. This was another pack of the Turkish Marlboro Touch. All these packs were seized because they contravened The Tobacco and Related Products Regulations and The Standardised Packaging of Tobacco Regulations. Mr Bhatia was asked why there was an open pack with only 17 cigarettes left inside. He did not answer. It is an offence under The Children and Young Persons (Protection from Tobacco) Act 1991 for any person carrying on a retail business to sell cigarettes to any person other than in their original packaging. This legislation is intended to stop "Pocket money" sales of cigarettes to children.

Conditions 15 requires all alcohol to be purchased from AWRS registered Cash and Carry and wholesalers. Condition 16 slightly repeats this but states "All goods, including those subject to duty payments i.e. alcohol and tobacco products will be brought [bought] from cash and carries only an [with] invoices and they will be available upon request. All alcohol will be purchased from AWRS registered cash and carry or wholesalers".

Mr Bhatia was asked about his invoices for his purchases of alcohol. He had a few in the shop but said the rest were at home or with his accountant. Of note was an invoice for the purchase of 6 bottles of Glens vodka on 17 October 2024, this being the brand of vodka sold to the underage girls ten days later on 27 October. No Glens vodka was on sale on 6<sup>th</sup> November.

#### 11 November 2024 - second visit

Licensing returned with a formal notice requiring the production of invoices for the following drinks since the business had been operating:

Kestrel Super 9%

Perla Mocne 7.1%

Debowe 7%

Carlsberg Special Brew 7.5%

Oranjeboom Imported 8.5%

Lomza Jasne 5.7%

Dragon Stout 7.5%

Guinness Foreign Extra 7.5%

Mr Bhatia and his son were present. He said he would be able to produce them by 14 November. He was also reminded about production of the CCTV footage that Trading Standards had required. They said that would also be done by then.

Whilst handing over the paperwork, Licensing noted some of those drinks above either had not been removed from the shelves after the 6 November visit or had been put back on since. They included Guinness Foreign Extra, Oranjeboom Imported, Dragon Stout, Carlsberg Special Brew and Debowe. They were told to remove that alcohol immediately and the officer assisted them in doing so.

#### **17 November 2024**

Since the invoices and CCTV footage still had not been produced Licensing revisited to chase this up. Premises Licence Holder/DPS, Mr Bhatia, was working in the shop and said they were with his Licensing Agent who he was going to see on 20 November and would be in contact with us. He was asked about other breaches and whether they had been remedied. No attempt had been made to address the previously identified breaches. Licensing did however notice in the "alcohol fridge" cans of Oranjeboom Imported (8.5% ABV) and bottles of Guinness Foreign Extra (7.5% ABV) were back on display for sale. The Oranjeboom was scanned for a selling price; £1.80/can – not much more than the UK Duty payable on such a high strength beer. The expected price for such a drink purchased through legal channels would be around the £2.40-£2.50 mark. The Guinness was priced at £1.99.

Mr Bhatia said his wife must have put it back on sale. He was told to remove it from the shop.

#### 27 November 2024

Licensing and Trading Standards still had not heard from Mr Bhatia or received any documentation or CCTV and so Licensing visited the shop yet again, only to find that bottles of the Guinness Foreign Extra beer were still on sale. The officer spoke to his Licensing Agent, who said no CCTV or invoices would be produced.

#### 9 December 2024

Mr Bhatia was interviewed under caution by Trading Standards and Licensing. Also present was his Licensing Agent and an "Approved" Interpreter. A summary of his answers are as follows:

He, his wife and son are the only people who work at the shop

- He had never worked or run a similar business before this
- The only training he had to run the business was the course he took in order to gain his personal licence
- He was unable to explain what "Challenge 25" was and when to use it.
- He recalled the sale of the nicotine vape on 4 November
- He said the shop was very busy with customers and a colleague or another person must have sold it
- Having then been shown a clip of CCTV supplied by his son, he accepted
  there were no other customers in the shop and only one person serving and
  so he may have sold the nicotine vape
- He was aware the legal age to sell nicotine vapes was 18
- Having been shown a photo of the girl and boy he said their age could be 16 or possibly 13
- He said he had made a mistake
- He was unable to explain how the EPOS "till prompt" worked and accepted nicotine vapes were not programmed to prompt the seller to check for proof of age
- He said he always checked people's age but was unable to show any evidence of refused sales
- He said he had no grounds to believe the business had made any other underage sales and no one had ever complained to him about this
- He said no one in the family smoked.
- In relation to the illegal cigarettes found in the shop on 11 November he said someone had given him the cigarettes to sell but he didn't usually sell cigarettes
- He was unaware it was illegal to sell these cigarettes from the shop
- He didn't question himself that they looked different to other cigarettes sold in in the UK and was not paying attention
- He was given the cigarettes by a Punjabi man who he had never met before
- He was given them the day before the seizure
- All the packs were sealed
- The open pack may have dropped on the floor and the pack fell open
- The beers above the 5.5% ABV were also given to him by another Punjabi man who came into the shop and said he could have them because he had just sold his shop and had some extra beers.
- He did not know this man
- He had never heard of the AWRS (Alcohol Wholesalers Registration Scheme

- operated by HMRC)
- When prompted it would have been covered in his personal licence course,
   he remembered it meant he had to pay taxes on products
- He was unable to explain why he had said he would supply invoices for these items or why he had not mentioned this to The Licensing Officer when he had visited asking where these invoices were.
- He said the shop takings were about £5k per week and mark up was between
   10 and 50%
- His son worked there 2-3 hours a day
- He accepted that on the personal licence course he had been taught about not selling illegal goods like tobacco and alcohol and never to buy goods from people off the street
- He accepted he had ignored that advice
- He was unable to explain even the most basic responsibilities a DPS had in relation to the sale of alcohol by his staff.
- He said his son and wife were not authorised to sell alcohol if he was not present in the shop
- Pressed on this (inaccurate) answer, he accepted his son may sell alcohol
  when he was not there but there were no cameras for him to see that
- When explained that virtually all conditions had been breached, he said he had made mistakes but it was not done on purpose
- He said he didn't know some of the things on his licence
- When asked he said he was in control of his business
- Asked why the over strength beers kept returning the shelves after having been told to remove them, he said it was an unintentional mistake. Some had been put in the bin but must have been taken out and put back on display by someone
- Regarding the CCTV and why it was not produced, as had been required, he said the system may have been done, that he was getting someone to repair it and once done he would send it
- He said it went wrong about a month ago
- Asked how long it retained recorded footage he said it was on a "loop" and normally it was for a day, though some days, three days but he didn't really check it
- When told the requirement was 31 days minimum, he said "yes but we couldn't find anything"
- He accepted he was unable to view the footage from the two "Verisure

- cameras" and was dependant on his son showing him it
- When it was explained that his son had said on 6 November that there was footage back to 12 October, asked why footage for 27 October was not provided to Trading Standards, he replied, "I'm not sure, I've not asked him"
- The main reason for the interview and why he had inspections was then explained. He was asked who was working in the shop at that time, to which he said it was him
- Asked how he could be so sure it was him he said because he always worked
   Sunday evenings
- Asked if he had knowledge of this underage sale allegation, he said he did know but never sold to anyone who was underage.
- He did not answer why his answer was different to that given earlier about receiving any complaints, merely saying again he did not sell products to underage children
- He recalled the mother coming into his shop on the Monday but did not make a record of complaints. He was aware of ambulances being called.
- He said he asked the girls for ID to show their age and they were 18/19, so he sold.
- He repeated that he only sold such items if someone produces ID
- It was put to him that he had said to the mother it was his son working that day and that officers had been told it was a young male who had made the sales, to which he replied it was him and it could not have been his son
- He then went on to say one girl in the shop showed her ID and she was 20 years old
- Questioned on that, he said she produced a driving licence and a passport
- Once the details were explained about the numbers of girls involved and how they "pooled" their money to pay for the items he then said there was only one girl in the shop and the others were standing outside
- Asked if he was lying to protect his son, he said he knew it was him working in the shop at that time.

#### Other relevant information

The mother who visited the shop after the sales has supplied her 13-year-old daughter's pre-payment card statement which shows her daughter's contributions towards the purchases, the date shown being applied the following day – as is normal. There were two transactions and the statement is produced with this

application and identified with the mark WRM 1.

#### **Conclusions and recommendations**

This application for a review of the premises licence has been made following a very serious incident that was reported to have occurred on 27 October 2024 where vodka and nicotine inhaling products in the form of disposable nicotine vapes were purchased by a group of local girls aged between 13 and 14. Had it not been for the swift action and professionalism of London's Ambulance Service and those professionals at The Chelsea and Westminster Hospital this application may well have been referring to fatalities.

No CCTV footage has been produced by The Premises Licence Holder, despite his son saying there was footage back to 12 October, though of course the son's claim cannot be verified. The sub- Committee is invited to draw the conclusion that no such footage (albeit in a non-compliant format in terms of compliance with licence condition 13) was produced for the sole reason that it was self-criminating. Having read this application up to this stage it should be clear by now that it was unlikely to have ever been produced to authorised officers. It is not possible to say whether the properly installed CCTV system which has been identified by those at the shop as not working at this particular time was in fact working but deliberately destroyed soon after the mother went to the shop. The sub-committee is invited to treat the breach of the CCTV as seriously as the sale of vodka (37.5% ABV) (and vapes) to teenage girls; girls being as much as five years under the legal age to purchase these products. Their mothers are adamant they look their actual age and any person who had been properly trained should have refused the attempted sale or, in the worst case scenario, required acceptable proof of age which would not have been forthcoming.

Since there was a "till prompt" on the EPOS till system, for those sales to have taken place a positive action of approving the sales had to be taken by the seller on both occasions within a short time.

Despite at least one mother going to the shop and trying to discuss these matters with the Premise Licence holder just a day after the incident, not even a week later on 4 November, Mr Bhatia failed a Trading Standards' test purchase of a disposable vape pen to a 16 year old.

Virtually all conditions on the Premises Licence have been breached. These breaches have continued when Licensing Enforcement has carried out further visits with no attempts made to comply with the conditions, not even simple ones such as the display of notices required by some conditions.

Alcohol in the form of beer and stout has continued to be placed back on display for sale in breach of the maximum strength of 5.5%ABV - condition 19. No invoices have ever been produced for their purchase.

Illegal tobacco was found on the premises and no adequate explanation has been given for the "open" pack of cigarettes.


Hammersmith and Fulham Licensing say the answers given under caution, many of which contradict what was previously said to officers, lack any credibility and show how badly the business has been run, with a general disregard to legal responsibilities and in particular to young people.

Hammersmith and Fulham Licensing say the Licensing Objectives have not been promoted and there is a complete lack of confidence in The Premises Licence Holder being able to promote these in the future. The conditions on the premises Licence if read, and followed, would have prevented these incidents from occurring. The Premises Licence Holder here is also the Designated Premises Supervisor and so has a Personal Licence, following formal training. The Personal Licence was only obtained just over a year ago in late 2023 and all that was learnt has been totally disregarded. Further, the Variation submitted by the Premises Licence Holder in November 2023, that led to a Licensing Sub-Committee hearing on 14 February 2024 revolved around the applicant proposing to the Sub-Committee, six further conditions to be added to the licence if the licensable hours were increased. These have all been breached. The Licensing Sub-Committee's decision has been dismissed.

Instead of engaging with the relevant authorities, The Premises Licence Holder/Designated Premises Supervisor has shown a complete disregard for his responsibilities and to those damaged by and/or affected by his actions.

Licensing is therefore saying the addition of further conditions would not be appropriate, nor would a long period of suspension.

The Licensing Sub-Committee is therefore invited to strongly consider revocation of the Premises Licence.

#### **Annex 1 - Mandatory Conditions**

- 1. Mandatory Condition
- 1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
- (a) a holographic mark, or
- (b) an ultraviolet feature.

- 2. Mandatory Condition
- 1.A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1—
- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula—

$$P = D + (D \times V)$$

where-

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that subparagraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4(1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.
- 3. Mandatory Condition
- (1) No supply of alcohol may be made under the premises licence-
- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

#### Annex 2 - Conditions consistent with the operating Schedule

- 4. Notices shall be prominently displayed at the premises by the entry door and point of service stating that CCTV is in use.
- 5. A Challenge 25 proof of age policy shall be operated at the premises. The only acceptable forms of identification shall be a photographic driving licence, a valid passport or a proof of age card with the bearer's photograph and the PASS logo in a hologram format.
- 6. Notices shall be prominently displayed at the premises by the entry and point of service stating that a challenge 25 policy is in force at the premises.
- 7. Notices shall be prominently displayed at the premises stating the provisions of the Licensing Act regarding underage and proxy sales.
- 8. Staff shall receive training for their role on induction and refresher training every 6 months. Training shall include identifying persons under 25, making a challenge, acceptable proof of age, making and recording a refusal, proxy sales, avoiding conflict and responsible alcohol retailing. Written training logs shall be kept for all staff and these logs shall be made available to police / local authority upon request.
- 9. An incident log shall be kept at the premises, and be made available to the police or an authorised officer of the council upon request, the incident log shall record the following;
- a) all crimes reported to the venue;
- b) all ejections of patrons;
- c) any complaints received;
- d) any incidents of disorder;
- e) any faults in the CCTV system;
- f) any refusal of the sale of alcohol; and
- g) any visit by a relevant authority or emergency service.
- 10. During the hours when the premises are open outside the permitted hours for the sale of alcohol, all alcohol shall be covered from view from customers.
- 11. Alcohol shall only be supplied in sealed containers for consumption off the premises. No alcohol shall be consumed on the premises at any time.
- 12. Notices shall be prominently displayed by the exit asking customers to respect nearby residents and to leave quietly, to not loiter outside the premises nor drink in the street and to dispose of litter responsibly.

#### Annex 3 – Conditions attached after a hearing by the licensing authority

- 13. High-Definition CCTV covering the interior and exterior of the premises shall be installed and shall be kept operational at all times the premises are open to the public. The CCTV:
- o shall be capable of taking a head and shoulders shot of persons entering the premises.
- o shall be capable of storing images for a minimum of 31 days.
- o shall be accessible by a member of staff who is capable of downloading images for

the police or authorised council officers, and shall be on duty at all times the premises are open. This staff member must be able to provide a police or authorised council officer copies of recent CCTV images or data with the minimum of delay when requested.

- 14. Licensable activities shall only be carried out at the premises at times when the CCTV system is fully operational.
- 15. All alcohol shall be purchased from AWRS registered cash & carry and wholesalers.
- 16. All goods, including those subject to duty payments i.e., alcohol and tobacco products will be brought from cash and carries only an invoices and they will be available upon request. All alcohol will be purchased from AWRS registered cash & carry or wholesalers.
- 17. All staff employed at the premises will have UK right to work status checked, once passed that stage they shall be offered employment.
- 18. A refusal book shall be kept at the premises and updated as and when required, and made available for inspection on request to a Licensing Officer, Police or other responsible authority.

19. Beer, lager, cider and stout above 5.5% ABV shall not be displayed or sold.







#### Premises Licence Review Application Number - 2024/02117/LAPRR

I am a Police Licensing officer for the borough of Hammersmith and Fulham acting on behalf of the chief officer of the Metropolitan Police.

The Metropolitan Police fully support the application for review of the above Premise Licence. It is clear from the report submitted by the council that the premises has not been promoting the licensing objectives and those of particular concern to Police in the Prevention of Crime and Disorder and in the Protection of Children from Harm.

As detailed in the report provided by the Local Authority Licensing team it is unacceptable and concerning that children were able to purchase alcohol from the premises without challenge undermining the Licensing objective in the Protection of Children from Harm.

It is also noted on the report the continuous breach of conditions that the premises demonstrated throughout the council's investigation and the impact that this would have had on crime and disorder in the area. Within the local vicinity of the premises there is a high level of street drinking, the products that are often favourable to those who drink on the street are often high strength (beers, lagers or stouts above 5.5%) and of low value to purchase, which is why Police propose the following condition for off licences in the local area;

#### 'Beer, lager and stout above 5.5% ABV shall not be displayed or sold'

The Licence holder was reminded of this condition during the investigation by the Local Authority and asked to remove the products that breached this. He showed a complete disregard to the request by placing the prohibited products back on display less than a week later. The continuous non-compliance leads Police to have a complete lack of faith in the premises licence holder and their ability to promote the licensing objectives. Failing to comply with premises licence conditions places more children at risk of harm and further risk of anti-social behaviour in the local area, in turn increasing the risking of crime and disorder. The Metropolitan Police therefore supports the Local Authority's application to revoke the premises licence.

## Premises licence 2023/01949/LAPR JMB Food & Wine Ltd t/a Newsmart, 143 Askew Road, W12 9AU Trading Standards representation to review application

- 1. Following the application to review this premises licence, made by Bill Masini of the LBHF Licensing Team, I wish to make the following representation to outline Trading Standards' knowledge of the business and to recommend the revocation of the licence.
- 2. The only dealings Trading Standards have had with this business since JMB F&W Ltd took over the operation of the shop was on 24/11/23, when a volunteer working with Trading Standards visited the shop and undertook a test purchase with the intention of seeing whether the business would require proof of age before selling a nicotine vape. The volunteer was female, aged 18 years and 7 months and ID was requested. No sale was made when no ID was produced.
- 3. I can confirm that the application accurately reports on the Trading Standards issues following the complaint made at the end of October 2024, but I wish to add the following additions.
- 4. I have attached, as Appendix 1, photographs of the two underage volunteers who visited the shop on 4<sup>th</sup> November. The photographs were taken on the night of the test purchase and show them as they appeared during the time they were in the shop. I have seen the passport of the male volunteer and can confirm that it shows he was born in mid-October 2008, making him only just 16 at the time of the sale.
- 5. There has not, at any time, been a reason given to explain why the requested CCTV for the time of the alleged sale to the 13- & 14-year-old girls on Sunday 27<sup>th</sup> October 2024 was not provided, despite the Licensee's son initially confirming that recordings were available back to 12<sup>th</sup> October.
- Trading Standards prioritise work to prevent illegal tobacco from being available in the borough because ready availability of cheap tobacco is known to make it easier for people to start smoking, harder for them to quit, and smokers tend to smoke more, exacerbating the health inequalities suffered by poorer communities.
- 7. There were only a few packs of illicit cigarettes seized, but that is not necessarily an indication of how much illicit tobacco had been sold by the business, or may have been in future had the business not come to our attention. In my experience, many businesses who make regular sales will only keep minimal amounts on the premises, with the rest being kept where it is less likely to be found. I have attached annotated photographs of samples of the cigarettes seized by Mr Masini, as Appendix 2.

8. Mr Bhatia, when he was interviewed by Mr Masini and myself (with an interpreter provided), showed himself to be totally ill-equipped to manage a licensed premises, unable to describe the basic elements of running such a business legally, or in accordance with the Licensing Act objectives. There were also several answers he gave in the interview – that he had made no payment for the illicit tobacco and alcohol products identified at the shop; that he did not know it was illegal to sell cigarettes that were clearly intended for a foreign market or in branded packaging which has not been allowed in the UK for nearly ten years; that the opened pack of cigarettes had not been intentionally opened, for instance – that could not have possibly been true.

#### Recommendations


- Even if only those matters described which have been witnessed by officers are considered, there is
  no doubt that Mr Bhatia has failed both to manage a licensed business to a standard that could be
  considered the minimum acceptable, or to give any confidence that he could, in future, manage it
  well.
- 10. Although the Committee will not hear from the victims directly, I think there is no doubt that, as alleged, there were repeated sales of alcohol and vapes to groups of girls only just into their teenage years were made on 27<sup>th</sup> October, either by Mr Bhatia (who claimed only he was working in the interview under caution) or by his son (mentioned by the complainants and previously identified by Mr Bhatia as typically working on Sundays).
- 11. It seems inconceivable that any person this young could have been mistaken for over 18, let alone 25 (below which the licence requires age verification). Here, there were said to be five in the shop (although Mr Bhatia gave a contradictory version, denying this, in interview) and the only reasonable conclusion must be that they were believed to be underage by the seller.
- 12. Mr Bhatia failed, without any valid explanation, to provide CCTV footage of these incidents, despite the initial indication that it was available. This can only, in my opinion, have been an attempt to obscure exactly what happened and / or the identity of the seller on that day.
- 13. The premises licence should, in my opinion, be revoked by the Licensing Sub-Committee.
- 14. Trading Standards are proceeding with a criminal investigation, that will cover the underage sale, the illicit tobacco and alcohol found in the shop and the breaches of licence conditions. No decision on an outcome has been made yet, but the matter is undoubtedly of a nature serious enough for legal proceedings against the company and director, Mr Bhatia, to be considered.

I believe this representation is consistent with the LBHF Statement of Licensing Policy and the promotion of the Licensing Objectives.

I fully support the review submitted by the licensing Authority to revoke Newmart's License to sell alcohol or any tobacco products. Sadly my daughter was a victim of Newsmart in underage selling of Alcohol and vapes and ended up in a critical condition in hospital.

On Sunday 27th October at approximately 3pm my daughter ( ) and four of her friends ( ) went into Newsmart and bought a bottle of vodka and two vapes. At no point were they asked for any ID or questioned in any way. 30 minutes later they went back in and bought a further bottle of Vodka. They were clearly underage and look like 13 and 14yr olds.

They then proceeded to drink the Vodka and smoke the Vapes which resulted in four ambulances being called and three children in particular, (including my daughter who is passed out. When the ambulance came my daughter was already in a partial shut down and her blood pressure was dangerously low, one of the other girls was Tachycardia and passed out. We were blue lighted to the hospital, on our way we had to pull over as my daughter's blood pressure dropped again and they had to pull it back up before carrying onto the hospital.

On arrive at A and E, Chelsea and Westminster, they were unable to get a line in her as she was so dehydrated and in a partial shutdown. She required a heat blanket, fluids and it took her 8 hours to come around.

As a result of this and as a mother of three I can honestly say it was one of my darkest days in parenting and the experience has deeply shaken me. My daughter as a result is traumatised by her experience and the horror she inadvertently put us as her family through. I don't hear a siren or look at an ambulance and not remember that night.

The Newsmart should not be able to continue to sell alcohol or tobacco products whilst not adhering to basic safeguarding of our children and teenagers. They have a reputation amongst the local schools for being easy to buy such items underage. The

girls in question have witnessed in the past other children of a similar age procure with no question vapes and vodka.

I hope this supports the review of the above licence.

Please can you ensure my name and any personal information is redacted from this email so my daughter and I remain anonymous. We live locally and need to ensure my child's safety.

RE: Incident Sunday 27th October 2024- Alcohol being sold to children - Askew Road

I fully support the review submitted by the licensing Authority to revoke Newmart's License to sell alcohol or any tobacco products. Sadly my daughter was a victim of Newsmart in underage selling of Alcohol and vapes and ended up in Chelsea & Westminster hospital on 27th October with 2 of her friends.

On Sunday 27th October at around 3-3:30pm 5 young girls aged 13 and 14 (including my daughter) went into Newsmart and bought a bottle of vodka and two vapes. At no point were they asked for any ID or questioned in any way. 30 minutes later they went back in and bought a further bottle of Vodka. They counted out their change in front of the shop attendant and paid for the 2nd bottle with coins. They were clearly underage and look like 13 and 14yr olds.

The 5 girls drank the Vodka and smoked the Vapes which resulted in four ambulances being called and three children in particular, being blue-lighted to hospital as they had passed out. When the paramedics came into the house one girl was already in a partial shut down and her blood pressure was dangerously low, one of the other girls was Tachycardia and passed out. 3 girls were taken to Chelsea and Westminster where they were cared for for 8 hours until 2 of the girls came round. It was a horrific experience.

The Newsmart should not be able to continue to sell alcohol or tobacco products; they have a local reputation amongst the secondary schools that they will sell both alcohol and vapes without asking for any form of identification. They are clearly not adhering to basic safeguarding of our children and teenagers. My daughter was coming home from school just before Christmas and after the event on October 27th and some girls in her school year went into Newsmart and bought several vapes - they are clearly still behaving and selling products to children such as vapes and vodka.

I hope this supports the review of the above licence.

- a ground for review specified in an earlier application for review made in relation to the same premises licence or certificate which has already been determined; or
- representations considered by the licensing authority when the premises licence or certificate was granted; or
- representations which would have been made when the application for the premises licence was first made and which were excluded then by reason of the prior issue of a provisional statement; and, in addition to the above grounds, a reasonable interval has not elapsed since that earlier review or grant.
- 11.13 Licensing authorities are expected to be aware of the need to prevent attempts to review licences merely as a further means of challenging the grant of the licence following the failure of representations to persuade the licensing authority on an earlier occasion. It is for licensing authorities themselves to judge what should be regarded as a reasonable interval in these circumstances. However, it is recommended that more than one review originating from a person other than a responsible authority in relation to a particular premises should not be permitted within a 12 month period on similar grounds save in compelling circumstances or where it arises following a closure order or illegal working compliance order.
- 11.14 The exclusion of a complaint on the grounds that it is repetitious does not apply to responsible authorities which may make more than one application for a review of a licence or certificate within a 12 month period.
- 11.15 When a licensing authority receives an application for a review from a responsible authority or any other person, or in accordance with the closure procedures described in Part 8 of the 2003 Act (for example, closure orders), it must arrange a hearing. The arrangements for the hearing must follow the provisions set out in regulations. These regulations are published on the Government's legislation website (<a href="www.legislation.gov.uk">www.legislation.gov.uk</a>). It is particularly important that the premises licence holder is made fully aware of any representations made in respect of the premises, any evidence supporting the representations and that the holder or the holder's legal representative has therefore been able to prepare a response.

## Powers of a licensing authority on the determination of a review

- 11.16 The 2003 Act provides a range of powers for the licensing authority which it may exercise on determining a review where it considers them appropriate for the promotion of the licensing objectives.
- 11.17 The licensing authority may decide that the review does not require it to take any further steps appropriate to promoting the licensing objectives. In addition, there is nothing to prevent a licensing authority issuing an informal warning to the licence holder and/or to recommend improvement within a particular period of time. It is expected that licensing authorities will regard such informal warnings as an important mechanism for ensuring that the licensing objectives are effectively promoted and that warnings should be issued in writing to the licence holder.
- 11.18 However, where responsible authorities such as the police or environmental health officers have already issued warnings requiring improvement either orally or in writing that have failed as part of their own stepped approach to address concerns, licensing authorities should not merely repeat that approach and should take this into account

when considering what further action is appropriate. Similarly, licensing authorities may take into account any civil immigration penalties which a licence holder has been required to pay for employing an illegal worker.

- 11.19 Where the licensing authority considers that action under its statutory powers is appropriate, it may take any of the following steps:
  - modify the conditions of the premises licence (which includes adding new conditions or any alteration or omission of an existing condition), for example, by reducing the hours of opening or by requiring door supervisors at particular times;
  - exclude a licensable activity from the scope of the licence, for example, to exclude the performance of live music or playing of recorded music (where it is not within the incidental live and recorded music exemption)<sup>10</sup>;
  - remove the designated premises supervisor, for example, because they consider that the problems are the result of poor management;
  - suspend the licence for a period not exceeding three months;
  - revoke the licence.
- 11.20 In deciding which of these powers to invoke, it is expected that licensing authorities should so far as possible seek to establish the cause or causes of the concerns that the representations identify. The remedial action taken should generally be directed at these causes and should always be no more than an appropriate and proportionate response to address the causes of concern that instigated the review.
- 11.21 For example, licensing authorities should be alive to the possibility that the removal and replacement of the designated premises supervisor may be sufficient to remedy a problem where the cause of the identified problem directly relates to poor management decisions made by that individual.
- 11.22 Equally, it may emerge that poor management is a direct reflection of poor company practice or policy and the mere removal of the designated premises supervisor may be an inadequate response to the problems presented. Indeed, where subsequent review hearings are generated, it should be rare merely to remove a succession of designated premises supervisors as this would be a clear indication of deeper problems that impact upon the licensing objectives.
- 11.23 Licensing authorities should also note that modifications of conditions and exclusions of licensable activities may be imposed either permanently or for a temporary period of up to three months. Temporary changes or suspension of the licence for up to three months could impact on the business holding the licence financially and would only be expected to be pursued as an appropriate means of promoting the licensing objectives or preventing illegal working. So, for instance, a licence could be suspended for a weekend as a means of deterring the holder from allowing the problems that gave rise to the review to happen again. However, it will always be important that any detrimental financial impact that may result from a licensing authority's decision is appropriate and proportionate to the promotion of the licensing objectives and for the prevention of illegal working in licensed premises. But where premises are found to be trading irresponsibly, the licensing authority should not hesitate, where appropriate to do so, to take tough

## Reviews arising in connection with crime

- 11.24 A number of reviews may arise in connection with crime that is not directly connected with licensable activities. For example, reviews may arise because of drugs problems at the premises, money laundering by criminal gangs, the sale of contraband or stolen goods, the sale of firearms, or the sexual exploitation of children. Licensing authorities do not have the power to judge the criminality or otherwise of any issue. This is a matter for the courts. The licensing authority's role when determining such a review is not therefore to establish the guilt or innocence of any individual but to ensure the promotion of the crime prevention objective.
- 11.25 Reviews are part of the regulatory process introduced by the 2003 Act and they are not part of criminal law and procedure. There is, therefore, no reason why representations giving rise to a review of a premises licence need be delayed pending the outcome of any criminal proceedings. Some reviews will arise after the conviction in the criminal courts of certain individuals, but not all. In any case, it is for the licensing authority to determine whether the problems associated with the alleged crimes are taking place on the premises and affecting the promotion of the licensing objectives. Where a review follows a conviction, it would also not be for the licensing authority to attempt to go beyond any finding by the courts, which should be treated as a matter of undisputed evidence before them.
- 11.26 Where the licensing authority is conducting a review on the grounds that the premises have been used for criminal purposes, its role is solely to determine what steps should be taken in connection with the premises licence, for the promotion of the crime prevention objective. It is important to recognise that certain criminal activity or associated problems may be taking place or have taken place despite the best efforts of the licence holder and the staff working at the premises and despite full compliance with the conditions attached to the licence. In such circumstances, the licensing authority is still empowered to take any appropriate steps to remedy the problems. The licensing authority's duty is to take steps with a view to the promotion of the licensing objectives and the prevention of illegal working in the interests of the wider community and not those of the individual licence holder.
- 11.27 There is certain criminal activity that may arise in connection with licensed premises which should be treated particularly seriously. These are the use of the licensed premises:
  - for the sale and distribution of drugs controlled under the Misuse of Drugs Act 1971 and the laundering of the proceeds of drugs crime;
  - for the sale and distribution of illegal firearms;
  - for the evasion of copyright in respect of pirated or unlicensed films and music, which does considerable damage to the industries affected;
  - for the illegal purchase and consumption of alcohol by minors which impacts on the health, educational attainment, employment prospects and propensity for crime of young people;
  - for prostitution or the sale of unlawful pornography;
  - by organised groups of paedophiles to groom children;
  - as the base for the organisation of criminal activity, particularly by gangs;

- for the organisation of racist activity or the promotion of racist attacks;
- for employing a person who is disqualified from that work by reason of their immigration status in the UK;
- · for unlawful gambling; and
- for the sale or storage of smuggled tobacco and alcohol.
- 11.28 It is envisaged that licensing authorities, the police, the Home Office (Immigration Enforcement) and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence even in the first instance should be seriously considered.

# Review of a premises licence following closure order or illegal working compliance order

- 11.29 Licensing authorities are subject to certain timescales, set out in the legislation, for the review of a premises licence following a closure order under section 80 of the Anti-social Behaviour, Crime and Policing Act 2014 or an illegal working compliance order under section 38 of and Schedule 6 to the Immigration Act 2016. The relevant time periods run concurrently and are as follows:
  - when the licensing authority receives notice that a magistrates' court has made a closure order it has 28 days to determine the licence review – the determination must be made before the expiry of the 28th day after the day on which the notice is received;
  - the hearing must be held within ten working days, the first of which is the day after the day the notice from the magistrates' court is received;
  - notice of the hearing must be given no later than five working days before the first hearing day (there must be five clear working days between the giving of the notice and the start of the hearing).

# Review of a premises licence following persistent sales of alcohol to children

11.29 The Government recognises that the majority of licensed premises operate responsibly and undertake due diligence checks on those who appear to be under the age of 18 at the point of sale (or 21 and 25 where they operate a Challenge 21 or 25 scheme). Where these systems are in place, licensing authorities may wish to take a proportionate approach in cases where there have been two sales of alcohol within very quick succession of one another (e.g., where a new cashier has not followed policy and conformed with a store's age verification procedures). However, where persistent sales of alcohol to children have occurred at premises, and it is apparent that those managing the premises do not operate a responsible policy or have not exercised appropriate due diligence, responsible authorities should consider taking steps to ensure that a review of the licence is the norm in these circumstances. This is particularly the case where there has been a prosecution for the offence under section 147A or a closure notice has been given under section 169A of the 2003 Act. In determining the review, the licensing authority should consider revoking the licence if it considers this appropriate.

#### 1. THE APPLICATION

On the 24<sup>th</sup> December 2024, the Licensing Authority received a valid application for a new premises licence in respect of the premises known as MG Food & Wine, 143 Askew Road, London, W12 9AU submitted by Manpreet Singh Kapoor of Personal Licence Courses UK on behalf of, Mandeep Singh Bhatia ("the applicant").

#### 1.1 Application Requested

The applicant has applied for a new premises licence for the sale of alcohol off the premises only as outlined below:

Sale by Retail of Alcohol - Off the Premises

Mondays to Sundays 08:00 to 23:00

Proposed Opening Hours:

Mondays to Sundays 08:00 to 23:00

A copy of the application form and plan can be seen on pages **90-109** of this report.

### 1.2 Applicants Operating Schedule

The applicant has proposed a number of steps to promote the four licensing objectives if the application is granted. A copy of the proposed conditions can be seen on pages **99-101** of this report.

#### 2. BACKGROUND

The premises currently benefit from a premises licence which is held by Mr Subir Singh Bhatia, under the reference 2023/01949/LAPR. This premises licence is currently under review which is due to be heard before the Licensing Sub-Committee on the 17<sup>th</sup> February 2025. The main access to the premise's is located on Askew Road. The premises intend to operate as an off-licence convenience store. There is a mixture of both residential and commercial premises within the area. A map showing the location of the premises and neighbouring licensed premises can be seen on page **110-131** of this report.

There are several options for transport away from the area including buses and taxis which run from in and around Askew Road area. Stamford Brook tube station is a 15-minute walk away, Ravenscourt Park tube station is a 17-minute walk away and Goldhawk Road tube Station is a 19-minute walk away.

#### 3. CONSULTATION

A public notice was displayed at the premises for 28 days. The application was advertised in a local circular and all statutory consultees were notified as required by the Regulations.

The Council has served written notice of hearing upon the applicant and all those parties that have made representations in respect of the application.

#### 3.1. Relevant Representations

The licensing section received one representation objecting to the licence application from Mr Adrian Overton on behalf of the Licensing Authority. A copy of the representation can be seen on page **132** of this report.

The licensing section received two representations objecting to the licence application from local residents. A copy of the representation can be seen on pages **133-136** of this report.

#### 4. OTHER INFORMATION

#### 4.1 Enforcement History

On the 6<sup>th</sup> November 2024, Trading Standards and Licensing Enforcement officers made a joint visit to the premises with a letter requesting CCTV footage to be produced. A full licensing inspection was carried out and breaches of conditions 9, 10, 12, 13, 14, 18 and 19 attached to the premises were identified. A verbal warning was given, and the inspection sheet was left at the premises as a warning letter.

On the 11<sup>th</sup> November 2024, Licensing Enforcement officer visited the premises accompanied by a Law Enforcement Officer ("LET"). Licensing Enforcement identified breaches of conditions 1, 4, 5, 7, 9, 13, 14, 15, 16 and 18 attached to the premises licence. A verbal waning was given, and the inspection sheet was left at the premises as a warning letter.

On the 9<sup>th</sup> December 2024, a PACE interview under caution was carried out by Licensing and Trading Standard officers with the current premises licence holder and his representative in attendance. The PACE interview was undertaken in relation to an incident which occurred at the premises surrounding sales of alcohol to persons under 18 years old. Following the PACE interview, the premises licence holder has been informed he will be reported for possible prosecution.

## 4.2 Temporary Event Notices ("TENs")

There have been no TENs which have been submitted in respect of this premises in the past twelve months.

#### 5. POLICY CONSIDERATIONS

**5.1** Section 2 pages 7 and 8 of the Statement of Licensing Policy ("SLP") states the Licensing Authority is keen to support the licensed sector and leisure offer within the borough, with a particular focus on business resilience and growing a robust and thriving cultural and leisure sector.

To achieve this the Licensing Authority has identified three key themes of the Licensing Policy and the Licensing Authority's approach to implementing it. These are:

- A sustainable, well-run licensed sector;
- Hammersmith & Fulham as a good place to live, work and enjoy leisure; and,

- A safe licensing environment and night-time economy.
- **5.2** Section 5 pages 12 and 13 of the SLP states that in order to ensure the promotion of the four Licensing Objectives the Licensing Authority will require applicants to detail in their operating schedule:
  - the steps proposed to promote the licensing objective of the prevention of crime and disorder on, and in the vicinity of, the premises, having regard to their location, character, condition, the nature and extent of the proposed use and the persons likely to use the premises;
  - the steps proposed to ensure the physical safety of people using the relevant premises or place;
  - how they intend to prevent nuisance arising, prevent disturbance and protect amenity so far as is appropriate to ensure that the Licensing Objectives are met.
     Where there is a relevant representation regarding extended hours, the Licensing Authority will not permit an extension unless it is satisfied that the Licensing Objectives would be met;
  - the measures and management controls in place to protect children from harm. Where appropriate a written childcare policy should be available and be incorporated in the induction of staff.
- **5.3** Section 7 pages 13 to 15 of the SLP states that operating schedules for premises licences are the key to ensuring compliance with the four Licensing Objectives. The measures proposed in the operating schedule will normally be converted into conditions to be attached to the premises licence and should therefore fulfil the following criteria:
- (i) Be precise and enforceable
- (ii) Be unambiguous
- (iii)Not duplicate other statutory provisions
- (iv)Be clear in what they intend to achieve, and
- (v) Be appropriate, proportionate and justifiable

Operators of licensed premises will have to comply with planning, environmental health, trading standards, fire safety, licensing and building control legislation when opening or adapting licensed premises. The Licensing Authority will seek to avoid confusion and duplication by not imposing licence conditions relating to matters that are required or controllable under other legislation, except where they can be exceptionally justified to promote the Licensing Objectives.

For sales of alcohol for consumption off the premises – applicants in respect of off licences and other premises selling alcohol for consumption off the premises may need to consider whether:

- there are shutters to prevent alcohol from being selected in non-licensed periods.
- there are appropriate numbers of staff on duty to deal with possible 'intimidation' to sell alcohol.
- there are restrictions required on the sale of low price, high strength alcohol and drink promotions.
- an incident log book is available to record incidents.
- there are measures in place necessary to prevent underage sales.
- there are measures in place necessary to prevent alcohol from being sold outside permitted hours where the operating hours of the premises exceed those for the sale of alcohol.

- there are procedures in place to prevent sales of alcohol to intoxicated persons (with particular attention to street drinkers) or individuals leaving premises in the vicinity such as a late night bar; where there is evidence to suggest this is a problem the Licensing Authority may require a temporary cessation of alcohol sales during high risk times.
- **5.4** Policy 1 page 18 confirms that The Secretary of State's Guidance states that applicants are expected to obtain sufficient information to enable them to demonstrate, the steps they propose to take to promote the licensing objectives; and that they understand the layout of the local area and physical environment including:
- a) crime and disorder hotspots;
- b) proximity to residential premises;
- c) proximity to areas where children may congregate;
- d) any risk posed to the local area by the applicants' proposed licensable activities; and
- e) participation in any local initiatives (for example, local crime reduction initiatives or voluntary schemes, such as 'Ask for Angela', local taxi-marshalling schemes, street pastors and other schemes) which may help to mitigate potential risks.

Applicants are expected to include positive proposals in their application on how they will manage any potential risks.

The Guidance goes on to state that 'Applicants are expected to provide licensing authorities with sufficient information in this section to determine the extent to which their proposed steps are appropriate to promote the licensing objectives in the local area. Applications must not be based on providing a set of standard conditions to promote the licensing objectives and applicants are expected to make it clear why the steps they are proposing are appropriate for the premises.'

The Licensing Authority notes the contents of these paragraphs from the Secretary of State's Guidance and, in particular, the use of the word 'expected'. Licence applications that do not in any way address the contents of these paragraphs in their operating schedules may be returned to the applicant as 'incomplete'.

- **5.5** Policy 3 page 21 and 22 of the SLP states that where there is a relevant representation, the Licensing Authority will consider each particular case on its merits having regard in particular to the following matters:
- a) Whether the licensed activities are likely to have an adverse impact especially on local residents and, if there is potential to have an adverse impact, what, if any, appropriate measures will be put in place to prevent it;
- b) Whether there will be a substantial increase in the cumulative adverse impact from these or similar activities, on an adjacent residential area;
- c) Whether there is a suitable level of public transport accessibility to and from the premises at the appropriate times;
- d) Whether the activity will be likely to lead to a harmful and unmanageable increase in car parking demand in surrounding residential streets suffering high levels of parking stress or on roads forming part of the Strategic London Road Network or the London Bus Priority Network leading to a negative impact on the Licensing Objectives relating to the prevention of crime, disorder, anti-social behaviour (ASB), nuisance and vehicle emissions;
- e) Whether there have been any representations made by Responsible Authorities, or other relevant agency or representative.

The Licensing Authority will closely scrutinise extended hours applications to ensure that the Licensing Objectives are met. In determining an application the licensing committee might decide that the circumstances are such that a restriction on hours is the only appropriate means to achieve the Licensing Objectives. If an 'hours' restriction is imposed, the Licensing Authority will normally require that customers should be allowed a minimum of thirty minutes to consume alcohol.

To act as a guide for new or existing operators we have set out the suggested closing times for licensed premises below:

Type of premises	Town centres	Mixed use areas	Residential areas
Off-licences and alcohol sales in supermarkets	23:00 daily	23:00 daily	22:00 daily

**5.6** Policy 4 pages 22 and 23 of the SLP states that in determining an application where there has been a relevant representation the Licensing Authority will, where appropriate, take into account the cumulative effect of the number, type and density of licensed premises already existing in the area. Consideration will be given to the proximity to any drug and alcohol treatment site, A&E department or homeless hostel in a local area type remit ie applicants need to make the case for how they would not increase further problems for residents/clients nearby.

In coming to any decision regarding cumulative impact the Licensing Authority will consider other mechanisms outside of the licensing regime which may also be available to address this issue, these include but are not limited to:

- Police and other enforcement of the normal law concerning disorder and anti-social behaviour
- Prosecution or other enforcement of any personal licence holder or member of staff at such premises who is selling alcohol to people who are drunk
- Prosecution or other enforcement of any personal licence holder or member of staff at such premises who is selling to underage persons or selling illegal alcohol or tobacco
- Police powers to close down instantly any licensed premises or temporary events on grounds of disorder, the likelihood of disorder or excessive noise emanating from the premises, for up to 24 hours. The power of the police, other responsible authorities, a local resident, business or Councillor to seek a review of the licence or certificate in question.
- Police and Local Authority power to issue a Closure Notice for up to 48 hours where serious antisocial behaviour is taking place at licensed premises under the Anti-social Behaviour, Crime and Policing Act 2014.
- To ensure that residents are protected from the negative impact of late-night local licensing activities the Licensing Authority may decide to adopt an Area Specific Cumulative Impact Policy in relation to a specific area; where the number, type and density of premises providing licensable activities is having a serious negative impact on the local community and local amenities.
- **5.7** Policy 11 pages 29 and 30 of the SLP states that Licensing law is not the primary mechanism for the general control of nuisance and anti-social behaviour caused by people once they are away from the licensed premises and, therefore, beyond the direct control of

the licensee. However, licensing is a key aspect of such control and licensing law is part of a holistic approach to the management of the night-time economy.

As a matter of policy the council expects every holder of a licence, certificate or permission, to accept and be responsible for minimising the impact of their activities and anti-social behaviour by their patrons within the vicinity of their premises by taking appropriate measures and action consistent with that responsibility.

Licensees and certificate holders should take reasonable steps to prevent the occurrence of crime and disorder and public nuisance immediately outside their premises, for example on the pavement, in a beer garden or in a smoking area, to the extent that these matters are within their control.

Population densities in this borough are high, with many residential premises located above or in close proximity to licensed premises. This means that the public nuisance and crime and disorder objectives will be of paramount concern when evaluating Operating Schedules. Licensing Committees will place high regard on the control measures put in place by the applicant to ensure that our residents are protected from the potential detrimental effects of any licensed premises.

- **5.8** Policy 12 pages 30 and 31 of the SLP states that we are committed to the Regulators Code and supporting businesses.
- i) We will work with businesses in our borough and provide the advice you need to help you comply with the law. This may be through meeting with you at your premises or at our offices, providing written advice in an email or letter or verbally over the telephone.
- ii) We will usually confirm any technical/ legal advice in writing. For applicants and agents, we also offer a pre-application advice service. Further details about this service can be found on our website.
- iii) We will attend pub watch meetings and work with local businesses, including the Hammersmith Business Improvement District (BID) and Fulham BID, to help facilitate the sharing of information and advice amongst licensees in our borough.
- iv) We are continuously working to improve our online application process for a range of licence permissions. If you want to know what services are available or you want to make an application online, please check our website for further details.
- v) We want to ensure that businesses comply with the law. Where this has not been possible through advice and education, we will carry out enforcement action in accordance with our enforcement policy and as part of our commitment to the Regulators Code.
- vi) We want local businesses in our borough to thrive and survive. We recognise that the law can be complex at times and that despite trying to resolve issues through discussion in the first instance, enforcement will be necessary on some occasions. We also recognise that attitudes, circumstances and personnel often change over time.

Where enforcement action has been taken against a business in the past, relevant Responsible Authorities will be mindful of this when considering any new applications. However, all new applications e.g. variations to hours or licensable activities will be decided on their merits and the information provided to demonstrate promotion of the four licensing

objectives. Where a premises licence or club premises certificate has previously been reviewed or the business has been prosecuted for licensing offences, licensees are advised to discuss any new/proposed changes with the Licensing Authority and/or the relevant Responsible Authority e.g. The Police, to resolve any ongoing concerns and/or issues.

- **5.9** Policy 16 of the SLP pages 33 and 34 of the SLP in relation to the safety of women and girls in licensed settings states that the Licensing Authority expects licence applications to specifically include measures to ensure the safety of women and girls in licensed premises. The Licensing Authority will use its powers to regulate the night-time economy, both with specific regard to spiking incidents and more generally in relation to violence against women and girls. This may include:
- a) Using the Licensing Authority's powers to impose conditions or revoke premises licenses, where venues do not take sufficient measures to protect and provide support to customers in spiking incidents;
- b) Considering the prevalence, prevention and reporting of sexual harassment and misconduct and gender-based violence in licensed premises.
- c) Requiring the presence of suitably trained and accredited door staff,
- d) Require presence of CCTV, or to introduce entry searches for example.

Licence applicants and existing licence holders are encouraged to include in their operating schedules clear polices relating to potential abuse or violence against women and girls.

This would include but is not limited to the 'Ask for Angela' programme, Welfare and Vulnerability Engagement' training package (WAVE) for staff to identify and assist women and girls being at risk or being subjected to violence, and the implementation of clear policies in the premises on preventing and addressing violence against women and girls. The Licensing Authority would also encourage off licensed premises to take part in the Ask for Angela scheme in an effort to increase the visible promotion of the scheme in all licensed premises across the borough.

Implementing these measures, particularly for on-licence premises, providing training for staff to increase awareness and provide skills and tools for identifying and assisting when it is at risk of happening or is happening, and having clear policies against violence against women and girls provide a solid basis for addressing the issue when it occurs in licensed premises. Furthermore, having policies on staff reporting incidents to Police and Council officers will help to ensure that these incidents are addressed.

As part of the Government's and the Council's Violence Against Women and Girls Strategy, venues may also wish to consider boosting their security measures e.g. the recruitment and training of additional door security staff, particularly female staff.

The Council are proud supporters of the Women's Night Safety Charter, and we would like to encourage all our licensed premises to consider how you and your business can contribute to making your workplace and H&F a borough where all women feel confident and welcome whenever and wherever they happen to be. The Women's Night Safety Charter is a voluntary pledge to show you take women's safety seriously. By signing the Charter, you show your acknowledgement of the issue and that you're ready to get proactive in improving women's safety.

- **5.10** Annex 1 pages 35 and 36 of the SLP in relation to the prevention of crime and disorder states licence applicants will be expected to demonstrate the following in their operating schedules:
- a) Measures to control excessive consumption and intoxication.
- b) Consideration of any additional measures or restrictions that may be placed on alcohol sales to prevent binge drinking and promote 'sensible drinking'.
- c) Operators of off-licences in areas problems relating to street drinking and underage drinking are prevalent, measures should be outlined to strictly monitor the way alcohol is sold, specifically where the premises are located close to schools and hostels and similar premises that provide shelter or services to alcohol dependent persons.
- d) It is important to ensure that staff working at off licences are suitably trained and receive appropriate refresher training in their responsibilities under the Act and can discharge their duties in full compliance with the licence conditions and requirements of the Act. This includes the ability to competently check a customer's age with acceptable forms of identification where necessary. The Licensing Authority will particularly consider the following matters where they are material to the individual application:
- i. The likelihood of any violence, public order or policing problem if the licence is granted;
- ii. The measures taken to control admission to the premises, and to take reasonable steps to prevent the occurrence of crime and disorder and public nuisance immediately outside the premises, where and to the extent that these matters are within their control.
- iii. Past conduct and prior history of complaints against the premises.
- iv. Whether a dispersal policy has been prepared to minimise the potential for disorder as customers leave the premises; and
- v. Any relevant representations.
- g) Conditions will, so far as possible, reflect local crime prevention strategies, and the Licensing Authority will also have regard to the views of the local Crime and Disorder Reduction Partnership.

The following provides a non-exhaustive list of risks associated with the crime and disorder objective that applicants may want to consider when preparing their Operating Schedule:

- j) CCTV using CCTV inside and/or outside the premises together with appropriate procedures and having staff properly trained to use CCTV equipment.
- I) dealing with and reporting crime and disorder training for staff and door security aimed at reducing crime and disorder in the premises and its vicinity and dealing with and reporting incidents if they occur.
- o) excessive drinking training for staff to recognise when customers are becoming drunk and adopting appropriate 'cut off' procedures for drunken customers, so as to reduce the likelihood of fights or aggressive behaviour.
- **5.11** Annex 1 page 37 and 38 of the SLP in relation to public safety states the Licensing Authority will require the applicant to demonstrate the steps proposed to ensure the physical safety of people using the relevant premises or place. This does not cover the separate need for applicants to provide relevant public safety requirements dealt with by Environmental Health.

The following provides a non-exhaustive list of risks associated with the public safety objective that applicants may want to consider when preparing their Operating Schedule:

e) incident and occurrence book – keeping an incident book on the premises so staff can record any instances of crime, disorder, refused sales, ejections and intimidating behaviour.

**5.12** Annex 1 pages 38 and 39 of the SLP in relation to the prevention of public nuisance states that the Licensing Authority will require the applicant to demonstrate within the operating plan how they intend to prevent nuisance arising, prevent disturbance and protect amenity so far as is appropriate to ensure that the Licensing Objectives are met.

This is expected to include:

- a) In considering an application, the Licensing Authority will consider the adequacy of proposed measures to remove or effectively manage the potential for public nuisance and anti-social behaviour and any Public Spaces Protection Orders (PSPOs) in place.
- b) Licensing Authority will particularly consider the following matters where they are material to the individual application:
- ii. The proximity of residential accommodation.
- iii. The type of use proposed, including the likely numbers of customers, proposed hours of operation and the frequency of activity.
- xvii. The history of the applicant in controlling anti-social behaviour and preventing nuisance. xix. Any other relevant activity likely to give rise to nuisance.
- xx. Any representations made by the Police, or other relevant agency or representative.
- **5.13** Annex 1 pages 40 and 41 of the SLP in relation to the protection of children from harm states the Licensing Authority will require operating plans to specify the measures and management controls in place to protect children from harm. Where appropriate a written childcare policy should be available and be incorporated in the induction of staff. This is expected to include:
- b) The Licensing Authority will particularly consider whether:
- vi. There are licensable activities that are likely to appeal to minors/children under 16 taking place during times when children under 16 may be expected to be attending compulsory full-time education:
- c) The sale of alcohol to a minor is a criminal offence and Trading Standards officers will conduct appropriate covert test purchasing exercises and will take account of any complaints and intelligence. The Act permits the use of children under the age of 18 to undertake test purchases when they have been directed to do so by a duly authorised officer. d) Where a sale of alcohol has been made on the same premises to a minor on two or more different occasions within a period of three months the premises licence could be suspended for a defined period.
- g) The Licensing Authority will expect operating plans to specify the measures and management controls in place to prevent alcohol being served to children, other than in those limited circumstances permitted by the Act. The Council's Trading Standards officers have a role to play in the protection of children from harm, and proof of age schemes, and are able to provide advice in relation to measures that can be taken to help prevent the sale of alcohol to underage children. Potential licence holders should also be aware of the Proof of Age London (PAL) Scheme hosted by Southwark Council.
- i) Where premises are subject to age-restrictions, the procedures in place to conduct age verification checks. The Council will expect premises only to accept current passports, driving licences or documents bearing the national PASS logo, such as Citizencard. The Proof of Age Standards Scheme (PASS) is the UK's national guarantee scheme for proof-of-age cards as endorsed by the Home Office. More information can be found on The Proof of Age Standards Scheme (PASS) website.

#### 6. DETERMINATION

- **6.1** In determining this application, the Committee must have regard to the representations and take such of the following steps as it considers necessary for the promotion of the licensing objectives. The steps are:
- (a) Grant the application in full
- (b) Grant the application in part modifying the proposed hours, activities or conditions.
- (c) Reject the application

It is the Council's duty under the Licensing Act 2003 ("The Act") to determine applications with a view to promoting the four licensing objectives; Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance and the Protection of Children from Harm.

In reaching a decision the Council shall consider the details of any relevant representations received; the applicant's Operating Schedule; the Council's adopted Statement of Licensing Policy and the guidance issued by the Secretary of State under section 182 of the Act.

If the Committee is minded to grant the application conditions may be attached to the licence to alleviate the concerns raised through the representations.

#### b) The prevention of crime and disorder

- 1. The premises shall install and maintain a comprehensive CCTV system which records 24 hours a day. All CCTV recordings shall be stored for a minimum period of 31 days and all recordings will be stamped with the correct date and time. Viewing of recordings shall be made available, subject to Data Protection legislation, immediately upon the request of Police or an authorised council officer.
- 2. That licensing activities are only carried out at the premises at times when the CCTV system is fully operational
- 3. A staff member from the premises who is conversant with the operation of the CCTV system shall always be on the premises when the premises are open. - 9. All staff employed at the premises will have UK right to work status checked, once passed that stage they shall be offered employment.
- 10. Any alcohol sold for consumption off the premises shall be sold in a sealed container.
- 11. Strong beer, lager, cider and stout above 5.5% ABV shall not be displayed or sold.
- 12. Previous management who owned this business or had any involvement Mr Subir Singh Bhatia and his son shall not be allowed to enter the property, they shall be banned from the premises.

NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

## Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

#### Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is A British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A current Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, when produced in combination with an
  official document giving the person's permanent National Insurance number and their name issued by a
  Government agency or a previous employer.

- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder
  with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not
  subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity
  when produced in combination with an official document giving the person's permanent National Insurance
  number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK
  with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or
  reasonable evidence that the person has an appeal or administrative review pending on an immigration
  decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but
  who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in
  the UK including:-
  - evidence of the applicant's own identity such as a passport,
  - evidence of their relationship with the European Economic Area family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and
  - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
    - (i) working e.g. employment contract, wage slips, letter from the employer,
    - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
    - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
    - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

**Original documents must not be sent to licensing authorities.** If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

#### Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <a href="https://www.gov.uk/prove-right-to-work">https://www.gov.uk/prove-right-to-work</a>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. - Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
  - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
  - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the
  audience does not exceed 500. However, a performance which amounts to adult entertainment remains
  licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
  - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
  - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
  - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
  - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

I attach the account below of the afternoon my daughter was a victim of such a sale.

RE: Incident Sunday 27th October 2024- Alcohol being sold to minors - Askew Road

I fully support the review submitted by the licensing Authority to revoke Newmart's License to sell alcohol or any tobacco products. Sadly my daughter was a victim of Newsmart in underage selling of Alcohol and vapes and ended up in a critical condition in hospital.

On Sunday 27th October at approximately 3pm my daughter (and and four of her friends (and and two vapes. At no point were they asked for any ID or questioned in any way. 30 minutes later they went back in and bought a further bottle of Vodka. They were clearly underage and look like 13 and 14yr olds.

They then proceeded to drink the Vodka and smoke the Vapes which resulted in four ambulances being called and three children in particular, (including my daughter who is passed out. When the ambulance came my daughter was already in a partial shut down and her blood pressure was dangerously low, one of the other girls was Tachycardia and passed out. We were blue lighted to the hospital, on our way we had to pull over as my daughter's blood pressure dropped again and they had to pull it back up before carrying onto the hospital.

On arrive at A and E, Chelsea and Westminster, they were unable to get a line in her as she was so dehydrated and in a partial shutdown. She required a heat blanket, fluids and it took her 8 hours to come around.

As a result of this and as a mother of three I can honestly say it was one of my darkest days in parenting and the experience has deeply shaken me. My daughter as a result is traumatised by her experience and the horror she inadvertently put us as her family through. I don't hear a siren or look at an ambulance and not remember that night.

The Newsmart should not be able to continue to sell alcohol or tobacco products whilst not adhering to basic safeguarding of our children and teenagers. They have a reputation amongst the local schools for being easy to buy such items underage. The girls in question have witnessed in the past other children of a similar age procure with no question vapes and vodka.

I hope this supports the review of the above licence.

Please can you ensure my name and any personal information is redacted from this email so my daughter and I remain anonymous. We live locally and need to ensure my child's safety.

Dear Mercy and Zarar

I write to you as Chair and councillor of the Licensing committee as I wish to make a representation to application: 2024/02120/LAPR.

There are concerns that the new licence holder at 143 Askew Road, Mandeep Singh Bhatia may have a direct connection to the previous licence holder. I have serious concerns if this is to be granted due to an incident that occurred on 27th October 2024 concerning children of ages 13 and 14 in our community, being sold vodka and vapes and ending up with 3 minors in a serious way unconscious in Chelsea and Westminster hospital.

Please see below the outline of this incident. I hope this supports the review of this new licence.

## Kind regards

On Sunday 27th October at around 3-3:30pm 5 young girls aged 13 and 14 (including my daughter) went into Newsmart and bought a bottle of vodka and two vapes. At no point were they asked for any ID or questioned in any way. 30 minutes later they went back in and bought a further bottle of Vodka. They counted out their change in front of the shop attendant and paid for the 2nd bottle with coins. They were clearly underage and look like 13 and 14yr olds.

The 5 girls drank the Vodka and smoked the Vapes which resulted in four ambulances being called and three children in particular, being blue-lighted to hospital as they had passed out. When the paramedics came into the house one girl was already in a partial shut down and her blood pressure was dangerously low, one of the other girls was Tachycardia and passed out. 3 girls were taken to Chelsea and Westminster where they were cared for for 8 hours until 2 of the girls came round. It was a horrific experience.

The Newsmart should not be able to continue to sell alcohol or tobacco products; they have a local reputation amongst the secondary schools that they will sell both alcohol and vapes without asking for any form of identification. They are clearly not adhering to basic safeguarding of our children and teenagers. My daughter was coming home from school just before Christmas and after the event on October 27th and some girls in her school year went into Newsmart and bought several vapes - they are clearly still behaving and selling products to children such as vapes and vodka.
