Late Night Refreshment (Indoors and Outdoors):

Monday and Tuesday: 23:00 to 01:00

Wednesday: 23:00 to 02:00.

Thursday to Saturday: 23:00 to 03:00

Sunday: 23:00 to 00:00

Performance of Live Music, Recorded Music, Films, Dance and Anything Similar to

<u>Live Music, Recorded Music or Dance (Indoors and Outdoors):</u>

Monday and Tuesday: 11:00 to 01:00.

Wednesday: 11:00 to 02:00.

Thursday to Saturday: 11:00 to 03:00

Sunday: 11:00 to 00:00

2. The opening hours of the Premises are as follows: -

Hours Open to the Public:

Monday and Tuesday: 11:00 to 01:00

Wednesday: 11:00 to 02:00

Thursday to Saturday: 11:00 to 03:00

Sunday: 11:00 to 00:00

- 3. The licence is subject to any mandatory conditions.
- 4. The licence is subject to the conditions proposed by the Applicant as amended by the Committee
- 5. The licence is subject to the conditions proposed by the Police and agreed by the Applicant

This licence becomes operational with immediate effect. If problems are experienced, then an application for a review of the premises licence can be made.

A copy of this Committee's full decision including its reasons and the full text of the conditions added to the licence will be sent to the parties forthwith.

If the Applicant or any person who has made a relevant representation is unhappy with the decision they are entitled to appeal to the magistrates' court within 21 days from the date of notification of the full decision
