1. REVIEW APPLICATION:

On 16 September 2025, an application for a review of a premises licence under Section 51 of the Licensing Act 2003 (the Act) was served by the Metropolitan Police ("The Applicant"). The review application was made in respect of AB Wines – 218 Uxbridge Road, London, W12 7JD ("the Premises") held by Lexcom Management Services Ltd ("the Premises Licence Holder").

It is not the purpose of this report to reiterate the far-ranging submission made by the Police. However, as Appendix 1 shows, the original review application was made on the grounds of the prevention of crime and disorder and prevention of public nuisance. The Police have subsequently supplied additional information to support their application, which can be found at Appendix 2.

2. CURRENT LICENCE:

The current premises licence, which can be found at Appendix 3 and was originally granted on 19 August 2005 (and in the possession of the current premises licence holder since 20 February 2009), allows for the following activities:

Sale of Alcohol (Off the Premises)

Monday to Saturday: 11:00 to 23:00. Sunday: 11:00 to 22:30.

Hours Premises Open to the Public

Monday to Saturday: 09:00 to 23:00. Sunday: 10:30 to 22:30.

3. BACKGROUND:

The main access to the proposed premises is located on Uxbridge Road and the premises operates as an off-licence. The immediate area around the application site could reasonably be described as a mixed area owing to the presence of commercial and residential dwellings around the site. A map showing the location of the premises and neighbouring licenced premises can be found in Appendix 4.

4. CONSULTATION:

A public notice was displayed at the premises for 28 days and all statutory consultees were notified as required by the Regulations, as well as a notice being put up at the Town Hall. The Council has served written notice of hearing upon the Applicant and all those parties that have made Representations in respect of the Application.

4.1 Relevant Representations:

During the consultation period, representations were received from the following people and groups:

• The Council's Community Safety Team (Appendix 5).

- 37 individual representors supporting the review (Appendix 6).
- 9 individual representors opposing the review (Appendix 7)

As can be shown from Appendix 8, these comments, along with additional supporting evidence from the Police, were submitted to the Premises Licence Holder's Agent on 21 October 2025. No specific response has been received back from the Premises Licence Holder or their Agent thus far.

5. OTHER INFORMATION:

5.1 Enforcement History:

5.2 Temporary Event Notices ("TENs"):

There is no recent history of TENs being applied for in respect of this premises.

6. POLICY CONSIDERATIONS:

- 6.1 It is the Council's duty under the Act to determine the review with a view to promoting the four licensing objectives:
 - Prevention of crime and disorder;
 - Public safety;
 - Prevention of public nuisance;
 - Protection of children from harm.
- 6.2 In reaching a decision, the Council must have regard to its adopted Statement of Licensing Policy ("SLP") and the Guidance issues by the Secretary of State under Section 182 of the Act (the Guidance), both of which can be found below:

Members should be aware that Paragraphs 11.16 to 11.28 of the aforementioned Guidance in particular, which can be found in Appendix 10, gives advice on the review of a premises licence. So too does the Council's SLP.

6.3 Policy 10 pages 28 and 29 of the SLP in relation to reviews states that the Act describes two "groups" that may make representations to applications and may apply for an existing premises licence or club premises certificate to be reviewed by the Licensing Authority. These groups are Responsible Authorities and "Other Persons".

At any stage, following the grant of a premises licence, a Responsible Authority, such as the Police or the Fire Authority, or other persons, may apply for a licence to be reviewed because of a matter arising at the premises in connection with any of the four Licensing Objectives.

A licence may be reviewed where it is alleged that the Licensing Objectives are not being promoted and there is evidence to show this. Guidance on grounds for a review are outlined in Annex 5 of the SLP.

- 6.4 Policy 11 pages 29 and 30 of the SLP states that in in relation to the consideration of residents, the Licensing Authority expects that any licence applicant will give due consideration to the needs of Hammersmith & Fulham residents and any negative impacts from licensable activities and business operations.
 - Any review of a licence would need to be evidence based and as such is best supported by evidence from responsible authorities such as the Police or Environmental Health to be successful.
- 6.5 Policy 16 pages 33 and 34 of the SLP in relation to the safety of women and girls in licensed settings states that the Licensing Authority expects licence applications to specifically include measures to ensure the safety of women and girls in licensed premises. The Licensing Authority will use its powers to regulate the night-time economy, both with specific regard to spiking incidents and more generally in relation to violence against women and girls. This may include:
 - a) Using the Licensing Authority's powers to impose conditions or revoke premises licenses, where venues do not take sufficient measures to protect and provide support to customers in spiking incidents;

- b) Considering the prevalence, prevention and reporting of sexual harassment and misconduct and gender-based violence in licensed premises.
- c) Requiring the presence of suitably trained and accredited door staff,
- d) Require presence of CCTV, or to introduce entry searches for example. Licence applicants and existing licence holders are encouraged to include in their operating schedules clear polices relating to potential abuse or violence against women and girls.

This would include but is not limited to the 'Ask for Angela' programme, Welfare and Vulnerability Engagement' training package (WAVE) for staff to identify and assist women and girls being at risk or being subjected to violence, and the implementation of clear policies in the premises on preventing and addressing violence against women and girls. The Licensing Authority would also encourage off licensed premises to take part in the Ask for Angela scheme in an effort to increase the visible promotion of the scheme in all licensed premises across the borough.

Implementing these measures, particularly for on-licence premises, providing training for staff to increase awareness and provide skills and tools for identifying and assisting when it is at risk of happening or is happening, and having clear policies against violence against women and girls provide a solid basis for addressing the issue when it occurs in licensed premises. Furthermore, having policies on staff reporting incidents to Police and Council officers will help to ensure that these incidents are addressed.

As part of the Government's and the Council's Violence Against Women and Girls Strategy, venues may also wish to consider boosting their security measures e.g. the recruitment and training of additional door security staff, particularly female staff.

The Council are proud supporters of the Women's Night Safety Charter https://hammersmithbid.co.uk/womens-night-safety-charter/, and we would like to encourage all our licensed premises to consider how you and your business can contribute to making your workplace and H&F a borough where all women feel confident and welcome whenever and wherever they happen to be. The Women's Night Safety Charter is a voluntary pledge to show you take women's safety seriously. By signing the Charter, you show your acknowledgement of the issue and that you're ready to get proactive in improving women's safety.

6.6 Annex 4 page 52 of the SLP in relation to the grounds for considering a review states that the Licensing Authority will regard applications for the review of any premises licence particularly seriously where they involve evidence of:

- a) Use of licensed premises for the sale and distribution of drugs and the laundering of drugs money;
- b) Use of licensed premises for the sale and distribution of illegal firearms and the laundering of illegal firearms money;
- c) Evasion of copyright in respect of pirated or unlicensed films and music;
- d) Underage sales and consumption of alcohol;
- e) Use of a licensed premises contrary to any emergency legislation requesting its closure;
- f) Use of licensed premises for prostitution or the sale of unlawful pornography;
- g) Serious risks to children;
- h) Use of licensed premises for unlawful gaming and gambling;
- i) Use of licensed premises as a base for organised criminal activity;
- j) Use of licensed premises for the organisation of racist, homophobic, sexual abuse, attacks or any discriminatory behaviour;
- k) Use of licensed premises for storing or selling illegal alcohol or tobacco or smuggled goods;
- I) The use of licensed premises for the sale of stolen goods;
- m)Incidents of disorder;
- n) Instances of public nuisance where warnings have been disregarded;
- o) Serious risks to public safety which the management is unable or unwilling to correct;
- p) Frequently operating outside permitted hours.
- q) There may be legal implications if activity of child sexual exploitation (CSE) is taking place on licensed premises and there has been a failure to demonstrate due diligence or that adequate safeguards are in place this may lead to prosecution or any of the licensing sanctions detailed in the paragraph below.

7. DETERMINATION:

In determining this application, the Sub-Committee must have regard to the representations and take such of the following steps as it considers necessary for the promotion of the licensing objectives. The steps are:

- (a) Take no further action.
- (b) Modify the conditions of the licence.
- (c) Exclude a licensable activity from the scope of the licence.
- (d) Remove the Designated Premises Supervisor.
- (e) Suspend the licence for a period not exceeding three months.
- (f) Revoke the licence.

Where the Sub-Committee takes a step mentioned in (b) or (c) above, it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.

In making its decision, the Sub-Committee must act with a view to promoting the licensing objectives:

- the prevention of crime and disorder;
- the prevention of public nuisance;
- public safety;
- protection of children from harm.

It must also have regard to its own SLP and the Guidance.

If the Sub-Committee is minded to amend the licence, conditions may be attached to the licence to alleviate the concerns raised through representations; nevertheless, this is a matter for the Sub-Committee to determine in light of the above matters, and any others it considers material.

The Metropolitan Police are requesting a review of AB Wines, 218 Uxbridge Road, W12 7JD, relating to breaches of licence conditions and an allegation of crime concerning the designated premises supervisor.

There was one offence of the designated premises supervisor handling stolen goods.

The breachers are:

Condition 8 on the premises licence states:

A staff member from the premises that is conversant with the operation of the CCTV system will be on the premises at all times that the premises are open to the public. This staff member will be trained to be able to show the police recent footage with the minimum of delay when requested. – The DPS was not able to use the CCTV system at the time of police visiting.

Condition 16 on the premises licence states: Strong beer, lager, cider and Stout above 5.5% ABV will not be sold. – There was alcohol in a fridge at the rear of the shop over 5.5% ABV.

Condition 18 of the premises licence states:

The licensee will report to Trading Standards any instance of a caller to the shop attempting to sell alcohol or tobacco products within 24 hours. – Trading Standards were not contacted and Handling Stolen Goods occurred.

The premises has also been reviewed in 2014 and 2020 due to its contribution to crime and disorder through the sale of high strength alcohol.

Please provide as much information as possible to support the application: (please read guidance note 3)



On Monday 28th July 2025 a shoplifter was detained in AB Wines following a theft from a Tesco which is in the close vicinity. The attending PCSO spoke to the designated premises supervisor, who stated on bodyworn video that he had bought the stolen alcohol, which was 10 cans of Jack Daniels and Coke. The DPS stated he had given the suspect £5. The DPS therefore committed the offence of handling stolen goods.

The Handling Stolen Goods element of this offence is related to Condition 18 of the premises licence.

The condition specifies what the premises should do in the eventuality of someone attempting to sell alcohol at the premises from a caller to the shop.

This condition is specifically intended to restrict the movement of stolen or counterfeit goods, both of which pose a societal problem. The inclusion of such a specific condition on the licence indicates that there has previously been an issue at the premises in relation to stolen property or counterfeit good. The condition has been imposed to prevent this from occurring again and to emphasise the standards in which the premises should be operating to.

On Tuesday 29th July 2025, I attended AB Wines with PC Tanner to speak to the designated premises supervisor and request the CCTV. When I asked the DPS to provide the CCTV of the incident, it became clear that he was unable to operate the system. This was a breach of licence Condition 8, which requires that a staff member conversant with the CCTV system be present at all times and able to provide footage to police without delay. I then located the relevant footage myself which took be some time to do. It showed the suspect leaving the alcohol towards the middle of the shop and then waiting in the shop for a little while. It is unknown what was said between both parties and there is no sound. The DPS is seen taking money from the till and handing it to the suspect. The stolen alcohol is left in the shop.

When I had finished viewing the CCTV I checked the fridges and shelves at the front of the premises for high strength alcohol. My colleague, PC Tanner inspected the rear and found strong alcohol stored in a fridge that was accessible at the time. When I informed the DPS that the sale of such alcohol was prohibited, he did not deny that it had been available for sale. This was a breach of licence Condition 16, which prohibits the sale of beer, lager, cider, and stout above 5.5% ABV. It was then also apparent that the DPS and Licence holder failed to notify Trading Standards of the attempted sale of stolen alcohol on the 28th July, which was a further breach of Condition 18, which requires trading standards to be made aware within 24 hours. During the visit I also observed unusual behaviour from the DPS towards customers, with certain individuals being told to they didn't have certain products at that current time and these customers would leave and not purchase goods. I found this suspicious.

After the visit I contacted the premises licence holder, who later provided CCTV via Axon video link. A meeting was then arranged on the 26th August 2025 to discuss the concerns that I had. At this meeting the premises licence holder claimed that the high strength alcohol found on the premises had been placed in a broken fridge and it was out of date and had not been intended for sale. This explanation in my opinion does not address why it was on site and accessible, especially since Condition 16 has been on the premises licence following the last review in 2020. The premises licence holder gave no reasonable response as to why the DPS could not operate the CCTV, even though the system had been installed in June 2025 and had therefore been in place for over a month without the DPS being trained. When Condition 18 to notify Trading Standards was raised to the premises licence holder, he just questioned the meaning of the condition rather than accepting responsibility that they hadn't been informed.

Throughout the meeting the premises licence holder offered excuses about the breaches and was dismissive about the handling stolen goods. At no point did the premises licence holder provide solutions to improve the operation of the shop. No evidence was provided of steps being taken to improve the management of the premises either. He even in my opinion downplayed the incident of handling stolen goods, stating that the DPS had simply given money to the male because he was begging and refusing to leave but this account was never given to myself or PCSO Lambert when we had interactions with the DPS. I am of the opinion that if a DPS is approached by someone attempting to sell stolen goods, the logical step to take is to call the police, not to pay the individual to leave the shop, as this just encourages it to happen again.

This also raises questions as to why the shoplifter chose to attend AB Wines, when there are other off licences in the surrounding

The premises licence holder also made reference to a previous licence officer who had engaged with them about having a condition implemented regarding the high strength alcohol. From the premises licence holders tone and body language, I got the impression that he disagreed with the condition, despite the fact that it was necessary to address ongoing problems with street drinkers buying from the premises.

The DPS has also been involved in the sale of alcohol to intoxicated individuals and this has been raised in previous reviews. For me, he has demonstrated that he is not a responsible manager. AB Wines has already been subject to reviews in 2014 and 2020 due to the premises contributing to anti social behaviour in the area by selling high strength alcohol to street drinkers and refusing to agree to conditions suggested by the police. Conditions were implemented to address these issues but the premises continues to disregard the rules.



I believe the DPS is not suitable to operate the premises in this area and that the licence holder has demonstrated a disregard for the licensing objectives. Residents and the wider community in Shepherds Bush are entitled to live alongside businesses that act responsibly and support efforts to reduce crime and antisocial behaviour.

AB Wines continues to not support the issues faced by the area. The handling of stolen goods by a DPS is a criminal offence and it is not conduct expected of a responsible operator.

AB Wines is contributing to problems of shoplifting, disorder and criminality in Shepherds Bush. Given the failures of both the DPS and the premises licence holder, I do not believe that the DPS is suitable in this shop and I do not believe that the premises licence holder is capable of operating the premises responsibly. A robust approach is needed in Shepherds Bush due to the issues surrounding violent crime, theft and ASB. I believe all of the responsible authorities should also protect the community and maintain confidence in the authorities to not accept irresponsible operators to hold premises licences. Allowing the premises to continue operating in this manner risks further deterioration in the area and undermines the responsible operators who do comply with the law.

I have also collated relevant reports made to police involving AB Wines and summarised them below:

On the 03/05/2024 a report was made in relation to AB WINES, 218 UXBRIDGE ROAD, W12 7J becoming an increasing cause of concern in the local community. The report suggests the shop is a focal point for ASB, as many street drinkers are buying their alcohol from the shop and then gathering directly opposite the shop at a bus stop. It is thought that members of these groups are then spilling over into nearby residential street and causing ASB. The report details that has been an increase of ASB incidents on this road in recent months.

On the 24/10/2024 Police responded to a GBH whereby a female had been hit with a glass bottle causing a laceration to her ear, which was described as bleeding substantially. This incident took place outside of AB Wines but the suspect involved in the altercation has entered AB Wines, retrieved a glass bottle and hit the victim with it. Another bottle has been picked up in the venue by the suspect and thrown towards the victim. Police have then noticed this altercation and responded. The DPS was on duty at the time but stated he was not aware of what was going on, as a lot of the incident happened outside and was not covered by CCTV.

Officers then stated that it was apparent that there were a lot of people in the vicinity, who were very drunk and were causing a nuisance as members of public walked past the venue.

Police say in the report that the staff had lost control in selling alcohol to the public. The report also mentions that it was easy to remove these bottles from the premises. The report states that there were a lot of intoxicated males outside the venue and the environment felt unsafe. The report also mentions that police observed drunk males, who in their opinion were too drunk to be served were going in to try to buy more alcohol.

On the 18/09/2024 police received intel about a frequent drug dealer, dealing outside of AB Wines.

On the 18/03/2025 a report was made stating there are ongoing problems with large groups of youths congregating outside the A&B Wine shop which appears to be an off license.

It describes the general behaviour of group to participate in ASB by drinking, smoking weed, playing loud music and urinating at nearby bus stop. The person reporting says they feel threatened by their presence and behaviour.

On the 26/03/2025 a witness has called police to report an ongoing issue of ASB outside of AB Wine.

They say the problem is recurring, with large groups using drugs and blocking paths with scooters.

The youths are male and female and are described as unpleasant.

The individual reporting states it has been going on for a while but this time there was lots of people so it's worse.

Police then attended AB Wines on the 3rd April 2025 and said the staff mentioned that a large group of people gather outside the store but he also mentioned that they do no harm to the shop or to them and that they just gather outside the shop and play music with big speakers.

The Metropolitan Police are requesting a review of AB Wines, 218 Uxbridge Road, W12 7JD, relating to breaches of licence conditions and an allegation of crime concerning the designated premises supervisor.

There was one offence of the designated premises supervisor handling stolen goods.

The breachers are:

Condition 8 on the premises licence states:

A staff member from the premises that is conversant with the operation of the CCTV system will be on the premises at all times that the premises are open to the public. This staff member will be trained to be able to show the police recent footage with the minimum of delay when requested. – The DPS was not able to use the CCTV system at the time of police visiting.

Condition 16 on the premises licence states: Strong beer, lager, cider and Stout above 5.5% ABV will not be sold. – There was alcohol in a fridge at the rear of the shop over 5.5% ABV.

Condition 18 of the premises licence states:

The licensee will report to Trading Standards any instance of a caller to the shop attempting to sell alcohol or tobacco products within 24 hours. – Trading Standards were not contacted and Handling Stolen Goods occurred.

The premises has also been reviewed in 2014 and 2020 due to its contribution to crime and disorder through the sale of high strength alcohol.

On Monday 28th July 2025 a shoplifter was detained in AB Wines following a theft from a Tesco which is in the close vicinity. The attending PCSO spoke to the designated premises supervisor, who stated on bodyworn video that he had bought the stolen alcohol, which was 10 cans of Jack Daniels and Coke. The DPS stated he had given the suspect £5. The DPS therefore committed the offence of handling stolen goods.

The Handling Stolen Goods element of this offence is related to Condition 18 of the premises licence.

The condition specifies what the premises should do in the eventuality of someone attempting to sell alcohol at the premises from a caller to the shop.

This condition is specifically intended to restrict the movement of stolen or counterfeit goods, both of which pose a societal problem. The inclusion of such a specific condition on the licence indicates that there has previously been an issue at the premises in relation to stolen property or counterfeit good. The condition has been imposed to prevent this from occurring again and to emphasise the standards in which the premises should be operating to.

On Tuesday 29th July 2025, I attended AB Wines with PC Tanner to speak to the designated premises supervisor and request the CCTV. When I asked the DPS to provide the CCTV of the incident, it became clear that he was unable to operate the system. This was a breach of licence Condition 8, which requires that a staff member conversant with the CCTV system be present at all times and able to provide footage to police without delay. I then located the relevant footage myself which took be some time to do. It showed the suspect leaving the alcohol towards the middle of the shop and then waiting in the shop for a little while. It is unknown what was said between both parties and there is no sound. The DPS is seen taking money from the till and handing it to the suspect. The stolen alcohol is left in the shop.

When I had finished viewing the CCTV I checked the fridges and shelves at the front of the premises for high strength alcohol. My colleague, PC Tanner inspected the rear and found strong alcohol stored in a fridge that was accessible at the time. When I informed the DPS that the sale of such alcohol was prohibited, he did not deny that it had been available for sale. This was a breach of licence Condition 16, which prohibits the sale of beer, lager, cider, and stout above 5.5% ABV. It was then also apparent that the DPS and Licence holder failed to notify Trading Standards of the attempted sale of stolen alcohol on the 28th July, which was a further breach of Condition 18, which requires trading standards to be made aware within 24 hours. During the visit I also observed unusual behaviour from the DPS towards customers, with certain individuals being told to they didn't have certain products at that current time and these customers would leave and not purchase goods. I found this suspicious.

After the visit I contacted the premises licence holder, who later provided CCTV via Axon video link. A meeting was then arranged on the 26th August 2025 to discuss the concerns that I had. At this meeting the premises licence holder claimed that the high strength alcohol found on the premises had been placed in a broken fridge and it was out of date and had not been intended for sale. This explanation in my opinion does not address why it was on site and accessible, especially since Condition 16 has been on the premises licence following the last review in 2020. The premises licence holder gave no reasonable response as to why the DPS could not operate the CCTV, even though the system had been installed in June 2025 and had therefore been in place for over a month without the DPS being trained. When Condition 18 to notify Trading Standards was raised to the premises licence holder, he just questioned the meaning of the condition rather than accepting responsibility that they hadn't been informed.

Throughout the meeting the premises licence holder offered excuses about the breaches and was dismissive about the handling stolen goods. At no point did the premises licence holder provide solutions to improve the operation of the shop. No evidence was provided of steps being taken to improve the management of the premises either. He even in my opinion downplayed the incident of handling stolen goods, stating that the DPS had simply given money to the male because he was begging and refusing to leave but this account was never given to myself or PCSO Lambert when we had interactions with the DPS. I am of the opinion that if a DPS is approached by someone attempting to sell stolen goods, the logical step to take is to call the police, not to pay the individual to leave the shop, as this just encourages it to happen again.

This also raises questions as to why the shoplifter chose to attend AB Wines, when there are other off licences in the surrounding area.

The premises licence holder also made reference to a previous licence officer who had engaged with them about having a condition implemented regarding the high strength alcohol. From the premises licence holders tone and body language, I got the impression that he disagreed with the condition, despite the fact that it was necessary to address ongoing problems with street drinkers buying from the premises.

The DPS has also been involved in the sale of alcohol to intoxicated individuals and this has been raised in previous reviews. For me, he has demonstrated that he is not a responsible manager. PCSO Lambert stated that he had spoken to the designated premises supervisor, who said that they had given the suspect £5 for the 10 cans of Jack Daniels and Coke. By purchasing the stolen property the designated was handling stolen goods.

With this information I then visited A B Wines with PC Tanner on Tuesday 29th July 2025. When I requested the DPS to provide the CCTV of the incident, he was unable to operate the CCTV system and I then had to use operate the system myself to view the incident. Condition 8 on their premises licence requires that a staff member conversant with the CCTV system be present at all times and able to provide footage to police without delay. The footage showed the suspect from Tesco leaving alcohol towards the middle of the shop and then waiting in the shop for a little while. The DPS is seen taking money from the till and handing it to the suspect. The stolen alcohol is left in the shop.

When I had finished viewing CCTV I checked the fridges and shelves at the front of the premises for high strength alcohol. My colleague, PC Tanner inspected the rear and found strong alcohol stored in a fridge that was accessible at the time of her looking. When I informed the DPS that the sale of the high strength alcohol was a breach of their licence conditions, he did not deny that it had been available for sale.

It is thought that members of these groups are then spilling over into nearby residential street and causing ASB. The report details that has been an increase of ASB incidents on this road in recent months.
- On the 24/10/2024 Police responded to a GBH whereby a female had been hit with a
 glass bottle causing a laceration to her ear, which was described as bleeding
 substantially. This incident took place outside of AB Wines but the suspect involved in
 the altercation has entered AB Wines, retrieved a glass bottle and hit the victim with it.

Another bottle has been picked up in the venue by the suspect and thrown towards the victim. Police have then noticed this altercation and responded. The DPS was on duty at the time but stated he was not aware of what was going on, as a lot of the incident happened outside and was not covered by CCTV.

- Officers then stated that it was apparent that there were a lot of people in the vicinity, who were very drunk and were causing a nuisance as members of public walked past the venue.
- Police say in the report that the staff had lost control in selling alcohol to the public.
 The report also mentions that it was easy to remove these bottles from the premises.
 The report states that there were a lot of intoxicated males outside the venue and the environment felt unsafe. The report also mentions that police observed drunk males, who in their opinion were too drunk to be served were going in to try to buy more alcohol.
- On the 18/09/2024 police received intel about a frequent drug dealer, dealing outside of AB Wines.
- On the 18/03/2025 a report was made stating there are ongoing problems with large groups of youths congregating outside the A&B Wine shop which appears to be an off license.
- It describes the general behaviour of group to participate in ASB by drinking, smoking weed, playing loud music and urinating at nearby bus stop. The person reporting says they feel threatened by their presence and behaviour.
- On the 26/03/2025 a witness has called police to report an ongoing issue of ASB outside of AB Wine.
- They say the problem is recurring, with large groups using drugs and blocking paths with scooters.
- The youths are male and female and are described as unpleasant.
- The individual reporting states it has been going on for a while but this time there was lots of people so it's worse.
- Police then attended AB Wines on the 3rd April 2025 and said the staff mentioned that a large group of people gather outside the store but he also mentioned that they do no harm to the shop or to them and that they just gather outside the shop and play music with big speakers.
- On the 27/09/2025 Police were made aware of ongoing anti-social behaviour outside AB Wines at approximately 1934 hours, involving a crowd of young men gathering, drinking, and causing a nuisance. This type of behaviour is reported to be a regular occurrence associated with the premises.
- On the 28/09/2025 Police were called by a victim, who reported being assaulted inside AB Wines, 218 Uxbridge Road, W12. They stated that around 1920 hours, they were near the entrance when they were grabbed and slapped in the face.
- Officers reviewed the store's CCTV, which corroborated the sequence of events.

I, PC Tanner, am a police constable and work as a dedicated ward officer for WHITE CITY which incorporates UXBRIDGE ROAD W12. I have been in this role for approximately 18 months and during this time, I have received and personally witnessed, numerous reports and complaints from local residents regarding ongoing anti-social behaviour associated with AB WINES. These include groups congregating outside the premises, playing loud music and engaging in disorderly behaviour, drug sales and drug addicts collecting drugs and the fallout from this has had a detrimental impact on the local community.

There have also been reports of supply and sale of alcohol in circumstances that raise significant concerns. On one occasion a male was arrested for theft of alcohol from a local supermarket and was then witnessed selling this alcohol to AB WINES.

This is supported by Body Worn Video footage.

During a joint SNT and licensing visit to AB WINES after the above incident, staff were unable to correctly operate the CCTV system which is a clear breach of their licensing conditions. Furthermore, officers located alcohol in fridges at the location exceeding the permitted percentage under their license. When challenged, a staff member working at the rear of the store attempted to obscure these items from me by pushing a storage bin and boxes in front of the fridge, suggesting deliberate concealment.

I have on several occasions attempted to engage with the management to discuss these ongoing issues and explore ways to

address community concerns. However, there has been no cooperation or response in some cases, and yet the store say that police are not helping to deter the ASB outside their location. In my professional opinion, the premises have demonstrated a pattern of non – compliance, dishonesty, and disregard for licensing conditions.

Given the repeated breaches, the purchase of stolen goods and the persistent negative impacts on the local community, I have asked for impact statements from local residents and have sent these alongside this statement. I strongly support a review of this license. Based on the seriousness of these matters and the continued failure of management responsibility, I believe that permanent closure of this venue is the most appropriate and proportionate outcome to protect the public and uphold the licensing objectives.



- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that subparagraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4(1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of

paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.
- 3. Mandatory Condition
- (1) No supply of alcohol may be made under the premises licence-
- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Annex 2 - Conditions consistent with the operating Schedule

- 4. Alcohol shall not be sold or supplied except during the following permitted hours
- (a) Weekdays, other than Christmas Day and Good Friday, 8am to 11pm
- (b) Sundays, other than Christmas Day, 10am to 10:30pm
- (c) Christmas Day, 12 noon to 3pm and 7pm to 10:30pm
- (d) Good Friday, 8am to 10:30pm.

Subject to the following exceptions no person shall, except during the permitted hours listed above, sell or supply alcohol or take alcohol from the premises. The exceptions are:

- i. During the first 20 minutes after the above hours the taking of the alcohol from the premises , provided it is not taken in an open container;
- ii. The ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- iii. The sale of alcohol to a trader or club for the purposes of the trade or club;
- iv. The sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of her Majesty's naval, military or air forces.
- 5. Alcohol shall not be sold in an open container or be consumed in the licensed premises.


Annex 3 - Conditions attached after a hearing by the licensing authority

- 6. CCTV covering areas inside of the premises shall be installed and maintained to a standard agreed with the Police, with properly maintained log arrangements. All images shall be stored, stamped with the date and time of recording, for a minimum period of 31 days from the date that they are recorded.
- 7. (Compliance with Data Protection Act) CCTV is to be maintained in a fully working condition whilst the premises are open to the public.

- 8. A staff member from the premises that is conversant with the operation of the CCTV system will be on the premises at all times that the premises are open to the public. This staff member will be trained to be able to show the police recent footage with the minimum of delay when requested.
- 9. There will be one personal licence holder or a person with the BII Level 1 Award in Responsible Alcohol Retailing at the premises whilst the premises are open to the public.
- 10. No beer or cider shall be sold unless they are marked with the name of the premises.
- 11. A refusals book shall be kept at the premises to record details of all refusals to sell alcohol. This book shall contain the date and time of the incident, a description of the customer, the name of the staff member who refused the sale and the reason that the sale was refused. This book shall be made available to Police and authorised officers of the Council upon request.
- 12. The Designated Premises Supervisor or a named person whose name appears in the front of the refusals book shall regularly check the book to ensure that it is being consistently used by all staff.
- 13. In relation to the Proof of Age Scheme, the only identification that will be accepted is a driving licence with a photographic image of the holder, a passport, pass card or other form of identification noted by the licensing authority as acceptable.
- 14. Full records of alcohol purchases shall be maintained for a period of no less than 12 months from the date of purchase and shall be provided to the police or an authorised officer of the council within 14 days of a request to do so.
- 15. All staff responsible for selling alcohol shall receive biannually training of how to identify drunk or drug impaired customers as well as in the Licensing Act 2003 in terms of the licensing objectives, offences committed under the Act and conditions of the Premises Licence. Written records of this training shall be retained and made available to police and authorised officers of the Licensing Authority on request.
- 16. Strong beer, lager, cider and Stout above 5.5% ABV will not be sold.
- 17. Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied.
- 18. The licensee will report to Trading Standards any instance of a caller to the shop attempting to sell alcohol or tobacco products within 24 hours.
- 19. No spirits shall be purchased in a resealed box, without thorough checks being made to ensure it is legal to sell.





Good morning team

I would like to comment on the above review.

I will mention just a few of the incidents, which has come to our attention, from concerned local residents.

- Fights
- Public urination and also urinating in side roads and in residents front gardens
- Large groups behaving anti socially, blocking the pavements
- Large groups gathering under the bus stop, resulting in genuine bus users standing further up the road until the bus arrives
- Amplified music on various devices
- Litter images shared have shown individuals with bags containing alcohol containers

The majority of these offences, by witness accounts, have been associated to alcohol bought from the premises.

CCTV images I have seen shows offenders outside, causing a nuisance and then entering the premises to make purchases, leaving and continuing to drink. Images have also been sent in showing the location the following day. Bottles, cans and litter from the groups quite evident as well as signs of urination.

The residents report they are fearful of leaving their homes at night, as this is when the majority of fights and unruly behaviour takes place. We have also received reports of individuals stating they have had to collect children or family members and accompany them home.

We, Community Safety, and other officers have entered the premises and spoken to staff but on each visit, staff have said that they had also been impacted by the group and that there was very little they could do to manage any behaviours outside.

Having visited the premises myself on numerous occasions, as a customer, I now believe that staff are complicit to what goes on. It may be because they are scared to **not** sell alcohol to these individuals or have no training or confidence on how to deal with these types of incidents. As far as I am aware, they do not conduct any cleaning of litter from the front of the premises, it is relied on the council's street cleansing team to address.

This is just an overview of the types of reports Community Safety have received and to also note, we have used a lot of resources to patrol and monitor the area, at times at

officers risk of safety. I could be wrong but at no time have the staff worked with the council on what measures they can put into place to mitigate a rise in incidents.

I am a long-term resident of Stanlake Villas. I wish to object in the strongest possible terms to the renewal of AB Wines's licence.

AB Wines is one of the primary hubs for antisocial behaviour locally and is a clear and documented gathering point for drug dealers, drug takers, and large groups of intoxicated people playing loud music. I cannot count the number of times I have felt intimidated walking past this space which I must do at least twice daily to reach my home, and the number of times I have witnessed people dealing drugs and taking drugs around this venue as well as drinking alcohol. Many of the regular attendees at AB Wines then steal from the properties of the adjacent streets (e.g. parcel deliveries, anything not nailed down in gardens), to support their habit. I have the impression this is, at best, tolerated by the owners who may or may not be complicit in the activities. The frequency and severity of the ASB is evidenced by local crime statistics and does raise questions as to why AB Wines has not dealt with this issue as it has been ongoing for a very long time. A related question is why such behaviour is not being experienced to the same degree by other similar local shops (i.e. why is it focussed on AB Wines?).

The area, and particularly adjacent streets, has deteriorated drastically and become dangerous as a result of the ASB associated with AB Wines. There is filth and litter around the shop, area and bus stop which has become frequently unusable as it is

taken over by addicts, dealers and drunks. At home we often refer to AB Wines as 'Club AB' (i.e. holding the same status as a nightclub venue).

I strongly object to the licence renewal on the following grounds:

- 1. Public Safety and (ii) Protection of Children from Harm: As a neglected and abandoned part of the borough, the local community including children and vulnerable groups are exposed to harassment and intimidation on a daily basis as a result of activity associated with AB Wines. The renewal of AB Wines licence will only lead to further degradation of the area and more risk to local residents. There is a School within one minute of AB Wines (if not less) and children are forced to navigate this danger zone and witness acts of criminality and drug taking daily.
- (iii) Prevention of Public Nuisance: The premises attract and enable behaviour that leads to noise, litter, drug paraphernalia, public urination, indecent exposure, and general degradation of the area.
- (iv) Prevention of Crime and Disorder The premises are clearly being used as a base for drug dealing and other criminal activity.

I am a local resident and - among with others in my neigbourhood, I want to object to the premises licence for AB Wines, 218 Uxbridge Road, Shepherd's Bush, W12 7JD.

This shop is in a highly unsuitable location to sell alcohol for a number of reasons - not least that I understand that it shares an address with Westfield Hostel, which houses vulnerable residents. I gather that the same owner of Westfield Hostel also owns AB Wines - this apparent conflict of interest should be of concern.

The shop is also directly opposite St Stephen's Primary School, close to Miles Coverdale Primary School and to Greenside Primary School.

It is extremely close to Shepherds Bush Market Tube Station and there is a bus stop directly outside the shop - a busy area for commuters and families.

As you will know, it has become a frequent gathering point for groups of men and women who buy and consume alcohol there, put on loud music and cause a nuisance. This particular area is also a hot spot for other antisocial activities.

The behaviour outside AB affects me whether I bringing my children home from school in the afternoon or when I am coming home from work later in the evening - the groups that gather there are unpleasant and can be threatening.

These things make AB Wines very different to other local off-licences who manage to sell alcohol but do not generate the same problems.

As you will be aware, the problems also stretch to around the bus stop on the the other side of the road - where I have seen groups of men and women smoking drugs in broad daylight as I have brought my children home from school.

I have lived close to this shop for for 30 years and was a regular customer for 25 years. In the last 5 years something has changed. The shop has become a magnet for antisocial behaviour, drunks, drug users and aggressive street loiterers. I avoid the shop now and dread having to walk near it in case these people that I have not seen in the area until recently have decided to congregate and intimidate everyone else with their aggression, shouting, swearing, substance abuse and often loud music.

I believe the shop staff might themselves be scared of these people and are unable to stand up to the very unpleasant people who have adopted the shop as a kind of street bar.

I do not remember the shopfront being upgraded or renewed once in all the time I have lived here and I think this is a major cause of the problem. It has become dilapidated, ramshackle and dirty over many years and now gives the impression of a business with very low standards of compliance - which is a signal to criminals.

I believe the business staff are not bad people, I think they might have found themselves overrun by lawless thugs. A licence renewal should depend on a signal change to the people who loiter inside and outside of the shop. Closure for a period while there is a complete refurbishment of the shopfront and interior to signal to anyone thinking of going inside that it is properly managed, with appropriate standards of control and compliance to the law. At the moment it looks the opposite - and that is why there are problems.

Protecting children from harm:

The shop is a few meters from a primary school. I have read many times on our Neighbourhood Watch groupchat of the fear and intimidation that residents often have when passing the shop, particularly when collecting their children from school.

This situation is not right. It is a council's primary duty to protect the safety of residents. This must come first in any decision you make about this.

Representation Objecting to the Renewal of AB Wines Licence

I am a resident at the top of Frithville Gardens and experience the effects of AB Wines on a daily basis. I am a mother of two small children (aged 4 and 2) and must pass the AB Wines shop front and bus stop regularly to take them to St Stephen's Primary School and nursery.

As a woman and a parent, I feel threatened and unsafe when crossing this space. The area around AB Wines is routinely taken over by drug dealers and their customers. These individuals openly use the shop and its immediate surroundings as a meeting point for drug transactions. I have personally witnessed deals occurring both outside and inside the premises, apparently tolerated by the shop owners.

This activity leads to numerous problems which directly affect local residents:

- Groups of intoxicated and aggressive individuals congregating outside the shop and bus stop.
- 2. Broken glass, litter, urine and drug paraphernalia regularly left in the area.
- 3. Men urinating in plain sight, often exposing themselves, which women, residents, and children are forced to witness.

- 4. Antisocial behaviour spilling over into the front gardens and the corner of Frithville Gardens and Uxbridge Road.
- 5. Women and young people feeling unsafe and, in some cases, being harassed.

For example, a 20-year-old friend staying with me was followed by two men and had to run back home on Frithville Gardens. My own mental health has suffered from the constant fear and hopelessness created by this situation. At times I avoid the area completely, ordering food online rather than crossing the street. If I see groups gathered at the Shepherd's Bush Market stop when returning home, I delay my journey rather than risk walking past them.

The issue of public urination is especially degrading and unacceptable. On several occasions I have seen men exposing themselves while urinating at the bus stop and in front of AB Wines. This behaviour happens in full view of my children and other families on their way to school. It is shocking, distressing, and completely inappropriate for young children to be exposed to nakedness and indecent behaviour in their own neighbourhood.

This behaviour often begins as early as 5 p.m. and continues into the evening, making it impossible for my family to feel safe in our own community. It is not limited to late-night hours — it disrupts family life and the school run as well.

I therefore strongly object to the renewal of the licence for AB Wines on the grounds of:

I strongly object to the premises licence for AB Wines, 218 Uxbridge Road, Shepherd's Bush, W12 7JD.

The location is totally unsuitable, and the operators seem to care nothing about the impact on the area. For one it shares an address with Westfield Hostel, many of whose residents visibly have a drug/alcohol problem.

It is directly opposite St Stephen's Primary School, and close to Miles Coverdale Primary School and Greenside Primary School. Pupils have to walk past men drinking and shouting at the bus stop outside.

There is a bus stop directly outside the shop, which has become a frequent gathering point for groups of men who buy alcohol there, drink, play loud music and cause nuisance and a sense of threat. This affects residents trying to navigate walking through the road and makes me concerned for other residents, particularly females.

I recently heard you were looking for comments on the prevalence of anti social behaviour in and around AB Wines.

I am a resident of Frithville Gardens and almost every evening I see the combination of AB wines, the hostel above it, and the bus stop with seating opposite attracting a huge amount of aggressive and antisocial behaviour.

In the last year I have witnessed verbal assaults including once to a very elderly woman getting off at the bus stop who was a little disorientated as a result. She stood in front of AB wines and when somebody came out of it, they hurled drunken insults at her for standing in their way.

I myself have also had aggressive stares and on one occasion told to fuck off by somebody who has just got some drinks from AB Wine and was sitting at the bus stop.

We have significant issues at the top of Frithville Gardens, which I know you're aware of, including people openly urinating, dealing drugs, playing loud music late at night from ghetto blasters and generally making the whole area feel quite unsafe. I am a local resident and I wish to object to the premises licence for AB Wines, 218

Uxbridge Road, Shepherd's Bush, W12 7JD.

AB Wines is very different to other local off-licences. Other shops sell alcohol nearby but do not generate the same problems. The combination of being next to a hostel, directly opposite a primary school, and beside a bus stop has made AB Wines a hotspot for crime, disorder, and anti-social behaviour. In particular the bus stop has become a frequent gathering point for groups of men who buy alcohol there, drink, party, put on loud music through speakers and cause regular nuisance.

I understand that the police themselves support closing AB Wines, which shows how serious and long running the issues are. I also understand this application has been objected to before. AB Wines undermines all four licensing objectives:

Crime and Disorder: Regular loitering, intimidation, drunken behaviour outside.

Protection of Children: Pupils at St Stephen's Primary School must walk past men drinking and shouting at the bus stop outside.

Public Nuisance: Noise through public speakers, litter, bottles and cans are constant problems.

Public Safety: I do not feel safe walking on the road, especially outside AB Wines, because of this loitering and anti-social behaviour.

For these reasons, I ask that the Licensing Sub-Committee revokes the licence for AB Wines. Uxbridge Road has serious issues as they are with a proliferation of betting shops; open drug dealing; litter and anti-social behaviour. Uxbridge Road has been in the focus of the Council in recent months due to one of the largest petitions the Council has ever seen - "fix Uxbridge Road: no more crime, no more neglect" and needs significant Council intervention to make the road safe, clean and accessible again. Revoking the licence for AB Wines will be a first step to help residents reclaim their road.

the other hand, has not done so.

Most importantly, it is the surely the responsibility of the police to contain social disorder, and not of the proprietor. The shop contributes to the community by providing services other than the sale of wines and beverages (eg, Oyster top-up). The local community would benefit far more from the regular appearance of police officers in the area than by the closure of what is a useful and generally well-tended establishment.

London Borough of Hammersmith and Fulham Decision of the Licensing Sub-Committee ("Committee") 17 June 2020

AB Wines, 218 Uxbridge Road, London, W12 7ID ("the Premises")

The Committee has considered an application for the review of a premises licence under the Licensing Act 2003 ("the Application").

The Committee has considered the committee papers and the submissions made by all of the parties, both orally and in writing. In reaching its decision the Committee has had regard and has taken into account the relevant legislation, the Secretary of State's Guidance ("Guidance") and the Authority's Statement of Licensing Policy ("SLP").

The Committee has decided, after taking into account all of the individual circumstances of this case, that it is appropriate for the promotion of the licensing objectives to:

1. Amend the hours for sale of alcohol off the Premises as agreed by the Licence Holder as follows:

Monday- Saturday 11:00-23:00 Sunday 11:00-22:30

- 2. Delete condition 10 from the licence as suggested by the Applicant
- 3. Amend condition 11 of the Licence to now state:
 - 11. No beer or cider shall be sold unless they are marked with the name of the premises.
- 4. Delete condition 16 of the Licence and replace it with the following:

"All staff responsible for selling alcohol shall receive biannually training of how to identify drunk or drug impaired customers as well as in the Licensing Act 2003 in terms of the licensing objectives, offences committed under the Act and conditions of the Premises Licence. Written records of this training shall be retained and made available to police and authorised officers of the Licensing Authority on request."

- 5. Impose two conditions proposed by the Applicant as referred below:-
 - 1.Strong beer, lager, cider and Stout above 5.5% ABV will not be sold
 - 2. Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied
- 6. Impose two conditions proposed by the Trading Standard Officer as referred below:-
 - 3. The licensee will report to Trading Standards any instance of a caller to the shop attempting to sell alcohol or tobacco products within 24 hours.
 - 4. No spirits shall be purchased in a resealed box, without thorough checks being made to ensure it is legal to sell

Procedural Matters

- 1. The application to review the Premises Licence ("the Licence") was submitted by Police Constable, Kris Cardwell on behalf of Metropolitan Police, on the grounds of the prevention of crime and disorder and the prevention of public nuisance.
- 2. One representation in support of the Application was received by Mr. Doug Love on behalf of the Trading Standard Department. Mr. Love recommended to the Committee to consider either revocation or suspension of the Premises Licence as the sale of smuggled alcohol was detected at the premises. Mr. Love attended the hearing.
 - 3. Representations in support of the Application were received by 5 local residents. None of them attended the hearing. The local residents supported the Application on the grounds of prevention of crime and disorder and prevention of public safety because of the problems associated with street drinkers.
 - 4. Representations against the Application were received by 2 local residents. None of them attended the hearing. The local residents objected to the Application as according to them there was no evidence to link the Premises to the problems in the area with street drinking.
 - 5. The Applicant was represented by PC Cardwell. PC Stuart McKee Shepherd's Bush ward officer also attended the hearing.
 - 6. Lexcom Management Services Ltd the Premises Licence Holder was represented at the hearing by Mr. Rajesh Shah the director of the company.
 - 7. At the hearing the Licensing Officer explained to the Committee that an email was received by Mr. Love a few hours before the hearing, informing the Licensing Authority that an appendix was missing from his representation.
 - 8. The Committee noted that the Applicant and Committee members have not seen this information. The licence holder confirmed he was aware of the information as it was an email correspondence between him and Mr. Love.
 - 9. Based on the fact that all interested parties were made aware of this administrative error only two hours before the hearing, the Committee asked for clarification on whether the parties would object to the introduction of this new information. The licence holder and the Applicant both agreed to the introduction of the appendix.
 - 10. Considering the fact that both the Applicant and the Licence Holder were happy for the hearing to go ahead the Committee decided that the evidence could be submitted and allowed a short adjournment for all parties to consider the new evidence all parties.

Reasons

11. The Committee recognises that the proceedings set out in the Act for reviewing premises licences represent a key protection for the community when problems associated with crime and disorder, public safety, public nuisance or the protection of children from harm are occurring. Representations must relate to the particular premises in question and must be relevant to the promotion of the licensing objectives.

- 12. Under the Act any responsible authority may apply for a review of a premises licence if they are concerned about licensed activities at premises and want to intervene early without waiting for representations from other persons and where it considers that this step is necessary for the promotion of the licensing objectives.
- 13. In deciding which of these powers to invoke, the responsible authority should so far as possible seek to establish the cause or causes of the concerns which the representations identify. The remedial action taken should generally be directed at these causes and should always be no more than an appropriate and proportionate response.
- 14. The Committee is entitled to and has taken into account local knowledge in reaching its decision.
- 15. Mr. Adrian Overton from the Licensing Department provided a summary of the case for the Committee. He confirmed that there have been previous licence enforcement issues at this premises and an interview under caution took place in February this year following the seizure of non-duty paid alcohol and in relation to an alleged alcohol sale to a drunk customer.
- 16. The Committee noted that in 2014 the Applicant submitted an application for a review of the licence on the grounds of the prevention of crime and disorder, the protection of children from harm, promotion of public safety and the prevention of public nuisance. The Police requested the hours the premises are open to the public be changed and that 15 conditions be added to the licence. The request for reduction of the hours were dropped at that hearing however the Committee imposed 11 conditions to the Licence
- 17. The Committee heard that Applicant requested a review of the licence on the grounds of prevention of crime and disorder and prevention of public nuisance. The Applicant was concerned that the premises were not operating in such a manner as to promote the licensing objectives. The police evidence suggests that the Premises has become an attraction for the street drinkers due to the fact that high strength beers, lagers and ciders were sold at the Premises. There was evidence that the Premises were selling alcohol to drunk customer which was witnessed by a police officer. Moreover the Applicant was also concerned that the premises was operating a credit system to sell alcohol.
- 18. The Committee noted that the Premises was located in Shepherds Bush Green, a CIP area which has problems with street drinking and anti-social behaviour associated with it. It was noted that the fact that the Premises is located in a CIP zone is not a relevant consideration for the review.
- 19. The Applicant explained to the Committee that the behaviour of street drinkers has a detrimental effect on the local residents who have complained of people urinating in the streets, fighting and that the area has become unpleasant to live in and that they also feel threatened and intimidated by drunk people gathering near their properties.
- 20. The Committee noted that the local residents in support of the Application were also concerned about the problems of street drinking associated with the Premises, Their main concerns were noise and nuisance from street drinkers and people smoking cannabis, problem with litter and also issues with people being sick and urinating in their front gardens. The local residents felt intimidated and threated at their homes by large groups of drunk people congregating near the Premises and near the residential streets
- 21. The Committee heard that the Licence Holder has been aware of these issues. The proposed conditions by the Applicant during the consultation process were not accepted by the licence holder because the addition of these conditions in the licence would not resolve the issues with street

- drinkers. The Applicant believes that the premises licence holder is more concerned about revenue ant not the effect that the issues have at the local community.
- 22. The Applicant proposed the removal of condition 10 and 11 from the Licence and imposition of 2 new conditions which will address with credit sales and sale of high strength alcohol as referred above.
- 23. At the hearing the Committee asked clarification from the Applicant regarding removal of condition 10 of the licence which state: "No single cans of beer or cider over 5.5% ABV shall be sold unless it is a brand agreed in writing with the police".
- 24. The Applicant explained that the condition imposed by the Police in 2014 allows customers to buy more than one can of high strength alcohol. In order to promote the licensing objective of prevention of crime and disorder and prevention of public nuisance the Applicant has proposed to remove this condition and replace it with a new one as stated below:
 - a. Strong beer, lager, cider and Stout above 5.5% ABV will not be sold
- 25. At the hearing the Applicant clarified for the Committee that imposition of the above condition at various premises licences near this area has proven to deal with the issue of street drinking, and that they have seen a reduction of street drinkers attending these premises.
- 26. The Committee asked the Applicant to also clarify the removal of condition 11 from the licence which restricts the sale of single cans of beer or cider unless they are marked with the name of the premises. It was the view of the Committee that the removal of this condition will not assist the Applicant in their attempt to promote the licensing objectives. The Applicant agreed at the hearing that the condition 11 of the Licence should remain. The Committee decided that in order to deal with the concerns of the Applicant and the local residents as well promote the licensing objectives condition 11 should be amended as referred at paragraph 3 above.
- 27. Mr. Shah confirmed that they have started to deal with the problem of street drinkers since 2014 when Police requested a review of the Licence. Some of the measures they have taken included identifying the street drinkers and banning them from the premises, putting the price of the alcohol up, ceasing the sale of strong ciders. However it was pointed out that street drinkers have recently started coming to the area from nearby towns which made it difficult to identity the usual street drinkers.
- 28. The Committee noted that the Applicant referred in the representation to some footage recorded on the police body worn video showing a drunk customer buying alcohol at the Premises. Mr. Shah explained that this customer was not drunk and if he was that would have been obvious to the member of staff who served him at that time. According to Mr. Shah the Premises is very small and a drunk customer would not be able to manage his way through the shop without falling or bumping into shelves.
- 29. The Committee took into consideration the representations of the local residents who objected to the Application. They confirmed in their representation that the licence holder and their staff were working hard to keep drunk customers away from the premises and that they have not witnessed any sale of alcohol to drunk customers.
- 30. The Committee took into consideration the concerns of the local residents and the Applicant regarding all the above as well as the representation of local residents in objection to the Application, and decided that in order to promote the licencing objectives of prevention of public nuisance and prevention of crime and disorder it was necessary for condition 11 not to be deleted from the Licence.

- 31. It was the Committee's opinion that Condition 11 was necessary and helpful to both the relevant authorities and licence holder in order to prevent issues arising in the area with street drinkers as well as to identify where the street drinkers were buying their strong alcohol.
- 32. The Committee agreed with the Applicant's concerns that Condition 10 in the original Licence was not appropriate in promoting the licensing objectives as it allowed the purchase of more than one can of high strength alcohol to customers. The Committee decided that it was appropriate and proportionate to restrict the sale of strong beer, lager, cider and Stout above 5.5% in order to deal with the problem of street drinkers.
- 33. The Committee asked for clarification from the Applicant regarding the proposed condition regarding credit sales. The Applicant clarified that it was clear from CCTV footage showing a customer obtaining 6 bottles of alcohol without paying that the Premises were operating a type of credit sale system to help street drinkers purchase alcohol. The Applicant clarified that in conjunction with other conditions of the Licence the proposed condition banning credit sale of alcohol was enforceable and appropriate.
- 34. Mr. Shah explained that the Premises do not operate a credit system and that the video footage that the Applicant was relying upon, related to only one time when a customer forget his money to pay for his purchase.. The Committee heard that the licence holder cannot afford to operate a credit system as it was not financially viable.
- 35. The Committee took into consideration the concerns of the Applicant that by allowing the Premises to operate a credit system made it attractive to street drinkers. It was the Committee's opinion that in order to promote the licencing objective of prevention of public nuisance it was appropriate and proportionate to add to the Licence condition 2 as referred at paragraph 5 above.
- 36. The Committee asked for clarification of the licence holder's understanding of licensing objectives and how often does training of the staff takes place at the premises. Mr. Shah confirmed that all the personal licence holder and the DPS are trained on aspects of licensing and have an experience of operating on this type of business for over 10 years.
- 37. The Committee noted that the DPS and licence holder have tried to identify all street drinkers and banned the from the premises. However the Committee took into consideration the concern's of the Applicant that during a visit at the Premises it was made clear that the DPS was not operating according to the conditions in the licence and in particular in relation to selling singe cans of beers to drunk customers.
- 38. The Committee noted the Applicant's concerns that the licence holder did not agree to the Applicant's conditions and they were more concerned of the effect that these conditions will have on the business rather than the effect that the way the Premises were operating was affecting the area and local residents and the impact on the licensing objectives and in particular the prevention of crime and disorder and prevention of public nuisance.
- 39. The Committee asked the licence holder to confirm what will they do in order to promote the licencing objectives. Mr. Shah explained that the hours the Premises is operating under the existing licence are 08:00-23:00. Mr. Shah confirmed that some of the problems they have experiencing with street drinkers were happening in the morning. Therefore in order to stop street drinkers from approaching the Premises at rush hour when children were going to school a decision has been made not to open the Premises before 09:00. However Mr. Shah stated at the hearing that he was prepared to amend the hours for sale of alcohol until 11am in order to promote the licensing objectives and deal with street drinkers.

40. The Committee took into consideration the above and in order to promote the licensing objectives agreed with Mr. Shah's proposal to change the hours for the sale of alcohol as follows:

Monday to Saturday 11:00 - 23:-00 Sunday 11:00-22:30

- 41. The Committee took into account the fact that the Licence Holder has taken some steps to deal with street drinkers and noted that a condition existed at the Licence regarding training however this condition was only in relation to induction training for legality and procedure of alcohol sales.
- 42. The Committee took into consideration the concerns from the Applicant and local residents regarding the fact that in several occasions the staff had been selling alcohol to drunk customers and decided that in order to further promote the licencing objectives of prevention of crime and disorder and prevention of public nuisance it was appropriate for all staff responsible for selling alcohol to receive biannually training of how to identify drunk or drug impaired customers as well as in the licensing objectives as referred at paragraph 4 above
- 43. The Committee took into consideration the representation in support of the Application by the Trading Standard Officer Mr. Love. The Trading Standard Department was supporting the Application on the grounds of prevention of crime and disorder as well as the prevention of organised crimes in the sale of illicit alcohol, however it was noted that the Trading Standards had different concerns regarding the operation of the Premises than those highlighted by the Applicant.
- 44. The Committee heard that during an inspection at the Premises Mr. Love identified that several illegal bottles of spirits were sold at the Premises. The illegal bottles seemed to have been bough by a calling in the Premises. The Committee heard that Mr. Shah has provided contradictory information regarding the illegal spirits. Initially he confirmed to Trading Standards that he became aware of the origins of bottles only after they were seized. However three months later after during the interview under caution he stated that he instructed DPS not to sell these bottles but the DPS had ignored his instructions.
- 45. The Committee noted that Mr. Love during the inspection at the Premises also noticed that several brands of wine and beer were unfamiliar brands or were on sale for less than expected, It was believed that these items may not have come from a registered suppliers as the prices were either the same or slightly just above wholesale prices. Some of the invoices provided suggest that these types of strong alcohol beers were being sold at a loss by the Premises of which were requested by Mr. Love.
- 46. The buying of illicit alcohol undermines the prevention of crime and disorder objective as these are distributed and managed by organised crime bands. The sale of illicit alcohol also endangers public safety therefore Mr. Love requested the Committee to revoke the licence in the first instance as suggested by the revised guidance when the sale of smuggled alcohol is detected. Trading Standards asked the Committee to focus on the acknowledged origin of some of the spirits and the likely explanations for the presence of certain alcohol.
- 47. If the Committee should not choose to revoke the licence, Trading Standards requested suspension of the premises licence for a period of time to allow the licence holder to review their business model, how they operate and to improve their procedures.
- 48. The Committee heard that Trading Standard Officer was also concerned about the role of the Premises DPS, Mr. Sultan, as he was identified by the Police as the person selling strong beers and ciders to drunk customers, that he was responsible for leaving an untrained members if staff in charge of the Premises as well as the person who was aware that the illegal spirits came from an unauthorised seller and did nothing to prevent them being sold. It was also noticed that the Premises was in breach of several licencing condition.

- 49. Taking all into account Mr. Love stated that if the Committee will not consider to revoke the licence than it should consider appropriate for the DPS to be removed. He suggested the imposition of two conditions to the Licence as summarised below:
 - The licensee will report to Trading Standards any instance of a caller to the shop attempting to sell alcohol or tobacco products within 24 hours.
 - No spirits shall be purchased in a resealed box, without thorough checks being made to ensure it is legal to sell.
- 50. Mr. Shah explained to the Committee that spirits sized by Trading Standard were delivered at the Premises at the time he was away for a week and when a temporary member of staff was left by himself at the Premises while the DPDS was taking some food orders. The Committee heard that the DPS thought that these bottles of spirits were maybe part of the old stock and that the box with the spirits had a UK duty paid stamp which seemed to be legal stock. With regards to selling strong beers at a low prices Mr. Shah said that they have taken the decision to sale these types of beers at the same price as the suppliers in order to avoid losing customers.
- 51. The Committee asked for clarification of why Mr. Love requested revocation of the Licence when it was the Applicant's opinion that their proposed conditions would be sufficient to deal with concerns regarding street drinkers and prevention of crime and disorder and prevention of public from harm.
- 52. It was noted that the issues with illicit alcohol came to the attention of Trading Standard after they were made aware that the Applicant was considering a review. The Trading standard concerns were different from those of the Applicants, they were mainly regarding sale of illicit alcohol and an Application for review would have been submitted by Trading Standard if the Applicant was not going to submit one.
- 53. The Committee took into consideration the concerns of the Trading Standard Officer regarding the way the Premises were operating as well the fact that the licence holder has a duty to promote the licensing objectives however it noted that there was not enough evidence to suggest that strong beers and wines that were bought from unauthorised suppliers to justify the revocation or suspension of the licence.
- 54. The Committee took into consideration the request to remove the DPS however it was noted that there was not enough evidence to suggest that he was involved in the sale and purchase of illicit alcohol. The Committee agreed that more work needed to be done by the licence holder to promote the licencing objectives and decided that the imposition of the training condition referred at paragraph 41 above.
- 55. The Committee decided that the conditions proposed by the Trading Standard Officer together with those proposed by the Applicant, the amendments to the existing condition 11 of the licence, the change of the hours for the sale of alcohol and the training condition would be sufficient to promote the licensing objectives of prevention of crime and disorder and protection of public safety.
- 56. The Committee took into consideration the fact that some illicit alcohol was sized at the premises due to a member of staff buying it from a person calling at the Premises but decided that based on the evidence presented at the hearing the revocation or suspension of the licence was not proportionate or appropriate.
- 57. If any of the parties are unhappy with the decision they are entitled to appeal to the magistrates' court within 21 days from the date of notification of this decision. This determination does not have effect until the end of the period given for appealing against the decision, or if the decision is appealed against, until the appeal is disposed of.

Licensing Sub-Committee 17 June 2020

Powers of a licensing authority on the determination of a review

- 11.16 The 2003 Act provides a range of powers for the licensing authority which it may exercise on determining a review where it considers them appropriate for the promotion of the licensing objectives.
- 11.17 The licensing authority may decide that the review does not require it to take any further steps appropriate to promoting the licensing objectives. In addition, there is nothing to prevent a licensing authority issuing an informal warning to the licence holder and/or to recommend improvement within a particular period of time. It is expected that licensing authorities will regard such informal warnings as an important mechanism for ensuring that the licensing objectives are effectively promoted and that warnings should be issued in writing to the licence holder.
- 11.18 However, where responsible authorities such as the police or environmental health officers have already issued warnings requiring improvement either orally or in writing that have failed as part of their own stepped approach to address concerns, licensing authorities should not merely repeat that approach and should take this into account

when considering what further action is appropriate. Similarly, licensing authorities may take into account any civil immigration penalties which a licence holder has been required to pay for employing an illegal worker.

- 11.19 Where the licensing authority considers that action under its statutory powers is appropriate, it may take any of the following steps:
 - modify the conditions of the premises licence (which includes adding new conditions or any alteration or omission of an existing condition), for example, by reducing the hours of opening or by requiring door supervisors at particular times;
 - exclude a licensable activity from the scope of the licence, for example, to exclude
 the performance of live music or playing of recorded music (where it is not within the
 incidental live and recorded music exemption)¹⁰;
 - remove the designated premises supervisor, for example, because they consider that the problems are the result of poor management;
 - · suspend the licence for a period not exceeding three months;
 - · revoke the licence.
- 11.20 In deciding which of these powers to invoke, it is expected that licensing authorities should so far as possible seek to establish the cause or causes of the concerns that the representations identify. The remedial action taken should generally be directed at these causes and should always be no more than an appropriate and proportionate response to address the causes of concern that instigated the review.

- 11.21 For example, licensing authorities should be alive to the possibility that the removal and replacement of the designated premises supervisor may be sufficient to remedy a problem where the cause of the identified problem directly relates to poor management decisions made by that individual.
- 11.22 Equally, it may emerge that poor management is a direct reflection of poor company practice or policy and the mere removal of the designated premises supervisor may be an inadequate response to the problems presented. Indeed, where subsequent review hearings are generated, it should be rare merely to remove a succession of designated premises supervisors as this would be a clear indication of deeper problems that impact upon the licensing objectives.
- Licensing authorities should also note that modifications of conditions and exclusions of licensable activities may be imposed either permanently or for a temporary period of up to three months. Temporary changes or suspension of the licence for up to three months could impact on the business holding the licence financially and would only be expected to be pursued as an appropriate means of promoting the licensing objectives or preventing illegal working. So, for instance, a licence could be suspended for a weekend as a means of deterring the holder from allowing the problems that gave rise to the review to happen again. However, it will always be important that any detrimental financial impact that may result from a licensing authority's decision is appropriate and proportionate to the promotion of the licensing objectives and for the prevention of illegal working in licensed premises. But where premises are found to be trading irresponsibly, the licensing authority should not hesitate, where appropriate to do so, to take tough

action to tackle the problems at the premises and, where other measures are deemed insufficient, to revoke the licence.

Reviews arising in connection with crime

- 11.24 A number of reviews may arise in connection with crime that is not directly connected with licensable activities. For example, reviews may arise because of drugs problems at the premises, money laundering by criminal gangs, the sale of contraband or stolen goods, the sale of firearms, or the sexual exploitation of children. Licensing authorities do not have the power to judge the criminality or otherwise of any issue. This is a matter for the courts. The licensing authority's role when determining such a review is not therefore to establish the guilt or innocence of any individual but to ensure the promotion of the crime prevention objective.
- 11.25 Reviews are part of the regulatory process introduced by the 2003 Act and they are not part of criminal law and procedure. There is, therefore, no reason why representations giving rise to a review of a premises licence need be delayed pending the outcome of any criminal proceedings. Some reviews will arise after the conviction in the criminal courts of certain individuals, but not all. In any case, it is for the licensing authority to determine whether the problems associated with the alleged crimes are taking place on the premises and affecting the promotion of the licensing objectives. Where a review follows a conviction, it would also not be for the licensing authority to attempt to go beyond any finding by the courts, which should be treated as a matter of undisputed evidence before them.

- 11.26 Where the licensing authority is conducting Fit to width (Ctrl+\) ounds that the premises have been used for criminal purposes, its role is solely to determine what steps should be taken in connection with the premises licence, for the promotion of the crime prevention objective. It is important to recognise that certain criminal activity or associated problems may be taking place or have taken place despite the best efforts of the licence holder and the staff working at the premises and despite full compliance with the conditions attached to the licence. In such circumstances, the licensing authority is still empowered to take any appropriate steps to remedy the problems. The licensing authority's duty is to take steps with a view to the promotion of the licensing objectives and the prevention of illegal working in the interests of the wider community and not those of the individual licence holder.
- 11.27 There is certain criminal activity that may arise in connection with licensed premises which should be treated particularly seriously. These are the use of the licensed premises:
 - for the sale and distribution of drugs controlled under the Misuse of Drugs Act 1971 and the laundering of the proceeds of drugs crime;
 - · for the sale and distribution of illegal firearms;
 - for the evasion of copyright in respect of pirated or unlicensed films and music, which does considerable damage to the industries affected;
 - for the illegal purchase and consumption of alcohol by minors which impacts on the health, educational attainment, employment prospects and propensity for crime of young people;
 - for prostitution or the sale of unlawful pornography;
 - · by organised groups of paedophiles to groom children;
 - · as the base for the organisation of criminal activity, particularly by gangs;

 - · for the organisation of racist activity or the promotion of racist attacks;
 - for employing a person who is disqualified from that work by reason of their immigration status in the UK;
 - · for unlawful gambling; and
 - · for the sale or storage of smuggled tobacco and alcohol.
- 11.28 It is envisaged that licensing authorities, the police, the Home Office (Immigration Enforcement) and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence even in the first instance should be seriously considered.
