### SUMMARY

The Council must divide each parliamentary constituency in the area into polling districts, designate polling places for those polling districts, and keep them under review. This report sets out the methodology and results of the 2025 review and seeks approval for the updated polling scheme.

### RECOMMENDATIONS

1. That General Purpose Committee approve the adoption of parliamentary polling districts and parliamentary polling places as set out in the scheme contained in Appendix 1.
2. That General Purpose Committee approve the adoption of the scheme contained in Appendix 1 in relation to all other referenda and elections held within the borough.
3. That General Purpose Committee instruct the Electoral Registration Officer to make the necessary amendments to polling districts and to revise and republish the electoral register on 1 February 2026.

## Financial Impact

Approval for the updated polling scheme will result in a small increase in costs of approximately £1100 for polling station hire overall.

The new station in Parsons Green and Sandford will cost £1350 to hire, and the move from West London Free school to the Quaker Meeting House will cost an additional £850. There is a saving of £1083 in Palace and Hurlingham from the cessation of use of the Parsons Green Club.

At Parliamentary and Greater London Authority Elections, the additional hire fees will be funded by central government, through the Ministry for Housing, Communities and Local Government, or by the Greater London Authority. Local council elections are funded by Hammersmith and Fulham Council.

## DETAILED ANALYSIS

### Proposals and Analysis of Options

1. Due to the complexity of the proposals, with maps and tables, please see the separate document at Appendix 1 which sets out the proposals and the reasoning behind them, and Appendix 2 which provides detailed maps.

### Reasons for Decision

2. Under Section 18A of the Representation of the People Act 1983 (as amended) the Council is required to divide each parliamentary constituency in the area

into polling districts, to designate polling places for those polling districts, and to keep these under review.

3. Some previously designated polling places are no longer available or are no longer the most convenient venues available, and this review has identified new or more suitable polling places that the Council is asked to approve.

## **Equality Implications**

4. Local authorities have a duty to review the accessibility of all polling places to disabled voters and ensure that every polling place and prospective polling place for which it is responsible is accessible to disabled voters 'so far as is reasonable and practicable' (Representation of the People Act 1983, Section 18 (2)(a)).
5. An Equality Impact Assessment, shown in Appendix 3 was developed alongside the review to consider the review's impact on electors who have protected characteristics.
6. All pre-existing polling places were visited by electoral services officers to conduct a survey to ensure they were sufficiently accessible (or could be made to be accessible with additional equipment or other adaptations). A standard survey, based on Electoral Commission guidance, was completed for each venue. The template used is provided in Appendix 5.
7. Electoral Commission guidance, shown in Appendix 5, provides further information on considering accessibility issues that was followed in completing this review.

## **Risk Management Implications**

8. The review of polling districts and places seeks to mitigate the risk that electors are impeded from voting due to poor accessibility of polling places, whether due to location, physical access, sub-standard facilities.
9. In reviewing polling places, the reasonable facilities for staff at polling stations during elections has also been considered, as has the space, facilities and general safety for members of the public visiting their polling stations. All recommended new polling places have also been assessed to ensure that they comply with accessibility requirements.

## **Consultation**

11. A notice of review and initial proposals were published on the council's website and on the "Have your Say" website on 14 August 2025, updated on 22 October where new proposals were made following the initial consultation period, and closed on 5 November.
12. Links to the consultation and invitations to respond to the proposals were sent to all local elected representatives, including all Councillors, the three Members of Parliament that represent the borough, and to local political party organisers and agents active at the most recent sets of elections.
13. Although the Council used "Have your say" as the main pathway for responses, emails, letters or other written methods of response were also encouraged via the Council website and email.
14. Representations were specifically sought from local disability action groups on the accessibility and suitability of polling places.
15. 548 charities and local organisations were emailed directly inviting them to respond to the proposals either online or via email or post.
16. There were 27 responses, and these are provided in Appendix 4, both in full and summarised with the Returning Officer's comments.

# Polling District and Polling Places Review 2025

## Final Proposals

### Introduction and background

1. Under the Representation of the People Act 1983 (RPA83) the Council has a duty to divide the borough into parliamentary polling districts and to designate polling places for each one. The same districts are used at all elections and referendums.
2. There was a comprehensive review of the polling districts and polling places in 2021, which followed the ward boundaries review conducted by the Local Government Boundaries Commission, and subsequent elections have shown the arrangements are working well.
3. As a result, the Returning Officer proposed to keep the existing polling arrangements and to make changes only where circumstances required them, to minimize potential confusion for voters.
4. Additionally, three very small polling districts, created to allow a Parliamentary by-election to take place under the old constituency boundaries if needed, are now superfluous to requirements, and the Returning Officer has proposed that they be re-incorporated into the larger districts they were divided from.
5. The submissions to the review then identified some additional changes, which have been incorporated into these final proposals where appropriate. These are explained in the “Returning Officers comments”, below, as are those proposals that were made but not considered beneficial for the polling scheme.

### Timeline of engagement and decision making

6. The review has followed the following timetable:

14 August 2025	Publication of notice of review and initial proposals. Start of consultation period
22 October 2025	Publication of updated proposals following initial consultation period.
5 November 2026	Public consultation closed
28 January 2026	Formal meeting of Full Council to approve new proposals
30 January 2026	Publication of electoral register

### Criteria used for assessing proposals

7. The following criteria were used when drawing up these proposals. The first two are required by electoral law; the others are taken from previous reviews and proposal documentation. They are general guidelines and not strict rules.

- a. The Council must seek to ensure that all electors have such reasonable facilities for voting as are practicable in the circumstances.
- b. The Council must seek to ensure that so far as is reasonable and practicable

every polling place is accessible to electors who are disabled.

- c. Ideally the polling place should be in its own polling district.
- d. Polling districts should have no less than 1000 and no more than 3000 electors per polling district and ideally between 2000 and 2500 electors.
- e. Polling places should not be shared by two wards.
- f. Where possible “natural” boundaries should be used, e.g. railways, major roads, waterways.
- g. All properties in a minor road or estate should be in the same polling district.
- h. Polling places should be “logical”; that is, electors should not have to pass another polling place to get to their own place.
- i. Schools will be avoided where possible if polling prevents the school in question remaining open to pupils and/or other suitable venues are available in a polling district.

### **Access for Disabled voters**

- 8. All polling stations that are currently used by the council have reasonable, if not always ideal, facilities for Disabled voters, albeit with some venues requiring adaptation for polling day such as ramps or additional lighting.
- 9. All polling stations have been visited by electoral services staff, and a survey of each is completed. The survey used is provided by the Electoral Commission, with some additional data gathered that is useful locally.
- 10. As part of the formal consultation process, information about the review will be forwarded to local Disability action groups for comment and/or alternative proposals.

# Returning Officer's proposals

11. The tables below shows the Returning Officer's proposals for the new polling scheme. Where this involves a change to the polling place, this is indicated in the table. This is followed by tables showing the proposals for each ward, giving the rationale for any changes and explaining which other alternatives were considered.

12. The electorate figures shown are the number of electors on the register of local government electors as at 1 August 2025. This electorate was chosen over the smaller Parliamentary electorate to ensure stations will be big enough to accommodate the maximum number of electors whichever poll is taking place.

### Returning Officer's comments

A proposal was received suggesting that boundaries in this ward be changed as follows:

- Voters in Lillie Road around Bishop Creighton House, Delorme Road, Bothwell, Hawkmoor, Everington and possibly Averill Street would vote at Twynholm Church
- Voters in Queens Club Gardens would vote at St Matthew's Hall instead of Twynholm Baptist church
- Voters in Cobbs Hall and Clifford Haigh House would vote at Queens Manor school

Electoral Services Officers visited the ward and timed various routes from properties in affected roads to existing and new stations to assess the convenience of the alternative scheme.

While the suggested scheme was viable, the improvement to journey times was not of such significance that it would outweigh the potential for confusion for voters who are currently accustomed to polling at their usual stations.

It is not, therefore, proposed to alter the existing arrangements at this time.

## 7. Fulham Town (FT)

### Returning Officer's comments

Two somewhat opposing proposals were submitted for this ward. These were:

- A proposal that voters in FTC and FTB polling districts to vote at Thomas's Academy, and to cease using Norah Phillips as the premises are not easily located
- A proposal that voters in Munster Road, together with Filmer Road, Swift Street, Felden Street and potentially Rostrevor Road vote at Norah Phillips Hall.

Proposal a, that voters in FTB polling district should vote at Thomas's Academy is not supported by the Returning Officer because Thomas's Academy already hosts two polling stations, one from another ward (PHC district). Although it is not impossible, accommodating a third polling station in the venue would be difficult and a likely source of confusion and queues on polling day. Norah Phillips Community Hall, though not as readily located as a school building, is well placed within the FTB district.

Proposal b, that voters move to Norah Phillips Community Hall from their current station at Fulham Library is not supported because the venue itself is rather small, and although reasonably easily located, is not as well situated as the library, as the other submission received for this ward points out. The journey times are not significantly different, and the Returning Officer does not believe this would improve convenience for voters.

### Returning Officer's comments

Since the 2022 council elections, the Quaker Meeting House at 30-32 Bradmore Park Road, W6 0DT has been used for polling because West London Free School has been unavailable.

The meeting house is a good venue, easily located by voters, and has good facilities for

voting and for staff, and avoids disrupting the school previously used for voting.

## 9. Hammersmith Broadway (HA)

### Returning Officer's comments

A proposal was received to move district boundaries so voters in the Fulham Reach development, and in the north side of Chancellor's Road, would vote at St Augustine's Church Hall instead of at St Paul's Primary School.

As with the suggestion made for Fulham Reach, this would be a viable scheme for the area, but Electoral Services Officers did not find the difference in travel time was significant. The current polling place at St Paul's School is very close to the transport hub at Hammersmith Broadway, so there is little difference in convenience for those voters who need to commute.

Given the difference in convenience is very minimal, it does not outweigh the potential inconvenience and confusion that may be caused by moving voters to a new polling place.

### Returning Officer's comments

As part of the review, the Returning Officer sought alternatives for Vignola Hall, which, has become more difficult to access due to the installation of a gate at the estate's entrance on Lillie Road.

Some alternatives were suggested – these were:

- Potentially designating Fulham Primary School as the polling place for LEB
- Using the resident's common room at Viking Court or a room at the new MerCure Hotel for polling
- Moving voters in Racton Road and potentially Seddlescombe Road to vote at Fulham Primary School

Although voting at Vignola Hall is not ideal, the gate can be managed, so although an alternative venue would be welcome, it is not absolutely imperative one be found.

The alternatives of Viking Court and the Mercure hotel were investigated. Viking Court is not suitable due to security and welfare concerns for residents, who require access to the common room daily as it gives access to other facilities, such as their laundry room.

The Mercure hotel rooms would be reached via the hotel lobby. The lobby was very busy on the day that the electoral services officers visited, demonstrating that access would not be very straightforward for voters. The price is also likely prohibitive given the hotel is a commercial concern.

The final suggestion, to move voters from Racton Road into LEC, is a sensible tidying up of the district boundary, as it also removes an anomaly whereby electors walking south from Tamworth Street could pass voters from Racton Road going north to their polling station, and it also slightly reduces journey time for Racton Road's voters.

**PHB** – the All Saints Church Hall is still undergoing building work, which is expected to finish in 2026. As it is not available at present, the Church itself will continue to be used. This district will be reviewed again when the Church Hall is rebuilt, allowing a reversion to the previous arrangement (subject to review).

### Returning Officer's comments

The old West Kensington Estate Tenants Hall building has been demolished and is being rebuilt. The replacement building is expected to be completed by October 2026. There is no room on the site on which to place a temporary cabin.

Submissions were received that indicated the Earls Court Community Hub is not a well-located venue for the WEB polling district, and some alternatives, such as using Vignola Hall, in a neighbouring district, were suggested.

# **Equalities Impact Assessment Polling District and Places Review**

## **A. Background**

This assessment is informed by the council's Equality Impact Analysis Tool. It reflects the public sector equality duty that came into force in April 2011, and Electoral Commission guidance on accessibility of polling venues. .

## **B. Summary**

This assessment reviews voting at polling station and assesses the impact on residents, and specifically those with protected characteristics. It will identify particular issues that may impact on people with each particular characteristic and will list the mitigations we can make for each.

All new polling places are subject to a site assessment where electoral officers visit the premises and conduct a thorough assessment of the facilities, access and location.

Existing polling venues have been visited by electoral services staff within the last two years, in addition to being reviewed using polling station logbooks and other feedback from Presiding Officers

Note that no polling place will be recommended unless it can be adapted to allow it to pass the assessment (such as by providing temporary ramps or lighting, for example), or, in very exceptional circumstances, where there is simply no more suitable venues or other alternative available within the polling district or within a reasonable distance of it.

The assessment includes access, size of venue, width of entrance and internal doors, space for tellers, lighting, ventilation, kitchen and restroom facilities, etc. In particular, the officer must conduct checks for the accessibility of the site in order to determine suitability as a polling place with regards to disabled voters, such as level access, good lighting, handrails, non-slip flooring and so on.



I've heard back from [REDACTED], the Development Manager. Unfortunately, he says that they are not expecting to complete the project until October 2026 so the new TRA hall at West Kensington estate won't be available next May.

I also asked if there was room to put a temporary cabin on/near the site, but he's looked at construction sequencing and the site space constraints also mean a cabin isn't an option.

He did suggest either Vignola Hall or Gibbs Green TRA Hall as potential solutions – but neither are in the same ward.

To add to that, Gibbs Green TRA is a lot further away than the Community Hub we currently use, and although Vignola Hall is closer, voters would have to cross Lillie Road. It is already used as a polling station and I don't think another would fit in very comfortably as it's not a very large room.

So for the time being I think we're going to have to propose using the community hub as at the last election, but we can put in a provision that the district gets reviewed again next year with a view to reinstating / designating the new West Kensington TRA hall as soon as possible? What do you think?

Thank you for sharing the proposals for the Polling District and Places Review.

I would like to raise concerns regarding the proposed change for the WEB polling station from the West Kensington Estate Tenants Hall to the Earls Court Community Hub.

During the 2024 General Election, we experienced significant issues with signage and voter confusion at the new ECDC site. Many residents were unaware of the change, and the signage provided was poorly positioned, facing away from the estate, making it difficult for voters to locate the polling station. This led to dozens of residents arriving at the old site, where we had to leave a volunteer to redirect people throughout the day. The situation escalated to the point where we had to stop an officer who began removing signs prematurely at 8pm.

Given that the Tenants Hall has been a familiar polling place for over 30 years, its absence was keenly felt.

I also believe it may be incorrect to assume that the Tenants Hall has been permanently demolished. In fact, the site is currently being redeveloped, and the new building is expected to be handed back to LBHF in late 2025. Further details can be found here: <https://www.lbhf.gov.uk/housing/building-homes-and-communities/lillie-road-development>. Given this timeline, it may be possible to reinstate the original polling place in future elections, and I would appreciate confirmation on the expected handover date.

If the hall can be rebuilt and made available in time for the 2026 Local Elections, then I would strongly recommend reinstating it as the polling place for WEB.

Thank you for considering this feedback. I'm happy to discuss further if needed.

Dear Zoe,

Thank you for letting me know about the review of polling districts. I support the vast majority of the recommendations but, as I've previously expressed to you, I do have concerns or ideas about a handful (some of which haven't been raised within the review, but which I hope you'll consider), as follows. I'll go through them by ward, alphabetically.

**Fulham Reach FRB/D**

I think it is unreasonable to expect voters from Queens Club Gardens to have to vote at Twynholm, which is a significant distance away AND not at all a "natural" direction of travel for them. I would prefer that Queens Club Gardens vote at FRB: Matthews Hall, which is both nearer and just off the Greyhound Road-Star Road thoroughfare onto which this development leads.

I acknowledge that there are issues of congestion at peak voting times at Matthews Hall, but this is resolvable. The congestion arises because the polling station only allows people in and out of the main entrance in Margravine Road. But Matthews Hall has fire escape doors within the hall itself which exit onto the green to the rear and, thereafter, to a side gate into St Albans Terrace and back onto Margravine Road.

If voters were directed to leave via this exit (presumably the side gate may need unlocking?) and signs provided telling arrivals to use the main gate not the side gate, I think the congestion issue could be resolved, in what is otherwise an almost perfect polling station in terms of capacity. Matthews Hall has even been used as a counting venue (1988 Margravine by-election) so there is not a wider issue of space here: it's just about the numbers exiting and entering at peak times.

Using the fire door/side exit should also not produce any accessibility issues either.

**Other Fulham Reach polling district boundary issues**

I would also suggest moving the section of Lillie Road in FRA, around Bishop Creighton House, plus Delorme, Bothwell, Hawksmoor, Everington and – perhaps – Averill, into FRB as Twynholm is far closer to these residents than Melcombe School is.

Clifford Haigh House and Cobbs Hall, in my opinion, would be somewhat better located in the FRC polling district as Queen's Manor School is a bit closer than Melcombe for both. These are both chronically low turnout blocks so whichever polling district they're located in won't be ideal but, having once represented them I think it'd be worth giving this a try.

**Fulham Town FTA/FTB**

This is not an issue with the recommendations the council has made, which I support, but I would ask that you consider moving the FTA stretch of Munster Road plus Filmer Road, Swift Street, Felden Street and – maybe - Rostrevor Road into FTB as the Norah Phillips Hall is significantly closer for these residents than Fulham Library.

Lillie LLB/C

This is not an issue with the proposals the council has made, which I support, but could I ask you to consider moving Racton Road from LLB to LLC as the Fulham School, Halford Road polling station is significantly closer, and easier for the residents of this road to reach, than going around the houses to Vignola Hall, Lillie Road? The same is true for Sedlescombe Road, though there is slightly less in it.

Munster MSB

I understand your preference for using Lygon House over the Childerley Centre. I do have considerable reticence, however, about using a sheltered housing scheme as a polling station given that the clue is in the name: it is secure, sheltered accommodation never intended for the wider public to be given access to, even if on a limited basis and only for a day.

I may be being too sensitive about protecting the interests of the senior citizens living here but I know that if Rowberry Close or Cedar Lodge had ever been proposed as polling stations in Crabtree ward during my time as their councillor I would have fought tooth and nail against such an idea – as would the residents and the (then) sheltered housing officers. Personally, I think the Childerley Centre should be preferred unless it is, exceptionally, unavailable.

Hammersmith Broadway HAB/C

This is not an issue with the proposals the council has made, which I support, but please could I again make the case that it is far more logical for the Fulham Reach development and the north side of Chancellors Road, currently within HAB, to vote in HAC, at St Augustine's Church.

A round-the-houses walk to Worlidge Street for these voters is not naturally how I would imagine the bulk of them flow. When leaving for work or to travel or shop they are far, far more likely to walk to the Broadway via Chancellors Road and up Fulham Palace Road than go all the way around Crisp Road, Queen Caroline Street and then down Worlidge. St Paul's School is much further from them than the Church is.

Yes, they would need to cross Fulham Palace Road but this is hardly the most difficult road to cross and there is a pedestrian crossing almost immediately outside the church. The council also requires Peterborough estate residents to cross New Kings Road to vote, and Gibbs Green estate/Beaumont Crescent residents to cross North End Road to vote. Moving Fulham Reach across to HBC also better balances the electorates of these two districts, B being 900 electors larger.

Parson's Green & Sandford PSB

The lack of suitable venues for polling stations in this ward generally is far from ideal, but I would again flag that the Peterborough estate should, ideally, vote at Christ Church rather than Holy Cross School in Basuto Road, which is a considerable distance away from them.

When the Labour Party suggested this following the ward boundary changes, I believe you did investigate and was told that the church could not accommodate a polling station for the 2022 local elections. I don't believe they said it would never be available for use: it was, at least at that time, just unavailable for that election.

When Sulivan ward existed, this church was the polling station for (I think) the VB polling district, so it is not a "new" idea for this to be used as a voting place: it was used as one for decades.

### New PSD polling district?

On a wider issue, I note that so-called “King’s Road Park” is beginning to come onto the electoral register.

As this large development populates the register, presumably fairly quickly now, the inappropriateness of the current polling station for PSC – which is already less than ideal, lying in another ward – will rapidly increase. Hence I wonder whether this is the appropriate review to redraw the polling districts in Parson’s Green & Sandford, or if you want to wait until the next one?

I have no idea what communal facilities are being provided for this development but presume there will at least be a gym, or even sufficient outdoor space to locate a temporary polling station somewhere within it? Could the marketing suite in Sands End Lane be used?

I would propose that a new polling district be created for the Sandford Manor side of this polling district (ie south east of Kings Road) while the Moore Park area continues to vote with WAC at the Methodist Church in Fulham Road. If there continue to be no suitable venues within the ward then perhaps the Wharf Rooms – the current SAA polling station, would be an acceptable (shared) polling station for them?

### Palace & Hurlingham PHE

I very strongly dislike the use of the Parson’s Green Club as a polling station for PHE. The club is not within the polling district and for many residents is little further than the Sands End Community Centre, which is of course more centrally located in Peterborough Road than the Club on Broomhouse Lane.

There exist options to the Parson’s Green Club and perhaps even better ones will emerge as Hurlingham Wharf is completed, but to suggest four:

- Philpott Square Tenants Hall – right in the middle of the polling district and ideally placed for where the bulk of the electorate live
- Thomas’s Fulham School in Hugon Road, a few metres east of Peterborough Road. I appreciate this is now a private school and so they are under no compunction to assist, but they would surely have the space and the site is accessible and convenient
- Even better – the former council building right on the corner of Hugon and Peterborough Roads (can’t recall what it was originally for: maybe an adult education centre or an annexe to the school?) I’m not sure whether this is derelict but it has a sign advertising TK martial arts, both suggesting a suitably sized hall and with disabled access to the rear. Needs a bit of clearing up though.
- I don’t know how much longer this building will still be here (if it still is) but the Thames Water Tideway Tunnel offices on Carnwath Road appear to be fully accessible and may be a suitable venue for a polling station?

All four of these suggestions – before knowing if there might be a fifth option within the Hurlingham Wharf development – are, in my opinion, superior to the Parsons Green Club, being within the polling district and central to the bulk of its electorate. But even if none of these ideas prove workable, I would return to my earlier point that they’d be better served voting at Sands End Community Hall over the PG Club until somewhere better can be found.

## Reviews of polling districts, polling places and polling stations

### The accessibility requirements of a polling place review

Every person should be able to vote without facing barriers. By identifying and understanding the physical, psychological and information barriers disabled people may face when voting, ROs will be better able to make appropriate arrangements to help support them.

You can find more information in our guidance: [Understanding the barriers to voting for disabled people](#).

As part of the compulsory review, local authorities must consider the accessibility of potential polling stations when considering designating or reviewing a polling place. In doing so they must seek to ensure that:

- all electors in a constituency in the local authority area have such reasonable facilities for voting as are practicable in the circumstances
- so far as is reasonable and practicable every polling place for which it is responsible is accessible to electors who are disabled

### Engaging with accessibility experts

As part of the review the local authority must seek representations from those who have a particular expertise in relation to access to premises or facilities for persons who have different forms of disability, as well as engaging any disability access groups and/or disability officer.

### Your duty to consider the accessibility issues

Local authorities have a duty to review the accessibility of all polling places to disabled voters and ensure that every polling place, and prospective polling place, for which it is responsible is accessible to disabled voters 'so far as is reasonable and practicable'.

According to the Equalities and Human Rights Commission the duty to make reasonable adjustments comprises three requirements.

For service providers and those exercising public functions, these requirements are:

- Where a provision, criterion or practice puts disabled people at a substantial disadvantage compared with those who are not disabled, to take reasonable steps to avoid that disadvantage.
- Where a physical feature puts disabled people at a substantial disadvantage compared with people who are not disabled to avoid that disadvantage or adopt a reasonable alternative method of providing the service or exercising the function.
- Where not providing an auxiliary aid, for example a ramp for wheelchair user<sup>1</sup>, puts disabled people at a substantial disadvantage compared with people who are not disabled, to provide that auxiliary aid.

Access to the polling station is still a barrier to some disabled people who want to cast their vote in person. Some of the main physical access issues which should be considered as part of a review are:

- polling places and stations with steps into the entrance, or otherwise inaccessible
- narrow doorways and corridors
- lack of space within the polling place that did not enable motorised wheelchair manoeuvrability
- lack of space and secrecy for the elector and their companion to discuss the elector's choice of vote
- lack of low level polling booths or booths/tables that didn't provide disabled voters with confidence that they could cast their vote in secrecy as they were positioned close to the polling station staff
- a lack of chairs to enable people to rest
- a lack of a clear display of guidance or aids (such as tactile voting devices) to enable people to feel confident about the process
- inadequate lighting

The Elections Act 2022 provides a duty for ROs to provide each polling station with such equipment as it is reasonable to provide for the purposes of enabling, or making it easier for, relevant persons to vote independently and in secret<sup>2</sup>. The review should therefore include consideration of whether the building can accommodate the equipment you will provide to support disabled voters.

We have produced an accessibility checklist that can be used to assess the suitability of each polling place and polling station which covers these, as well as other issues.
