The Good Growth Fund is Mayor Sadiq Khan's new £70 million regeneration programme to support growth and community development in London. Working with the London Economic Action Partnership (LEAP), the fund will support projects that are: inclusive, innovative and which demonstrate an outstanding approach to challenges faced across London.	
The NOURISH project combines two proposals detailed later in this report into one project that delivers on all 3 Good Growth Fund priority areas of making better places, empowering people, and growing prosperity. This report seeks authority to use section 106 monies to part fund the project.	
Reasons for Urgency:	

Urgent decision is required to enable the Council to enter into funding agreement with the Greater London Authority to avail of their match funding for the project. The set deadline to enter into the funding agreement was 31st March which has already passed and we are working with the GLA to achieve urgent sign-off.

Agreed:

- 1. Agree to delegate authority to the Strategic Director of Growth and Place, in consultation with the Strategic Director of Finance and Governance, the Cabinet Member for Economic Development and Regeneration and the Cabinet Member for Finance to use section 106 monies to fund the Nourish project as outlined in the Finance section in the report.
- 2. Agree to delegate authority to the Strategic Director for Growth and Place, in consultation with the Strategic Director of Finance and Governance, the Cabinet Member for Economic Development and Regeneration and the Cabinet Member for Finance to take the necessary steps to enter into funding agreement with the Greater London Authority to secure the match funding for the project.
- Agree to delegate authority to the Strategic Director of Growth and Place in consultation with the Strategic Director of Finance and Governance, the Cabinet Member for Economic Development and Regeneration and the Cabinet Member for Finance to take the necessary steps to enter into funding agreements to secure additional funding for the Nourish project.
