Due to an omission on a previous report, four contracts delivering accommodation and support to vulnerable residents in the borough are due to expire on 31 March 2019. To ensure continuity of service for vulnerable residents we are seeking a leaders' urgency decision.

1. EXECUTIVE SUMMARY

- 1.1. Between 2010 and 2013, the council commissioned four providers to deliver supported accommodation: Centrepoint to deliver a young people's service; St Christopher's to deliver a young people's assessment centre; Hestia to deliver a domestic violence refuge and Metropolitan to deliver young parents supported accommodation.
- 1.2. Two Cabinet reports were approved on 5 March 2018 to direct award four contracts for the above services for the period 1 April 2018 to 31 March 2019, with the option to extend for up to an additional 12 months. Letters extending the original contracts dated 21 March 2018 were issued based on the terms of the original contracts.
- 1.3. With regards to the option to extend for a further period of 12 months from 31 March 2019, explicit wording to delegate the extension decision to the Director of Adult Social Care in consultation with the relevant Cabinet Member was omitted.
- 1.4. Due to expiry of the existing extension periods in respect of the Contracts set out above, approval to exercise a further extension for a duration of 12 months, from 1 April 2019 to 31 March 2020, is sought by way of Leaders' Urgency Decision.

2. RECOMMENDATIONS

It is recommended the Leader:

- 2.1. approves the extension of the contract with Hestia Housing and Support to deliver a Domestic Violence Refuge for a duration of 12 months from 1 April 2019 to 31 March 2020, at a total value of £121,934;
- 2.2. approves the extension of the contract with St Christopher's to deliver supported accommodation to young people for the period 1 April 2019 to 31 March 2020, at a total value of £218,475;
- 2.3. approves the extension of the contract with Centrepoint to deliver supported accommodation to young people for the period 1 April 2019 to 31 March 2020, at a total value of £316,536; and
- 2.4. approves the extension of the contract with Metropolitan to deliver supported accommodation to young parents for the period 1 April 2019 to 31 March 2020 at a total value of £139,580.

3. REASONS FOR DECISION

3.1 To ensure continuity of service for vulnerable residents whilst Officers complete a strategic review of these services and run a procurement exercise for these services.

4. PROPOSAL AND ISSUES

- 4.1. Two Cabinet reports were approved on 5 March 2018: the Young People's Accommodation Services Direct Contract Award Report and the Domestic Abuse Refuges Direct Contract Award.
- 4.2. In these Cabinet reports, three direct awards for Young People's Accommodation contracts and one Domestic Violence Refuge contract were approved. This covers the period 1 April 2018 to 31 March 2019 with the option to extend for up to an additional 12 months. The total contract value for the two year period was approved. However, explicit wording to delegate the extension decision to the Strategic Director of Adult Social Care in consultation with the Cabinet Member was omitted.
- 4.3. This report therefore seeks approval to extend the four contracts, outlined in Table 1 for 12 months each from 1 April 2019 to 31 March 2020.

- 4.4. The primary objectives of the services are:
 - 4.4.1. to enable residents to move on successfully and rebuild their lives;

- 4.4.2. to enable vulnerable young people to develop the skills and resilience to be independent in adulthood;
- 4.4.3. to prevent homelessness; and
- 4.4.4. to increase the number of people in employment, training, or education.
- 4.5 All four contracts continue to deliver good outcomes for residents. These four contracts provide 57 units of accommodation and in 2017-18 supported 95 individuals. One of the main objectives of the services is to enable residents to move on successfully and rebuild their lives; the contracts' KPI (Key Performance Indicator) target for planned moves is 78%. All four providers cumulative planned move rate over the last two years has exceeded this target.

Review Timetable

4.6 All the services are being reviewed and the expected timetable to develop proposals for the future procurement strategies and business cases are outlined below. The Specialist Housing Board and Programme set up by the Public Services Reform department in 2018 will ensure a coherent strategic approach to commissioning supported accommodation services, and facilitate joint working across the council

5. OPTIONS AND ANALYSIS OF OPTIONS

Allow existing contracts to expire on 31 March 2019

5.1 The services are non-statutory and therefore the Council is not obligated to replace them when the current contract expires. However, the Council is committed to supporting women and children who have experienced domestic abuse and preventing homelessness, therefore this option is not recommended.

Extend for an additional 12 months to the incumbent providers

5.2 This will enable the Council sufficient time to consult with residents and other stakeholders to determine the future commissioning and procurement

strategy and ensure new services are in place to improve outcomes and value for money by April 2020.

This option is the recommended way forward.

6. CONSULTATION

6.1. The service providers have confirmed their willingness to continue to provide services as set out above. Further engagement with residents, suppliers and other stakeholders is being undertaken as part of the service review and the development of the procurement strategy.

7. EQUALITY IMPLICATIONS

- 7.1. There are no direct negative equality implications for protected groups because of the proposed extension of these contracts, under the Equality Act 2010. A continued positive impact is anticipated through service continuity, which will ensure vulnerable young people and victims of domestic violence are provided vital support and accommodation.
