Good morning Mr Samaroo

Further to my previous e-mail attached, please note the exact wording of the 2 conditions that would be added by the licensing team should the licence be granted would be as follows:

1. The premises shall not operate until;

- 1. A pre-opening inspection by an authorised officer of the Council has been undertaken at the premises; and**
 - 2. Written confirmation that the premises is safe for members of the public to access has been submitted to the licence holder. This written confirmation shall be made available to authorised officers on the Council upon request.**
-
- 1. A public safety management plan shall be implemented. The plan shall be made available to authorised officers of the Council and shall include:**
 - 1. A Fire Safety Policy, a Risk Assessment together with evacuation and escape plan including all premises using the shared evacuation route.**
 - 2. Staff training records, including all employees using the shared evacuation route.**
 - 3. Statutory certificates for utilities.**
