I should like to add that I have also used an App to measure the noise of the market (at setting up / packing up and during trading hours), the school when the children are on playground equipment and the outside of school and market hours. I am unsure how to provide this information to you (I lack the IT skills). In summary, when the children are playing in the playground, the noise levels reach well above 70 decibels (maximum recorded was 78d); when the market is setting up or packing up, noise levels are just under this level (maximum recorded was 71d in the morning and 75d in the afternoon); when the market is trading, noise levels recently (i.e. without music, during a quiet half term and trying to behave themselves) were around 60 decibels (maximum recorded was 62d) - but they would be right up in the 70s with the music and a busier market. In contrast, on the Friday and Sunday of half term, the maximum noise level recorded at various times of the day ranged from 35 to 46 decibels.

The school playground is very noisy and close to permitted safe levels of noise (which I understand is c. 80 decibels) and way above what is generally considered acceptable in a residential area. Those of us who live here all accept that these are noises that we took on when we moved here. The flip side of this was that we would only have noise during school days. Now we have significant noise from the market at weekends and in the evenings and

this is unreasonable particularly given the level of noise we tolerate from the school during the week.
