I, Hari Malhi, live at Gayford Road, Shepherds Bush, W12 9BY three doors down from The Good Shepherd School. My home is within very close proximity to the main gate of the school and I write this comment in support of the premises licence being granted. Despite my home being only a number of metres from the school, I have never been disturbed by the school, any events they hold there or the weekly Sunday Farmers' market, which I would fully support being made permanent.

Having the farmers' market running not only raises much needed extra funding for the school, but also as a premises in general, it has always been respectful to neighbours and the general local community. I am yet to encounter anybody who has any complaints against the market.

The people who run the school and the market are very clean and tidy; the premises is always left spotless by the end and they regularly clean the premises throughout the day to keep it safe for everyone. The street is cleaner in fact, since the market began some months ago.

There is no nuisance or disturbance in terms of noise, aside from the usual children playing. There is never any antisocial behaviour and the safety of the school/surrounding residents is, I believe, unaffected by there being a premises licence or the sale of alcoholic beverages. All local children are entirely safe and happy on this site and I cannot see how a permanent premises license would change this.

I do not hear anything remotely loud enough to bother me on the Sundays when the market is on and in fact was unaware it existed for quite some weeks. I am writing in support of The Good Shepherd School's application for an alcohol license for the premises and the Sunday Farmer's Market. I tried to do so using the on-line form but twice my submission was rejected by the system for reasons I do not know other than it said 'error in the system'.

I have lived in very close proximity to the school for six years and my son is now a pupil. In this time, the school has run fund-raising events where alcohol has been made available without it ever having a negative impact on our lives. My direct experience is that the school leadership and PTA have always taken the utmost care to ensure that events are run responsibly with respect to the school children, their families and our wider local community. These events offer a family-friendly atmosphere with zero evidence of excessive drinking. Noise is always kept to a minimum and events finish early out of respect to neighbours. There is no reason to suspect that this would change at all by the granting of this alcohol license.

Ditto the new Farmers' Market. In several visits with my young son, I have never witnessed any problems arising inside or outside the market which would suggest it has a negative impact on public safety or would create a nuisance in our community. Friendly stewards at the gate set the tone from the start with their calm and positive welcome. This continues inside with stewards visible at all times. I am always impressed at how quiet the surrounding streets are when the market takes place. Further, on our most recent visit, only when we made our way deep into the playground did we actually hear an acoustic musician playing gently to market goers. The sound was well-contained within the confines of a small section of the playground and did not extend outside the grounds of the school playground. I also want to commend the market team for keeping the premises and surrounding streets free of rubbish or waste.

When alcohol has been made available at either school/PTA events or the market, the atmosphere has remained respectful and family-friendly. Organisers take the utmost care to prevent any possibility of crime or disorder. People are seen to be drinking sensibly and usually with a meal, or other food available, and often sat down at tables chatting, offering little to no disturbance to neighbours.

Events welcome people of all ages from across the social and ethnic mix of our community, creating a safe and enjoyable environment for neighbours to spend quality time together. Our busy modern world doesn't provide for such things easily but The Good Shepherd does so with creativity, caution and an abundance of responsibility to keep everyone involved safe and happy.
