Comments: 15/06/2022 9:44 AM I object to the licence operating beyond 11pm on any day of the week. I also object to the premises being allowed to operate on the pavement area day or night.

1) Caxton Village already suffered from excessive traffic issues from customers parking while collecting fast food and using shops and transport services of She[herds Bush Green. Any increase in the operating hours of food and beverage or retail on the Uxbridge Road will increase the traffic (cars / motor bikes etc) that are using the streets of Caxton Village for free parking.

2) Noise pollution from outside seating after 11pm will impact the residential amenity of the local residents.

3) If such venues are going to be allowed to operate beyond the 10pm times, then LBHF should evaluate the impact of transport and parking on the communities behind the Uxbridge Road. I understand a transport analysis was due to take place this year to understand the values of illegal parking, frequent use as a drop off/ collection for taxis and trade vehicles and associated anti-social behaviour that takes place due to this.

4) until provision is made for traffic / delivery drivers etc, then any further late night licences should be placed on hold.
