1. High Definition CCTV shall be installed, operated and maintained, at all times that the premises are open for licensable activities and;(a) shall be checked every two weeks to ensure that the system is working properly and that the date and time are correct. A record of these checks, showing the date and name of the person checking, shall be kept and made available to Police or authorised Council officers on request
(b) one camera shall show a close-up of the entrance to the premises, to capture a clear, full length image of anyone entering.
(c) shall cover any internal or external area of the premises where licensable activities take place.
(d) recordings shall be in real time and stored for a minimum period of 31 days with date and time stamping.
(e) footage shall be provided free of charge to Police or authorised council officer within 24 hours of a request.
(f) a staff member from the premises that is conversant with the operation of the CCTV system shall be on the premises at all times. This staff member will be able to show Police or authorised Officers of the Licensing Authority recent data footage with the minimum of delay when requested. This data or footage reproduction shall be almost instantaneous.
2. After 23:00, drivers shall wait inside the premises between deliveries/for deliveries.
3. Delivery drivers/riders will be given clear, written instructions to use their vehicles

in a responsible manner so as to not cause nuisance to any residents or generally outside the licensed premises; not to leave engines running when the vehicle is parked; and not to obstruct the highway. The licence holder will positively encourage delivery drivers/riders to use quieter vehicles that are less likely to cause a nuisance such as bicycles.

Good Afternoon Akil,

It was good to meet you yesterday and discuss your business model. As I explained, the Police do have some concerns with the hours of licensable activity that you have applied for. I explained that the vicinity of your premises suffers with a high level of anti-social behaviour and also it is situated at the end of a residential street. Operating later than you currently do, could have an effect on the quality of lives of local residents.

I explained that colleagues from other Responsible Authorities, specifically Noise and Nuisance Officers from the Local Authority may also have concerns and may contact you. We discussed, that although you are not selling alcohol, the conditions offered in the Operating Schedule are just statements and don't actually reference any specific conditions. I stated that I would be requesting further conditions.

To avoid an objection from the Police, I recommend the following conditions:

The provision of late night refreshment – **Indoors**
Fridays and Saturdays **23:00 to 00:00**

The provision of late night refreshment – **Outdoors**
Thursday **23:00-00:00**
Friday and Saturday **23:00-00:30.**

Opening hours of the premises
Sundays to Wednesdays **11:00 to 23:00**
Thursday **11:00 to 00:00**
Fridays and Saturdays **11:00 to 00:30**

To summarise, you cannot open any later than 23:00 Sunday- Wednesday. On Thursdays you can do take-away only until 00:00 and on a Friday and Saturday, you can have customers eating inside the premises until 00:00 and operate a take away until 00:30.

I am requesting the following conditions too:-

1. **High Definition CCTV shall be installed, operated and maintained, at all times that the premises are open for licensable activities and;(a) shall be checked**

every two weeks to ensure that the system is working properly and that the date and time are correct. A record of these checks, showing the date and name of the person checking, shall be kept and made available to Police or authorised Council officers on request

(b) one camera shall show a close-up of the entrance to the premises, to capture a clear, full length image of anyone entering.

(c) shall cover any internal or external area of the premises where licensable activities take place.

(d) recordings shall be in real time and stored for a minimum period of 31 days with date and time stamping.

(e) footage shall be provided free of charge to Police or authorised council officer within 24 hours of a request.
