We already experience significant night time noise at the base of Loftus Road from the cafe and people hanging around. At times I've had to sleep with earplugs as groups use the cafe and then walk up and down the street talking really loudly and refuse to stop when challenged.

Residents have frequently reported the area feeling unsafe due to the amount of men hanging around at late hours. Antisocial behaviour is already up because of businesses at the foot of a residential road with a recent stabbing because of the taxi and food delivery drivers using the cafe. This road no longer feels safe because of one late business, it is unacceptable to add another.

Crime is up in this street because of people hanging around at late hours. I've reported so many drug deals that I can see from the window in the very hours that this business wants to operate. We cannot condone this.

Parking is already nearly impossible in this street. It is always full, let alone with the customers of the cafe using residential parking spaces (and lbhf wardens not ticketing them as they know the people!!!) so people using this cafe will either be the users of the cafe, promoting noise and prolonging disturbance for residents, or will invite new footfall making problems worse.

Littering is already bad at the base of Loftus Road. Why bring a late business into the mix?

Not to mention, in a street with mass late night drug dealing going on, why does a company suddenly want to start a late night business? Have the police been informed in advance? You might want to save some time.

PLEASE do not permit this. The only customers who will use a late night business are the disruptive, aggressive and abusive cafe owners who are already making our lives a bloody misery, or drug buyers /drug dealers. Or loud abusive drunks after throwing out time. There is no excuse for this in what is supposed to be a residential area.

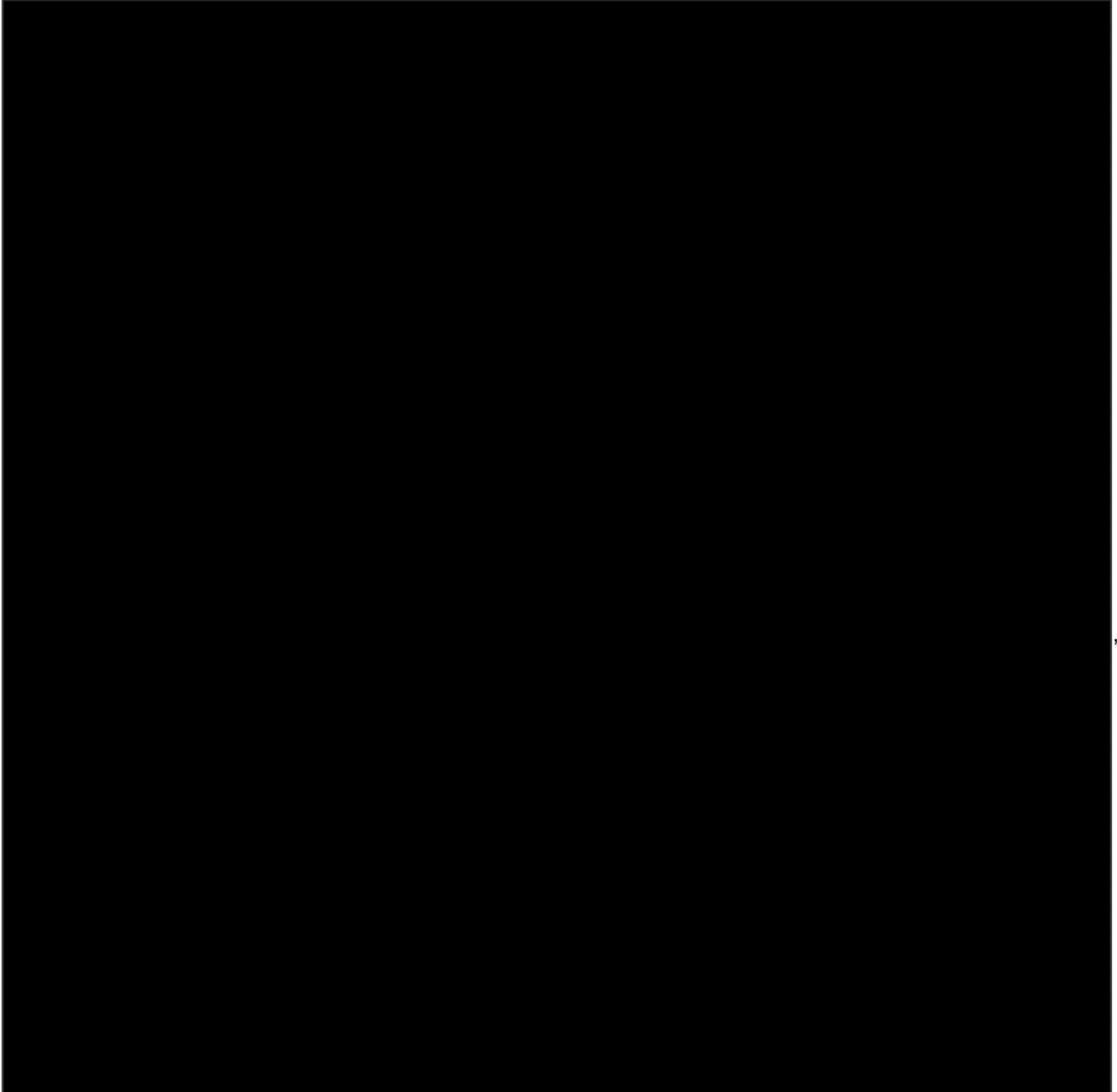

The junction of Loftus Road and Uxbridge road at which this venue sits is already a problematic space that residents, local police and the street enforcement officer fight to constrain. Currently there is sporadic drug dealing, frequent peeing on doorsteps in the first 100m of the street, haphazard and dangerous driving and parking, intimidating behaviour from groups of delivery riders covering the pavements. These latter choose the darkest narrowest parts of the pavement to gather and have offered my teenage children drugs and made suggestive and derogatory comments to my daughters so that on busy nights I have to walk down and fetch them from the junction. The litter, smell, excreta and waste these groups leave is shameful.

We have asked repeatedly for better lighting and 360 cameras on the junction - the one that points up-and-down Uxbridge Road at that point is insufficient to the Loftus Road problems.

The idea that an eat-in-eat-out restaurant will be open and licensed for these extended hours is genuinely horrifying. Currently drunkenness is not one of the challenges we face, if you add this in, the traffic will be more dangerous, the illegal parking near/on the junction worse. At the moment we manage to clear most of the noise and antisocial behaviour by around 23:30 (apart from occasional excesses on thus-sat nights). Late opening and serving alcohol from 'Tiger' will make this impossible and make our lives as local residents significantly worse.

The council has a key priority to work with residents, please work with us on this matter and do not make the local problems worse by imposing an ill-suited licensed venue that is extremely likely to make a challenging situation even worse. Loftus Road is a diverse and broadly

tolerant community with a strong neighbourhood ethic, Please help us tackle this and do not grant a license or permit such late hours.

Cliff Pinto, our street enforcement officer, has had a very difficult job trying to deal with the litter, the noise, the constant drug-dealing and the occasional violence that breaks out between the delivery drivers. I saw young people smoking weed or selling. The police are aware of the situation as we reported many times. The cafe on the opposite side, Revive, has often been reported. We have had meetings with the police and it is a notorious trouble spot. Because one of the doors to the restaurant is actually ON Loftus Road, this makes the problem worse. If the restaurant is licensed it will encourage yet more noise and trouble. If it is licensed that won't be popular in a predominantly Muslim area Loftus Road is a residential street which has usually been quiet at night, so that residents can sleep. If this diner is licensed it will encourage more people hanging about, more drug-dealing and more noise in the middle of the night. People in this street are very much opposed to granting this diner a license which will only exacerbate existing problems. I hope the police are fully aware of this destructive request for a license."

Comments: 23/10/2022 11:51 AM The corner of Loftus & Uxbridge is already very busy with the Revive Cafe plus taxis, motorbike parking and delivery drivers taking breaks. Our street enforcement officer, Cliff Pinto, takes real pride in his work on Loftus Road and we appreciate that. But he has a huge challenge keeping up with the litter, the noise, the constant drug-dealing and the occasional violence that breaks out between the delivery drivers at the junction with Uxbridge Road, where the Tiger restaurant is seeking a premises licence. As residents, we have been reporting issues with the cafe, Revive, on the opposite side - and that has no licence. Residents have had meetings with police over the issue and we have been asking for 360 degree CCTV for a number of years but are ignored. The junction of Loftus & Uxbridge is a notorious trouble-spot in W12 and the main door to the restaurant is actually on Loftus Road, so this makes the problem for residents worse. If the restaurant is licensed to sell alcohol it will encourage yet more noise and trouble and that won't be popular in a predominantly Muslim area which damages community cohesion. Loftus Road is a residential street with many families of many cultures living on it. If this diner is licensed it will encourage more people hanging about, more drug-dealing and more noise in the middle of the night which damages children's prospects. Residents are very much opposed to granting this diner a license which will only exacerbate existing problems. One of the key priorities of the council is to do things WITH residents and not TO them, and as a resident I hope this planning application will be rejected.

As a resident of the area, I object to the proposed Licence application for late night opening for this restaurant.
The Uxbridge road area of Shepherds Bush has a large number of establishments already operating late at night and I believe the area is considered rightly as a "Cumulative Impact Zone" as a result. We experience negative aspects of other local cafes and restaurants already operating late in to the night (with and without the relevant permits). There are significant disruptions to family life with noise and nuisance from clients of the late night cafes and restaurant congregating by their cars parked in nearby residential roads such as ours. We are writing to strongly oppose the above license for Tiger Restaurant on the corner of Uxbridge Road and Loftus Road. We are local residents on Loftus Road.

We **object strongly** to application for late night refreshment from 11pm 7 days a week by Mr Akil Efkih; opening hours Mon-Wed + Sunday 11am to midnight, Thurs 11am to 12.30am, Fri + Sat 11am to 1am in the morning; month of Ramadan 7 days a week 11pm to 1am in the morning.

We also object strongly to the take away restaurant seeking 'license for late night refreshment both indoors and outdoors' 7 days a week as 'outdoors' is understood to be use of the public pavement and road in Uxbridge Road and Loftus Road as both entrance doors access directly onto public space. Understand there is no outdoor external space at the rear of the property; if so we object to this being used after 11pm to avoid disturbance to residential neighbours.

The junction of Uxbridge Road and Loftus Road is currently a problem for local residents, police, Council, road safety, parking control officers, refuse collectors and street cleaners. The granting of this license will exacerbate these problems by encouraging the large numbers of Uber drivers and motorbike/moped/electric bike delivery men who congregate in this area. They park often with engines/air con running on double yellow lines, in bicycle lanes, double park and park in bays without paying, dropping litter and spitting, using and dealing in drugs, blocking the pavement and intimidating female pedestrians and disturbing the peace after 11pm. These problems and other ASB have been repeatedly reported to the police, Council, Highways and parking control officers who have been unable to control these 'non-residents' using our residential street for their commercial and illegal activities.

The licence would not only encourage them to visit more frequently and stay until 1am but attract more to congregate here at anti-social hours.

In addition to this application, we object to the use of the entrance with direct access to Loftus Road and the painting in black of the brickwork along Loftus Road which is not in keeping with the street and is aggressive like the Tiger Diner signage. As a residential street, such commercial presence should not be permitted. Following the illegal fixing of the giant advertising hoarding high on the walls of the residential flats of this property, the activities of Mr Efkih need to be carefully monitored by our Council.

Object strongly to application for late night refreshment from 11pm 7 days a week by Mr Akil Efkih; opening hours Mon-Wed + Sunday 11am to midnight, Thurs 11am to 12.30am, Fri + Sat 11am to 1am in the morning; month of Ramadan 7 days a week 11pm to 1am in the morning.

Object strongly to take away restaurant seeking 'license for late night refreshment both indoors and outdoors' 7 days a week as 'outdoors' is understood to be use of the public pavement and road in Uxbridge Road and Loftus Road as both entrance doors access directly onto public space. Understand there is no outdoor external space at the rear of the property; if so I object to this being used after 11pm to avoid disturbance to residential neighbours.

The junction of Uxbridge Road and Loftus Road is currently a problem for local residents, police, Council, road safety, parking control officers, refuse collectors and street cleaners. The granting of this license will exacerbate these problems by encouraging the large numbers of Uber drivers and motorbike/moped/electric bike delivery men who congregate this area. They park often with engines/air con running on double yellow lines, in bicycle lanes, double park and park in bays without paying, dropping litter and spitting, using and dealing in drugs, blocking the pavement and intimidating female pedestrians and disturbing the peace after 11pm. These problems and other ASB have been repeatedly reported to the police, Council, Highways and parking control officers who have been unable to control these 'non-residents' using our residential street for their commercial and illegal activities.

The licence would not only encourage them to visit more frequently and stay until 1am but attract more to congregate here at anti-social hours.

In addition to this application, I object to the use of the entrance with direct access to Loftus Road and the painting in black of the brickwork along Loftus Road which is not in keeping with the street and is aggressive like the Tiger Diner signage.

Additional air con units have been added to flat roof above ground floor overlooking both Uxbridge and Loftus Road which are unsightly and noisy for neighbours.

As a residential street, such commercial presence should not be permitted.

Following the illegal fixing of the giant advertising hoarding high on the walls of the residential flats of this property, the activities of Mr Efkih need to be carefully monitored by our Council.

Cliff Pinto, our street enforcement officer, has had a very difficult job trying to deal with the litter, the noise, the constant drug-dealing and the occasional violence that breaks out between the delivery drivers. The cafe on the opposite side, Revive, has often been reported. We have had meetings with the police and it is a notorious trouble spot. Because one of the doors to the restaurant is actually ON Loftus Road, this makes the problem worse. If the restaurant is licensed it will encourage yet more noise and trouble. If it is licensed that won't be popular in a predominantly Muslim area Loftus Road is a residential street which has usually been quiet at night, so that residents can sleep. If this diner is licensed it will encourage more people hanging about, more drug-dealing and more noise in the middle of the night. People in this street are very much opposed to granting this diner a license which will only exacerbate existing problems. I hope the police are fully aware of this destructive request for a license.

Thank you for the update which considers anti social behaviour in the immediate vicinity of the restaurant. Having read these terms I am now also concerned about who the police think will be coming to this restaurant - it makes me worry for my security and that of my kids now in this area.

My objection to this application is not addressed by these measures. The impact on the adjoining streets and LBH&F residents has not been considered. The issues I raised are: Noise of customers entering and leaving, having parked in nearby residential streets, including traffic, car alarms etc

Kerbside rubbish from customers buying food to consume near by. See photo - this is a daily issue for residents. This food attracts vermin, reduces our quality of life. The council is unable to keep up with the rubbish and other late night licences in the area have required the owners to collect rubbish. This has never happened. It's a waste of time imposing these rules without consequences for lack of adherence.

Noise from customers buying food to eat in their cars (music, loud conversations)

Urine left in bottles on the street or people using our streets as a toilet having finished their meal sat in their cars.

These licences attract out of borough traffic and each one awarded makes it more ingrained that this area is a hub for late night food.
