Friday and Saturday 23:00-01:00

Opening Hours:-

Sunday –Thursday (no change) between the hours of 08:00 – 00:00

Friday and Saturday 08:00- 01:00

**To summarise, the application has been amended to only extend the current licensable activities by 1 hour on a Friday and Saturday. All other licensable activities and hours remain the same.**
