SUMMARY

This report requests approval to award a contract to Kabaku General Services Ltd for £388,850 to facilitate the repair and refurbishment of the 1km of riverside railings in Bishops Park. The works will be wholly funded using secured external funding through the lease agreement with Fulham Football Club. This project will contribute towards Council priorities and aspirations, including repairing damaged infrastructure and 'Taking pride in H&F'.

RECOMMENDATIONS

That the Strategic Director of the Environment, in consultation with the Cabinet Member for Public Realm:

1. Award a contract to Kabaku General Services Ltd to facilitate the repair and refurbishment of the riverside railings in Bishops Park, at a total contract cost of £388,850.

Financial Impact

The proposed contract award to Kabaku General Services Ltd for the repair and refurbishment of riverside railings has a total contract value of £388,850. The estimated cost of the total project, including project costs (such as surveys, architects, Port of London Authority and project oversight) is £460,000 and is included in the Environment Department's capital programme. The total project cost, including the recommended contract award, will be fully funded from secured external funding from Fulham Football Club (held as the Bishop's Park earmarked reserve).

Although Kabaku General Services Ltd exceeds the Council's minimum required Credit Safe rating (as at 15 December 2023), the Credit Safe annual recommended contract limit is below the contract award value proposed in this report. To mitigate any associated risk, it is expected that payment will only be made upon completion of agreed milestones.

Legal Implications

The Council has the power to undertake these works as part of its duty to maintain parks under the Open Spaces Act 1906. The contract is for works and below the threshold for the Public Contracts Regulations 2015 to apply. There are therefore no statutory requirements governing the procurement.

This is a high value contract for the purposes of the Council's Contract Standing Orders. The open procurement which has been undertaken is compliant with CSOs 18 and 19. This is a key decision under the Council's constitution and will need to be included in the key decision list on the Council's website.

DETAILED ANALYSIS

Proposals

- 1. Hammersmith and Fulham council is committed to providing high quality outdoor space for its resident's and a key aspiration is to become the greenest borough in the country. This project also fits with the Councils values of 'Taking pride in Hammersmith and Fulham' and 'Doing things with residents, not to them', as this is very much a priority of the Friends of Bishops Park and a necessity to improve the aesthetics and safety of the riverside walk.
- 2. Refurbishing the 1km of riverside railings will benefit the park as it would accompany the recently renovated riverside walkway which has been resurfaced, using a more sustainable material. This area of Fulham has many businesses nearby and a high footfall of visitors during match days at the nearby Fulham FC ground. By refurbishing the railings, we will improve the look of the park and reassure visitors that ongoing maintenance of parks infrastructure is taking place and ensure that the railings are safe.
- 3. Twenty-two of the borough's parks have Green Flag status. Bishops Park obtained a Green Flag for the first time in 2013 and improving the park will contribute to safeguarding this award of excellence in future years.
- 4. Bishops Park also has Grade 2 Heritage listing, although the railings are not a listed structure but form a key element of the splendour of the park. This project, however, is part of the agreed Parks Capital Programme (project 20) and is fully funded from secured external funding.

Reasons for Decision and options

- 5. A procurement strategy was approved by the Strategic Director of the Environment in consultation with the Cabinet Member for Public Realm. An open tender opportunity was then carried out between the 15th September and 18th October on the Council's online procurement portal (ITT_17482).
- 6. During this process two bids were received however the submission by Bidder 2 failed to pass the Council's qualification criteria as they failed to provide details of previous experience as outlined in the Qualification envelope.
- The Council were however able to successfully evaluate Kabaku General Services tender with the evaluation scores shown below. Table 1: Tender evaluation scores:

- 8. Kabaku General Services Ltd scored well in their social value submission, issuing a proposal of 15.7%. They also provided satisfactory responses to the method statement, health and safety and environmental awareness sections of the response document, providing reassurance that they have the necessary experience to deliver this project.
- 9. The Parks Team therefore recommends Kabaku General Services Ltd as the preferred bidder to deliver this project.
- 10. The project delivery will be managed through onsite inspections along with the following key performance indicators.
 - a. Tenderer to produce a logistics and operations plan prior to the start of any works to be agree with the local authority
 - b. Tenderer to produce a works programme where an accurate assessment of the percentage of completed works will be assessed and monitored. This will provide valuation certificates against contract spend.
 - c. The Council and appointed architects will conduct regular inspections and reviews of completed works and to ensure all health and safety requirements are being adhered to.
- 11. The contract length is estimated to be 12-14 months, but this may be shortened once approved and conversations with the successful bidder begin.

Equality Implications

12. An Equalities Impact Assessment has been completed for this project and is shown in Appendix 1.

Risk Management Implications

- 13. There is a risk to public health during the delivery of the contract. An accompanying health and safety review should be undertaken to protect the public during the delivery.
- 14. There is a risk that the delivery may not be of an acceptable standard. It is therefore advised that a spot check review of the delivery is conducted.

Climate and Ecological Emergency Implications

- 15. Refurbishing rather than replacing the railings at Bishops Park will reduce the amount of embodied carbon and waste materials generated, and Kabaku General Services will be asked to use recycled materials where possible for components that do need to be replaced.
- 16. Kabaku advise of a companywide programme to reduce excess packaging and to also re-use packaging where possible. Excess materials are also often sent to Material Recovery Facilities which will clarify during the construction phase.

17. The licence agreement with the Environment Agency required a bat suitability survey to be carried out. This has been completed and shown a negligible likelihood of roosting sites along the railings coping stones. However, sites have been identified in adjacent trees and the Environment Agency have issued recommendations on how to reduce the impact on potential roosts by managing any lighting used.

- 18. The results of the evaluation process have been verified against the e-tendering system.
- 19. The contract shall be created in the contract register and a signed copy of the contract uploaded to ensure compliance with statutory transparency requirements.

Local Economy and Social Value Implications

- 22. It is a requirement that all contracts let by the council with a value above £100,000 propose and commit to social value contributions that are additional to the core services required under the contract.
- 23. This supplier has committed to a proxy value of 15.6%.
- 24. It is recommended that the commissioner works closely with Legal Services to ensure appropriate social value clauses are included in the contract, so that the council can enforce its right to remedies if social value commitments are not delivered.
